

DEDICATION



This year's town report is dedicated to the Grafton Volunteer Ambulance Department in honor of their 20th birthday. On September 14, 1974, 14 members of the Grafton Fire Department met to organize a FAST squad. Ken Cushing was among those members that enrolled in a sixty hour advanced first aid course. Nine members went on to take a 150-hour EMT course.

In December of that same year, Grafton's Civil Defense director acquired a former Navy ambulance and an important ruling was made by the Attorney General allowing a broader use of the Kilton Fund, thus Grafton Volunteer Ambulance Department was born.

In October of 1975 the Grafton Volunteer Ambulance Department was formally recognized as a volunteer department. During the past 20 years there have been several ambulance captains and members have come and gone, none have remained for the duration, except one - Kenneth Cushing.

The Town of Grafton wishes to commend Ken for his many years of volunteer service on the Grafton Volunteer Ambulance Department.

Those requiring the services of the ambulance are not charged. The members volunteer their time and the department has proven its worth to the people of our town.

The foresight of those 14 people contributed to what the ambulance is today.

SUMMARY OF 1995 WARRANT ARTICLES

- 1. All Officers duly elected.
- 2. Voted to hear report of Budget Committee and act thereon.
- 3. Defeated article to purchase highway truck for \$38,800.
- 4. Voted to raise \$32,500 for replacement of bridge by recreation field. (second of three installments)
- 5. Established capital reserve fund for a new fire truck and raised \$15,000 for same.
- 6. Defeated article to raise \$15,000 to be added to the Bridge Replacement Capital Reserve Fund.
- 7. Created an Expendable General Trust Fund to be known as the Fire Equipment Fund and to transfer \$11,379 from 12/31/94 fund balance for said purpose.
- 8. Raised \$10,000 for upgrade of fire engine #2.
- 9. Raised \$5,500 for top course of paving to be put on parking lots at the town offices, fire station and library.
- 10. Defeated article to add \$2,500 to the Recreation Shelter Capital Reserve Fund.
- 11. Raised \$2,000 for survey and site plan of the town office property.
- 12. Raised \$2,000 for a local household hazardous waste collection project.
- 13. Raised \$4,950 for dry hydrant program. (5 year non lapsing fund)
- 14. Raised \$2,000 for library handicap ramp. (2 year non lapsing fund)
- 15. Raised \$528 for restoration of old records. (5 year non lapsing fund)
- 16. Defeated article to appropriate funds to make town hall handicap accessible as no monies were attached to the petitioned article. It will be researched for next year.
- 17. Passed article to recognize the Grafton Volunteer Fire Department as a town managed department and authorize Selectmen to confirm all nominations for members and officers.
- Passed article to recognize Grafton Volunteer Ambulance Squad as a town managed department and authorize the Selectmen to confirm all nominations for members and officers.
- 19. Voted to allow Historical Society to lease old fire station.
- 20. Voted to establish a five member Recreation Commission. Members to be elected by official ballot.
- 21. Voted to discontinue the following Capital Reserve Funds: Town Office Capital Reserve Fund, New Ambulance Capital Reserve Fund, History Book Capital Reserve Fund and the New Fire Station Capital Reserve Fund.
- 22. Defeated article to take action to prepare 2-acre lot adjacent to recreation field for a parking lot as no funds attached to petitioned article.
- 23. Voted to remove street light on Route 4 by the post office.
- 24. Voted to elect a full time police chief instead of a part time police chief.
- 25. Voted to change from electing a police chief for one year to electing a police chief for three years starting in 1996.

WARRANT FOR THE TOWN OF GRAFTON THE STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Grafton in the County of Grafton in said State qualified to vote in Town affairs:

You are hereby notified to meet at the GRAFTON TOWN HALL in said Grafton on Tuesday, the twelfth day of March next, between the hours of 11 AM and 7 PM to act upon the following subjects:

- To choose all necessary town officers for the next year ensuing including Selectman (3 years), Moderator (2 years), Town Clerk (1 year), Tax Collector (3 years), Town Treasurer (1 year), Road Agent (1 year), Budget Committee (3 years), Trustee of Trust Funds (3 years), Chief of Police (3 years), Auditor (2 years), Cemetery Trustees (2 & 3 years), Planning Board (3 years), Supervisor of Checklist (6 years), Recreation Committee (1 year), two Recreation Committee (2 years), two Recreation Committee (3 years).
- 2. Also to take any other action required to be inserted on the official ballot.

The remaining articles to be acted upon on at 1 p.m., Saturday, March 16th, 1996 at the Grafton Fire Station.

3. To see if the Town will vote to hear a report from the Budget Committee and to raise and appropriate the sum of \$545,290 as detailed below and recommended by the Budget Committee for general town maintenance. Said sum does not include special warrant articles addressed.

- 4. To see if the Town will vote to raise and appropriate the sum of \$70,296 for a new highway vehicle and to withdraw \$33,600 from the Highway Equipment Capital Reserve Fund, receive \$5,700 on trade-in of '73 and '84 vehicles and the remaining \$30,996 to be raised by general taxation. Not recommended by the Selectmen. Recommended by the Budget Committee.
- 5. To see if the Town will vote to raise and appropriate the sum of \$39,330 for the purpose of a 3-inch course of paving for Slab City Road (3000 feet). Recommended by Selectmen and Budget Committee.
- 6. To see if the Town will vote to change the purpose of the New Fire Truck Capital Reserve Fund established in 1995 to the Fire Truck Capital Reserve Fund. (2/3 vote necessary)
- 7. To see if the Town will vote to raise and appropriate the sum of \$30,000 for a fire truck and to withdraw from the capital reserve fund established for said purpose, the sum of \$15,000 plus accrued interest until time of withdrawal and the remaining monies to come from taxation. Recommended by the Selectmen and Budget Committee.
- 8. To see if the Town will vote to raise and appropriate the sum of \$32,500 which is the last of three installments to replace bridge 151/073 next to the recreation field. This is a five year non-lapsing appropriation. The revised State estimate is \$445,000 and the town's share is \$89,000. Recommended by the Selectmen and Budget Committee.
- 9. To see if the Town will vote to raise and appropriate the sum of \$15,000 to be added to the already established capital reserve funds as follows:

Highway Equipment Capital Reserve Fund - \$10,000 Property Reappraisal Capital Reserve Fund - \$5,000

Recommended by Selectmen and Budget Committee.

- 10. To see if the Town will vote to raise and appropriate the sum of \$8,600 for purpose of installing vinyl siding on the town hall and for two window replacements. Recommended by the Selectmen and not recommended by the Budget Committee.
- To see if the Town will vote to raise and appropriate the sum of \$6,700 for the purchase of a used Onan 15KW propane generator including delivery and installation for use at the town office and fire station. Not recommended by the Selectmen and Budget Committee.
- 12. To see if the Town will vote to raise and appropriate the sum of \$7,000 for converting the two bathrooms at the town hall into one unisex bathroom that is handicapped accessible, construction of a handicap ramp and renovation of the entry way. Not recommended by the Selectmen or Budget Committee.
- 13. To see if the Town will vote to raise and appropriate the sum of \$3,500 for a new chimney and roof repairs for the library. Recommended by the Selectmen and Budget Committee.
- 14. To see if the Town will vote to raise and appropriate the sum of \$3,000 for upgrade of fire engine #2. Not recommended by the Selectmen and Budget Committee.
- 15. To see if the Town will vote to raise and appropriate the sum of \$447 to be added to the five year non-lapsing appropriation for the continuation of restoration of old town records. (Fund has a balance of \$78 at year ending '95). Recommended by Selectmen and Budget Committee.
- 16. To see if the Town will vote to grant the employees of the Grafton Recycling Center two(2) paid, floating holidays, per year, effective immediately. By petition.
- 17. To see if the Town will vote to establish a recreation fund, pursuant to RSA 35-B:2, II. The fund will be used to establish, maintain, and operate town recreation facilities. All revenues from fees and charges for Town recreation park services and facilities will be deposited in this fund. The fund shall accumulate from year-to-year and shall not be considered part of the general surplus. The Town Treasurer shall have custody of the fund and expenditures from the fund shall be made only for purposes specified in RSA 35-B upon order of the Recreation Committee.
- 18. To see if the Town will vote to abolish the positions of Fire Commissioners and to have such abolishment become effective immediately. By petition.
- 19. To see if the Town will vote to change the road agent term from one year to three years pursuant to RSA 231:62-a. If passed, this would become effective at the next annual Town Meeting. (Paper ballot required)
- 20. To see if the Town will vote to clarify the organizational structure of the Town Fire .

Department as follows:

- 1. The Fire Chief shall be elected by the members of the department subject to confirmation by the selectmen. The Chief shall serve an annual term beginning in January of each year.
- 2. Members of the department shall be elected by the membership with approval of the Chief.
- 3. Finances and property shall be handled pursuant to RSA 154:1-a.
- 21. To see if the Town will vote to clarify the organizational structure of the Town Ambulance Squad as follows:
 - 1. The Ambulance Captain shall be elected by the members of the department subject to confirmation by the Selectmen. The Captain shall serve an annual term beginning January of each year.
 - 2. Members of the department shall be elected by the membership with the approval of the captain.
 - 3. Finances and property shall be handled in the same manner as is provided for the handling of municipal fire department property by RSA 154:1-a.
- 22. To see if the Town will vote to discontinue the Sleeper Road, so called, leading from Razor Hill Road in an easterly direction to the Brundage Estate homestead for a distance of 3880 feet (0.735 mile) pursuant to RSA 231:43.
- 23. To see if the Town will vote to authorize the Board of Selectmen to submit an application to the Federal Emergency Management Agency (FEMA) to accept the Town of Grafton into the National Flood Insurance Program (NFIP). The Board of Selectmen will work with the Planning Board to begin the process of adopting the NFIP requirements at next year's town meeting.

SELECTMEN'S REPORT

At the annual Town Meeting the townspeople voted for a full-time Police Chief. Merle Kenyon was elected to the position as part-time, and once approved full-time, the Selectmen appointed him to fulfill the year, although he did not begin his duties until June.

The Town experienced another change when John Bassett, Road Agent of 30 years, decided to retire.

The Town instituted mandatory recycling in the month of April. Although this change was difficult in the beginning, the townspeople, with the help of the Recycling Center employees, have made the program a success. Two grants were received through the Recycling Center, one with matching funds for a waste oil furnace and the second towards hazardous waste pick-up.

The Selectmen are working with the Fire Department towards the installation of 2 dry hydrants. The first to be installed at Kilton Pond and the second to be incorporated with the Prescott Hill bridge.

The Highway Department prepared the groundwork for paving projects on Library Road, Prescott Hill, the Town Office and Fire Department parking lots last summer.

The Selectmen, with the assistance of department heads, have been writing job descriptions, policies and a Personnel Handbook. A Safety Committee for Joint Loss Management to comply with Compensation Funds of New Hampshire has been formed. This committee will be utilizing many of the job descriptions along with addressing new policies for preventative measures.

A contract was signed between the Town and the American Red Cross allowing them to assist during disasters or emergencies. In the event of such an emergency the Fire/Ambulance station would be the Red Cross headquarters.

The enhanced 9-1-1 system is now ready for use. In the event of any emergency simply dial 9-1-1 for assistance.

Grafton held an annual Green-up Day in May encouraging all townspeople to help clean up the roadsides and their property.

The Prescott Hill Bridge project will be put out to bid soon and, hopefully will be completed in 1996. In 1997 the Selectmen encourage the Town to continue with the bridge projects.

The Town of Grafton is seeking the approval of another housing block grant this year. The submission for the grant is slated for July.

In looking to the near future of the Town it is necessary to address the needs of some of the town buildings such as the Library, the Town Office and the Town Hall. These buildings are in need of many renovations and repairs. Now that some of the Town's other projects and purchases are nearing completion it will allow us to address some of these problems.

In closing, the Selectmen wish to thank all of the volunteers and townspeople for their support during this past year and encourage all to be part of your town government.

REPORT OF TOWN FOREST FIRE WARDEN AND STATE FOREST RANGER

In calendar year 1995, our three (3) leading causes of fires were Children, Non-Permit fires not properly extinguished and Smoking Materials.

Violations of RSA 224:27 II, the fire permit law and the other burning laws of the State of New Hampshire, are misdemeanors punishable by fines of up to \$2,000 and/or a year in jail. Violators are also liable for all fire suppression costs.

To aid your Forest Fire Warden, Fire Department and State Forest Fire Officials, contact your local Warden or Fire Department to find out if a permit is required. This also helps to prevent unnecessary response to a controlled burn.

Engine 2 received an upgrade this past year. This upgrade gives the department a better operational vehicle, as Engine 2 is their most demanded piece on any emergency call. Space has been adjusted to allow for a more timely accessibility to equipment.

The department, with the help of the Ladies Auxiliary, has been steadily getting new pagers for its members. Our area is a difficult one for the transmission of radio waves. The new pagers help with this and allow more members to hear emergency calls.

This past year has been difficult for the members, as well as the township. Being under the direction of three Chiefs took many adjustments on the part of department members. Members did, however, make the adjustment and responded to all emergency calls in 1995. Over the past year it seemed to be a concern to the people of Grafton that the department response would be inadequate. Fire Department members working as a team of professionals managed to put the difficulties aside and respond to emergency situations in the manner in which they were trained. It is fortunate that Grafton has such a team working together for the safety and protection of its community.

Please remember that 911 is now in effect. Make all your emergency calls to this number. Dialing 911 will process your call quickly and alert emergency response personnel in a more timely manner.

This past year we participated in the Independence Day Celebration, Old Home Day, the Grafton Country Fair and held our 4th Annual Auction and BBQ. By setting up a booth at these events we are able to raise funds and make purchases of equipment, supplies, materials for the station, or help with training expenses.

In 1995 the Association provided the following services or materials to the Fire Department and/or the Town of Grafton: Electrical work on the interior of the Station, flooring tile and glue for the kitchen/bathroom area, a stove and refrigerator for the station, training expenses for Fire Department members, Alert All 911 packets and calendars, and awards for recognition of Fire Department members. The pagers were given to the Fire Department to help provide emergency equipment that was not allotted in their annual budget.

AMBULANCE REPORT

Grafton Ambulance responded to 59 calls in 1995. These responses included both serious and minor trauma, emergency cardiac care, and other medical problems. We responded as mutual aid for the fire department at structure fires and to the towns of Canaan and Danbury. We had the opportunity to work with DHART, the medical helicopter at Dartmouth-Hitchcock Medical Center, during a critical trauma call that occurred in a remote area in Grafton. We thank both the DHART crew for their expertise and follow-up, and the Canaan Fire Department for their efficiency in creating a landing zone for the helicopter to land and meet the ambulance crew.

This past year a public CPR course was held in the Spring and the Fall. We hope this will become a regular bi-annual event that we can offer to our community. Please consider taking one of these courses. The skills you learn can help save a life. We have also started a blood pressure clinic that is held on the third Saturday of each month at the Grafton Post Office. We thank Postmaster Linda Loop and her staff for their support with this project. We continued to co-sponsor the summer swim program with the Grafton Recreation Committee. The program received many compliments and our thanks go to swimming instructor Jerome Kramer for his dedication and hard work with the children. Two ambulance members spent a day surveying the town for potential pre-designated landing zones for the DHART helicopter. We enjoyed getting out and talking with people as we accomplished this task. A second trip was made with the Emergency Management Department as they completed collecting information for the Enhanced 911 program.

This year the service decided to purchase four sets of emergency gear. This includes fireproof and rip resistant jackets, boots and helmets to protect responders at dangerous scenes such as car accidents and structure fires. Two of the sets were bought with ambulance funds with the other two sets being purchased through donations received from the Canaan Lions Club, the Grafton Fire and Ambulance Women's Auxiliary and general donations. Thanks to all who contributed.

Highlights of our training included some members participating in the EMS for Children's Pediatric Trauma Care Course, a gunshot wound management class held in Grafton and a member attending classes at UNH at Durham and receiving certification as an EMS Instructor/Coordinator. Three members have recertified as Emergency Medical Technicians and two as EMT-Intermediates. We welcomed one new member, Stephanie Sudrabin, to our service. There are many changes being proposed and some already in place for emergency medical services. For this year the new basic curriculum will be introduced and all EMT's will be trained in the new skills and approaches to patient care. Looking even further ahead is a movement towards expanding our field with EMS providers assuming roles in primary care. There are now ten active members providing emergency pre-hospital care. EMT and First Responder courses have been offered in the area and more are planned. We encourage anyone with an interest to contact any ambulance member or the Town Office for information about training and joining the service.

Providing emergency services in Grafton can be challenging and requires responders to be well trained in their field. We have a lengthy transport time to our hospitals due to our distance from them and some of the physical barriers of this region. Because of these hindrances we urge you not to hesitate to call 911 if you are in need of an ambulance. The earlier you call in an emergency the sooner you or your loved one can receive medical attention and be delivered to an appropriate hospital for further definitive care. It is important to remember that pre-hospital emergency care is the first tier in the delivery of "total patient care". We transport to five different hospitals with Dartmouth-Hitchcock Medical Center being our

"Medical Resource Hospital". This is where we receive our protocols from and where our medical director is located. We are fortunate to be affiliated with such a dynamic institution and have received a tremendous amount of support from the physicians and Emergency Department staff. We have also benefited from the EMS programs at Franklin Hospital and from the support of the staff at New London Hospital.

This past year we saw some unfortunate situations arise that attracted the attention of local media. The bottom line is that the ambulance is committed to ensuring that safe, quality prehospital care is delivered to our patients. We are not only responsible to our patients, but also to our medical director and the Department of Health and Human Services, Bureau of EMS, to maintain the highest quality of care that we can provide. ROAD AGENT'S REPORT

The year 1995 started as a mild winter that saw spring come early and almost no mud season so the road crew could start grading, raking and graveling roads. The highway crew spent two weeks hauling gravel and grading on Hardy Hill Road and Grafton Pond Road, as these were the worst roads.

The dry summer made it very difficult to keep up with the washboard and dusty roads in town.

The Highway Department ditched and swepted Library Road and Prescott Hill Road for paving and Blaktop Inc. came in August and top-surfaced the parking lots, all of Library Road and Prescott Hill Road from Braley's bridge to Williams Hill Road.

We also shimmed with hot top Library Road, Prescott Hill Road, Barney Hill Road and Grafton Turnpike.

New culverts were installed on Grafton Turnpike, Razor Hill Road, Riddle Hill Road, Hardy Hill Road and the corner of Snug Harbor Road and Razor Hill Road.

A road project was done on Gifford Hill Road below Gray's. This consisted of cutting trees, stumping, replacing culverts and graveling.

The Highway Department started a clean-up project at the Highway Garage of unused equipment and junk.

After stockpiling winter sand we had heavy rains that washed many roads in town so the road crew repaired them, while installing sanders and plow frames on the trucks for winter which started in November.

The Road Agent also worked at the Recycling Center, Library, and Town Offices, attended to driveway permits, complaints and meetings. Also took classes for drug and alcohol testing for supervisors which is mandatory.

Thank you for all your support in 1995.

GRAFTON POLICE DEPARTMENT

Nineteen ninety five was a year of many changes for the Grafton Police Department. It was voted at town meeting to have a full-time chief and also to change the term of office from one year to three years starting in 1996.

I graduated from the New Hampshire Police Standards and Training Council Academy and was certified as a full-time officer in November of 1995. A task that would have been impossible without the support of my family, the townspeople, and the town administration. I can't begin to thank everyone for their help and understanding.

The new radar unit has arrived and is even a better piece of equipment than I had expected. The total price was \$1,970.00. We have been approved for a grant from the New Hampshire Highway Safety Agency to cover half the cost.

The dog issue once again has become a major problem. If you own a dog you are responsible for having it licenses with the town and also having it under your control at all times.

The 911 system went on line in June 1995. If you have an emergency you can dial 911 and your call will be directed to the correct agency to handle your emergency. The police department has entered into an agreement with the Grafton County Sheriff's Office to handle our dispatching. If there is not an officer on duty a call to the station will be call forwarded to the sheriff's office and they will contact whoever is on call. The sheriff's office will also receive our police 911 calls.

As usual the majority of our calls are generated from townspeople who observe something they think is not right. This system works very well. If you notice something unusual please don't hesitate to call.

EMERGENCY MANAGEMENT REPORT

We welcome the year of nineteen hundred ninety six as we put away the past year. We are still working toward productive change in our emergency services. It has been said that change is one of the hardest things to accept. The Emergency Services team of this community started about fifty years ago and, much like a child growing up, it started as an infant stumbling, listening and learning. It grew and became a child and tested its independence. It then became an adolescent, testing and questioning everything. Finally, we have become a young adult and must seek the wisdom of our elders and others. Sometimes this becomes very hard to do because of the lessons that we were exposed to as we grew up. As you know, the Fire and Ambulance departments have had a rough couple of years of growth, as do most in their young adult years. This does not mean that it was not productive growth. Although not all involved will agree with this statement, I believe it is true. In the past eight years we came from the wonderful but cramped quarters that the youth of our team built as they grew from their infancy over fifty years, to a new station. You had the faith in them and now in us. Through the support you have given we have been able to do the following: to purchase new equipment to keep our fire fighters safe: to purchase a new, fully equipped ambulance to help save lives; to build a police station; and to place a full time police chief for a safer environment. In turn, each portion of the team has instituted specialized training for each of their departments. The team's efforts and your help are making our emergency services one of the best trained and equipped in the area, which has made your town a great deal safer for all.

It has taken a toll on some and made others shine. I take my hat off to <u>ALL MEMBERS</u>, from Fred Gage, the first Fire Warden in 1918, through to our present members, and on to the future. We have come to a point in the growth of our community that we must put all of the trials of the past behind us. We must use candor with diplomacy in what we do and work, not for personal gain, but for the community's welfare.

I ask that when you read this that you understand that not all the members of this team want to argue. So please keep on helping us as you have in the past to move forward in the areas of safety.

The Emergency Management Department has spent most of this year working on the emergency plan and 911 mapping. We have been in constant communication with NYNEX over some 200 address changes and discontinued phone numbers. We have also been meeting with the Selectmen over road naming and the town map updating. We have spent time with the Ambulance department regarding Dartmouth-Hitchcock Air Rescue Team (DHART) locations for the mapping.

We are still working toward completion of the enhanced 911 system. As you know, it is on line. Please remember if you call 911 that some of the over 600 phone numbers in our community have very generic addresses attached to them. For example, Route 4 or Grafton Turnpike. These are long roads and you could be anywhere on them. When you call 911 it is picked up by the Enhanced 911 operator at a central location in our state and an address appears on a computer screen in front of them. If you are disconnected during the call the only thing they can forward to dispatch is what they have on the screen. So please be clear and concise with the name and location first and the nature of the call. We are working toward getting all of your names and addresses matched properly so they appear correctly on the screen. We are still waiting for the numbered address mapping from the state. I think that when the State of New Hampshire started this numbered mapping they thought it would be an easier task. We will have a public meeting after Town Meeting on road names. I will be around with the Postal Service when the maps are in and you will be notified of any road and numbered address changes.

Most recently the team has signed an agreement with the American Red Cross team to assist you in the event of a personal emergency, as well as to provide assistance to the town in the event of a major disaster. Their services include the provision of food, clothing, shelter, and financial aid. I ask you to vote yes for the purchase of an emergency generating system to be installed in our fire station so that the station can be used for shelter. The town offices as emergency operations center, and police station as radio communications and security will also benefit from this equipment. The installed cost is \$6,700.00. Thank you.

I ask that you vote "yes" on the National Flood Plain Management article. This will give us mitigation money to offset the high cost of our bridge replacement and other highway mitigation projects in the future. This could save us \$50,000.00 or more on the Prescott Hill Bridge project. If you have any questions, please call me at 523-4313.

I have done the paperwork necessary to receive about \$11,000.00 from the Federal Emergency Management Agency in mitigation money for damages to our roads from the severe rain storms of October and November 1995. Grafton and Coos counties were declared disaster areas during these storms. This is mitigation money that can only come to us after the damage has occurred and the area has been declared a natural disaster by the President. The Hazard Mitigation money that I mentioned in the paragraph above for mitigation before a disaster, are only accessible to us if we become a member of the National Flood Plain Management Program.

The Selectmen's office has placed a safety team in effect. It consists of the board of Selectmen: Chris Williams, Jennie Joyce and Bonnie Haubrich; Chief of Police, Merle Kenyon; Capt. of the Ambulance, Michael Gauthier; and Director of Emergency Management, John D. Knott Jr. This team will meet and discuss possible ways to mitigate safety issues concerning town operations. This is designed to lessen liability risk and save on insurance costs.

I appreciate the years of support you have given me and this department. I could not have done without the community uniting in one great team effort.

RECYCLING STATION

In 1995 we had one of our busiest years at the Recycling Center. The start of mandatory recycling and educating the people on what to recycle and where to put it took a while. We were also busy trying to tell people how important it is to recycle. Recycling protects our environment by sending less trash to landfills. We as taxpayers save money by not sending our trash to landfills. Transportation costs and tonnage fees are just a few ways that we save. More importantly we receive monies from our recyclables. The money that we receive goes into the general fund to help offset taxes.

In 1995 we were paid for two trailer loads of cardboard, two loads of plastics, two green boxes of newsprint, and a load of rags. By recycling these items the town received \$9,769.23. As you can see, the importance of recycling pays off.

We received a grant from New Hampshire the Beautiful in the amount of \$2000.00 to help with the purchase of an oil furnace that is used in the recycling building. It is run by used motor oil and is set up to burn other fuel as well. Also in 1995, we received a second grant from the state to help with the Hazardous Waste Day in Grafton. Due to unforeseen circumstances we had a difficult time trying to let people know when this event was taking place. We did receive a substantial amount of hazardous waste for the day. The problems we experienced in our first year should be ironed out to make our second year more successful. We are hoping to hold a hazardous waste collection day sometime in July.

We will also start recycling household batteries (such as flashlight and camera) so watch for signs letting you know when we will start. We have started taking magazines, junk mail, books, etc. so remember to keep these items separate.

We would like to thank the town's people for their cooperation in the changeover to mandatory recycling, which helped things move smoothly. Although we still have some rough spots, we will conquer them in time.

I would like to thank Wesley Joyce, Stew Downs, and everyone else that worked or volunteered their time to help out at the Center. Also a special thanks to Bob Bassett and his road crew for the work you have done at the Recycling Center.

Please remember to tell friends and relatives how important it is to recycle. Not just in Grafton, but everywhere else too.

GRAFTON HISTORICAL SOCIETY

1995 has been an excitingly busy year for the Grafton Historical Society.

The old fire station was moved to a temporary location near the pole barn, and a lease was signed on November 4, 1995 between the Town and the Society. The building will be moved to a permanent site this spring and work will commence on Grafton's Museum.

We are working with the owner of the Carding Mill in East Grafton who is interested in donating the building and land to the Society.

The Grafton Historical Society is very much involved in fund-raisers in order to meet the restoration expenses ahead. Included have been the sale of maps, mugs, a yearly pancake breakfast on Old Home Day, flea markets, bake sales, country dance, Christmas Auctions, fundraising letters including a questionnaire, and a cord-of-wood raffle. In addition, we are actively pursuing grants in order to purchase the Pine Schoolhouse on Cherry Hill Road. The plan is to completely restore the Schoolhouse and to focus on our school children. To invite children and their teachers to spend time in a school environment from our past, without current-day teaching aids.

A Donors' Record book is being kept which lists the names of people who donate artifacts, funds or volunteer their time.

Ongoing are requests from folks doing genealogical research on their Grafton forefathers.

The Society meets the 3rd Sunday of every month at 6:00 p.m. in the Town Office Conference Room. Membership is \$10.00 per person and we currently have 25 members.

UPPER VALLEY LAKE SUNAPEE REGIONAL PLANNING COMMISSION

The Upper Valley Lake Sunapee Regional Planning Commission is a voluntary association of 31 towns, 4 Vermont and 27 New Hampshire communities. The Commission is concerned with the development of comprehensive plans for beneficial and balanced economic, environmental and social growth in the Region. It functions as a research, resource, and informational agency, and when appropriate, acts to obtain Federal, State and other approvals, grants-in-aid, loans and similar assistance for individual member towns and for the Region. The Commission provides technical assistance to member communities in the areas of planning (land use, transportation, water quality, etc.), mapping, community development, grantsmanship and grant administration. In addition, regional publications, such as our **Regional Profile**, regional studies, such as our Regional Transportation Plan, and regional projects, such as the Lake Sunapee Watershed Management Plan, are undertaken to the benefit of more than one community.

In the past year, services such as our Planning Board training series, and library which features maps, planning resources and US Census data, were available to all of our member communities. A complete list of services and regional projects which benefit our members follows the list of services provided directly to residents of Grafton.

In 1995, our work specifically for the Town of Grafton included:

- Held a series of workshops on the economic development potential of the Route 4 corridor.
- Developed a one-page economic data summary sheet for the Town.
- Provided information about manufactured housing in town.
- Provided administrative assistance to the Upper Valley Solid Waste Management District.

Our Commission looks forward to continuing to serve Grafton in the coming year.

COMMISSIONERS' REPORT

The Grafton County Board of Commissioners is pleased to present the following reports and financial statements. We hope they will increase your understanding of Grafton County's finances and operations and assure citizens that their county tax dollars have been expended wisely.

During FY 1995, funds received exceeded the budget by \$163,615.52 for a total of \$14,981,914.52 in actual County revenues. This was primarily due to the receipt of Medicaid Proportionate Share Payment, given by the Federal Government to partially offset the cost of serving a disproportionate share of Medicaid recipients at the County Nursing Home.

Actual expenditures totaled \$14,598,041.22 which was \$220,257.78 less than had been budgeted. This includes \$378,525 paid to the State of New Hampshire to enable the County to receive \$757,050 in Medicaid Proportionate Share Payment, for a net receipt of \$378,525 which was used by the County to start a Nursing Home Capital Reserve Account in the amount of \$200,000 and the balance going to surplus to help reduce the amount to be raised

by County taxes. Expenditures for Medical Referee, Dispatch Center, Grafton County Conservation District, and Outside Counsel were all a little overexpended based on what was budgeted, but all other County departments were well under their budgeted amounts.

The bottom line for FY 1995 showed that revenues exceeded expenditures by \$383,873.30 leaving the County in a sound financial position at the end of its fiscal year. The Commissioners feel extremely proud of this financial picture, which exemplifies good management by all County department heads, both elected and appointed.

Grafton County experienced some major changes during FY 1995, some of which were the retirement of Douglas "Bum" Bigelow who served the County with forty-four years of dedicated, loyal service. The Commissioners would also like to take the opportunity to thank former Commissioner Betty Jo Taffe for her years of dedicated service to the citizens and employees of Grafton County. The Commissioners would also like to extend their thanks to Joanne Mann for doing an excellent job as Acting Administrator of the Nursing Home through November of 1994. At that time, Mr. John Will came on board as the Nursing Home Administrator, and we would like to welcome Mr. Will and inform you he has done a superb job thus far. Last but not least, we would like to welcome our newest Commissioners, Mr. Steve Panagoulis, Vice-Chairman, Grafton County Board of Commissioners, District 3. Commissioner Panagoulis brings a great deal of knowledge and sound judgment to the Board, and has shown those qualities since January, 1995. We feel Commissioner Panagoulis is a great asset to the citizens and employees of Grafton County.

FY 1995 was another busy year for the Department of Corrections. Admissions were up, although inmate days decreased slightly. The Electronic Monitoring Program continues to grow, and appears to be an excellent form of alternative sentencing, and now has expanded to include the Drug Freedom Program which is funded through a grant from the Attorney General's Office. Superintendent Bird continues utilizing many volunteers for a number of inhouse programs.

The Grafton County Nursing Home has seen changes during the past year in the following areas: computer hardware upgrade, and adding a new part-time dietary aide to help serve meals. In May, Cheryl Ridley, RN, became our new Director of Nursing, our census continues to grow, and our Staff Development Coordinator has implemented a "Quality Assurance" program in-house.

The Commissioners are extremely proud of the Whole Village Family Resource Center project, which continues on track, and hopefully will be completed by the end of the next fiscal year. We are certain it will benefit many citizens and their families in Southeastern Grafton County.

All other County departments were extremely busy during FY 1995. The County Treasurer did an excellent job investing County funds, and exceeded the budgeted interest revenue figure by \$55,177.78. The new County Attorney has done an excellent job in his office, and the number of backlog cases has been reduced drastically. Our Sheriff's Department and Dispatch Center continue to increase with activity, and remain as effective and efficient as always. Carol Elliott, Register of Deeds, and her staff also continue to be overwhelmed with work, and continue to do an excellent job and to generate a great deal of revenue for the County and the State of New Hampshire.

For FY 1995, the Commissioners concluded with preparation of the FY 1996 County Budget, which was adopted by the County Legislative Delegation in late June.

The Grafton County Board of Commissioners holds regular weekly meetings at the County Administration Building on Route 10 just north of the County Courthouse in North Haverhill, with periodic tours of the Nursing Home, Department of Corrections, County Farm, and Courthouse. The Commissioners also attend monthly meetings of the Grafton County Executive Committee. All meetings are public, with interested citizens and members of the press encouraged to attend. In closing, we wish to express our appreciation to all staff members, elected officials, other agency personnel, and the public for their efforts in serving the citizens of Grafton County.

Services for older residents of Grafton were often important to their efforts to remain in their own homes and out of institutional care despite chronic health problems and increasing physical frailty, saving tax dollars and contributing to the quality of life of our older friends and neighbors.

GCSCC very much appreciates the support of the Grafton community for services which enhance the independence and dignity of our older citizens and assists them to meet the challenges of aging in place.

VISITING NURSE ALLIANCE OF VERMONT AND NEW HAMPSHIRE, INC.

We are grateful for the continued support of the town in helping us meet the home care and hospice needs of uninsured persons in Grafton. All services are provided in collaboration with hospital discharge planners and/or with the attending physician and are available to persons of all ages and all economic means. Our VNA staff working out of the Mascoma Branch office provide skilled services for people who may have had recent surgery, may be recovering from an acute illness or disability or may have long term care needs or who may need supportive care and symptom control services during a terminal illness.

While the majority of services are covered by Medicare, Medicaid and commercial insurance; the town funds are critical in helping to support home care and hospice for people without insurance, inadequate insurance or the ability to pay for services. Town funds also help to subsidize blood pressure and screening clinics, foot clinics and flu clinics in the town. This past year, the VNA incurred a financial loss due to exceeding the subsidy available for the growing numbers of uninsured persons. Each year we hope this tend will reverse and that health insurance will be more available to everyone. However, we are now terribly concerned about the pending changes in Medicare and Medicaid and the impact on home care and hospice services. At a time when there are pressures to reduce hospital stays and freeze nursing home beds, it would seem logical that resources would be shifted to home care and hospice programs. We hope that will be the case.

REPORT TO THE CITIZENS OF COUNCIL DISTRICT ONE

As Executive Councilor for District One, it is a privilege for me to communicate with the citizens of this town and area which are a part of District One of 98 towns and four cities.

The five member Executive Council is at the top of your Executive Branch of Government. The NH House and Senate make laws and pass into law a budget. It is then the constitutional and lawful duty of the Governor and Council to carry out those laws and budget. The entire Judicial Branch of judges are all nominated by the Governor and confirmed by the Council. The Governor and Council also nominate and confirm 267 Commissioners and Directors to terms of office in the various state executive branch departments.

The Governor and Executive Council also are required by law to nominate and confirm dozens of citizens to various volunteer boards and commissions. If anyone is interested in serving, they should forward their resume directly to Governor Merrill or my office at the State House. A list of these boards and commissions may be obtained by calling my State House Office at 271-3632.

The year ahead will prove challenging in the area of town, county and state administration of the recently passed House Bill 32 which reallocates, reorganizes most of the Health and Human Services Department of NH State Government. It is extremely important that local and county officials stay in close touch with their State Senators and State Representatives. I have asked Health & Human Services Commissioner Terry Morton to appoint at least 15-20 people from each county to act as advisers to this office as commission. If any of you are interested in serving, please call his office direct 1-800-852-3345 ext. 4331 or send him a note at his office on Hazen Drive, Concord, NH 03301 expressing your interest.

As of this writing there is still about \$270,000 waiting to be matched by local dollars in the Economic Development Matching Grant Program and \$275,000 waiting to be matched in the Joint Tourist Promotional Program. Both of these programs can be accessed by calling 271-2411.

Some 9 million dollars is waiting at the Office of State Planning (tel. no. 271-2155) in the Community Development Block Grant Program. A town, county, regional economic development council or other regional group is eligible to apply.

The Governor's Advisory Commission on Intermodal Transportation has submitted our recommendation to the Governor on various projects submitted to us by towns and regional planning commissions. It is now up to the Governor to submit his recommendations to the House and Senate by February 15, 1996 and then it's up to those two bodies of state government as to the final disposition of the plan. I don't look for much in the way of new highways, bridges and transportation projects due mainly to lack of money. Hopefully, we'll be able to keep in good repair the transportation system we've got.

It is amazing the advice and technical assistance available in State Government to citizens, businesses and local municipalities. The Office of Industrial Development has a very attractive brochure listing technical, financial and community resources available for the asking by calling 271-2411.

Should my office be of help in matters relating to the Executive Branch, please know that I welcome the opportunity to respond. It is a pleasure to serve you.
