George S. Currier

Dedicated to George S. Currier in recognition of his years of service to the town of Sanbornton. George was appointed fire chief prior to the organization of the volunteer fire department in 1951. He retired as chief in December 1975. He has served as executive committeeman and director of the Lakes Region Mutual Aid Association and is a past president of the Fire Chief's Association of New Hampshire. It is by his untiring efforts that the local department has grown from ownership of one piece of equipment without a station in which to house it to two stations and many pieces of equipment.

George was born in Sanbornton in 1904 and with the exception of a few years in Gilford, has always lived here. In addition to serving as fire chief, he has served the town as a forest fire warden; director of Civil Defense and a member of the solid waste committee.

He is a long time member of Moulton's band; of the local, state and national granges; and a dedicated participant in the activities of the Sanbornton Congregational Church.

The residents of Sanbornton are grateful for all his efforts which have contributed to making Sanbornton a better place in which to live.

To the inhabitants of the Town of Sanbornton in the County of Belknap in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Sanbornton on Tuesday, the Fourth day of March, next at 10 of the clock in the forenoon, to act upon the following subjects.

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
- To choose all necessary district officers for the Winnisquam Regional School District.
- To vote on the following proposed amendments to the Zoning Ordinance as recommended by the Planning Board: No. 1. To remove conflicting language from Article III,
 - Paragraph B, concerning removal of clay, sand or gravel, so that Article XII, Paragraph D (2) alone shall govern the removal of said materials. YES

SPECIAL TOWN MEETING WARRANT September 16, 1975

The State of New Hampshire
The polls will be open from 10:00 A.M. to 6:30 P.M.

To the inhabitants of the Town of Sanbornton in the County of Belknap in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Town Hall in said Sanbornton on Tuesday, the sixteenth day of September next at 10 of the clock in the forenoon, to act upon the following subjects:

1. To bring in your votes for the purpose of filling vacancy in the office of United States Senator from the State of New Hampshire. RSA 39:2 — John Durkin had 231 votes; Louis Wyman had 213 votes; Carmen Chimento had 31 votes.

You are hereby notified to meet at the Town Hall in said Sanbornton on Tuesday the sixteenth day of September at 8 of the clock in the evening to act upon the following subjects:

1. To see what action the Town will take on the following resolutions relative to Flood Insurance:

Resolution A:

WHEREAS, certain areas of Sanbornton are subject to periodic flooding from streams, rivers and lakes, causing serious damages to properties within these areas: and

WHEREAS, relief is available in the form of Federally subsidized flood insurance as authorized by the National Flood Insurance Act of 1968; and

WHEREAS, it is the intent of this Town Meeting to require the recognition and evaluation of flood hazards in all official actions relating to land use in the flood plain areas having special flood hazards; and

WHEREAS, this body has the legal authority to adopt land use and control measures to reduce future flood losses pursuant to N.H. RSA Chapter 31, 36, 156, 156A.

NOW THEREFORE, BE IT RESOLVED, that this Town Meeting hereby:

- 1. Assures the Federal Insurance Administration that it intends to enact and maintain in force for those areas having defined flood hazards, adequate land use and control measures with effective enforcement provisions consistent with the Criteria set forth in Section 1910 of the National Flood Insurance Program Regulations: and
- 2. Vests the Planning Board with the responsibility, authority, and means to:

- (a) Delineate or assist the Administrator, at his request, in delineating the limits of the areas having special flood hazards on available local maps of sufficient scale to identify the location of building sites.
- (b) Provide such information as the Administrator may request concerning present uses and occupancy of the flood plain.
- (c) Cooperate with Federal, State and local agencies and private firms which undertake to study, survey, map and identify flood plain areas, and cooperate with neighboring communities with respect to management of adjoining flood plain in order to prevent aggravation of existing hazards.
- (d) Submit on the anniversary date of the community's initial eligibility an annual report to the Administrator on the progress made during the past year within the community in the development and implementation of flood plain management measures.
- 3. Appoints the Selectmen to maintain for public inspection and to furnish upon request a record of elevations (in relation to mean sea level) of the lowest floor (including basement) of all new or substantially improved structures located in the special floodshazard areas. If the lowest floor is below grade on one or more sides, the elevation of the floor immediately above must also be recorded.
- 4. Intends to take such other official action within its powers as may be reasonably necessary to carry out the objectives of the program.

Resolution B-1:

WHEREAS, the Town of Sanbornton has adopted and is enforcing Zoning Ordinances, Subdivision Regulations and building permit system WHEREAS, Section XI(2) of the Zonings Ordinance prohibits any person, firm or corporation from erecting, constructing, enlarging, altering, repairing, improving, moving, or demolishing any building or structure without first obtaining a separate building permit for each structure or building from the Board of Selectmen, and

WHEREAS, the Board of Selectmen must examine all plans and specifications for the proposed construction when application is made to them for a building permit,

NOW THEREFORE BE IT RESOLVED, by this Town Meeting:

1. That the Board of Selectmen shall review all building permit applications for new construction or substantial improvements to determine whether proposed building sites will be reasonably safe from flooding. If a proposed building site is in a location that has a flood hazard, any proposed new construction or substantial improvement (including prefabricated and mobile homes) must (i) be designed (or modified) and anchored to prevent flotation, collapse, or lateral movement of the structure, (ii) use construction materials and utility equipment that are resistant to flood damage, and (iii) use construction

methods and practices that will minimize flood damage; and

- 2. That the Planning Board shall review subdivision proposals and other proposed new developments to assure that (i) all such proposals are consistent with the need to minimize flood damage, (ii) all public utilities and facilities, such as sewer, gas, electrical, and water systems are located, elevated, and constructed to minimize or eliminate flood damage, and (iii) adequate drainage is provided so as to reduce exposure to flood hazards; and
- 3. That the Town Health Officer shall require new or replacement water supply systems and/or sanitary sewerage systems to be designed to minimize or eliminate infiltration of flood waters into the systems and discharges from the systems into flood waters, and require on-site waste disposal systems to be located so as to avoid impairment of them or contamination from them during flooding. ACCEPTED

You are hereby notified to meet at the Town Hall in said Sanbornton on Tuesday, the Second day of March, next at 10 of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To choose all necessary district officieers for the Winnisquam Regional School District.
- 3. To vote on the following proposed amendments to the Zoning Ordinance as recommended by the Planning Board:

AMENDMENT NO. 1. To establish a Flood Plain Conservation District consisting of land areas subject to periodic flooding and to restrict the use of land therein.

AMENDMENT NO. 2. To establish a Wetlands Conservation District consisting of land areas defined by the Soil Conservation Service, U.S. Department of Agriculture as poorly drained and very poorly drained and to restrict the use of land therein.

- 23. To see if the Town will vote to raise and appropriate \$1.622.40 for Class V Roads.
- 24. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 of which sum \$1,000.00 is to be raised by the Town and \$1,000.00 in matching funds by grant from the New Hampshire American Revolution Bicentennial Commission, for the purpose of publishing and distributing to each family in Sanbornton an updated account of "Sanbornton's Revolutionary Heritage" and publication of a guide-book to the Town's historic buildings, sites and landmarks; the Town's share to be reimbursed to the Town through sale of this guide-book and other fund raising activities of the Sanbornton National Bicentennial Commission.

SELECTMEN'S REPORT

We were proud to be the ninety second town designated as an official Bicentennial Community.

TRA and Duncan Fundswere used to finish the work on Lower Bay Road.

The balance of the flood damage reimbursement was received from the State for damage done in the 1973 disaster.

New voting booths were installed at the Town Hall and first used at the last Town Meeting. The Sanbornton Bicentennial Committee made a generous contribution towards the new booths. Other improvements at the Town Hall and Town Office were also made.

A 10,000 gallon gas tank was installed at the highway garage with a four key key-trol pump and is being used by the highway, police, and fire departments.

New Hampton was able to use the partially completed Town Beach at Hermit Lake to give swimming lessons through their summer recreation program.

The Selectmen have been working with the Budget Committee and Town Departments to work out an equitable fringe benefit plan for Town Employees. As proposed, this plan includes Blue Cross-Blue Shield Family Plan C, Life Insurance, Disability Insurance, six paid holidays and paid vacation.

Please remember the following items:

- If you feel you qualify for current land use assessment, Veterans' Exemption or Elderly Exemption, you must apply before April 15.
- 2. Each taxpayer must file an inventory with the Selectmen before April 15, or he has no legal recourse regarding his assessment for tax purposes.
- 3. Taxpayers requesting an appeal or tax abatement must request the appeal or abatement in writing within four months of the receipt of the tax bill.
- Students who wish to apply for scholarships may acquire applications from their school principal or the Selectmen's office. These must be filed no later than May 1 at the Town Office.

All taxpayers are welcome and encouraged to meet with the Selectmen with all matters. Meetings are every Monday. Meetings are open to the public and minutes of meetings are posted in the Town office.

SANBORNTON FIRE DEPARTMENT

In submitting my 27th and final report as Fire Chief of the town of Sanbornton may I say it has been a pleasant and rewarding experience. Through the untiring efforts of the firemen and the Ladies Auxiliary, and the generosity of interested citizens, Harmony Grange and the voters of the town, we have been able to build a Volunteer Fire Department second to none.

Five years ago with the formation of the Lakes Region Mutual Aid Dispatch Center a sizeable reduction in fire insurance rates benefited all people living within a radius of three miles from the Fire Station. Three years ago, while I had the honor of serving as President of the New Hampshire Fire Chief's Association, we were able to obtain a two mile extension of the lower rate. With the protection of the Winnisquam Fire Department, Central Station, and Chapel Valley Station, approximately 90% of the homes in Sanbornton benefit from this favorable rate. Approximately 700 homes are covered under the F-5 rate and a saving on the fire insurance premium of only \$20.00 per home, would amount to \$14,000.00. Our Fire Department budget, plus Winnisquam Fire Department budget, and the town's share of the cost of operating the Dispatch Center is about \$7,000.00. Therefore, the residents of Sanbornton receive their fire protection at no cost and also are afforded a sizeable reduction on their insurance premiums.

Much credit goes to the Lakes Region Mutual Aid Dispatch Center for their superb handling of calls and dispatching of equipment. Our department responded to 18 calls in town and 14 Mutual Aid calls.

The compliment of men in our department had been increased so that we now have thirty-seven active firemen. We have spent many hours in training, both locally and in the Mutual Aid system. Ten men attended the two-day Fire School at Lilly Pond. Several men attended special classes at the Technical School. Every fireman's home is equipped with a receiver which is activated from the Dispatch Center. With the arrival of our new fire truck we will become a fully equipped department and should be able to continue for many years without much added expense. Our fire department budget for 1976 will be decreased by about 34%. In the small town category the Sanbornton Fire Department has a high rating.

We wish to thank Rev. Richard Crooks for his generous contribution in providing outstanding entertainment for our programs and at special occasions. We wish to thank the Ladies Auxiliary for their untiring efforts on behalf of the fire department. They have contributed much in financial support and in providing suppers and entertainment for the firemen and our guests. Without any doubt they have become the best known and most admired Ladies Auxiliary in the state of New

Hampshire. Many thanks to all who have contributed with gifts of money, or in any other way.

It must be remembered that this department could not have been built to its present position without the complete co-operation of the firemen, who have contributed so much of their time, talents, and money. We must also acknowledge contributions made by the Ladies Auxiliary, the voters of the town, and all interested persons. A better group of men and women just could not exist.

The time has arrived for me to step down from the office of Fire Chief and it is with a note of sadness that after 28 years I find myself on the outside looking in. May I take this opportunity to thank the town's people for their confidence in me and the honors bestowed upon me. Catherine and I wish to thank all who attended my retirement party. The kind words and gifts received will be remembered as long as we live. It was a wonderful occasion.

May I wish the new Chief the very best in his endeavors, and if at any time I can be of service to him or the fire service, I would be most happy to assist.

The Fire Service is my life.

REPORT OF THE FOREST FIRE WARDEN

Upon the recommendation of town selectmen and city councils, the Division of Forest and Lands appoints a forest fire warden and several deputy forest fire wardens in each town and city every three years. The town or city warden is responsible for maintaining a force of men and adequate equipment to suppress any wildfire that occurs in his town or city during his term of appointment. The fire warden must authorize all open burning when the ground is not covered with snow. No open fires can be authorized between 9 a.m. and 5 p.m., unless it is raining, without the additional permission of the state district fire chief.

Any person wishing to kindle an open fire when the ground is not covered with snow must first obtain the written permission of the forest fire warden. Camp and cooking fires also require the warden's permission.

The Division of Forests and Lands, through its Forest Fire Service, assists all cities and towns in meeting these requirements by training the warden and deputy forces in wildfire suppression tactics, making hand tool suppression equipment available at fifty percent of cost, supplying pieces of Federal excess property for use as fire attack vehicles and sharing up to fifty percent of the cost of wildfire suppression costs.

Wildfire prevention is also a joint state, city or town program. Smokey Bear is available from the Forest Fire Service for local fire prevention programs. Posters and Junior Ranger kits are available for distribution by local fire departments upon request to the Forest Fire Service. Each forest fire warden is expected to carry on a continuous wildfire prevention program within his town or city.

PLANNING BOARD REPORT

Amendments to the Zoning Ordinance proposed by the Board were adopted at the March 4, 1975 Town Meeting. Most important of the amendments was a measure to define and protect potential public water supplies. Hunkins Pond was approved as a future public water supply and thus extended anti-pollution agreements that the Board had negotiated with an active subdivider, to all of the land surrounding the Pond.

The Board enacted a Site Plan Regulation in accordance with authority granted by the Legislature and the Special Town Meeting of October 2, 1973. The Site Plan Regulation provides for Board review, and optional public hearings, for Non-Residential development and construction. Also added to the Subdivision Regulation was a provision permitting the Board to require large developers to determine the likely impact of proposed subdivisions on services the Town furnishes, such as schools, police, and fire protection, and also the effect on the environment.

The Board responded to a request from the Town Conservation Commission to protect Wetlands areas against unwise use. Amendments to the Zoning Ordinance establishing both Flood Plain and Wetlands Conservation Districts were drafted by the Lakes Region Planning Commission, modified after hearings; and are to be voted on at Town Meeting.

A Board of Adjustment suggestion to clarify Article XII of the Zoning Ordinance has resulted in rewriting the Article to include all the powers granted the Board of Adjustment by state law and town action. It is hoped that better understanding of the Board of Adjustment role will result.

The Town received a favorable decision by the court in a suit brought by Steele Hill Development Co., Inc., to permit a mobile home park with substandard lots in the General Agricultural District.

We are pleased that the Board of Selectmen implemented a law enacted by the 1975 State Legislature, and appointed Andy Prokosch as Alternate Member of the Planning Board.

Activity by subdividers was at a low level again this year. Most applications involved only two or three lots. An exception was a new application from Steele Hill Development Co., Inc., for thirty three regulation and oversize lots. The Board has also worked in conjunction with the Board of Selectmen to resolve problems concerning the Leighton Estates subdivision.

ROAD AGENTS REPORT

In this year of our country's bicentennial, much interest has been aroused about the past and there are some interesting changes that have occurred regarding the roads of Sanbornton. In 1888 there were 175 different men paid for labor on the roads and the amounts paid them ranged from 75 cents to \$150.00. The following year there were such items in the budget as \$12.00 for pasturing oxen and \$8.50 to a man for "lighting a washout". In 1893 the headings for highway maintenance were "Roads Generally, Expenses Partly and Bridges Mainly".

The first mention of a road agent was in 1894, and then they had three up until 1900 when they changed to a "District System" with no road agent at all. In 1908 there is the first mention of State Aid Funds but the town paid for construction of state highways in Sanbornton. 1909 brought such modern materials as cement and steel material for bridges and 1910 an item "Expenses Extraordinary - for repairing Hill bridge damaged by ice that winter". Well that wasn't so extraordinary after all because on March 22, 1913 the bridge was carried away by an ice jam and then destroyed by fire. Loss of that covered bridge ended the era of "snowing" the bridge and paying for oil and lanterns to light it.

In 1917 they went back to three road agents but the following year they consolidated to just the East and West District and 2 road agents. In 1920 each district bought a Sears, Roebuck and Co. grader but the West District only paid \$59,10 for theirs and the East District paid \$61.83. That same year they paid a man 88 cents for "cutting ice out of road".

Mid 1920's saw the first expenses for gasoline and repairs - work on truck, and an article in the 1927 town warrant read "To see what action the Town will take in regard to snow plows."

Was it a sign of the times that in 1932 they spent \$18.00 for road closed signs? In 1933 they had an article "to see if the town will vote to dispose of the snowrolls", and in 1934 they voted to have just one road agent the following year. But even then they paid 54 men for summer maintenance and 48 for winter not counting those men hired with their trucks.

During the 40's, the war years, there was little change for the highway department but the 50's brought more effort toward highway improvement and more equipment was purchased and more money appropriated. Even then in 1958 there were wages paid to 16 different men.

In 1963 the new Highway Department Garage was built and the Highway Department continued to evolve toward what it is

today.

You no longer see items such as "board of town help" or "labor man and horses" in the Highway budget for work for the Department is now a full time job. The men are full time employee's and no longer are there 175 different men filling in here and there. Sanbornton has approximately 80 miles of road to maintain and we are a very mobile society who expect to be able to travel anywhere at any hour. No longer do most men just have to walk to the barn to be at work. Very few if any of our children walk to school as in the "good old days" so school bus routes must get early attention for the childrens safety. The days of being snowbound are past for now most people with good snow tires and good driving sense can always get around on roads that highway crews have spent long hours plowing, salting and sanding.

Frequently the hours are long, the work hard, complaints irritating and words of praise few and far between, but over the years right through to the present, Sanbornton has had Highway Crews it can be proud of.

REPORT OF THE SOUD WASTE COMMITTEE

The Solid Waste Committee has had a busy year. The Committee this last fall was ready to start construction when some of the nearby residents raised some questions and concerns. The Selectmen stopped the initial work. The Solid Waste Committee answered all questions and met all the demands of the area residents in a responsible manner. Since the fall of 1975, there has been a few persons that have tried to disrupt, delay, and or stop all work at the landfill. This delaying tactic is in the opinion of the Solid Waste Committee an effort to cause the loss of the \$15,000.00 State Grant and the subsequent sale of part of the Landfill to make up that loss. This would prevent the Town from using the extra land area there at the 49 acre site. These delays will possibly result in the Town not being able to utilize the Town's equipment and manpower as we must have the road and dump completed by July 1, 1976.

The use of town equipment could result in further savings. The Committee would like to inform the residents and taxpayers of Sanbornton of the following savings made or to be made by the Committee in the construction and development of the Landfill Site on Town-owned land on Shaw Hill Road:

SANBORNTON CONSERVATION COMMISSION REPORT

Members of the Commission investigated wetland areas at Rollins Pond & recommended to the Planning Board that it be kept as a wetland area.

Town Tax maps were explored by the Commission & R. C. D. and our conclusion was that the State of N.H. aerial maps were adequate for our tax map purposes. We have reviewed several tax map proposals and the Chairman of the Conservation Commission has urged R. C. & D. to advise tax map guidelines for us to work by and to make recommendations to the Selectmen. We are attempting to save property taxpayers money, thus we are continuing to investigate the cost of tax maps.

The Commission is hoping to complete Phase II of the Hermit Lake Beach Project so the townspeople can make use of the beach and area

Recycling of newspapers, bottles, and cans is another area being investigated by the Commission and it is hoped to establish a recycling center at the Town dump.

Logging, Dredge and Fill operations are continuing to be observed by the Commission. We are also checking into Scenic Roads in the town, and find there is a tremendous amount of research involved and we would appreciate assistance from any townspeople who are interested in helping us with this project, please contact any member of the Conservation Commission. The Commission meets every second Monday at 7 P.M. at the Sanbornton Town Office, these meetings are open to the public.

SUMMARY OF FINDINGS AND RECOMMENDATIONS

Gentlemen:

Submitted herewith is the report of an examination and audit of the accounts of the Town of Sanbornton for the fiscal years ended December 31, 1973 and December 31, 1974, which was made by this Division in accordance with the vote of the Town. Exhibits as hereafter listed are included as part of the report.

One of the enclosed audit reports must be given to the Town Clerk for retention as part of the permanent Town records.

SCOPE OF AUDIT

Included in this examination and audit were the accounts and records of the Board of Selectmen, Treasurer, Tax Collector, Town Clerk, Public Library, Fire Department and the Trustees of Trust Funds.

FINANCIAL STATEMENTS

General Fund:

Comparative Balance Sheets: (Exhibits 1 and 16)

Comparative Balance sheets which disclose the financial condition of the general fund as of December 31, 1972-1973 and December 31, 1973-1974 are presented in Exhibits 1 and 16. As indicated herein, the current surplus of the Town increased by \$14,700 in 1973 and by \$240 in 1974.

Analysis of Change in Current Financial Condition: (Exhibits 2 and 17)

Statements presenting an analysis of the factors which caused the change in the current financial condition of the Town during the fiscal years ended December 31, 1973 and December 31, 1974 are presented in Exhibits 2 and 17, respectively.

The factors which caused the increase of \$14,700 in current surplus during 1973 were as follows:

Comparative Statements of Appropriations and Expenditures - Estimated and Actual Revenues: (Exhibits 3 and 4; 18 and 19)

Comparative statements of general fund appropriations and expenditures, estimated and actual revenues for the fiscal years ended December 31, 1973 and December 31, 1974 are presented in Exhibits 3 and 4; 18 and 19.

As indicated in Exhibit 4, a net unexpended balance of appropriations of \$10,402, plus a revenue surplus of \$5,642, resulted in a net budget surplus of \$16,044 in 1973. In 1974, as disclosed by Exhibit 19, a revenue surplus of \$5,838, less a net overdraft of appropriations of \$5,616, resulted in a net budget surplus of \$222.

Long-Term Indebtedness:

Comparative Balance Sheets: (Exhibits 5 and 20)

Comparative Balance Sheets of the outstanding long-term indebtedness of the Town as of December 31, 1972-1973 and December 31, 1973-1974 are shown in Exhibits 5 and 20. The long-term debt decreased by \$12,885, from \$15,245 to \$2,360 during 1973. In 1974 the long-term debt increased by \$7,640, from \$2,360 to \$10,000; matured long-term notes of \$2,360 were paid and \$10,000 of authorized long-term notes were issued.

Statements of Debt Service Requirements: (Exhibits 6 and 21)

Statements showing annual debt service requirements as of December 31, 1973 and December 31, 1974 are contained in Exhibits 6 and 21.

TREASURER

General Fund:

Classified Statement of Receipts and Expenditures: (Exhibits 7 and

Summary statements of general fund receipts and expenditures for the fiscal years ended December 31, 1973 and December 31, 1974, made up in accordance with the uniform classification of accounts, are included in Exhibits 7 and 22

AUDIT PROCEDURE

The accounts and records of all town officials charged with the custody, receipt and disbursement of public funds were examined and audited in accordance with generally accepted auditing standards and accordingly included such tests of the accounting records and such other auditing procedures as were considered necessary in the circumstances.

Vertification of uncollected and unredeemed taxes was made by mailing notices to delinquent tax payers as indicated by the Tax Collector's records. Consequently, the amounts of uncollected and unredeemed taxes as indicated in this report are subject to any changes which may be necessitated by the return of verification notices.

Hermit Lake Project:

A special Town Meeting held on October 2, 1973 voted to "spend the sum of \$8,700, out of the recreation fund, together with matching Federal Funds, to construct a town beach at Hermit Lake."

However, a review of the Town's records indicate that the balance of the recreation fund as of the date of the above Town Meeting was only \$2,199. (Sale of Fredette property - Article 28, 1970)

Expenditures made against this appropriation during 1973 totaled \$3,867. A reimbursement in the amount of \$1,981 was received from the United States Department of Agriculture in 1973. This resulted in an unexpended balance of \$313 in the Recreation Fund as of December 31, 1973.

On the basis of the foregoing, the Town at the meeting of October 2, 1973, voted to expend \$6,501 in excess of the amount actually on hand in the Recreation Fund. Hence, the appropriation of this amount, namely \$6,501 is invalid.

Special Meetings and Application of Municipal Budget Law:

Our examination also revealed that the above meeting was not supported by a posted budget as prescribed by R.S.A. 32:6, which reads as follows:

"32.6 SPECIAL MEETINGS. In case a special meeting shall be called in any town, school district or village district operating under the provisions of R.S.A. 32, the budget committee, so far as applicable, shall follow the same procedure as prescribed in R.S.A. 32:5."

Under the provisions of R.S.A. 32:5, no appropriation item may be voted upon at a town meeting unless it is mentioned in the budget and either recommended, or submitted without recommendation by the budget committee.

In addition, the foregoing conflicts with the provisions of the Local Fiscal Assistance Act of 1972, which require a municipality to provide for expenditure of amounts received only in accordance with the laws and procedures applicable to the expenditure of its own revenues. The special meeting had also voted to expend \$12,749 for capital improvements to be funded by revenue sharing funds.

Police Department Payroll Records:

The accounting policies for the Town require individual departments to prepare and submit detailed payroll sheets in substantiation of wage payments to employees. Our examination disclosed the omission of 2 (two) full-time employees from such records as prepared by the Police Department. However, it was noted that this situation had been rectified in fiscal year 1975.

Yield Tax Deposits:

Care should be exercised in the matter of accounting for yield tax deposits. When yield taxes are assessed and committed to the Tax Collector, the full deposit applicable to each particular tax, retained by the selectmen, should be transferred to the Tax Collector. However, when the deposit exceeds the amount assessed, the transfer should only be in the amount of the assessment, and the excess of the deposit over the assessment should then be refunded to the taxpayer.

Conclusion:

The provisions of Chapter 71-A, Section 21, require that the auditors' summary of findings and recommendations (letter of transmittal) shall be published in the next annual report of the Town. Publication of the Exhibits contained in this audit report is optional at the discretion of the Board of Selectmen. This letter, however, must be published in its entirety.

We express our thanks to the officials of the Town of Sanbornton for their assistance during the course of the audit.
