

DEDICATION



BOB BATES

Our 1996 Annual Report is dedicated to Robert Bates, who has been involved with our community here in Sandwich for over forty years, and during that time has shared his talent, zest for life, and his love of music with us.

Bob began his professional career at an early age, working as an organist for a church in Weymouth, Massachusetts while still in high school. When he was fifteen years old, he was awarded a full scholarship to Harvard University and graduated with a Bachelors degree in music in 1928. A contemporary of the great era of American song writing, Bob worked as a professional musician in both the world of theater and nightclub circles in New York City during the 1930s. For many years he played music at Tony's on 52nd Street - "the street that never slept-" accompanying singers and playing the piano into the early morning hours. He was also involved in productions of Gilbert and Sullivan operetta's in New York City, and toured with the prominent Shubert Theater organization.

From 1940 to 1960, Bob and his wife Billie, a modern dancer, taught in private schools in both Connecticut and Michigan. Then in the early 1960's, Bob became the organist and choir director at the Episcopal Christ Church Cranbrook in Bloomfield Hills, Michigan, a position that Bob held until his retirement in 1976.

Bob and Billie spent their first summer in Center Sandwich in 1949. With characteristic enthusiasm, the couple quickly enlisted the support of many local townspeople and began to work on what was to be the first of many years of Gilbert and Sullivan presentations. Bob used his talent and warm humor to guide large groups of young and old amateur performers on the town hall stage, and soon established a local tradition. The couple presented lively and sparkling productions that brightened many summers. Some of these operetta's were performed after only seven rehearsals! Many members of the community can look back on at least one August spent in the chorus, scrambling to learn lyrics under Bob's skillful tutelage.

In 1953 Bob began his long association with Frances Cleveland and the Barnstormers Theater acting as its music director. he has worked with the company every year since then, providing the musical force behind this talented group. In last year's production of <u>And A Nightingale Sang</u>, Bob, Sr. provided piano music from back stage as his son Bob "played" the part of a piano player on stage! In 1978, The Sandwich Players were organized, and Bob became an instrumental part of the operation. Bob

served as music director for many memorable Sandwich Players productions in the years that followed; to all of these performances, he brought his expert musicianship and his remarkable skills with people. Under his direction, the cast would shine, and all would finish with a sense of accomplishment and joy.

Bob accompanied The Sandwich Singers for many years under the direction of David Hugh Jones and Louise Barker, and then in the mid 1970's, he began to direct the group himself. For over twenty years under his sensitive guidance and expertise, the Sandwich Singers have performed a distinctive variety of music chosen with Bob's unerring ear for quality.

Bob continues to donate a considerable amount of his time playing for fund-raisers, including the past year's Barnstormer Gala. He also serves as organist for St. Andrews Church, where he has led the congregation in music for over twenty years. As if this were not enough, last year he expanded his repertoire to include the spoken word at a Robert Frost poetry recital! Bob delights in performing with his friends, (frequently on short notice!) and is often heard reciting his characteristic phrase "It's crazy!" as he plans his next musical event. Bob's charm, wit, and love of music and people, continue to lead and enrich the members of this community; a vital and enduring legacy!

SELECTMEN'S ANNUAL REPORT: 1996

This year in Sandwich several projects have been completed or are underway.

During the spring the long awaited Squam Lake Road relocation took place. Following a pair of public input hearings, the town road crew expanded the town beach and constructed parking areas to accommodate increased use. The "Beach Party" held during Old Home Week to celebrate completion was a great success, with over 200 attending, and discussions are underway for another...next summer.

During May, a number of disease-resistant elm trees were planted around the center of Town. Funds provided by the Historical Society and the Lena T. Nelson Trust have helped ensure that these once common trees will remain in Sandwich. The Quimby Trustees have offered a gift for 1997 to continue with a shade tree planting program.

This summer, the new gas and diesel fuel depot was built at the Town Highway Garage in North Sandwich. The construction of a small heating oil storage shed behind the Central Fire Station has allowed for the discontinuance of the underground storage tanks there. We're pleased that the completion of these projects has allowed for the "clean removal" of these two buried fuel tanks.

State approval was finally granted late this summer for our closure plan of the Town dump and bids were received early in October. Costs were higher than anticipated and the Selectmen decided to go ahead with capping the dump since there are sufficient funds in the Landfill Closure Capital Reserve. Construction is now underway and work should be completed in 1997. You will notice some changes, since much relocation of past activities was required. Though it will take some getting used to, we hope the new "traffic-flow" will simplify and streamline the operation of our transfer station.

The on-going legal battle between the Taylor Home and the Town of Sandwich has resulted in the following fees to our taxpayers: Legal Services \$22,759; Accounting Services \$3,856; and Appraisal Services \$2,172. Meantime, the loss of taxes is also a cost to the taxpayers. In 1996, that amounts to \$22,688.

Selectmen's Report (continued)

The Taylor Home claims that its Spokesfield Common property in Sandwich is a charitable operation and is eligible for a tax exemption. The Town maintains that the Taylor Home is not providing any significant charitable functions in our town and that it should be taxed as we all are.

Squam Lake access and school children safety will be among the more interesting Town Meeting warrant articles.

A boat ramp for Sandwich residents and taxpayers only is proposed at the exit end of the parking area at the Squam Town Beach consisting of a ramp and a dock. It is hoped that the project, if approved, could be constructed for less than \$10,000.

In response to concerns brought to the Town's attention, a dangerous sidewalk situation between the Central School and Main Street could be corrected by the vote of Town Meeting. The sidewalk, which now has no curbing, tilts toward the street and it is especially hazardous when it is icy. The curb was removed during the sewer project and it was never replaced.

Once again Town Meeting will discuss the controversial issue of whether the Town should be involved with plowing of private driveways. The Town's involvement in plowing began when it was about the only owner of snow removal equipment in the community. Also most Sandwich people worked in Town and it was not necessary for them to get out of their driveways early to commute.

Today, we find residents anxious to get on the road while Town plowing of their driveways cannot begin until all Town roads are open. Private contractors can do the job more quickly and since they have not been up all night plowing Town roads, they can probably do it better. As a result, we understand that we are one of only three New Hampshire towns which still plows driveways.

So, should the Town still be in the business of plowing driveways? Once again, this will be debated and voted on at the March Town Meeting.

Selectmen's Report (continued)

Meantime, the Town is obligated to plow driveways this winter season. Please remember that the Town does not plow until there is a minimum of 3 inches of snow and it is not liable for any damage while plowing private driveways.

Last season driveway plowing cost the Driveway Fund \$29,000, while the total fees amounted to only \$22,000, a loss of \$7,000.

Also, you are reminded that sand is available behind the Town Garage for residents and taxpayers to pick up for their own use (walks and driveways.) This sand is not to be used by people charging fees for providing these types of services.

The tax rate this year shows an increase from \$11.92 to \$12.71 a \$.79 rise. The breakdown of the increase is a follows. A \$.39 increase for the school portion, up from \$7.59 to \$7.98; and \$.40 for the county portion, up from \$.69 to \$1.09. The Town portion remained at \$3.64. The rate increase was due to both budget increases and a reduction in some property assessments. The Town offset its increase by applying \$54,000 of surplus to maintain the Town rate at the 1995 level.

INDEPENDENT AUDITOR'S REPORT ON FINANCIAL PRESENTATION

To the Members of the Board of Selectmen Town of Sandwich Sandwich, New Hampshire

We have audited the accompanying general-purpose financial statements of the Town of Sandwich as of and for the year ended December 31, 1996. These general-purpose financial statements are the responsibility of the Town's management. Our responsibility is to express an opinion on these general-purpose financial statements based on our audit.

We conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the general-purpose financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the general-purpose financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall general-purpose financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

The general-purpose financial statements referred to above do not include the general fixed assets account group which should be included in order to conform with generally accepted accounting principles. As is the case with most municipal entities in the State of New Hampshire, the Town of Sandwich has not maintained historical cost records of its fixed assets. The amount that should be recorded in the general fixed assets account group is not known.

In our opinion, except for the effect on the financial statements of the omission described in the preceding paragraph, the general-purpose financial statements referred to above present fairly, in all material respects, the financial position of the Town of Sandwich, as of December 31, 1996, and the results of its operations and the cash flows of its nonexpendable trust funds for the year then ended in conformity with generally accepted accounting principles.

Our audit was made for the purpose of forming an opinion on the general-purpose financial statements taken as a whole. The combining and individual fund financial statements listed in the table of contents are presented for purposes of additional analysis and are not a required part of the general-purpose financial statements of the Town of Sandwich. Such information has been subjected to the auditing procedures applied in the audit of the general-purpose financial statements and, in our opinion, is fairly presented in all material respects in relation to the general-purpose financial statements taken as a whole.

You are hereby notified to meet at the Town Hall in said Town on Tuesday, the 11th day of March 1997 from 10:00 a.m. until 7:00 p.m., then on Wednesday, the 12th day of March 1997 at 7:00 p.m. at the Sandwich Central School and if this meeting is reconvened, the date will be the 13th day of March 1997, at 7:00 p.m. at the Sandwich Central School to act upon the following articles:

(Explanation: Article 1 relating to the election of Town and Cooperative School District Officers, Article 2 relating to Elderly Exemptions and Article 3 relating to the Planning Board proposed amendments to the Zoning Ordinance will be taken up on Tuesday, March 11th by official ballot. The polls will be open from 10:00 a.m. until 7:00 p.m. A second session to consider all other Town business (as per vote of the Town to accept provisions of RSA 39:2a) will be held on Wednesday, March 12th at 7:00 pm. If this meeting is reconvened, the date will be Thursday, March 13th, at 7:00 p.m.)

ARTICLE 1. To elect by official ballot all necessary Town and Cooperative School District officers for the ensuing year.

ARTICLE 2. Shall we modify the elderly exemptions from property tax in the Town of Sandwich, based on assessed value, for qualified taxpayers, to be as follows: for a person 65 years of age up to 75 years, \$10,000; for a person 75 years of age up to 80 years, \$20,000; for a person 80 years of age or older, \$40,000. To qualify, the person must have been a New Hampshire resident for at least 5 years, own the real estate individually or jointly, or if the real estate is owned by such person's spouse, they must have been married for at least 5 years. In addition, the taxpayer must have a net income of not more than \$18,500 or, if married, a combined net income of less than \$25,500; and own net assets not in excess of \$35,000 excluding the value of the person's residence.

WARRANT AND MINUTES 1996 TOWN MEETING

The first session of the Sandwich Town Meeting was held on Tuesday, March 12, 1996 at the Town Hall. Moderator Robert J. Rowan convened the meeting at 10:00 AM and announced that there would be no smoking and no loitering and he requested quiet in the room. He said Articles 1 and 2 will be voted on today and Articles 3 through 46 will be taken up tomorrow night at 7:00 at the Sandwich Central School. He proceeded to read the 1996 Warrant, whereupon Lee Quimby made a motion to suspend reading of Articles 3 through 46 until tomorrow night. Fred Rozelle seconded the motion, it passed unanimously. The second session of Town Meeting was held at the Sandwich Central School on March 13, 1996. Moderator Robert Rowan called the meeting to order at 7:00 PM. Reverend Mark Henderson gave the invocation. Chris Cakars led the Pledge of Allegiance. Joe Canfield, Hannah Merriman and Evvy Greene were the microphone runners. The Moderator announced that there would be no smoking in the building; advised the location of the exits and restrooms and stated that the meeting would not be run by Robert's Rules but by the following:

A. Anyone wishing to make a motion, seconding a motion, or wishing to speak on an Article must first be recognized by the Moderator. B. All speakers must address the Moderator, there will be cross floor debates. C. When recognized, please stand and state name when making or seconding a motion. D. Voting will be a show of hands using voter cards. E. Seven voters may challenge the declared vote on any Article before the next Article is brought up, then a secret ballot must be held. F. If a secret ballot is desired on any Article, a written request signed by five voters is required and presented to the Moderator any time prior to the vote on the Article. G. Any Article may be legally amended, each amendment will be discussed independently and acted upon before the Article is called. H. Motion to reconsider an Article may be made at any time prior to final adjournment and the Article would be taken up again immediately unless protected by a vote to restrict reconsideration. I. Five voters may request a recount of a secret ballot before the next Article is taken up. (The vote margin must be less than 10% of total vote cast.) J. Only registered voters may vote. K. Only registered voters may speak to questions, non voters may speak only after the Moderator polls the meeting and hears no objection. L. The Moderator can be overruled by a simple majority vote. Any challenger will be recognized and no second is required. The challenger has the right to state his or her reasons for challenge. RSAs cannot be overruled by the Town Meeting.

The Moderator explained that all voters must check in with the ballot clerks to receive a voter card. When voting, only hands showing a voter card will be counted. If a voter leaves the room for any purpose, s/he must leave her/his voter card with the ballot clerks

and pick it up upon returning. All cards must be turned in upon adjournment. When casting secret ballots only properly numbered ballots will be counted. He asked that voter cards and ballots be handled carefully. If needed, pencils will be available while voters are in line.

The Moderator read the results of Articles 1 and 2 which were taken up on March 12th. He then went on to Article 3.


BOARD OF ADJUSTMENT

The following cemeteries are governed by private Associations with their own organization, fees and rules: Rural Cemetery (Baptist Church), Vittum Hill Cemetery, Little's Pond Cemetery, and the two Quaker cemeteries.

All other cemeteries are the responsibility of the Sandwich Cemetery Trustees.

The following rules apply to town cemetery operations:

1. Town cemeteries are open for burials, weather conditions permitting from April 1 through November 15.

2. Notify Trustees before any burial plans are finalized.

3. Trustees will approve of the grave digger.

- 4. Trustees will provide a person to prepare the grave for a cremains lot.
- 5. The fees for body and cremains burials shall be set by the Trustees.

CONSERVATION COMMISSION

The Conservation Commission conducted a monthly schedule of meetings this year. The meetings are held the second Tuesday of every month at 7:30 P.M. Members also reviewed the actual conditions for several Wetlands applications. We thank everyone who attended for their involvement and efforts.

We continued our support of the '5 Days of Sandwich' summer Conservation Education program. This program is for 10 to 13 year olds. Our thanks to White Sylvania Trust, private donors as well as the Town for their support. In 1996 the two one week sessions were very successful; this year they were grouped by age.

Another successful household hazardous waste collection was held in the summer. The location proved to be a fast and efficient drop-off. We urge everyone to turn in any hazardous waste at this free summer collection.

An important Conservation Commission project this autumn was the well water quality survey. This is a follow-up to a similar survey made in May 1983. Approximately 50 wells were tested; 26 of these were retests from 1983. Based on initial review of the retests, differences over the 13 years are minor and appear insignificant in most cases. In a couple wells chloride was lower in 1996; while nitrate was not detected in most wells a couple showed small increases perhaps due to fertilizer use. Overall the tests showed trace metals to be not detected except in a few cases where the concentration is below the minimum contaminant level. Some sources had small traces of copper, probably from piping. Also there was universal absence of organic chemicals trihalomethanes or volatiles. This is to be expected in rural areas, but confirmation is good news.

The Expedited Application Form provided by the Wetlands Board has reduced the time required to obtain both Expedited and standard form Wetlands Permits. Our Commission must review each Expedited application before it is sent to the Wetlands Board; this local review generally takes one week. The form covers many of the most frequent wetlands permit activities; these include: driveway culverts, pond construction or maintenance, dredging and docks. If your project does not meet the Expedited criteria your application must be submitted on the

Conservation Commission (continued)

standard form. Forestry Notifications continue to be filed with your Intent to Cut and promptly approved. If you are planning any new work or maintenance in Wetlands we suggest you contact a member of the Commission for a review before you submit your application.

We thank the Selectmen and the entire Town Hall office staff for their efforts this past year.

The total calls dropped this past year by 38 from last year's all time high making this the third busiest ever. All types of calls went down except mutual aid requests which went up by four. Search/Rescue & Medical Emergencies (which also included auto accidents) accounted for 52% of our calls.

Again we urge everyone to have their chimneys checked and cleaned at least once a year. I am pleased to note we only had to respond to five chimney fires this past year as opposed to nine the year before.

The Selectmen appointed a "Fire Equipment Needs Committee" to study these needs and try to understand the rationale the Department uses to address these needs. Myself and Assistant Chief Mykland met with this committee a number of times to explain the various guidelines we use and why they are used. We feel it was a very productive effort. We certainly wish to thank the committee members for their efforts.

We only had to respond to three working structure fires, not counting chimney fires, this past year. The most serious was a saphouse/camp fire off Diamond Ledge Road. This building was owned by the Ned Hardings and is down in the woods over a quarter of a mile from the road with the only access being by a path. When we arrived on the scene the building was basically gone. We had to hand lay over 1500 feet of hose to extinguish the remains. Another call was to a small house on the Holderness Road occupied by Ed Gaudette. A flare-up of cooking grease extended into the attic area but a quick stop was made and only relative minor damage was sustained. On the more humorous side we were toned out one Saturday morning to a structure fire...an outhouse! The "structure" was totally destroyed.

FOREST FIRE WARDEN AND STATE FOREST RANGER

To aid your Forest Fire Warden, Fire Department and State Forest Ranger, contact your local Warden or Fire Department to find out if a permit is required before doing any open burning. Violations of RSA 227-L:17, the fire permit law and the other burning laws of the State of New Hampshire are misdemeanors punishable by fines of up to \$2,000 and/or a year in jail. Violators are also liable for all fire suppression costs.

There are ten Forest Rangers who work for the N.H. Division of Forests and Lands, Forest Protection Bureau. State Forest Rangers are available to assist communities with forest fire suppression, prevention and training programs as well as the enforcement of forest fire and timber harvest laws. If you have any questions regarding forest fire or timber harvest laws please call our office at 271-2217.

The State of New Hampshire operates 15 fire towers, 2 mobile patrols and 3 contract aircraft patrols. This early detection and reports from citizens aid in the quick response from local fire departments.

HIGHWAY DEPARTMENT

1996 started off strong, with plenty of snow. We plowed driveways 12 times from December 1, 1995 through March 8, 1996, which amounted to 80+ inches of snow.

In March and April over 1500 cubic yards of 1 1/2" crushed gravel was placed on the dirt roads.

May through July we built the overflow parking lot, main parking lot plus made the new Town Beach area at Squam Lake.

Work was done on Stevenson Hill Road, digging rocks, ditching, shimming with 98 tons of cold mix then sealed with MC800.

Sandwich Slopes saw similar work done, with 165 tons of cold mix, plus stone-lining some of the ditches.

The new self contained fuel station for all the Town vehicles is now on line.

I would like to thank the men of the Highway Department: John, Bill, Ken, Tim and Roger. Also to the Selectmen and Joanne for their assistance and support.

LAND TRUST COMMITTEE

The highlight of 1996 was the construction and dedication of "Charlie's Bridge," a footbridge over the Bearcamp River. It was built in memory of Rev. Charles Crooker, an enthusiastic supporter of the Bearcamp River Trail. Some 75 people, including members of the Crooker family, attended a dedication of the trail on August 24.

The bridge spans a scenic gorge on the stretch of trail between Mt. Israel Road and Elm Hill Road. The land is owned by Dr. Frank Bates. The trail easement here was donated to the Town by the late Helen Bates.

The bridge was built by Fred Lavigne, Chip Kimball and Bob Miner with help from many volunteers. Two trees, cut nearby, were hoisted across the river to form the bridge. Dozens of volunteers also worked hard to drag a large boulder to the bridgehead. The boulder is engraved in memory of Rev. Crooker. Expenses for the project were paid for by private donations.

Earlier in the year, volunteers fanned out along the Bearcamp River Trail to clear blow downs, trim brush and spruce up trail signs. Winter flooding caused extensive damage to the trail and to adjacent hayfields at the confluence of the Cold River in East Sandwich. Throughout the summer, high water continued to erode the trail at this ford. The trail may need rerouting next summer.

In other work, the committee monitored easement properties and initiated a review of its easement records. In the coming months, the committee hopes to create a compendium of information about each easement.

The committee also spent time discussing how public or private interests could conserve large productive timberlands in the Town.

PARKS AND RECREATION DEPARTMENT

Activities and programs for 1996 included:

<u>Ski Program</u> - A six week program for downhill and cross-country instruction for school children at King Pine Ski Area and on the Fairgrounds and Quimby Field.

<u>Cross-Country Ski Trail</u> - A groomed packed trail is maintained on Quimby Field and the Fairgrounds; also a trail leading to Dinsmore

Pond Road and the Notch.

<u>Winter Carnival Weekend</u> - Held the last weekend of February, activities were held at Quimby Field, the Fairgrounds and at the school.

Maypole Dance - Ushered in the Spring season, participants included children in grades K-6 and interested adults, held on the Green.

Maintenance - The Parks and Recreation Department maintains the grounds at Quimby Field and part of the Fairgrounds, the Town Hall, the Green, Remick Park, Bearcamp and the Pot Hole.

Youth Baseball-Softball - Included instructional T-Ball, farm league, minor league, major league, senior league for boys and girls; also Babe Ruth. Seven teams took part with between 90-100 participants.

- <u>Ten Week Summer Program</u> Included tennis activities for children ages 5 & up and adults; swimming lessons, softball, basketball, volleyball, etc.
- Old Home Week Activities Included agility demonstration, triathlon, 2 club golf tournament, art show, jazz ensemble, field day and more.
- <u>Fishing For Kids</u> The Town Hall pond will be stocked with trout by the State and is open to children for fishing.

Youth Soccer - Instructional for grades K-2, teams for 3&4, 5&6 coed; there were three teams this year.

Great Halloween Pumpkin Display - At Remick Park in North Sandwich,

about 45 pumpkins were on display.

Adult Basketball and Volleyball - Both coed and at the school gym held twice weekly September -April; Volleyball once weekly the rest of the year.

Walking Program - The school was open Monday, Wednesday & Friday from 4:30-5:30p.m. for those wanting to walk during the winter

months.

Adult Tennis Programs - Spring and Fall.

Youth Basketball - Instructional for K-2, teams for 3&4, 5&6 boys and girls; four teams this year.

<u>Instructional Golf</u> - Grades 4, 5 & 6, golf instruction by Mr. Chuck Yeager, assistant Pro at the Bald Peak Country Club.

Advent Program and Festival of Lights - Children grades 4 and under held at the Town Hall.

Holiday Lights - Placed at three locations around Town.

Skating Rink - Held on the Frost Lot next to the Town Hall.

NYSCA Coaches Certification - Mandatory coaches training program for all youth coaches.

New Years-Last Night in Sandwich - The Recreation Department helped with activities at the school and the Town Hall.

<u>Adult Fitness</u> - A program designed to maintain strength, flexibility and cardiovascular fitness for adults held at the Town Hall three times a week.

<u>Community Tree</u> - The Recreation Department helped with the tree and set up at the school.

This summer the Squam Lake Beach area renovations were completed and the Bean Road construction also.

Much appreciation is given to the Lena Nelson Trust and Trustee Robert "Bud" Burrows for the purchase of work clothing for the Town employees and for the purchase of a trailer for the Parks and Recreation Department.

Area businesses sponsored all of the youth sports teams which included 14 teams; many thanks for their generous support.

Thanks to all the volunteer coaches giving their time to the youth sports programs and the volunteers who help with programs throughout the year. I would like to recognize and thank the following for their help during the year, Pete and the "Town Crew", the school staff, Joanne, Priscilla, Sharon, the Selectmen, Quimby Trustees, the Recreation Committee, Ms. Urda, and the Sandwich Fair Association for the use of their land. PLANNING BOARD

The Planning Board held a total of 22 meetings and hearings during the year. This included 12 regular meetings, 4 public hearings, 2 special meetings and 4 work sessions. It considered applications for 5 subdivisions, 3 boundary line adjustments, 1 site plan review, 3 developments or use without subdivision and 4 consultations.

Elected officers for the year were: Robert Erb, Chairman; Benjamin Bullard, Vice Chairman; Richard Crockford, Administrative Secretary; and Marcia Allen, Recording Secretary. After several years of significant contributions to the Board, Patricia Merriman stepped down and Roland Hoag Jr. was appointed to fill the vacancy. On behalf of the Board I would take this opportunity to thank Pat for her time and effort.

The Board proposed nine substantive amendments to the Zoning Ordinance, eight of which were approved by the March 1996 Town Meeting. The Zoning Ordinance is reviewed annually and a public hearing was held on January 8, 1997 to review and finalize the ten proposed amendments for the 1997 Town Meeting.

A committee consisting of Daniel Peaslee, Richard Crockford, Jocelyn Gutchess, Leonard Marino, Town Treasurer; Lee Quimby, Selectman and the undersigned were appointed to update the Capital Improvements Program. The committee held several meetings with Town department heads to review proposed upcoming capital expenditures. In November this report was presented and accepted by the Planning Board for consideration by the Selectmen as part of the over-all Town budget process.

It is the responsibility of the Planning Board to implement the goals of the Master Plan and the provisions of the Zoning Ordinance. The continuing support of the residents and the cooperation of other Town Boards is again appreciated.

LIBRARIAN'S REPORT

The Library Staff and Trustees looked to the future in 1996 by beginning a project to automate circulation. After a very successful fund raising campaign begun in November, 1995, hardware, materials and software were delivered in April, and bar-coding began in May. The bar-coding should be complete by this summer and the system will then be operational.

Among notable gifts this year were: \$20,000 plus raised for the automation project, two morris chairs in memory of Nancy Meredith, and \$1,000 for the purchase of Children's books from the Estate of Nancy Meredith. The Sandwich Home Nursing Association built a major collection of materials on health subjects and pledged continued support to maintain the collection. The collection included a spinning bookshelf for easy access and the purchase of the C. Everett Koop Time-Life video series "At time of diagnosis," a thirty volume set of great value to the community.



TAX CREDITS/EXEMPTIONS TOWN ORDINANCES

TAX CREDITS:

Applications for the following permanent property tax credits must be filed by March 1st.

\$ 100 credit for veteran/veteran's spouse/veteran's widow

\$1400 credit for service connected total and permanent disability

\$1400 credit for widow of veteran killed or died on active duty

Total tax credit for double amputee or parapalegic

(Service connected credits may also be claimed by those who served on active duty in the armed forces of our allies if they were citizens of the U.S. at the time of their entry into these armed forces and are presently residents of N.H.)

TAX EXEMPTIONS: (Applications must be filed by March 1st)

Exemptions (deductions from assessed valuation) are available for:

Solar energy systems

Woodheating energy systems

Wind powered energy systems

Persons who are legally blind

Elderly property owners: subject to certain age, income and asset restrictions

Owner/resident of property modified for the physically handicapped

Current Use and Conservation Easements also result in a reduction in assessed valuation. Applications for current use or conservation easement exemptions must be filed by April 15th.

TOWN ORDINANCES: (copies are available at the Town Hall)

PARKING ORDINANCE:

Defines the parking regulations on Routes 113 and 109 and the intersections on Squam Lake Road and Church Street.

DOG LEASH LAW:

Within the Town of Sandwich dogs must be kept on a leash or be under the control of their owner. Yearly licensing of dogs is required.

Credits/Exemptions/Ordinances (continued)

BEACH ORDINANCES:

Requires a Town Beach/Dump sticker for use of the Town Beach on Squam Lake Road, the Potholes in North Sandwich, Beede's Falls on Sandwich Notch Road and the beach at Bearcamp Pond. Times of use and conduct are also regulated.

DUMP/SOLID WASTE RECYCLING CENTER ORDINANCE:

Recycling requirements are listed. Fines are imposed if these are not met. A beach/dump sticker is required for use of the solid waste recycling center.

ALARM ORDINANCE:

Requires registration of all alarm systems with the Police Department. Fines are imposed for excessive false alarms.

PERMITS are required for parades on state roads and for raffles conducted in Town.

HOUSE NUMBERING ORDINANCE:

Requires numbering of all primary buildings.

ZONING ORDINANCE, SUBDIVISION REGULATIONS AND SITE PLAN REVIEW:

These regulations should be consulted before any new building or remodeling is planned and before changes in existing ownership of land through subdivision or boundary line adjustment. Topics covered include wetland protection, setbacks from lot lines, steep slopes, signs, septic regulations and other requirements.

HISTORIC DISTRICT GUIDELINES:

Within the Historic District certain guidelines apply to changes in exteriors of buildings and use of land.

EXCAVATION ORDINANCE:

Covers gravel pits and other excavations which may require attention to these regulations both during active use and later, when inactive.

BUILDING PERMITS:

Any new building or changes to an existing structure require a building permit if the value of the work to be done exceeds \$2,000 or when construction or reconstruction violates zoning regulation setbacks.

A state/federal permit is required for projects affecting wetlands.
