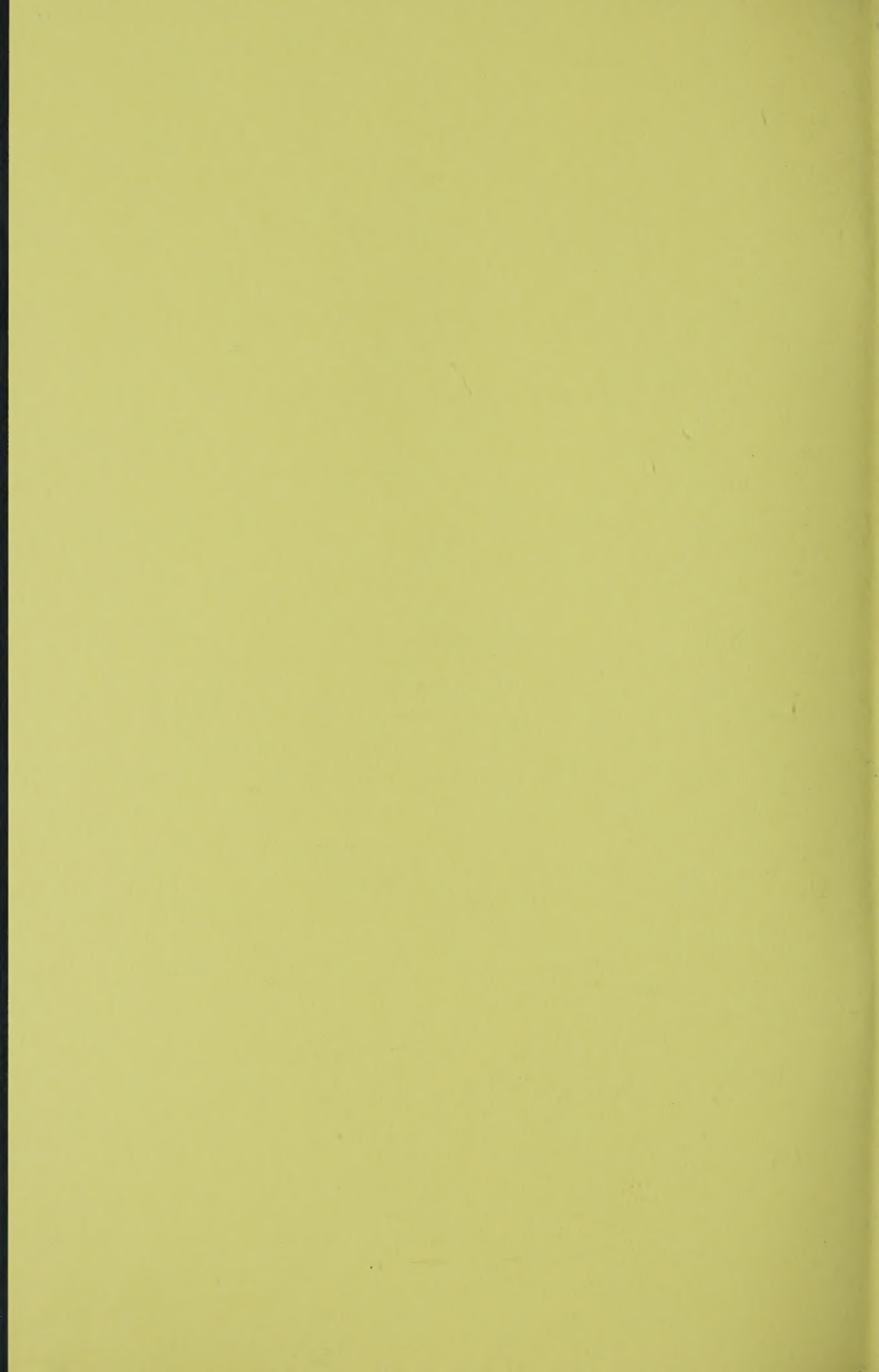

Town Warrant The State of New Hampshire

The Polls Will Be Open from 10:00 a.m. to 6:00 p.m.

To the inhabitants of the Town of Tuftonboro in the County of Carroll in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Tuftonboro Town House in said Tuftonboro on Tuesday the Fourteenth day of March, next, at 10:00 o'clock in the forenoon to act upon the following subjects:

Articles 1, 2, 3, 4, 5, 6, and 7 will be voted on by Ballot on March 14.

You are hereby notified to meet at the Tuftonboro Central School in said Tuftonboro on Wednesday, the Fifteenth day of March, next, at 7:30 p.m. to act upon the following subjects:

Article 1: To choose all necessary Town Officers for the year ensuing.

1989 Zoning Amendments

Article 2: Are you in favor of adoption of amendment No. 1 as proposed by the Planning Board for the Town of Tuftonboro Zoning Ordinance regarding shore lot frontage measurements, as follows:

2.1.22 Frontage: After "In the case of shore lots, Frontage shall mean the dimension on the body of water only", add: "and shall be measured in fifty foot (50) chords." and at

4,2,(3) Delete "150" and replace with "fifty foot (50)".

Article 3: Are you in favor of adoption of Amendment No. 2 as proposed by the Planning Board for the Town of Tuftonboro Zoning Ordinance regarding valet spaces and parking, as follows:

2.1 Insert the following new definitions: "Valet Spaces: Boat storage spaces intended for temporary dry storage of boats during the boating season. This does not include spaces occupied only for repair, long-term or off-season storage."

6.2.(i) After "One (1) space for every two (2) boat slips" add: "One (1) space for every two (2) valet spaces".

Article 4: Are you in favor of adoption of Amendment No. 3 as proposed by the Planning Board for the Town of Tuftonboro Zoning Ordinance regarding second dwelling units, as follows:

3.6 General Use Provisions (3) Replace existing paragraph with: "Any lot that can support a duplex residence without a zoning variance and without waiver by the New Hampshire Water Supply and Pollution Control Division will be allowed up to two (2) dwelling units. The second dwelling unit be subordinate in scope and scale to the existing main dwelling unit. The second dwelling unit shall have a net living area not to exceed 40% of the net living area of the existing main dwelling unit. The second dwelling unit may stand alone or be incorporated into an auxiliary structure such as a garage or a barn. The Town, under the provisions of this paragraph, shall have the right to require New Hampshire Water Supply and Pollution Control Division approved septic system design without waiver from current standards for the proposed dwelling and for the existing main dwelling unit. Further, the Town, under the provisions of this paragraph, shall have the right to require construction of said approved septic systems for the proposed dwelling and for the existing main dwelling as a condition of approval."

Article 5: Are you in favor of adoption of Amendment No. 4 as proposed by the Planning Board for the Town of Tuftonboro Zoning Ordinance regarding minimum lot size calculations, as follows:

4.2.(2) Delete: "exposed ledge".

Article 6: Are you in favor of adoption of Amendment No. 5 as proposed by the Planning Board for the Town of Tuftonboro Zoning Ordinance regarding Dwelling Unit Density calculations in Cluster Developments, as follows:

8.5.2 Delete: "and 100 year flood hazard areas" and replace with: "and slopes over 25%".

Article 7: Are you in favor of adoption of Amendment No. 6 as proposed by the Planning Board for the Town of Tuftonboro Zoning Ordinance regarding The Wetlands Conservation District, as follows:

12.2 Delete existing paragraph and replace with the following: "The Wetlands Conservation District is defined as those areas consisting of poorly drained and very poorly drained soils using the U.S. Department of Agriculture, Soil Conservation

Service soil types descriptions. Reference is made to **Soil Survey of Carroll County, N.H.** dated Dec. 1977 and published by the U.S. Department of Agriculture for the soils descriptions. The Wetlands Conservation District also includes those areas such as swamps, marshes and bogs that are inundated or saturated by surface or ground water at a frequency and duration sufficient to support a prevalence of vegetation adapted for life in saturated soil conditions, such as those species designated as obligate or facultative wetland plants in the lists of the National Wetlands Inventory of the U.S. Fish and Wildlife Service."

12.3 Delete the word "necessarily". After the first sentence, add: "The Tuftonboro Wetlands Map is intended as a general guide and does not include all wetlands areas. On-site tests and inspection of vegetation are required to delineate the Wetland Conservation District boundaries for each lot submitted for subdivision and/or site plan approval. The subdivision or site plan plat submitted to the Planning Board shall contain a certification by a licensed professional certifying that the wetland boundaries shown on the plat have been determined by on-site testing and are in conformance with the definitions of wetland contained in this ordinance." Delete the last sentence of the paragraph.

12.4 After the words "delineated as a wetland", insert: "on the Tuftonboro Wetlands Map".

12.7.1 Insert the following as the second sentence: "Applications for use of wetlands shall be referred to the Conservation Commission for review and comment prior to the Planning Board's granting approval.

12.7.2(a) Change to 12.7.1(g);

12.7.2(b) Change to 12.7.1(h); Explanation: These items become permitted uses following review by the Conservation Commission and approval by the Planning Board rather than being Special Exceptions.

12.7.2(c) Change to 12/7/2(a) Create: "12.7.3(d) No person shall fill areas occupied by wetlands, swamps, streams or lakes except as provided by New Hampshire Statutes."

Article 8: To see if the Town will vote to affirm, alter or annul the following ordinance enacted by the Selectmen on August 22, 1988.

ORDINANCE

There shall be no docking of commercial barges, or loading and unloading of commercial barges, at any town-owned dock, wharf, landing or right-of-way, formerly known as range-ways, other than at Union Wharf during daylight hours, for periods of time not to exceed four (4) hours. The use of Union Wharf by commercial barges is restricted to those barges doing work on islands within the Town of Tuftonboro.

Violators will be prosecuted.

Any person or entity violating this ordinance shall be fined:

One Hundred Dollars (\$100.00) for a first violation

Five Hundred Dollars (\$500.00) for each subsequent violation.

Article 9: To see if the Town will vote to amend the ordinance adopted by Article 9 of the 1987 Town Meeting and amended by the Selectmen on August 22, 1988 to provide that commercial uses may be made of the two public landings on Tuftonboro Neck as shown on Tax Map, Pages 61 and 62 and reached by the Crossneck Road. Said use shall be without restrictions except that the same may not be used prior to 7:00 a.m. in the morning nor after 6:00 p.m. and shall not be used any hours during Sunday.

This article on the Warrant by petition and does not have the approval of the Board of Selectmen.

Article 10: To see if the Town will vote to accept as Town Roads the roads presently under the jurisdiction of the Tuftonboro Colony Home Owner's Association as follows: Butternut Lane from Route 109A, Pine Street, Oakleaf Avenue, and Maple Street as shown on plan of Tuftonboro Colony and recorded at Registry of Deeds in Plan Book 26, Page 9.

This article on the Warrant by Petition and has the approval of the Selectmen.

Article 11: To see if the Town will vote to rebuild Whitten Road at an approximate expense of Twenty Thousand Dollars (\$20,000.00).

This article on the Warrant by petition and has the approval of the Selectmen and the Budget Committee.

Articles to Establish Capital Reserve Funds (Articles 12-17). The following articles are to raise and appropriate specific sums of money for the purpose of accruing surplus monies for the future purchase or funding of an improvement or specific item or items of equipment. The funds are to be invested as indicated and all interest earned will remain with the fund. The funds will be administered as outlined in New Hampshire Revised Statutes Annotated, 35:10, and any expenditures

from the fund shall be authorized by Town Meeting Vote stating the purposes for which such fund was established and for which such expenditure is to be made:

Article 12: To see if the Town will vote to raise and appropriate the sum of Four Thousand Dollars (\$4,000.00) to be used for the Police Cruiser Fund, said sum to be placed in a Certificate of Deposit.

This article has the approval of the Budget Committee.

Article 13: To see if the Town will vote to raise and appropriate the sum of Twenty-five Thousand Dollars (\$20,000.00) for the Fire Truck Fund, said sum to be placed in a Certificate of Deposit.

This article has the approval of the Budget Committee.

Article 14: To see if the Town will vote to establish a Piper House Capital Fund and to raise and appropriate the sum of Twenty Thousand Dollars (\$20,000.00) to be placed in a Certificate of Deposit.

This article has the recommendation of the Budget Committee.

Article 15: To see if the Town will vote to establish a Library Capital Building Fund and raise and appropriate the sum of Twenty Thousand Dollars (\$20,000.00) said sum to be placed in a Certificate of Deposit.

This article has the recommendation of the Budget Committee.

Article 16: To see if the Town will vote to establish a Reappraisal Fund and raise and appropriate the sum of Twenty Thousand Dollars (\$20,000.00), said sum to be placed in a Certificate of Deposit.

This article has the approval of the Budget Committee.

Article 17: To see if the Town will vote to establish a Dump Closure Fund and raise and appropriate the sum of Twenty Thousand Dollars (\$20,000.00), said sum to be placed in a Certificate of Deposit.

This article has the approval of the Budget Committee.

Article 18: To see if the Town will vote to authorize the Conservation Commission to retain the unexpended balance of its annual appropriation and any gifts of money received pursuant to RSA 36-A:4, said funds to be placed in a Conservation Fund as authorized by RSA 36-A:5 I.

Any balance remaining at the end of the current or subsequent fiscal years would be placed in the Conservation Fund unless the vote to do so was rescinded at a later Town Meeting. The Town Treasurer would have custody of the monies in the funds and would disburse same only upon order of the Conservation Commission.

Article 19: To see if the Town will vote to raise and appropriate the sum of Fifteen Thousand Dollars (\$15,000.00) for the necessary repairs to Union Wharf.

This article has the approval of the Budget Committee.

Article 20: To see if the Town will vote to raise and appropriate the sum of Four Hundred Ten Dollars (\$410.00) to assist the Family Health Centre.

This article on the Warrant by petition and does not have the approval of the Budget Committee.

Article 21: To see if the Town will vote to change the term of office of the Town Clerk from one (1) to three (3) years, beginning with the term of Town Clerk to be elected at next year's regular Town Meeting.

Article 22: To see if the Town will vote to change the term of office of the Tax Collector from one (1) to three (3) years, beginning with the term of Tax Collector to be elected at next year's regular Town Meeting.

Article 23: To see if the Town will vote to change the term of office of the Town Treasurer from one (1) to three (3) years, beginning with the term of Town Treasurer to be elected at next year's regular Town Meeting.

Article 24: To see if the Town will vote to change the term of office of Road Agent from one (1) to three (3) years, beginning with the term of Road Agent to be elected at next year's regular Town Meeting.

Article 25: To see if the Town will vote to eliminate the elected positions of Town Auditor, and empower the Selectmen to employ a certified public accountant to audit the Town's financial records. This article to take effect for end of fiscal year 1989.

Article 26: To see if the Town will reaffirm the action taken at last year's Town Meeting, under Article 14. To see if the Town will vote to appropriate and authorize the withdrawal from the Federal Revenue Sharing Fund the sum of Nine Hundred Forty-three Dollars (\$943.00), plus whatever interest that has accrued since January 1st, to use as a set-off against the Budget Appropriation for the Piper House Renovation.

This article has the recommendation of the Budget Committee.

Article 27: To see if the Town will vote to raise and appropriate the sum of One Thousand Dollars (\$1,000.00) for interest charges, as approved by the Budget Committee, and to authorize the Selectmen to borrow money in anticipation of taxes, Federal Grants and Bond

anticipation Notes, for the current year and issue notes therefor, said notes to be repaid from said sources.

Article 28: To see if the Town will vote to raise and appropriate such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriation of the same, the sum of Five Hundred Eighty-four Thousand Three Hundred Fourteen Dollars (\$584,314.00) as recommended by the Budget Committee and such sums as may be required to cover the costs to any additional items voted at the meeting and in accordance with RSA 32:8.

Article 29: To transact any other business that may legally come before this meeting.

Article 4: To see if the Town will vote to adopt the provisions of RSA 76:15-a providing for the semi-annual collection of taxes, with partial payment to taxes assessed April 1 and billed before June 1, due and payable on July 1 and payment of the remainder, minus the payment due on July 1 of that year, due and payable on December 1.

The motion was made by Connie Linnell and seconded by Janet Blake to adopt Article 4 as read. Article opened for discussion. Vote by show of hands in the affirmative and Article 4 declared passed by the Moderator.

Article 5: To see if the Town will vote to raise and appropriate the sum of Twelve Thousand Dollars (\$12,000.00) for interest charges, as approved by the Budget Committee, and authorize the Selectmen to borrow money in anticipation of taxes for the current year and issue notes therefor, said notes to be repaid from taxes.

The motion was made by Charles Rogers and seconded by Charles Berry to adopt Article 5 as read. Under discussion was the question whether this interest was necessary and would be needed with the adoption of semi-annual taxes. As it was not known at the time whether these taxes went into effect this year or next, it was determined that this article was necessary. Vote by show of hands in the affirmative and Article 5 was declared passed by the Moderator.

Article 6: Shall the Town of Tuftonboro vote to adopt the provisions of RSA 31:105; to indemnify and save harmless for loss or damage any person employed by it and any member or officer of its governing boards, administrative staff or agencies including but not limited to Selectmen, Planning and Zoning Boards, and School Board members, from personal financial loss and expense including reasonable legal fees and costs, if any, arising out of any claim, demand, suit or judgement by reason of negligence or other act resulting in accidental injury to a person or accidental damage to or destruction of property if the indemnified person at the time of the accident resulting in the injury, damage or destruction, was acting in the scope of his employment or office.

The motion was made by Ken Craigue and seconded by Charles Rogers to adopt Article 6 as read. Vote in the affirmative by show of hands and Article 6 was declared passed by the Moderator.

Article 7: To see if the Town will vote to raise and appropriate the sum of Twenty-two Thousand, Five Hundred Dollars (\$22,500.00) to build a parking lot on Town-owned land on Route 109 at Nineteen Mile Bay. (This article has the recommendation of the Budget Committee).

Motion was made by Ivan Phelps and seconded by Thad Coleman to adopt Article 7 as read. This article brought forth a lot of discussion: concern for safety of people walking along 109; matter should wait until relocation takes place; concern the parking lot would draw outsiders for free parking; where in other places payment has to be made; fees and parking tags; an escrow account; suggested regulations on parking be made before parking area becomes available. Selectman Vittum explained that this is a small part of a long range plan for the area. A vote by show of hands resulted in a tie vote.

Motion was made by Rick Chellman and seconded by Ken Craigue to reconsider vote on article. Moderator declared vote by show of hands in affirmative to reconsider article. Rick Chellman presented amendment to this article. To appropriate an additional \$7,500.00 for a total of \$30,000.00 to insure that the construction of the parking area is, in fact, in accordance with an overall plan of the 19 Mile Bay area, to be determined by the Selectmen. Seconded by Susan Weeks. The amendment to Article 7 was defeated by a show of hands in the negative and the Moderator declared the amendment not passed. Motion was made for a secret ballot, seconded and voted in the affirmative. Total Votes cast, 146; Yes 83, No 63, and Article 7 was declared passed by the Moderator.

Article 8: To see if the Town will vote to adopt as an ordinance:

ORDINANCE

Article 1: There shall be no overnight parking at Union Wharf.

Article 2: There shall be no parking on either side of Union Wharf Road. Any person violating this ordinance shall be:

1. Issued a warning for the first violation.
2. Fined not more than \$25.00 for the second violation.
3. Fined not more than \$100.00 for subsequent violations.

Motion was made by Connie Linnell and seconded by Lincoln Page to adopt article 8 as read. Vote by show of hands in the affirmative and Article 8 declared passed by the Moderator.

Article 9: To see if the Town will vote to adopt an ordinance restricting docking of commercial barges to one Town Wharf, Union Wharf, and during daylight hours only, as follows:

"There shall be no docking of commercial barges at Town Wharfs in the Town of Tuffonboro, other than at Union Wharf during daylight hours. Overnight docking of commercial barges at Town Wharf is prohibited."

Motion was made by Charles Whitten and seconded by Thad Coleman to adopt Article 9 as read. Vote by show of hands in affirmative and Article 9 declared passed by the Moderator.

Article 10: To see if the Town will vote to ratify the action taken by the Selectmen in filing in the Carroll County Superior Court a Petition to Rescind Purchase and Sale Agreement between the Town and PAK 2000 (OCOR Products) regarding the proposed sale of an approximate five (5) acre parcel of land abutting PAK 2000 as approved by vote of the Town at the 1982 Town Meeting.

Motion was made by Ken Craigue and seconded by Anne Levergood to adopt Article 10 as read. Atty. Pamela Albee explained in chronological order what has transpired since the 1982 Town Meeting. Two non-voters-employer Peter Roessiger and employee Carl Liedtke requested to speak to the audience in behalf of PAK 2000. Voters granted permission by an affirmative vote to allow them to speak in behalf of their company.

Motion was made by Ken Craigue and seconded by Clint Morgan to move the question. Vote in affirmative to move the question and end discussion. Vote by show of hands to adopt Article 10 and declared passed by the Moderator.

Article 11: To see if the Town will vote to authorize the Conservation Commission to retain the unexpended portion of its 1988 appropriation; such funds to be placed in a Special Conservation Fund in accordance with RSA 36A-5.

The motion was made by Rick Chellman and seconded by Walter Kirch to adopt Article 11 as read. Vote by show of hands in the affirmative and Article 11 declared passed by the Moderator.

Article 12: To see if the Town will vote to raise and appropriate the sum of Three Thousand Dollars (\$3,000.00) to be used for the Police Cruiser Fund; said sum to be placed in a Certificate of Deposit. (This article has the recommendation of the Budget Committee).

Motion made by Lincoln Page and seconded by Thad Coleman to adopt Article 12 as read. Vote by show of hands in the affirmative and Article 12 declared passed by the Moderator.

Article 13: To see if the Town will vote to establish a Fire Truck Fund and to raise and appropriate the sum of Twenty Thousand Dollars (\$20,000.00) to be placed in a Certificate of Deposit. (This article has the recommendation of the Budget Committee).

Motion was made by Ken Craigue and seconded by Clint Morgan to adopt Article 13 as read. vote by show of hands in the affirmative and Article 13 declared passed by the Moderator.

Article 14: To see if the Town will vote to appropriate and authorize the withdrawal from the Federal Revenue Sharing Fund the sum of Eight Hundred Ninety-seven Dollars (\$897.00), plus whatever interest that has accrued since January 1st, to use as a set-off against the Budget Appropriation for the Piper House Renovations. (This article has the recommendation of the Budget Committee).

Motion was made by Charles Whitten and seconded by Charles Rogers to adopt Article 14 as read. Vote by show of hands in the affirmative and article declared passed by the Moderator.

Article 15: To see if the Town will vote to raise and appropriate the sum of Ten Thousand Dollars (\$10,000.00) for the necessary repairs to the Melvin Wharf. (This article has the recommendation of the Budget Committee).

Motion was made by Walter Kirch and seconded to adopt Article 15 as read. Vote by show of hands in the affirmative and the article declared passed by the Moderator.

Article 16: To see if the Town will vote to raise and appropriate the sum of Thirty-five Thousand Dollars (\$35,000.00) to allow the Selectmen to negotiate for the Hydrogeological study of the Town Landfill as mandated by the Department of Environmental Services, Waste Management Division; by Administrative Order WMD 87-134, September 14, 1987. (This article has the recommendation of the Budget Committee).

Motion made by Ken Craigue and seconded by Lincoln Page to adopt Article 16 as read. It was questioned if this action was necessary. Selectmen stated Town was under State order. Bill Stockman suggested the Town order the State to test their land on Rte. 109A at Copp's Pond for pollution caused by storage of road salt. Vote by show of hands in the affirmative and article declared passed by the Moderator.

Article 17: To see if the Town will authorize the Selectmen to accept private donations of land, interest in land or money to be deposited into the Conservation Fund for the purposes of contributing to the local matching portion required for acquiring conservation land or interest in land and other costs associated therewith for permanent conservation use under the N.H. Land

Conservation Investment Program (LCIP) RSA 221-A, and authorize the Selectmen to apply for and accept the state matching funds under the LCIP for the purposes of acquisition of the fee or lesser interest in conservation land. Said appropriated or donated funds and state matching funds may be expended by majority vote of the Conservation Committee. By petition.

Motion was made by Stephen Snow and seconded by Connie Linnell to adopt Article 17 as read. Conservation Committee member Stephen Snow was called upon to explain definition of article. vote by show of hands in the affirmative and article declared passed by the Moderator.

Article 18: To see if the Town will vote to elect a board of two (2) Auditors by ballot and to further establish varying terms of office. The town meeting of 1989 will elect one (1) Auditor for two (2) years and one (1) Auditor for one (1) year.

Motion was made by Norman Vittum and seconded by Charles Whitten to adopt Article 18 as read. Vote by show of hands in the affirmative and Article 18 was declared passed by the Moderator.

Article 19: To see if the Town will vote to raise and appropriate such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriation of the same, the sum of Six Hundred Two Thousand Nine Hundred Ninety-nine Dollars and no/100 (\$602,999.00) as recommended by the Budget Committee and such sums as may be required to cover the costs of any additional items voted at the meeting and in accordance with RSA 32:8.

Motion was made by William Rollins to adopt Article 19 as read, seconded by James Berry. The appropriation of \$602,999.00 as stated and the sums of Articles 5, 7, 12, 13, 14, 15, and 16 make total to be raised and appropriated Seven Hundred Six Thousand Three Hundred Ninety-six Dollars (\$706,396.00). Vote by show of hands in the affirmative and Article 19 declared passed by the Moderator.

Before the close of the meeting Selectman Charles Whitten read the following resolution to the Fire Department, expressing the Town's appreciation for services performed by the Firemen for the Town. This Resolution to become a part of the records of this meeting.

TUFTONBORO VOLUNTEER FIRE DEPARTMENT**

- WHEREAS, THE TOWN OF TUFTONBORO IS DEEPLY APPRECIATIVE OF THE DEDICATION OF THE TUFTONBORO FIRE DEPARTMENT AS EXEMPLIFIED BY ITS FIRE FIGHTING AND FIRST RESPONDERS ACTIVITIES.
- WHEREAS, IN THE 1987 YEAR AND CONTINUING THE TUFTONBORO VOLUNTEER FIRE DEPARTMENT, UNDER THE LEADERSHIP OF CHIEF JOHN SCOTT, HAS INDEED PERFORMED AN UNUSUAL AND AS A MATTER OF FACT SPECTACULAR SERVICE TO THE TOWN.
- WHEREAS, BELOW IS A SUMMARY OF THE SIGNIFICANCE OF THAT 1987 SERVICE OVER AND BEYOND CONTINUOUS TRAINING FOR

EMERGENCIES AND ANSWERING ALL CALLS FOR HELP.

1. A new station was erected at Mirror Lake to house three pieces of apparatus and includes a training room, well water supply, toilet, and kitchen. If this entire project had been put out to bid the estimated cost would have been \$175,000.

Expended for this project by the Town was \$5,000. The remainder of the cost came from a fund raising effort of the Tuftonboro Volunteer Fire Department amounting to \$46,000.

Many contractors either donated their time or performed their work at costs. A great deal of the labor was by the Fire Department members and volunteers from the community.

2. Complete renovation of the Melvin Village Station including roof reinforcement, new ceiling, rewiring of the station, new lighting, new bay door openers, and renovated plumbing. This project continues with plans to paint the interior walls and a new side door entrance. All labor donated by Fire Department personnel and material costs of \$5,750 coming from funds raised in the community.
3. Purchase of Engine 4, a good used piece, for \$7,000. The Town appropriated \$5500 and the Tuftonboro Volunteer Fire Department contributed \$1500.

Engine 4 was placed in service at the Melvin Village Station in July of 1987 after \$10,100 was spent on equipment and maintenance. Much of the labor was by members of the Fire Department or volunteers from the community. The \$10,100 came from fund raising efforts by the Fire Department.

RESOLVED, THAT THE TOWN OF TUFTONBORO ADOPTS THIS RESOLUTION AND CONVEYS TO CHIEF SCOTT AND HIS DEPARTMENT ITS DEEP APPRECIATION FOR ALL THAT WAS ACCOMPLISHED IN 1987. THE TOWN ALSO EXTENDS ITS THANKS TO THE CONTRACTORS AND INDIVIDUALS WHO HELPED THE FIRE DEPARTMENT MAKE ITS DREAMS A REALITY. MANY CITIZENS VOLUNTARILY DONATED OVER \$63,000 TO THE FUND RAISING EFFORTS OF THE FIRE DEPARTMENT IN 1987.

WE THANK THEM FOR THEIR INTEREST AND GENEROSITY.

Article 20: To transact any other business that may legally come before this meeting.

Motion was made and seconded to close the meeting. Vote in the affirmative by voice and Moderator declared meeting closed. Meeting closed at approximately ten P.M. with about 150 residents in attendance.

TUFTONBORO CONSERVATION COMMISSION

During 1988 the Conservation processed thirty-seven (37) Fill and Dredge Applications. Fifty-six (56) were issued, many of which were carried over from 1987. There were seven (7) denials received from the N.H. Wetlands Board in Concord.

Report of the Tuftonboro Highway Department

The improvement on Windleblo Road was completed and the surface was hot topped the entire length. Ditching was done on New Road, County Road and Sodom Road. 80 feet of culvert were also put down on County Road and a catch basin was added to collect water run-off.

The usual road grading and brush cutting were done as scheduled.

Adversely dry weather conditions during the summer months made dirt road maintenance extremely difficult. Dust conditions and rough roads were severe.

The Durgin Road improvement should be completed by the summer of 1989 with the entire surface to be hot topped. Thus far 1,750 feet of underdrain, 500 feet of culvert, 4 catch basins, and a 300 foot stone lined ditch have been placed to alleviate a severe water run-off situation.

Water and ice conditions this winter have made road maintenance difficult. Severe frost heaves in places have been caused by lack of snow.

Park & Recreation Department

Continued growth of activities and use of facilities highlighted Tuftonboro's successful Recreation Program in 1988.

The summer swim classes, under the guidance of Mary Ann Murray, experienced another busy season accompanied by continued growth in enrollments. A partial cost recovery program was instituted by adding a small user charge to the required Red Cross fee. Families were asked for \$5 for one child or \$10 for the family with \$3 per child being paid to Red Cross. A new, advanced swimmer class was held and in 1989 this again will be offered plus an advanced lifesaving class.

A commercial buoy line will be installed at the Melvin Dock in 1989 to provide a more visible and safer swimming area for the classes and for town residents' use.

Davis Field, under the supervision of Bruce Johnson, was a busy area this past year. Not only is it now in constant use all summer but also by our school children during the winter months. Following the recommendations of the Carroll County Extension Service, 8,000 pounds of lime, plus a weed and feed fertilizer, were spread in the spring of 1988. In the fall another 4,000 pounds of lime were applied. Two permanent soccer goals were installed, the goal nets being donated by Brewster Academy. Approximately 130 children played soccer during the season. Little League baseball activities were equally busy. Future plans include creation of a paved area between the driveway and the ballfield to be used for basketball, volley ball and related sports. Two fixed basketball standards, backboards, rim nets and removable volley ball standards are projected. Volunteers are needed to help remove the old wooden backstop and to move up the existing chain link backstop.

The ice rink was not used due to a combination of changeable weather and lack of volunteer help during the fall to cut brush and rake the area before flooding it. The area is lighted and a nice warming hut has been installed.

The 19 Mile Bay area continues to be popular for family use. Ropes again were put out to keep boats off the rocks. The picnic area was well maintained, tables were set out, garbage cans placed for regular collection and portable toilets installed.

The town should give thanks to the people who have put in many volunteer hours to make the Park & Recreation program a success and to the Selectmen for setting out and picking up the picnic tables. Those who have aided the program are:

Tuftonboro Free Library

Again this year, the Library experienced a substantial increase in demand for services. We are particularly pleased to report that the 27% jump in circulation was fueled primarily by the children, who read 4,078 library books this year (2,542 last year). And patronage was boosted by registering 56 new borrowers in just ten months. Thanks to Librarian John E. Perkins and to assistant Arline Knapp. Their continuing dedication and hard work ensured the third straight year of major gains.

Special recognition is also due to the Library volunteers who support staff efforts. We thank Peggy Bashe, not only for all of her Wednesday afternoons, but also for vacation and emergency coverage throughout the year. We also thank Kay Hamel and Barbara Haskell, who transformed the card catalog into the 20th century over the summer of 1988. It would be impossible to provide the same level of library service without these generous gifts of time and expertise.

The Library Building Committee also dedicated a great deal of time this year to advancing plans for expansion. Herb Bing, Maureen Borowski, Jane Newcomb, and Mary and Jack Williams worked with the trustees, librarian, and State Library consultant Sue Palmatier to develop a prospectus for the proposed addition/renovation project. The Committee then interviewed four architects, and chose the firm of Ingram/Wallace to draft proposals for a future facility.

After careful consideration of four possible building variations and many amendments, the Committee selected one plan for development, and ordered a set of preliminary drawings. These plans, and a scale model, were presented at the annual meeting of the Friends of the Library in December, and then placed on display at the Library.

Each member of this Committee deserves public thanks for the time, energy, and imagination devoted to this effort over the past two years, and for continuing commitment to the project. And we are most grateful to Suzanne and George Slye and to the Trustees of the Hurlburt Charitable Trust Fund for their very generous donations to the Building Fund in 1988.

This year, 4,604 people walked through the door of the Tuftonboro Free Library, and made connections—to information, to great stories, to the worlds within and beyond our borders. In 1989, we will celebrate 150 years of library service to the people of Tuftonboro. We invite you to open the door, yourself. You're welcome.

Librarian's Report

The Library continued to be a source of information and pleasure for many residents and visitors in town in 1988. I am happy to report that residents are making greater use of Library materials and services than ever before. Circulation is up 27% over last year. Patronage is up 21%. We now have 10,000 volumes available for circulation which is a recognized standard for a town the size of Tuftonboro. Since the number of books circulated this year nearly equals the size of the collection, I believe that extremely good use is being made of the collection.

In 1988 the video-cassette and audio-cassette collections were expanded using gift funds. Both videos and audio-cassettes were well received, and the Trustees are committed to continued expansion of both collections.

The pre-school story hour and the adult book discussion group sponsored by the Friends of the Library continued to be popular attractions this year. Also this year, the Library sponsored the Purlly Gates Concert, the Starbird Puppet Theater, the Clearlakes Chorale, and a Christmas singalong with Mary Barkas.

These programs were funded by gifts, and by grants from the NH State Council on the Arts. I would like to thank the Friends of the Library, the Hikers, and the Tuftonboro Grange for the donations that made these programs possible.

I would also like to thank those in the community who have contributed books to the Library. These books are extremely helpful in building the Library collections and in keeping costs down.

I would like to thank volunteers Kay Hamel and Barbara Haskell, who typed duplicate catalog cards for all the remaining handwritten cards in the catalog, making the catalog easier to use.

The gifts of the Friends of the Library this year included a 1989 *Academic American Encyclopedia*, and donations to both the program and book budgets. This last donation purchased a new picture book in honor of every child born in Tuftonboro last year. The Friends cannot be praised too highly for their loyal stewardship.

The Library Building Committee was extremely busy in 1988, progressing from a written prospectus to a three-dimensional model over the course of the year. This was very interesting work for me, and it was rewarding to see everyone's ideas evolve into the architect's final plans.

I continue to be extremely grateful for the generous and skillful volunteer work of Peggy Bashe and for the loyalty and hard work of my co-worker, Arline Knapp.

I look forward to making many new friends in Tuftonboro in 1989.

The apparatus refurbishing on Tanker 1 was completed in May of 1988 with the unit being placed back in service. Other projects undertaken by the Department included a new roof for the Melvin Village Station and a paving project for the apparatus ramps and parking areas at the Melvin and Mirror Lake Stations.

A variety of training programs were undertaken in the past year with a combination of classroom sessions, equipment drill exercises, and area pre-plans developed within the Department. Four members of the Department

completed a 16-hour auto extrication training course and currently fourteen members are enrolled in the N.H. Certified Firefighters training program which will compliment the approximately dozen members of the Department already firefighter-certified.

The Department's first Responder Team continues to be a vital function of our service to the community. Members of the Team, living throughout the Town, are able to respond rapidly and stabilize emergency medical situations. Close cooperation with the Lakeside Ambulance Service of Wolfeboro and the Wolfeboro Rescue Squad provides our residents and guests with rapid, well-trained, emergency medical care.

Continued active membership in the Ossipee Valley Mutual Aid Association allows for coordinated central dispatching of the Town's Fire-Police-EMS services.

Report of Town Forest Fire Warden and State Forest Ranger

Between July 1987 and June 1988, we experienced more fires than normal. The three leading causes of forest fires were again children, fires kindled without written permission of a Forest Fire Warden and debris burning. All causes are preventable, but only with **your** help.

Please help our town and state forest fire officials with forest fire prevention. Contact your Forest Fire Warden for more information.

Enforcement of a state timer harvest regulation is the responsibility of State Forestry officials. Our state has excellent timber harvest regulations; however, your assistance is needed.

If you know of a logging operation and suspect a state timber harvest law may be violated, call your Forest Fire Warden, Concord Forest Protection Headquarters at (603) 271-2217, or local Forest Ranger.

On January 1, 1989, the Deceptive Forestry Business Practices Law (RSA 224:54) goes into effect. This law, in summary, states that a person is guilty of a misdemeanor if, in the course of buying or selling a forest product, he uses a false weight or measure for falsely determining any quality or quantity of a forest product. The Planning Board met 30 times during the year. Ivan Phelps resigned in June, and Walter Kirch was appointed to take his place. The Board approved 7 subdivisions for a total of 28 new lots; signed 2 plans of land and 4 boundary line adjustments. Also approved a 70 Unit Marina Condo. As of December 31st there are 4 new large subdivisions before the board. One subdivision approved was rescinded because incorrect data had been submitted. That applicant is currently submitting new data and revised plans.

In January and February of 1988 the Planning Board had many meetings concerning the proposed zoning changes for the March election. The Town adopted by ballot vote the proposed changes and rescinded the existing ordinance.

The County Soils Conservation Service has retained a certified Soil Scientist available to towns in the County upon request. We have already used his services and plan to use him a great deal more in the future. Fees for this service are paid for by the subdividers.

The Planning Board had an informal meeting with a soil scientist in the latter part of 1988 to discuss how to interpret soils maps & mapping. Also had an informal meeting with Lakes Region Planning Commission representative to discuss some of our ordinances in comparison to other towns in the area. Both meetings were very helpful. Several Board members attended the N.H.M.A. Law Lecture Series and other workshops throughout the year.

We have also worked on a few proposed ordinance changes to the Zoning Ordinance to be voted on at March Town Meeting.

Sample of Local Assistance Provided by the LRPC 1987-1988

Over the course of the past fiscal year, the Lakes Region Planning Commission provided support and assistance to the Town of Tuftonboro at both the regional and local levels. The following list represents a sample of some of the ways in which the LRPC has assisted the community.

Although the Town of Tuftonboro did not officially become a full member of the LRPC until July 1, 1988, the LRPC did provide the Planning Board with technical assistance in anticipation of full membership.

- Provided the Planning Board with information regarding minimum requirements for waterfront development.
- Researched and analyzed changes in local housing characteristics since the 1980 census as part of a Regional Housing Characteristics Study.
- Reviewed changes in local land use regulations to update a report on development regulations in the Lakes Region.
- Co-Hosted the annual Municipal Law Lecture Series, where practising attorneys provide a legal perspective on local planning, zoning, and procedural issues.
- Developed a guide book for developing Cluster Development Regulations.
- Presented three public workshops for local land use boards on how to prepare fiscal, traffic, and environmental impact studies.

Visiting Nurse Association of Wolfeboro and Vicinity, Inc.

The Visiting Nurse Association of Wolfeboro and Vicinity provides services to residents of eight towns. The Agency is both Medicare Certified and State Licensed, and employs a staff of fourteen including Registered Nurses, a Registered Physical Therapist and Certified Home Health Aides.

The staff made a total of 8,010 home visits. All services are provided under the orders of each client's personal physician. Nursing services are available seven days a week; other home care services are available Monday through Friday.

Report of the Tuftonboro Central School

School opened on September 6, 1988 with 187 students enrolled for classes. In December the registration figure climbed to 191. Both the primary and the intermediate grades are experiencing increases. The school's large class size enrollments and future space needs are currently being examined. We are looking for reasonable long-range solutions or alternatives that will provide financially realistic solutions to these issues.

I am pleased to report that the Tuftonboro Central School's 1988 Fourth Grade Total Battery Scores on the California Achievement Test will rank high again when compared to similar scores in the national and statewide testing programs. The overall battery placed the class higher than 89% of the students in the National Norm Group, indicating an above average performance for our students. The class median scores were higher in all tests scored in the district and state.

The Total Battery Score of the California Achievement Test results administered at the sixth grade level, but not statewide, places the school higher than 76% of the students in the National Norm Group.

The school's Volunteer Program will receive statewide recognition at Governor Gregg's Office for the sixth consecutive year as a recipient of the Blue Ribbon Achievement Award in the State of New Hampshire in February. This honor is possible only through the efforts, loyal support, and dedication of our 103 volunteers who have donated 4,313 hours to our community school.

This spring the children participated in the fund raising program "Jump Rope for Your Heart" Contest and raised \$1,832. The money was donated to the American Heart Association for research.

During the Fall Festival in October, the Fourth Graders raised \$3,600.00 to help pay their way to Nature's Classroom for a week in April, 1989. The students have been raising funds for and participating in this most beneficial environmental school for several years.

Special recognition should be given to our students who have achieved outstanding academic performance this past year. The 1988 National Science and National Social Studies Olympiad winners were: Science, Joseph Chellman and Ryan Jones; Social Studies, Shannon La Monica and Evan MacDonald. The Presidential Academic Fitness Awards were presented to Katja Liedtke, Robert Newhall, Michelle Hansen, Sophie Rice, Kelly Finn, Donald Meek, Evan MacDonald, Tajin Magoon, Kristina Andersen and Abigail Albee. This year's Presidential Physical Fitness Awards were presented to Douglas Ames, second year; Tajin Magoon, Kristin Bley, first year, and a Physical Fitness Merit Award to Joy Ramsbotham.

The school held its Third Annual Old Fashioned Christmas Bazaar in November. Thanks to Debbi Santulli and her committee, this event has now become a popular event for residents and local craftspeople.

Again, thank you all for your dedication to education, support and help in providing a quality education for our children.
