SELECTMEN'S REPORT

Patience is a virtue and a necessity in the job of town selectman. As the board is governed by the town meeting and the town is governed by the New Hampshire State Legislature, one must be patient.

The current board began talking three years ago about things we thought would be beneficial to the town. For instance, a priority was getting the town finances in a position of not having to borrow \$400,000 each year. By ordering items appropriated at town meeting in June, we only needed to borrow \$100,000 in 2001.

The town employees have job descriptions – an item that was on our list for nearly two years. Their reviews/raises will take effect in July. We would have liked to spend about \$8000 in 2001 to pay off the ambulance with the \$50,000 donation. The State Legislature dictated that we couldn't (patience) so it will cost the town somewhat more this year. A huge Thank You to the anonymous donor.

Town Hall office automation, our un-seen progress. We have come a long way since our computer nightmares of a few years ago. Data security is assured thanks to our Technology Committee's effort we now have a central file server networked with three work stations allowing us to automatically back-up the town data to a tape cartridge on a daily bases. This function occurs on a non-interfering basis over-night and the tape cartridge taken away from the town hall until a new one is made. Once a month, a copy of our town data is stored in the town's safety deposit box to insure long-term protection of our town data.

Great strides have been made with the utilization of the Town's financial software allowing us to track and report on a monthly bases, both expense and revenues. These reports are made available to both the selectman and the department heads to insure everyone is working with the most current information.

What we find in front of us is most exciting. The soon to be completed tax map effort combined with the implementation of both assessing and a new tax software will elevate our Town Hall to true push button property assessment information. All of these things contribute significantly toward providing the tools necessary for the Town Hall offices to operate efficiently without expanding staff and will help posture us well for the state required assessment certification in the year 2005

The year 2001 was a busy year with meetings. Mr. Williams and Mrs. Kelly attended Selectmen's Institute on four Saturdays, we met with the DRA and BTLA in Concord, had our usual twice monthly meetings and conducted workshops in our spare time as well. And it was a pleasure to serve the town. It is quite time consuming but the people you meet and the things you learn make it all a valuable experience in learning how a town functions.

INDEPENDENT AUDITOR 'S REPORT

To the Members of the
Board of Selectmen
Town of Deering
Deering, New Hampshire

We have audited the accompanying general purpose financial statements of the Town of Deering as of and for the year ended December 31, 2000 as listed in the table of contents. These general purpose financial statements are the responsibility of the Town's management. Our responsibility is to express an opinion on these general purpose financial statements based on our audit.

We conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

The general purpose financial statements referred to above do not include the general fixed assets account group which should be included in order to conform with generally accepted accounting principles. As is the case with most municipal entities in the State of New Hampshire, the Town of Deering has not maintained historical cost records of its fixed assets. The amount that should be recorded in the general fixed assets account group is not known.

In our opinion, except for the effect on the financial statements of the omission described in the preceding paragraph, the general purpose financial statements referred to above present fairly, in all material respects, the financial position of the Town of Deering as of December 31, 2000, and the results of its operations and the cash flows of its nonexpendable trust funds for the year then ended in conformity with generally accepted accounting principles.

Our audit was made for the purpose of forming an opinion on the general purpose financial statements of the Town of Deering taken as a whole. The combining and individual fund financial statements listed as schedules in the table of contents are presented for purposes of additional analysis and are not a required part of the general purpose financial statements of the Town of Deering. Such information has been subjected to the auditing procedures applied in the audit of the general purpose financial statements and, in our opinion, is fairly presented in all material respects in relation to the general purpose financial statements taken as a whole.

NOTE 4 - OTHER INFORMATION

A. Risk Management

The Town is exposed to various risks of loss related to torts; theft of, damage to, or destruction of assets; errors or omissions; injuries to employees; or natural disasters. During fiscal year 2000, the Town was a member of the New Hampshire Municipal Association Property-Liability Insurance Trust, Inc. and the Compensation Funds of New Hampshire -Workers' Compensation Division. These entities are considered public entity risk pools, currently operating as common risk management and insurance programs for member towns and cities.

The New Hampshire Municipal Association Property-Liability Insurance Trust, Inc. is a Trust organized to provide certain property and liability insurance coverages to member towns, cities and other qualified political subdivisions of New Hampshire. As a member of the NHMA Property-Liability Insurance Trust, Inc., the Town shares in contributing to the cost of, and receiving benefits from, a self-insured pooled risk management program. The membership and coverage run from July 1 to June 30. The program includes a Self-Insured Retention Fund (SIR) from which is paid up to \$500,000 for each and every covered property, auto physical damage or crime loss, subject to a \$1,000 deductible, and each and every covered general liability and public officials' liability loss.

The Trust maintains on behalf of its members the following reinsurance policies shared by the membership for the year ending June 30, 2001:

1. Signet Star Reinsurance Policy #9-02-AMD-07 -0001-1 which provides excess package coverage in the amount of \$1,500,000 in excess of the Trust's SIR for each and every loss.
2. Swiss Reinsurance Policy #2300895 which provides Excess Property/Excess Flood coverage in excess of the Trust's sm.
3. Hartford Steam Boiler Policy #FBP-CH-2213346 which provides a \$50,000,000 limit resulting from any "one accident" subject to a \$1,000 deductible.
4. Royal Insurance Company Policy #RHD309238 which provides a \$51,000,000 limit resulting from Flood and Earthquake and \$7,000,000 resulting from any "one accident" for Flood in Zone A subject to a \$1,000 deductible.

Contributions paid in 2000 for FY2001 ending June 30, 2001, to be recorded as an insurance expenditure totaled \$17,039. There were no unpaid contributions for the year ending June 30, 2001, and due in 2000. During December 2000, \$4,264 was returned to the Town in the form of a check as its 2000 "dividend" for the years 1990, 1994, 1995 and 1996.

The Trust Agreement permits the Trust to make additional assessments to members should there be a deficiency in Trust assets to meet its liabilities. At this time, the Trust foresees no likelihood of an additional assessment for any of the past years.

Compensation Funds of New Hampshire -Workers' Compensation Division is a Trust organized to provide statutory workers' compensation and employer's liability self-insurance coverage to member towns, cities, school districts, and other qualified political subdivisions of New Hampshire. As a member of Compensation Funds of New Hampshire -Workers' Compensation Division, the Town of Deering shares in contributing to the cost of and receiving benefits from a self-insured pooled risk management program. The membership and coverage run from January 1 to December 31. The coverage is for the statutorily required workers' compensation benefits and employer's liability coverage up to \$1,300,000. The program includes a Loss Fund from which is paid up to \$300,000 for each and every covered claim. The Trust Agreement permits the Trust to make additional assessments to members should there be a deficiency in Trust assets to meet its liabilities. At this time, the Trust foresees no likelihood of any additional assessments for any of the past years.

The Town continues to carry commercial insurance for all other risks of loss, including employee and public official fidelity bonds, health and accident insurance.

B. Defined Benefit Pension Plan

Plan Description and Provisions

The Town of Deering participates in the New Hampshire Retirement System (The System) which is the administrator of a cost-sharing multiple-employer contributory pension plan and trust established in 1967 by RSA 100-A:2 and is qualified as a tax-exempt organization under Sections 401(a) and 501(a) of the Internal Revenue Code. The plan is a contributory, defined benefit plan providing service, disability, death and vested retirement benefits to members and their beneficiaries. Provisions for benefits and contributions are established and can be amended by the New Hampshire State Legislature. The System issues a publicly available financial report that may be obtained by writing the New Hampshire Retirement System, 4 Chenell Drive, Concord, NH 03301.

Description of Funding Policy

The System is financed by contributions from both the employees and the Town. Member contribution rates are established and may be amended by the State legislature while employer contribution rates are set by the System trustees based on an actuarial valuation. Police officers are required to contribute 9.3% of gross earnings. For the period January 1 through June 30,2000, the Town contributed 4.93% for police officers. From July 1 through December 31,2000, the rate was 5.655% for police officers. The contribution requirements for the Town of Deering for the years 1998, 1999, and 2000 were \$6,037, \$5,141 and \$4,276, respectively, which were paid in full in each year.

The State of New Hampshire funds 35% of employer costs for police officers employed by the Town. GASB Statement No.24, *Accounting and Financial Reporting for Certain Grants and Other Financial Assistance* requires this amount to be reported as a revenue and expenditure in the Town's financial statements. This amount \$2,169 has been included on Exhibit B -Combined Statement of Revenues, Expenditures and Changes in Fund Balances -All Governmental Fund Types and Expendable Trust Funds and is reconciled to the budgetary expenditures in Note 1D.

C. Summary Disclosure of Significant Contingencies

Litigation

There are various claims and suits pending against the Town which arise in the normal course of the Town's activities. In the opinion of management, the ultimate disposition of these various claims and suits will not have a material effect on the financial position of the Town.

Deering Conservation Commission
Annual Report – 2001

The Deering Conservation Commission (DCC) has nearly a full compliment of members for the first time in many years. Several new members have provided fresh insight and a sense of vitality to the Commission. The combination of enthusiasm and experience should enable the DCC to continue to serve the community and protect its natural resources.

The DCC has made significant progress in its land protection efforts. The DCC is currently working towards the permanent protection of an additional \pm 250 acres of land with significant frontage on the Contoocook River. We have also interacted with other conservation groups who are currently closing on purchases and/or easements to protect another \pm 400 acres. Our efforts could not be successful without the generous donations of easements and finances from environmentally conscious landowners in the Town of Deering.

Other programs, which the DCC sponsors and manages, are the Woodduck nesting box program, conservation camp sponsorship for Deering youths, cleanup day, surface water monitoring, and Deering Lake testing. Our duties also include reviewing dredge and fill permits and yearly monitoring of Town held conservation easements.

The DCC works in concert with several local organizations including the Deering Fish & Game Club, the Deering Association, and the Deering Lake Improvement Association on various environmental issues. Most recently, a new Lake Questioner was circulated and the results collected and tabulated. The collection of this data provides the DCC with information as to how the landowners and citizens use this valuable resource and allows them the opportunity to express concerns relative to Deering Lake.

The DCC looks forward to the upcoming year but realizes that new development and financial pressures will be part of Deering's future. Hopefully, with the aid of the Selectmen, the various municipal land use boards, landowners, and the citizens of the Town, a pro-active effort to maintain our rural character and to preserve our open spaces and natural resources can be implemented in the near future.

MOMENTS OF TRUTH

Moments of truth are those "encounters" from which the customer forms an impression as to the quality of service that is provided by the department. This impression may be based upon a phone conversation, the issuance of a traffic citation, the handling of a call, or even the physical appearance of the officer and his equipment.

FIRE AND RESCUE REPORT

The Deering Department of Fire and Rescue responded to 54 calls in 2001. Of those calls, 3 were Building Fires, 2 Alarm Activations, 2 Electrical Emergencies, 2 Hazardous Materials, 7 Motor Vehicle Accidents, 2 Motor Vehicle fires, 19 Mutual Aid responses, 5 Brush Fires, 8 miscellaneous service calls, and 4 calls to assist the Rescue Company.

The Officers and Firefighters of the Department were very active throughout the year. Five achieved State certification as Level Two Firefighters; two became EMT's, and one became a Paramedic. Training, as always, continued to be a top priority within the Department, as members traveled throughout the State to approved locations to further their education as Emergency Providers.

Since last year's report our active roster has grown to 32 dedicated and motivated members. Our Information Night was a success and we plan to continue to include some form of this presentation in future Fire Prevention programs. One of our goals for 2002 is to provide more public education activities or announcements throughout the year rather than wait for a single week in October. Staying safe from fire is a yearlong activity that requires everyone's effort.

The Department acquired two pieces of apparatus this past year. The first arrival was a 1967 Jeep military ambulance, which is owned by the State of NH Division of Forest and Lands and is on loan to Deering for use as a Forestry vehicle. On October 15th the new 2001 ambulance was delivered. We would like to extend our most sincere thanks to everyone who made this important purchase possible!

Before closing I want to remind everyone to make sure that you have smoke detectors in your home and that they are working properly. *Make* and practice an exit plan with your family. At the first sign of fire evacuate immediately and report the fire to 911 from a safe location. Designate a place outside of your home where you can meet so you will be sure that everyone has left the building. If you have any questions contact any member of the Fire and Rescue and we will be happy to assist you.

The events of September 11th were felt by all of us, there are no words that can express how grateful we are to all of you that donated to the relief effort through our Ham and Bean Supper and Boot Drive. Your generosity was tremendous.

On behalf of the members of the Department I thank you for your faith and support.

FOREST FIRE WARDEN'S REPORT

2001 was one of the driest years in memory, which resulted in a statewide fire ban for several weeks. The Forest Fire Division was kept busy *responding* to small non-permit fires throughout the year. Additionally there *were* four reported outside fires: an illegal burn, a fire in the woods caused by a lightning strike, a stump fire caused by a construction vehicle, and a small brush fire in a mobile home park from an undetermined cause.

We acquired a 1967 Kaiser Jeep from Frankestown in May. This State owned Forestry Vehicle is a valuable piece of apparatus that enables us to bring manpower and equipment into remote areas to fight fires where other trucks cannot go.

A new law will take effect in January 2003 that will ban all burning of household trash in barrels. We will be educating the public regarding this change throughout the year.

As a reminder, Fire Permits are required for all outside fires including home made fireplaces unless the ground is completely covered by snow. If you have any questions I can be reached at 620-2539 or by contacting Hillsboro Dispatch at 464-3644.

Our Rescue Department currently consists of 1 Paramedic, 4 EMT-Is, and 5 EMT-Bs. We also receive great support from the fire fighters.

We did purchase a new ambulance this year. The new PL Custom ambulance was delivered in October of 2001. We now have more space to work in and it is hard to understand how we did the same job that we do now in the limited space of the old ambulance. Thank you to everyone who helped us achieve this goal. I would like to take the opportunity to invite anybody who would like to see the new ambulance to the Donovan Station on any Tuesday evening at about 7 pm and just ask to see it.

We would like to take this opportunity to remind everyone that the ambulance is an emergency transport unit. The State of NH guidelines tell us that we must transport to the closest, most appropriate hospital and, for most Deering residents, this would be either Concord Hospital or Peterborough Hospital.

We continue to be a volunteer service and do not charge for our services. We purchase all equipment and supplies for the ambulance through donations.

This past year we seen a lot of changes with the way Paramedic intercepts are done. The surrounding departments have started charging for this service; Hillsboro will also start charging for this service in the very near future. We are, unfortunately, looking into different options of charging for ambulance calls.

We are happy to report to all member communities that 2001 marked the twelfth complete year of successful operations. Some items which may be of interest follow:

The 2002 budget reflects a tipping fee of \$37.00 per ton. The same cost as in 2001. The fee for those tons over the FFT (133,600 tons) will be \$66.50 per ton. This fee decreased \$1 per ton for 2002.

Co-op waste delivered to the Wheelabrator facility this year totaled 139,638 tons. That represents an increase of 718 tons over 2000, or a .5% increase. Compared to previous years the increase was minimal.

A total of 63,168 tons of ash were delivered to the Franklin ash monofill for disposal. The Ashfill continues to operate very well. Phase III Stage IV is being filled at this time. The most recent expansion will provide disposal capacity for the next four years.

The air retrofit project at the plant has been completed. The project was completed on schedule and close to budget. The retrofit will enable the plant to meet the most recent EPA and DES regulations.

The Cooperative continues to look toward the future by planning for construction of Phase IV at the Franklin site as well as expansion to a Phase V. It is also possible that there will be some negotiations with Wheelabrator concerning extension of the contract this coming year.

SOLID WASTE ADVISORY COMMITTEE

This year has been one of less change at the transfer station than in prior years. We now have mandatory aluminum can recycling, and the closure and capping of the landfill is progressing forward. The physical layout of the facility has enabled all of the containers to be kept in a more centralized area.

ZONING BOARD OF ADJUSTMENT
Annual Report for 2001

During 2001, the Zoning Board of Adjustment considered and granted four applications for variance or special exception. They included:

- ! A variance to allow subdivision of one lot having approximately 28 acres and 385 feet of frontage on East Deering Road into two lots, one of which would have 25 ½ acres with 200 feet of frontage and the other which would have 2 ½ acres, but only 185 feet of frontage;
- ! A special exception to allow the operation of a bed & breakfast business in a residence on East Deering Road;
- ! A special exception to allow the limited operation of a small used car business near the intersection of Route 149 and Clement Hill Road; and
- ! A variance to allow the construction of a single-family home on a lot having 1.87 acres with 190 feet of frontage on Old County Road. The lot had been approved by the Planning Board in 1971 as part of the Langlois subdivision.

The Hillsborough Superior Court ordered a rehearing on a variance granted last year to build a residence on a small lot on Deering Reservoir. At the request of the applicant, a hearing has not yet been scheduled.

The ZBA prepared a number of recommended changes to the Deering Zoning Ordinance. Some of the proposed changes are regarded as merely “housekeeping;” however, some are substantive, setting limits upon the expansion of non-conforming structures and/or uses, and permitting certain types of home businesses without the need of obtaining a special exception from the ZBA.

The Board meets regularly at the Town Hall at 7:30 p.m. on the fourth Wednesday of every month.

During the coming year, the Board will secure proposals from companies doing Master Plans. The Planning Board will assist the process as well as input from resident of Deering.

To submit a budget to the Board of Selectmen taking in to account the requests and needs of the various departments.

To recognize that all, final budget submissions to the voters of Deering are the responsibility of the Board of Selectmen.

COMMITTEE RECOMMENDATIONS:

Beginning in October 2001 the Budget Advisory Committee along with the Board of Selectmen began the 2002 Town of Deering budget and 2002-2007 Capital Improvements Planning (CIP) review process. This year the committee and the Board developed a working style that complemented each entity in the budget process. It was a very productive endeavor with each committee and board member sharing his or her thoughts in a frank and constructive way. We met with each of the department heads, reviewed their budget proposals, made suggestions for decreases and sometimes increases, decided on a recommended budget and then, again, met with the department heads to explain the reasoning behind our recommendations. In this final meeting with the department heads, the budget committee also made budget changes and adjustments as new information was provided. These Town of Deering 2002 Budget proposals and the 2002 – 2007 CIP matrix are the result of a concentrated effort by the budget advisory committee to achieve the best possible town services in the most cost-effective manner, while also planning for the capital needs of the town well into the future. We wish to thank the Board of Selectmen and the department heads for their assistance.

These 2002 Town of Deering Budget Advisory Committee proposals, in our opinion, represent a realistic yearly budget proposal taking into account all of the necessary costs associated with the services provided by the Police Department, Fire and Rescue Department, and the Highway Department.

The Deering CIP Matrix proposal does show a recommended \$30,000 increase in the level this (2002) year. This 3-year increase in proposed expenditures is a direct result of the State of New Hampshire requiring our community to re-appraise all of the properties in the town.

If you are interested in becoming a member of the Deering Budget Advisory Committee or Capital Improvements Planning Committee we would welcome you. We, along with many other boards and committees in Deering, are experiencing a shortage of men and women interested in serving the town.

REPORT OF THE BUILDING COMMITTEE

As a result of the discussion about the deteriorating condition of the town hall at the annual town meeting in 2001, the Selectpeople requested volunteers to form a Building Committee. The charge to the committee was to survey and evaluate the condition of all town buildings, explore options for renovating and preserving the town hall and investigate various possibilities for providing additional space for the town offices and police department.

Twenty people volunteered for the committee and Lou Ellen Beard was appointed as chair. However, after the initial meetings only five members remained active on the committee.

In May the committee examined the three firehouses and the town road agent's buildings. The Fire Chief and Road Agent explained to us their immediate and long-range needs for maintaining and improving their facilities. Each committee member was asked to submit her/his reactions to these tours and recommendations for long-range action.

During the summer and fall the committee evaluated the condition of the town hall and studied the engineer's report based on the survey conducted by Nicholas Cricenti in 1999. An analysis of the Engineer's report suggests that basic repairs on the town hall would cost approximately \$40,000.00. The committee also interviewed the Town Clerk, Selectpeople and Police Chief to ascertain what they considered to be their basic needs for the conduct of their work and their estimates of future needs.

The Committee agreed that the present condition of the town hall needed immediate attention and that action was required to provide for even cosmetic needs. The Committee organized a painting bee on September 15th to paint the front of the building and the walkway to the town offices. The success of this endeavor was made possible by the generous donations of time and money by the committee members, citizen volunteers and the participation of several members of Americorps.

The building committee's major project was to develop, circulate and collect a survey of the towns' citizens asking them for their preferences among several options for preserving the town hall and providing needed additional space for town offices and the police force. The questionnaires, prepared by the Chair, Lou Ellen Beard, were included in the Deering Connection's summer issue and sent to all registered voters. Sixty-one completed questionnaires were returned.

The tabulated results of the questionnaire indicated the following:

- There is overwhelming support for preserving the town hall as a public meeting place and for renovating and maintaining the building.
- If new space is required, the respondents were equally split over whether to construct a new building for town offices and police station or to build an addition onto the town hall.
- The majority of respondents were opposed to purchasing a new building if one should become available and wanted to keep the town offices in the town hall if possible.

A sampling of the many comments offered were:

- Taxes too high – high salaried spenders – move to Massachusetts
- I smell a raise in taxes – all tighten belts
- Town hall is beautiful/historic place – keep it in good shape
- Wait until population gets to 4,000 or 5,000
- Put money and labor into existing town hall
- Explore possibility of purchasing a building and moving it to town center such as East Deering School House

The Commission's mission is to improve, through education, training, and planning assistance, the ability of the municipalities of the region to prepare and implement municipal plans; to prepare a plan for effective and appropriate development and utilization of the resources of the region; and to assist municipalities in carrying out the regional plan.

The Commission provides a variety of planning services, including consultations on planning issues; planning research; the development of sample ordinances, regulations, and other planning projects such as local master plans, capital improvement programs and corridor studies; circuit rider planner assistance; the compilation of local and regional demographic information; review and comment on planning documents; development review; and educational programs.

In 2001 the Central New Hampshire Regional Planning Commission undertook the following regional planning activities:

- Provided general local planning assistance to member municipalities and responded to inquiries regarding zoning ordinance, subdivision regulation, and site plan review regulation revisions. Prepared calendar and narrative describing critical dates in preparation for Town Meeting 2002.
- Held four meetings of the CNHRPC Regional Resource Conservation Committee (R2C2), which seeks to bring representatives of each of the region's communities together to work on conservation issues that affect the overall region.
- Completed and distributed the Guide to a Municipal Open Space Trail System Plan.
- Completed the update of the FY 2003-2012 CNHRPC Transportation Improvement Program (TIP).

- Organized and hosted five meetings of the CNHRPC Transportation Advisory Committee (TAC).

- Provided assistance to municipalities, groups and interested individuals regarding the Transportation Enhancements (TE) and Congestion Mitigation and Air Quality (CMAQ) programs.
- Provided assistance to local communities in the development of Land and Community Heritage Investment Program (LCHIP) proposals.
- Continued work on the update of the CNHRPC Regional Transportation Plan and preparation of the Regional Multi-Use Trail Plan.
- Provided continuing technical assistance to the Upper Merrimack River Local Advisory Committee (UMRLAC) and the Contoocook and North Branch Rivers Local Advisory Committee (CNBRLAC).
- Completed the update of the CNHRPC Regional Bicycle and Pedestrian Plan and the draft Regional Open Space Plan.
- Provided assistance to CNHRPC member and non-member towns regarding National Flood Insurance Program (NFIP) participation and compliance.

MINUTES OF THE TOWN MEETING
TOWN OF DEERING
March 13, 2001

A legal meeting of the inhabitants of the Town of Deering qualified to vote in Town affairs was called to order at 11:00 AM in the morning of March 13, 2001.

ARTICLE 1. To choose all necessary Town Officers for the ensuing year. Total ballots cast – 327.

ARTICLE 2. It was voted to change the term of the town treasurer from one year to 3 years, beginning with the term of the town treasurer to be elected at next year's regular town meeting. This article is non-lapsing until it is rescinded by a vote of the Town. (Yes 220; No 99)

ARTICLE 3. It was voted to amend Section 2 Paragraph J of the Deering Zoning Ordinance to clarify the requirements for manufactured housing and incorporate pertinent provisions of the Municipal Ordinance on the Regulation of Trailer and Mobile Home Parks relating to the conditions under which trailers and mobile homes may be used for temporary habitation or be stored in the residential/agricultural district. (Yes 207; No 104)

ARTICLE 4. It was voted to amend Section 4D of the Deering Zoning Ordinance to place the authority to regulate excavations under the provisions of N.H. RSA 1 55-E, to which excavations in the Town are now subject, with the Planning Board, as provided in RSA 1 55-E? They would also limit the authority of the Board of Adjustment to the approval of certain new and long-abandoned excavations, mining and processing facilities, and clarify the enforcement role of the Board of Selectmen in regard to excavations. (Yes 194; No 110)

ARTICLE 5. It was voted to amend the Deering Zoning Ordinance to define "junk", "junkyard" and "junkyard, commercial" in Section 1; to adopt new Section 2 Paragraph N (relating to junk other than in junkyards) and Section 4 Paragraph J Junkyards) of the Deering Zoning Ordinance incorporating pertinent provisions of the 1977 Municipal Ordinance entitled "Condition of External Property," while clarifying the requirements pertaining to junk, junkyards and storage of inoperable motor vehicles and other scrap materials; and clarifying the authority of the Board of Selectmen over the operation of such facilities. (Yes 193; No 121)

ARTICLE 6. It was voted to amend the Deering Zoning Ordinance to make minor improvements in several areas: (1) to add to Section 1 definitions of "accessory structure" and "structure"; (2) to amend Section 4 B to eliminate the need for a setback variance for most proposed businesses in existing residences; (3) to renumber paragraphs B(3) through I of Section 4; (4) to add a new Paragraph K to Section 4 clarifying the applicability of special exceptions granted by the Board of Adjustment and who determines a change of use; (5) to enumerate in Section 7 the regulatory authorities of the Board of Selectmen provided under statutes of the State of New Hampshire; (6) to better define in Section 10.3, the [definition of] term "right-of-way" as used in the Shoreland Protection District; and (7) to correct an ambiguity in Section 10.14 a(3), the setback requirements in the Shoreland Protection District. (Yes 190; No 109)

On Saturday, March 17, 2001, at 9:10 A.M., Mr. Arthur E. Walmsley, Moderator, opened the meeting with a moment of silence, and followed by a salute to the flag and singing of the first verse of America.

ARTICLE 7. By ballot it was voted to raise and appropriate the sum of One Hundred and Fifty Thousand Dollars (\$150,000.00) for payment of Deering's portion of the design, engineering, construction, and all other related costs for the purpose of final closure and capping of the Hillsborough Landfill in accordance with all state and federal regulations and to authorize the issuance of not more than One Hundred Fifty Thousand Dollars (\$150,000.00) of bonds or notes in accordance with the provisions of the Municipal Finance Act (RSA Chapter 33) and to authorize the Selectmen and Treasurer to issue and negotiate such bonds or notes and to determine the rate of interest thereon. (2/3 ballot vote required) (Yes 88; No 3)

ARTICLE 8. By amendment it was voted to authorize the Selectmen to enter into a lease/purchase agreement for obtaining a new ambulance for the Deering Fire Department. Cost of the ambulance to be \$105,000, to accept \$30,000 from the Deering Rescue Squad and to raise and appropriate the remaining balance of \$75,000 plus interest over a five year period as follows: five yearly payments of \$17,020.16 with the first payment being raised and due in the year 2001. The amendment was to stay with the original Article 8 as printed in the Town Report with the caveat that the Board of Selectmen inserts a saving, escape clause in their lease purchase agreement.

ARTICLE 9. It was voted to accept the reports of the Town Officials, Agents, Committees and Auditors for the year 2000.

ARTICLE 10. By amendment it was voted to raise and appropriate the sum of \$958,092.28 for general municipal operations.

ARTICLE 11. It was voted to raise and appropriate the sum of \$18,490.00 as estimated by the state for the purpose of funding the painting of the West Deering/Antrim Bridge on Second New Hampshire Turnpike in West Deering.

ARTICLE 12. It was voted to raise and appropriate the following sums:

1. Crushed Gravel \$19,500.00
2. Road Reconstruction \$69,000.00

ARTICLE 13. It was voted to raise and appropriate the sum of \$9,000.00 for the purpose of purchasing calcium chloride for the purpose of reducing road dust on dirt roads.)

ARTICLE 14. It was voted to raise and appropriate the sum of \$10,500.00 for the purpose of purchasing Avitar tax and assessment software.

ARTICLE 15. By amendment it was voted to raise and appropriate the sum of \$10,000 for the purpose of placing a deposit on a suitable property or properties that is or may become available to be used for a town sand pit.

ARTICLE 16. It was voted to authorize the Deering Fire and Rescue Department, pursuant to RSA 154:24, to go to the aid of another city, town, village, or fire district within or without the State, for the purpose of extinguishing fires, rendering other emergency assistance or performing any detail as requested.

ARTICLE 17. It was voted to adopt the provisions of RSA 80:58-86 for a real estate tax lien procedure. These statutes provide that tax sales to private individuals for nonpayment of property taxes on real estate are replaced with a real estate tax lien procedure under which only a municipality or county where the property is located or the state may acquire a tax lien against land and buildings for unpaid taxes. This article is non-lapsing until it is rescinded by a vote of the Town.

ARTICLE 18. Under this article the following recommendations were made with the consensus of the meeting:

1. Mr. Walmsley gave thanks to Laura Putnam and Richard Bono for handling the microphones, and to Keith Johnson for providing the sound equipment. He also thanked the Board of Selectmen for the orderly way in which the material was presented at the meeting. He also expressed his appreciation to the budget committee for all the work that was put into preparing the budget.
2. Keith Miles gave thanks to John Ramsey, who is resigning this year from the Budget Committee, for founding the Committee.
3. It was recommended that the reports of the Trust Funds and Cemetery Committee be included in future Town Reports.
4. The Board of Selectmen noted that there are vacancies on Town Boards and asked for volunteers. They also stated that they favored forming a Building Committee. From the floor it was urged that the Selectmen form a Committee to evaluate all Town Buildings, define the mission of the Committee and make recommendations at a Town Meeting.

The meeting was adjourned at 12:30 PM.
