No one knew at last town meeting that the state would give our town \$3,055.45 for the construction of Class 5 roads; in return the town to use their equipment for which they were to receive drivers pay, grease, gasoline and oil: Town to furnish tools, for this above amount the cost to the town was \$289.68, which came out of highway maintenance.

There were repairs at store house which had to be done as the old floor became unsafe.

These included cement floors, repair on doors, extra storage room upstairs for snow fence, sidewalk plows, and other various snow equipment, so that they could be repaired and painted during summer months, this cost \$221.73.

Your road agent thought it advisable to purchase a cement mixer to be used to mix tar patch as well as cement for various purposes; a second hand mixer was purchased, having been used but a little, nearly as good as new, at less than one-half its purchase price. This cost \$125.00. These extra's cost \$636.41.

If deducted from highway maintenance appropriation, would leave \$39.46 actually overdrawn.

There have been during the year 47 culverts relaid or replaced.  
Two small bridges rebuilt and one larger one replanked with  
double planking 3-inch at bottom and 2-inch on top.

Two bridges have been treated with tar.

Bridges have been painted with aluminum water proof paint.

Mrs. Webb's resignation was sent to the selectmen in order they might take the necessary action.

The motion was made to extend the lighting to the basement. The motion was carried.

Voted to spend \$100.00 for new books and the executive com-

mittee be empowered to authorize the expenditure of not more than \$50.00 additional.

To the president and trustees of the Frost Free Library, the librarian submits the following report for the year ending October 11, 1933.

The library has been open 107 times with a total circulation of 6,664 books; 3,979 of which were adult fiction, 1,870 juvenile fiction, 572 adult non-fiction and 243 juvenile non-fiction.

The total circulation of magazines was 5,496.

Miss Ruth Hemenway and Mrs. Abbie Landry faithfully continue to donate magazines.

Among the others who have given magazines during the past year, and thereby making an even greater variety of magazines to choose from are, Mrs. George Thatcher, Mrs. Carrie Webb, Miss Wally Kaerfer, Miss Lillian Boucher, Mr. Allen Wilcox, Mr. Harry Bemis, Mr. Allison Coutts and Robert Davis.

Through these donations the following magazines have been added: "The Open Road for Boys," "National Sportsman," extra copies of the "Woman's Home Companion," and the "Ladies' Home

Journal." the "Country Home," "The Pathfinder," moving picture magazines and "Radio Stars."

It is with sincere appreciation that I thank each and every one of those who have shown such a splendid, generous spirit in donating magazines.

Seventy-seven new books have been added during the past year, 34 were purchased from the library fund, the other 43 were gifts—21 from Mrs. Rufus Hale, 6 from Miss Emily Dawes, 6 from Miss Katharine Frasier, 6 from Ralph Bissell, 1 from Allison Coutts, 1 from K. K. Kawakami, Japanese author. The Woman's Christian Temperance Union donated, "The Drama of Drink," and the Marlboro Woman's Club donated, "New Hampshire Folk Tales."

I feel sure that all who use the library regularly join me in thanking those who have so thoughtfully given books.

A new set of reference books, "The American Educator," has been purchased from the library fund. One of the attractive features of this set is the privilege of writing the publishers concerning any topic that cannot be found in the encyclopedias. A type written pamphlet on any desired topic will be sent upon request. I feel that this service will prove especially helpful as time goes on.

## REPORT OF HEALTH OFFICER

---

There have been a few cases of contagious diseases in town the past year, but no epidemic.

There have been some complaints in regard to drains, but these have been fixed up.

All brooks flowing through the village where sewerage empties into them, should be covered, so as to protect the health of the people living near them.

Following is a report of the activities carried on in Marlboro during 1933 by the division of maternity, infancy and child hygiene of the state board of health.

In addition to the routine work of the division, a child's health conference was held in Greenwood Memorial church, for children of pre-school age. At this conference 50 children were given complete physical examinations by physicians. Of those examined 45 were found to have defects, while the remaining 5 were found to have no defects. The purpose of these clinics is to prevent illness, therefore children should be registered at an early age.

To the School Board and Citizens of Marlborough:

I herein submit my eleventh annual report as superintendent of schools.

If I were to express in a few words a philosophy of education with a psychological background, it would recognize (1) the human

mind as the most unique, delicately poised and wonderful mechanism the world has ever known; (2) that its stimuli are obtained through the so-called "Windows of the Soul" often called our common senses; (3) that its products are the conceptions, ideations and thoughts resulting from a coalition and cooperation of mental activity, righteous feeling and the power of discrimination between right and wrong.

To recognize these fundamental truths and provide the best environment for their healthy function and development is a problem of public education.

Not only must we develop the so-called skills in our schools but also those fundamental requisites essential to the highest type of American citizenship. This implies the cooperation of the school, the home and the church.

The condition of business is sometimes called the corner stone of our educational structure. Therefore, we can be more optimistic than we were one year ago. The indices of the business world are on the up-grade. Let not the schools lag behind.

6. To see if the Town will raise a sum of money for repairs, water storage, equipment, supplies and other expenses of the fire department.

7. To see if the Town will vote to establish one light at the corner of the Street leading to Leon Wilcox's residence, raise money for the same or act in any manner in relation thereto.

8. To see what sum of money the Town will raise for the support of electric lights.

9. To see if the Town will grant the free use of Engine Hall to the Clarence J. Croteau Post of the American Legion.

10. To see if the Town will vote to raise a sum of money to aid the Community Nursing Association or act in any manner in relation thereto.

11. To see if the Town will vote to purchase a new truck for the Highway Department, raise and appropriate money for the same or act in any manner in relation thereto.

12. To see what sum of money the Town will raise for Memorial Day.

13. To see what sum of money the Town will raise for Old Home Day.

14. To see if the Town will vote to cover the portion of Library Brook, starting opposite the Library Building and extending up the Brook near the house owned by Herbert Cloutier, raise and appropriate for the same or act in any manner in relation thereto.

15. To see if the Town will vote to accept the funds for perpetual care of cemetery lots received since Jan. 31, 1933.

16. To see if the Town will vote to cover the Brook through Charles Beauregard's field, raise and appropriate money for the same or act in any manner in relation thereto.

17. To see if the Town will vote to discontinue the present road past the so-called Corey place and accept a new layout at no expense to the Town.

18. To see if the Town will cover with tar the Class V road built from Fred Hemenway's residence over Frost Hill to the Cushing residence, raise and appropriate money for the same or act in any manner in relation thereto.

19. To see if the Town will vote to adopt the Australian Ballot system for the election of officers.

20. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired by the Town through Tax Collector's deeds.

21. To see if the Town will authorize the Selectmen to borrow on the credit of the Town in anticipation of taxes.

22. To hear the reports of Town agents or committees or other officers heretofore chosen or appointed and pass any vote relating thereto.

23. To transact any other business that may legally come before the meeting.
