TOWN WARRANT—1978

The State of New Hampshire

The polls will be open from 10:00 A.M. until 6:30 P.M.

To the Inhabitants of the Town of Sanbornton in the County of Belknap in said State, qualified to vote in Town Affairs:

You are hereby notified to meet in the Town Hall in said Sanbornton on Tuesday, the fourteenth day of March, next at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To choose all necessary district officers for the Winnisquam Regional School District.
3. To vote on the following proposition submitted by petition in accordance with statutory authority (RSA 39:2-a): To change the date of Town Meetings, other than the part of the Meeting at which Town Officers are chosen for the year ensuing, to the Saturday in March immediately following that part, at nine of the clock in the forenoon, and to take effect beginning in March 1979.
4. To vote on the following proposed amendments to the Zoning Ordinances as recommended by the Planning Board:

AMENDMENT NO. 1. To remove a conflicting provision (Article XVIII, Paragraph A-3) to as to require approval by the Board of Adjustment for professional offices, home occupations, and home industries in the Forest Conservation District so that the procedure will be the same as now in the General Residence, General Agricultural, and Historical Preservation Districts.

AMENDMENT NO. 2. To provide for a minimum lot frontage of 175 feet in the Highway Commercial District. (There is no minimum frontage requirement now.)

AMENDMENT NO. 3. To increase the front set back for buildings in the General Agricultural, Commercial, Recreation, General Residence, and Forest Conservation District;

To decrease the front set back for buildings in the Highway Commercial District;

To increase the rear and side set backs for buildings in all districts (except Historic Preservation District), and

To permit a building no more than 30' high at the highest point relative to the surrounding terrain (instead of the adjacent road) in the Commercial District.

To make the above set backs applicable to home industries, home occupations, and motels.

AMENDMENT NO. 4. To specify that the Selectmen be responsible for an on site inspection of reclaimed land previously approved for excavation, earth removal, deposition of garbage, rubbish, waste material or by products, to insure that the reclamation is according to plan, prior to release of owner/operator performance bond.

AMENDMENT NO. 5. To establish an Aquifer Conservation District to preserve the quality of underground water by placing certain restrictions on uses and development on land therein.

AMENDMENT NO. 6. To redefine the term "dwelling".

AMENDMENT NO. 7. To define the term "lot," which is not presently defined.

You are hereby notified to meet at the Town Hall in said Sanbornton on Wednesday, the fifteenth day of March next at seven-thirty of the clock in the evening, to act upon the following subjects:

1. To raise such sums of money as may be necessary to defray Town Charges for the ensuing year and make appropriations of the same.

2. To see what action the Town will take on the Budget as recommended by the Budget Committee.

3. To see if the Town will vote to authorize the Selectmen to hire such sums of money as may be necessary to defray Town charges in anticipation of taxes; to administer or dispose of any real estate, at public auction, acquired through Tax Collector's deeds; and to apply for and accept grants and funds which may be available to the Town from other governmental agencies.

4. To see if the Town will vote to raise and appropriate the sum of \$92,542.00 for maintenance of highways and bridges, this sum to include \$16,843.31 of State Highway Subsidy Funds.

5. To see if the Town will vote to raise and appropriate the sum of \$1,281.01 for Town Road Aid (TRA), the State's share \$8,540.07.

6. To see if the Town will vote to raise and appropriate the sum of \$2,856.33 for Class V Roads (Duncan Fund).

7. To see if the Town will vote to raise and appropriate the sum of \$9,649.73 in Additional Highway Subsidy Funds in accordance with the provisions of RSA 241:15 for Class IV and V Roads.

8. To see if the Town will vote to maintain the other half of the Range Road known as the Leavitt Road from the crest of the hill, where maintenance presently stops, to its junction with Lower Bay Road, a distance of approximately one third ($\frac{1}{3}$) of a mile. By Petition.

9. To see if the Town will vote to maintain Calef Hill Road from its junction with Pound Road to the Laughy residence, a distance of approximately one quarter ($\frac{1}{4}$) of a mile. By Petition.

10. To see whether the Town will vote to elect the members of the Planning Board, pursuant to RSA 36:4, II-b, instead of having the members appointed. By Petition.

11. To see if the Town will vote to designate Brook Road from Weeks Road to Hale Road (at Turkey Bridge) and Hale Road in its entirety from Weeks Road to New Hampton Road (Rte. 3B) as scenic roads. By Petition.

12. To see if the Town will vote to designate Randlett-Steele Hill Road from its junction with Taylor Road North to the Meredith Town Line as a scenic road. By Petition.

13. To see if the Town will vote to authorize the Selectmen to dispose of all excess, unserviceable, or unusable property by means of public auction. Said auction to take place on the first Saturday of April and October at nine of the clock in the forenoon with appropriate public notices to be given in usual manner. By Petition.

14. To see if the Town will vote to authorize the Selectmen to dispose of all real estate acquired by Tax Deed, and any other real estate, by means of public auction. Said auction to take place on the second Saturday of April and October at nine of the clock in the forenoon with appropriate public notice to be given in usual manner. By Petition.

To see whether the Town will vote to sell at private sale to Andrew McDaniels and Ruth McDaniels the real estate now occupied by the said McDaniels owned by the Town as purchasers at a tax sale for the total amount of all taxes, costs and expenses due on said property including the 1974, 1975, 1976 and 1977 taxes; subject to the condition that said premises shall revert to the Town unless a new and state approved septic system has been installed within 60 days after the date that title passes from the Town of Sanbornton to the said McDaniels. By Request.

16. To see if the Town will vote to raise and appropriate the sum of \$7,320.00 for the Sanbornton Fire Department.

17. To see if the Town will vote to raise and appropriate the sum of \$3,900.00 for the Winnisquam Fire Department.

18. To see if the Town will vote to raise and appropriate the sum of Five Thousand Dollars to establish a capital reserve fund for the purchase of a fire engine by the Winnisquam Fire Department, Inc. to replace Engine No. 1; and to appoint the Selectmen as agents of the Town to carry out the intent of the Town by making payment of said funds with the interest earned thereon to the Winnisquam Fire Department, Inc. in the 1981 or 1982 to be applied against the purchase of said fire engine.

19. To see if the Town will vote to raise and appropriate the sum of \$37,900.00 for the Sanbornton Police Department, this sum to include \$4,323.00 from Federal (LEAA) and \$241.00 from State (GCCD) funds.

20. To see if the Town will vote to raise and appropriate the sum of \$5,035.00 and make the same available to the Library Trustees.

21. To see if the Town will vote to authorize the Selectmen, until directed to the contrary at a subsequent Town Meeting, to apply, negotiate and do all other things necessary to obtain such Federal, State or other assistance as may be available for the report for, design of, and construction of a sewage disposal system, and to authorize the Selectmen to borrow money in anticipation of said assistance as outlined in N.H. R.S.A. 33:7-b et seq., as amended, and pass any vote relating thereto. By Petition. Not submitted to or approved by the Budget Committee.

22. To see if the Town will vote to raise and appropriate a sum of \$10,000.00 for the purpose of preparing a facilities plan on sewerage and sewage treatment facilities which are a requirement contained in the Federal Water Pollution Control Act, as amended (33U.S.C. No. 1251 et seq.) and will qualify the Town for Federal funds, such sum to be raised by the issuance of Serial Bonds or Notes not to exceed \$10,000.00 under and in compliance with the provisions of the Municipal Finance Act (N.H. R.S.A. 33.1 et seq., as amended) and to authorize the Selectmen to issue and negotiate such bonds or notes and to determine the rate of interest thereon, and to take such other actions as may be necessary to effect the issuance, negotiation, sale and delivery of such bonds or notes as shall be in the best interests of the Town of Sanbornton, and to allow the Selectmen to expend such monies as become available from the Federal Government under the Financial Assistance Program of the Construction Grants section of the Federal Water Pollution Control Act, as amended (33 U.S.C. No. 1251 et seq.) and pass any vote relating thereto. By Petition. Not submitted to or approved by the Budget Committee.

23. To see what action the Town will take on the following question: Shall we adopt the provisions of R.S.A. 72:62 for a property tax exemption on real property equipped with a solar energy heating or cooling system which exemption shall be in an amount of the cost of the solar system installed. By Petition.

24. To see if the Town will vote to authorize the Selectmen to designate the Conservation Commission of the Town of Sanbornton as the official municipal body to implement the provisions of the Trees and Roadside Act (N.H. R.S.A. 253:18 II).

25. To see if the Town will vote to raise and appropriate the sum of \$3,500.00 for paving at the Chapel Fire Station, this sum to include \$3,200.00 plus accrued interest from the Town Reserve Fund and to close that account, the balance to be raised by taxes.

26. To see if the Town will vote to raise and appropriate the sum of \$3,983.80 for regional social services as follows: \$311.30 for the Belknap-Merrimack County Community Action Program; \$200.00 for the Lakes Region Twin Rivers Council's Information and Referral Service; \$250.00 for the Lakes Region Family Service; and \$3,222.50 for the Lakes Region Community Health Agency, Inc.

27. To see if the Town will vote to raise and appropriate the sum of \$5,535.67 for the Youth Assistance Program, and to accept a grant of \$1,333.92 as an offset to this cost from Federal and State funds, the aforesaid sums based on the participation of Sanbornton and at least one other Town in the Program, and to be reduced to \$2,601.00 and \$803.50 respectively if three Towns participate, and to be cancelled in entirety if no other Towns participate..

28. To see if the Town will vote to raise and appropriate the sum of \$4,721.46 for the Winnepesaukee River Basin Program.

29. To see if the Town will vote to accept and appropriate the sum of \$2,854.00 received from Federal Anti-Recession Funds to be used as a set-off against the salary of the Selectmen's Secretary.

30. To see if the Town will vote to appropriate and authorize the withdrawal from the Revenue Sharing Fund established under provisions of the State and Local Assistance Act of 1972 for use as set-offs against Budget Appropriations for the following specific purposes and in the amounts indicated herewith or take any other action thereon:

31. To see if the Town will vote to raise and appropriate the sum of \$8,835.00 for the purchase of a new Highway Department pick-up truck with snow plow, and to authorize the Selectmen to accept a bid of \$3,235.00 for the sale of a used truck, the proceeds to go into the General Fund. (See Article 30)

32. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 for the purchase of heating equipment for the Library. (See Article 30)

33. To see if the Town will vote to raise and appropriate the sum of \$5,000.00 for a State Aid for Reconstruction (SAR) project to improve the intersections at the junctions of Bay Road with Lower Bay Road, and Upper Bay Road with Hunkins Pond Road, this sum to be matched by State Funds. (See Article 30)

34. To see if the Town will vote to raise and appropriate the sum of \$10,000.00 to be added to the Highway, Fire and Sanitation Heavy Equipment Fund established by previous vote of the Town. (See Article 30)

35. To see if the Town will vote to raise and appropriate the sum of \$15,000.00 to be added to the Town Building Improvement Fund established by previous vote of the Town, and to authorize the Selectmen to expend such portion of that Fund as may be necessary for the planning, design and installation of water and septic systems for the Library and Town Hall together with related improvements including, but not limited to, insulation, painting, roof and foundation repairs, and excavation and re-grading. (See Article 30)

36. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for Property Appraisal. (See Article 30)

37. To see if the Town will vote to release \$500.00 from the Winnisquam Recreation Trust Fund for a float.

38. To see whether the Town will vote to delete E, F, and G of Section V of the Town of Sanbornton Land Subdivision Control Regulations by which the Town takes 5 per cent or more of the total area of land when ten or more acres are involved, and also takes rights of way to reach the property. By Petition. (Items E, F, and G of Section V refer to "Reserved Land: Semi-Private Ownership," i.e. "Areas set aside for parks and playgrounds to be dedicated or to be reserved for the common use of all property owners by covenant in the deed. . ." Such land remains on the tax rolls as a portion of the land owned by the purchaser of the subdivision lot, and easements are provided for satisfactory access by the common owners and for the protection of watercourses.)

39. To transact any other business that may legally come before this meeting.

SELECTMEN'S REPORT**1977**

During 1977 many major, on-going projects were completed—the Sanitary Landfill, the recreation and picnic facilities at Hermit Lake Beach, grading, paving and erosion control at the Central Fire Station, grading and erosion control at the substation and the old Town Dump was closed and the area environmentally restored under the direction of the United States Soil Conservation Service.

The Highway Department working with the State Highway Department completed reconstruction of a portion of Hunkins Pond Road that had been regarded as particularly dangerous. Plans are underway for continuing the improvement of this heavily traveled route with funds appropriated for Town Road Aid. The newly created Supplementary Highway Subsidy derived from the additional 1¢ per gallon gasoline tax will also be used to upgrade Town Roads. State Aid for Reconstruction, if voted, will be used for the improvement of the intersections of Lower Bay Road with Bay Road, and Upper Bay Road with Hunkins Pond Road, both of which have been judged to be particularly hazardous by the Highway Safety Committee. New steel members were placed to carry Turkey Bridge and the guard rails reinforced. Reconstruction of Shaw Hil Road to the Sanitary Landfill Site was completed with the exception of final gravelling to a small portion.

In accordance with Article 20, an extensive feasibility study was completed for the water and septic systems of the Town Hall and Library and it was concluded that soil and water conditions in the area of these buildings is inadequate to support either conventional septic systems or to meet public water supply standards. It is, accordingly, planned to install composting toilets in both buildings and pipe water from the existing public water supply at the Fire Station. The work of the Building Committee has been of considerable assistance to the Selectmen in working out solutions to the many difficult problems that were encountered in connection with this project.

The feasibility study above mentioned also turned up considerable evidence of the need for further examination of the water and sewage disposal needs of the whole Sanbornton Square Area. In this connection, the Selectmen have initiated inquiries into the possibility of cooperating with State and Federal authorities for conducting a "201" study of the Town's needs. Such a study would assess the sewage disposal and water pollution problems on a Town-side basis and could not be limited to the Square alone if it is to be eligible for 95% Federal and State funding. In view of the broad implications of undertaking such a study it was decided to postpone action until such time as adequate public hearings on the matter can be held and full impact of the study given due consideration.

The contract for the preparation of the Tax Map was let to Ronald Mitchell Associates of Gilford and is well under way. The Selectmen will consider the possibility of a complete re-evaluation of the Town for property tax

purposes when the Tax Map has been completed, any earlier efforts in this direction would involve unnecessary duplication and expense.

As the volume of Town business continues to increase the work space and storage room available in the Town Office becomes increasingly inadequate. Accordingly, the Selectmen have again asked the Building Committee for its recommendations as to the best way to obtain more adequate office, storage, and meeting room space. Work planned for 1978 at the Town Hall will take these needs into consideration and any excavation or foundation work will be designed to provide for the future possibility of utilizing the underfloor space effectively.

The Selectmen continue to work closely with both the Planning Board and the Zoning Board of Adjustment in the resolution of Zoning and Subdivision problems. With the assistance of the Town Counsel, such legal problems as have been encountered have been satisfactorily resolved in the public interest. As population pressure increases, the Town will continue to be faced with problems of this sort, but many may be avoided by adequate long range planning. To this end, and with the purpose of maintaining an orderly growth pattern in the Town, the Selectmen and Planning Board have asked the Lakes Region Planning Commission to examine the Town Master Plan for its adequacy to meet the present and future needs of the Town. Prepared in 1962, as mandated by State Law, this Master Plan may be in need of extensive revision in the light of more recent developments. Should this be the case, the process would extend over the next two or three years and would require extensive citizen participation in its final phases. Only if the growth and development of the Town is orderly and deliberate can we expect to maintain our rural environment and avoid the burdensome property taxes which uncontrolled growth inevitably causes.

After several months of study and consultation, the Selectmen with the assistance of an appointed Personnel Advisory Committee, are nearing the completion and the adoption of a basic personnel policy for all employees of the Town.

Please remember the following items:

1. If you feel you qualify for current land use assessment, Veteran's Exemption or Elderly Exemption, you must apply before April 15.
2. Each taxpayer must file an inventory with the Selectmen before April 15, or he has no legal recourse regarding his assessment for tax purposes.
3. Taxpayers requesting an appeal or tax abatement must request the appeal or abatement in writing within four months of receipt of the tax bill.
4. Students who wish to apply for scholarships may acquire applications from their school principal or the Selectmen's office. These must be filed no later than May 1 at the Town Office.
5. Savings Bank Tax is awarded to the Towns on the basis of the amounts held in these banks by their residents. It is very important that your bank

know not only your mailing address but the fact that your resident address is the Town of Sanbornton so that our share of that tax is returned to the Town and not the Town shown in your mailing address.

FINANCIAL INFORMATION

General Fund:

Comparative Statements of Appropriations and Expenditures - Estimated and Actual Revenues: (Exhibits A-3 and A-4)

Comparative statements of general fund appropriations and expenditures, estimated and actual revenues for the fiscal year ended December 31, 1976 are presented in Exhibits A-3 and A-4. As indicated by the Budget Summary (Exhibit A-4) a revenue surplus of \$14,812 plus a net unexpended balance of appropriations of \$6,481, resulted in a net budget surplus of \$21,293.

Long-Term Indebtedness:Comparative Balance Sheets - As of December 31, 1975 and December 31, 1976: (Exhibit A-5)

Comparative balance sheets of the outstanding long-term indebtedness of the Town as of December 31, 1975 and December 31, 1976 is shown in Exhibit A-5. The long-term debt decreased by \$33,033 from \$36,367 to \$3,334 during 1976. Matured notes of \$3,303 were paid and the fire truck note of \$29,700 was paid in full.

Statement of Debt Service Requirements: (Exhibit A-6)

A statement showing annual debt service requirements as of December 31, 1976 is presented in Exhibit A-6.

Verification of uncollected and unredeemed taxes were made by mailing notices to delinquent taxpayers as indicated by the Tax Collector's records. Consequently, the amounts of uncollected and unredeemed taxes as indicated in this report are subject to any changes which may be necessitated by the return of verification notices.

GENERAL COMMENTSTown Treasurer:


The records of the Town Treasurer are poorly recorded. It was extremely difficult to trace receipts to source and to the deposits as recorded on the bank statements. It is recommended that receipts be recorded as received and deposited in such a manner that an audit trail be readily visible.



YOUTH ASSISTANCE PROGRAM

The Youth Assistance Program is currently in its third full year of offering services to the youth of Tilton and Sanbornton, having extended services to the town of Northfield from March 1976-1977. The program began with a grant from the Governor's Commission on Crime and Delinquency, with the purpose of providing:

COURT DIVERSION

When a juvenile has committed a crime, the arresting officer has two options:

1. Scold the child and release him to his parents.
2. Take the child to juvenile court, where basically the judge's only alternatives are to scold the juvenile and place him on probation, or send him to the Youth Development Center in Manchester, which is done usually after the juvenile's third or fourth court appearance.

With the Y.A.P., the arresting officer and the court have a third choice. Should the juvenile admit guilt to the crime, he can be referred for court diversion. The Police Chief and the Y.A.P. director first discuss the case to determine its appropriateness for court diversion based on the seriousness of the offense and the youth's previous involvement with the law. If a green light is given at this point, the Y.A.P. director then meets with the juvenile and his family, with his school teachers and principal, the arresting officer, and any other relevant person in his life. This is done to get the full picture of the juvenile's attitude, problems, possible reasons for his deviant behavior, and to achieve better insight as to what would be an effective consequence for his act. A full report is presented to the Juvenile Review Board (J.R.B.) with the youth and his parents present. (The J.R.B. is a trained volunteer committee of local citizens with various skills and professions who hear the case and assign the consequences.) The J.R.B. designs a consequence which provides:

1. Punishment—the youth must meet personally with the victim of his crime to apologize and to arrange restitution for the crime, usually in the form of work to repair the damage done, if possible.
2. Rehabilitation—the youth must report to the Y.A.P. director weekly for a mandatory period (six weeks minimum) to discuss his progress at home, in school, and in the community. If the youth is a behavior problem in school, the J.R.B. will often ask for an improvement in effort, conduct, and attitude, monitored by weekly progress reports from the school.
3. Deterrence—having the juvenile appear before local citizens to admit guilt to his crime holds the youth accountable to the community for his acts, as well as to help him to realize that there are consequences for breaking the law.

If the juvenile does not comply with the consequences assigned by the J.R.B., he is petitioned to court for the original offense, and a full report

and recommendation is submitted to the court by Y.A.P. Out of a total of thirty-three cases which have gone before the J.R.B., only one juvenile has failed to fulfill court diversion expectations, and had to be taken to court.

COUNSELING AND REFERRAL

Counseling and referral are services extended to all youth and their families of the participating towns. In the past year, there were a total of 104 referrals made to Y.A.P., 57 of these coming from parents, the schools, and the juveniles themselves. This is a healthy sign, as referrals which do not come from the police are not crime related, thus showing not only active use of Y.A.P. by the communities, but also a swing towards more preventative intervention.

Y.A.P. refers both juveniles and families to appropriate services throughout the Lakes Region, having made use of a total of 24 various agencies in the past year.

CRISES HOMES

The purpose of a crises home is to provide temporary shelter for youth in a time of crises and to create a "buffer space" of time during which the Y.A.P. and other helping agencies can work together with the youth and his family, or set up a more permanent alternative placement.

Y.A.P. currently has two active crises homes which have been used in the past year. Since the alternatives to crises home placement are leaving the juvenile in a potentially dangerous situation at home, or having him wrenched out of school to stay in a group home in Concord or the County Jail, crises homes have proven to be an extremely effective resource.

THE PEOPLE PROGRAM

A new addition to Y.A.P. services this year is a big brother—big sister type program which a group of volunteers have been designing for several months. The People Program will provide rehabilitating one-to-one relationships, matching a stable adult with a juvenile, the pair spending a minimum of three hours together each week.

"People" will also have monthly training sessions for all adult volunteers, monthly group meetings for all youth involved, and group activities including hiking, fishing, and camping trips.

The People Program is a community based operation, the success of which lies in the hands of each individual citizen. Volunteers are needed to act as senior people, task force members to help plan activities and/or provide transportation, and for businesses to offer their services to help the youth of our towns find healthy, alternative ways of spending their free time.

To date the Y.A.P. has employed the volunteer services of over thirty citizens who have gotten directly involved in combating delinquency in

our community. As parents, teachers, and authority figures in our children's lives, we cannot always control one of the most influencing factors on their development, that of peer pressure. Y.A.P., together with volunteer community support, is working hard towards developing a healthier attitude in the juvenile population by providing punishment for wrong acts; assistance in troubled times; education and counseling on issues which peer influence can often misguide our youth; and positive alternative activities to hanging around, crime, and drug abuse.

In cooperation with the police departments, Y.A.P. has seen not only a decrease in juvenile crime in the past year, but also a decrease in the number of repeating offenders. With the continued support of the towns, Y.A.P. plans for the coming year include solidly establishing the People Program in the community, as well as working together with the elementary and middle schools to introduce a curriculum teaching self respect and respect for authority figures. These goals are geared towards taking an even bigger step forward in preventing juvenile delinquency.

REPORT OF THE SANBORNTON FIRE DEPARTMENT

The demands on the Sanbornton Fire Department continue to grow. In 1977 the department responded to sixty-nine emergency calls. This represents an increase of nearly seventy per cent over the responses of the previous year.

Some of the increase in fire calls appear to be related to the increased use of wood burning stoves. Wood burning is a fine alternative to the use of fossil fuels, but there are hazards. To be safe, the stoves must be properly installed, operated, and maintained. The fire department will inspect stove installations upon request. It is hoped that by use of caution and good sense, wood stove problems will be kept to a minimum.

The Lakes Region Mutual Aid System again improved its services to the member departments this past year. One new feature is that of automatic responses. This means that several departments respond on the first alarm instead of waiting for requests for mutual aid. Sanbornton developed automatic response agreements with Tilton and New Hampton for certain sections of the towns. A similar agreement with the Winnisquam has been in effect for many years.

The Sanbornton Fire Department wishes to thank all of the people and organizations which have helped and supported us. Special thanks go to the Ladies' Auxiliary for the purchase of equipment and the providing of refreshments at fires and meetings. Also, we are grateful to the board of selectmen for its prompt, decisive support of the fire service.

The present fire equipment consists of: (1) 1968 International with 750 gallon pump/1000 gallon tank; (1) 1952 GMC with 500 gallon pump/600 gallon tank; (1) 1958 Van-type Emergency truck; (1) Government surplus 10-wheel truck with 350 gallon pump.

There are thirty-six (36) volunteer firemen enrolled in the department. Regular business meetings are held monthly, the first Thursday of each month, with special officer's meetings and drills held when necessary. Many members have attended local fire schools, and several are enrolled in the N.H. Vocational Technical School Fire Training Courses.

The Annual Carole Davis Memorial Christmas Party was held in December, for the children in the Winnisquam area. The customary Bingo games, suppers and other fund-raising events were held.

The number of emergency calls we have made during the past year has increased again, drastically. The following figures for the past five years are self-evident of the need for updating our equipment.

The largest increase is in Rescue and Medical Emergency responses. Since our Emergency Truck is twenty years old, and our First Line Fire Truck is ten years old, our department is badly in need of new equipment. The only source of funds for these necessary expenses are from the Taxpayers of the various towns we serve.

We have hopefully requested from each town an amount for capital funds, in addition to our regular department maintenance funds. This capital fund request, is to be spread over the next four years, giving sufficient money to purchase new trucks by 1981.

We have completely rebuilt our 1952 GMC Truck, which will hopefully carry us through until 1981, the target date for our new replacement.

REPORT OF DISTRICT FIRE CHIEF AND TOWN FOREST FIRE WARDEN

Forest fire control in New Hampshire is a joint state and town/city responsibility (RSA 224).

The Director, Division of Forests and Lands (State Forester) appoints a forest fire warden and several deputy forest fire wardens in each town/city upon the recommendation of local authorities.

The local forest fire warden is responsible for forest fire prevention and suppression activities in his town. He regulates the kindling of outside fires when the ground is not covered with snow by the issuance of written permits only when conditions are safe. He is responsible for suppression with the town/city and state sharing the cost. Suppression costs in excess of $\frac{1}{4}$ of 1% of the assessed valuation of the town are assumed by the state.

The state provides training for the local fire organization and helps coordinate activities between towns/cities. The state also supports local forces with backup personnel, equipment, and supplies for suppression and prevention.

This combination of state and local cooperation, started in 1893, works well, for New Hampshire has enjoyed one of the smallest acreage losses due to forest fires in the United States for the past 25 years.

Sanbornton Planning Board Report—1977

During 1977 the Planning Board continued the practice of meeting twice monthly, with meetings alternately devoted to processing subdivision applications and to problems of long range planning. In addition to these regular meetings, some twenty-five individual on-site inspections were made.

The volume of subdivision applications continued at approximately the same rate as in 1976. Of seventeen applications received, approval was granted for the creation of fifty-five building lots, representing a net increase in properties available for new dwellings of forty units. The largest approved subdivisions were three tracts that were divided into six lots each. Of the remainder, one tract was divided into five lots, six were divided into four lots each, and four were minor subdivisions creating two lots from one. Three applications were referred to the Zoning Board of Adjustment for consideration as special exceptions. Of the fifty-five lots approved, twenty-five are the properties of non-resident owners.

Of continuing concern to the Planning Board is the rapid rate of increase in available building properties which this volume of subdivision activity represents. Since 1970 the number of approved subdivisions registered with the County has grown from one hundred and ten to two hundred and ninety-seven; a seven year increase of some 160%. During the same period Sanbornton has experienced a population growth of some 60%; from 1,022 to 1,609. If the population continues to grow at the present rate it will have doubled in size in the ten year period between 1970 and 1980. The even more rapid growth of available building properties indicates the clear possibility of a population increase considerably in excess of this. At the present rate population growth has imposed a severe strain on available Town and School District facilities and services. Alleviation of an even more adverse impact will require constant monitoring of these factors, community awareness of their possible consequences, and effective long range planning.

The Planning Board continues to work closely with the Lakes Region Planning Commission in evaluating the impact of our rapid growth pattern on the business and employment environment in relation to the available natural resources. As the conservation of our natural resources is required in order to sustain growth in business and employment opportunities, the long range interests of business and environmental protection become merged. Of particular concern in this connection is the protection of an adequate water supply. As water resources are near exhaustion in N.H. towns bordering Massachusetts and in the Seacoast region, towns in those areas are looking inland and northward to our regionally richer water resources. To effect minimal protection of these resources the Planning Board has worked with the LRPC, the State Water Supply and Pollution Control Commission and the U.S. Geological Survey office to

design an Aquifer Conservation District. An amendment to the Zoning Ordinance creating this District is proposed for adoption at Town Meeting.

The Board has also requested the assistance of the LRPC in reviewing the Town Master Plan. Adopted in accordance with statutory mandate, the present plan was drawn up in 1962 and fails to address the many demographic and environmental changes which have taken place since that time. It is anticipated that this project will require in-depth study of the substantial revisions that will be required to bring the plan up-to-date, and completion of the project is not expected for two years or more. In view of the major impact which rapid growth has already imposed on Sanbornton, the importance of such long range planning as will be embodied in the revised Master Plan can scarcely be exaggerated.

In addition to the LRPC, the Board has received considerable assistance in resolving a number of knotty problems from the U.S. Soil Conservation Service of the Department of Agriculture in the amiable person of Mr. Clem Lyon. The Board wishes to acknowledge this assistance and to express its gratitude on behalf of the Town.

The Board of Selectmen accepted the resignation of Mr. Richard P. Davis from the Planning Board after many years of valuable service. The remaining members of the Planning Board regret that Dick found it necessary to give up his position, for he was a very active participant in all of the Board's activities and gave unstintingly of his time and expertise. We thank him for his many valuable contributions to the Board and wish him well. The Selectmen appointed Mr. Raymond Beaupre to full membership on the Board, and Mr. Daryl Woods to membership as Advisor. Ray had served for many months as an Advisor prior to his appointment. Daryl brings to the Board his useful experience in land surveying, a welcome addition to the Board's capabilities.

The Board's meetings are customarily held on the first and third Fridays of each month at 7:30 p.m. in the Town Office, and the public is cordially invited to attend. An informed community is vital to sound and effective Town planning.

SANBORNTON HIGHWAY SAFETY COMMITTEE

This period, March 1977 to March 1978 marks our first full year of operation. The Committee has come of age. It now has it's own budget, a modest one to be sure, but a budget nevertheless.

After operating for more than a year, we received our formal charge from the Selectmen. The Committee felt the charge was unduly restrictive in the realm of safety, while at the same time the sphere of duties was expanded to include an advisory overlook of the Police Department. To date, because of the time factor, the only attention given the Police Department was in the matter of the 1978 budget. No changes were recommended.

Hazardous traffic conditions throughout the Town are under constant surveillance and review. Committee activity has led to the inclusion of a State Aid For Reconstruction item in the budget which will make the Town eligible to receive State funds on a two to one ratio, two parts State, one part Town, for use in improving Class II roads. The various divisions of the N.H. Department of Public Works and Highways have been very co-operative in furnishing signs and services as requested. Accidents in the Chapel Area have led to the procurement of Yield signs which will be installed as soon as weather permits. An accident victim has raised a question as to the position of a fence on Bay Road. This being a Class II State Road, the question was referred to the State Highway Department. At our request, Tilton Selectmen have agreed to install a stop sign near the Winnisquam Post Office. It is hoped this will control a traffic pattern that poses a danger for travel to and from Bay Road.

Hazards too close to roadways such as utility poles and ledges are now receiving attention. A canvass of street lights has been completed and recommendations for some eliminations, additions and relocations have been made to the Selectmen. The Budget Committee requested this study with the intent of cutting skyrocketing Public Service charges. We believe adoption of our suggestions will save money and provide more effective lighting.

Our firm opposition to mandatory automobile air bag installations was made known to the U.S. Department of Transportation, the National Highway Traffic Safety Administration and our Congressional Delegation. Senator McIntyre responded that he was leaning in favor of air bags, Senator Durkin was undecided and Congressman D'Amours was opposed. Congress dallied too long and because of their inaction DOT's order mandating passive restraint installations will take effect starting with some 1982 model cars. There is still hope that legislation may overturn the order.

Perhaps our most important endeavor culminated in victory with the N. E. Telephone Company's phone call advising us that Sanbornton and

71 other communities will have toll free calling within their boundaries by late 1979. A company official acknowledged that the idea of unified in-town calling had been on the back burner for years and sporadic complaints from various directions were routinely brushed off with innocuous prose. The wide publicity generated early in our campaign caused several individuals, citizen groups and elected town and state officials to vigorously pursue toll free calling for their communities. None pursued with more vigor than this Committee. The concerted effort bore fruit.

Ironically, had the Selectmen provided a charge when the Committee was appointed, the telephone campaign would have been an unauthorized action and could not have taken place.

Which proves one thing.

Procrastination is sometimes rewarding.
