

TOWN WARRANT

The State of New Hampshire

To the inhabitants of the Town of Hart's Location, in the County of Carroll in said State, qualified to vote in Town Affairs;

You are hereby notified to meet at Notchland Inn, in said Hart's Location, on Tuesday, the 12th day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.

3. To see if the Town will vote to raise \$99.00 and accept State aid construction on Willey House Road.

4. To see what amount the Town will raise for the maintenance of Sawyers River Road.

5. To see if the Town will vote to borrow \$400.00 from the Bank.

6. To vote to authorize Selectmen to draw a voucher for S. Hunt and New Hampshire Highway Dept. for payment snow-plowing Sawyers River Road winter 1934 and 1935.

7. To see if the Town will vote for a Road Agent.

8. To see if the Town still wants to buy the snow fence, as ordered from Mr. Brooks.

9. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired by the Town, thru Tax Collector's deeds.

10. To see if the Town will vote to adopt the provisions of the Municipal Budget Act.

11. (Amendments to Article No. 3) To see if the Town will accept State Aid for construction of the Class No. 2 road known as Carrigan Station Road, and raise and appropriate or set aside for said purpose of \$97.50 or will accept State Aid for construction of Class No. 5 roads and appropriate or set aside for said purpose the sum of \$97.50.

12. To transact all other Town business that may be necessary before said meeting.

HIGHWAY REPORT

The Highway is the old 10th Turnpike and has always been State maintained.

The Town of Hart's Location has just completed its second year of State Aid construction on the Willey House road, which brings the road to very nearly the two-thirds completion point. As usual, the E R U fund coming from the Federal Government was applied on the Sawyer River road and a new method of maintenance, putting on 8 inches of sand to work into the original surface, which is of the loam texture to dry up the mud which comes to this road in the spring. After this process of nature has worked, the road will have to be brought into shape with a road machine. This road is now maintained 12 months in the year with the help of the State Highway Department.

SCHOOL REPORT
