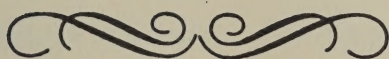

THE STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Langdon, County of Sullivan, in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Town Hall in said Langdon on Tuesday, the twelvth day of March, at twelve of the clock noon until six p.m.. Regular business meeting will be held at seven p.m.

Article 1. To choose all necessary officers for the ensuing year.

Article 2. To see if the Town will appropriate and authorize the Selectmen to use the income, estimated to be \$42,000.00, from:

a.	Filing Fees and Permits	\$ 600
b.	Interest on Taxes and Deposits	4,500
c.	Dog Licenses	400
d.	Motor Vehicle Permits	30,000
e.	Yield Taxes	500

Article 3. To see if the Town will vote to raise and appropriate the sum of \$100,000.00 for the maintenance of highways and bridges. The State of New Hampshire to furnish approximately \$32,466.00 in State Aid. The Town will raise the balance. (Approximately \$67,534.00).

Article 4. To see if the Town will vote to raise and appropriate the sum of \$2000.00 for the Capital Expense of the Fire Department.

Article 5. To see if the Town will vote to raise and appropriate the sum of \$2000.00 for renovations to the Town Hall.

Article 6. To see if the Town will vote to raise and appropriate the sum of \$1500.00 for the Capital Expense of the Police Department.

Article 7. To see if the Town will vote to raise and appropriate the sum of \$5000.00 for the Capital Reserve Fund previously established for the purchase of highway equipment.

Article 8. To see if the Town will vote to amend the exemption provisions of the Expanded Elderly Exemption which now is: "expanded exemption of real estate which provides for a resident of 65 years of age up to 75, a \$5000 exemption; a resident 75 years of age up to 80, a \$10,000 exemption; a resident 80 years of age or older, a \$20,000 exemption. Provided that resident owns the real estate individually or jointly with another or his spouse with whom he has been living for at least 5 years as man and wife; said resident has a net income of less than \$10,000 or combined income with spouse of less than \$15,000 and owns assets of any kind, tangible or intangible, less bona fide encumbrances, not in excess of \$100,000."

Article 9. To see if the Town will vote to accept Trust Funds for the perpetual care of the Cemetary Lots.

Article 10 To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes.

Article 11. To see if the Town will vote to authorize the Selectmen to sell property acquired by Tax Collector's Deed.

Article 12. To transact any other business that may legally come before said meeting.

Article 13. To allow accounts.

LIST OF APPROPRIATIONS -- TOWN MEETING 1990

Business meeting was called to order at 7 p.m. with the reading of the Town Warrant by Moderator, Donald Malcolm, followed by the Pledge of Allegiance. Action was then taken on various articles as follows:

ARTICLE 2: To see if the Town will appropriate and authorize the Selectmen to use the income, estimated to be \$39,425.00 and defray town charges, estimated to be \$116,545.00. VOTE: Yes

ARTICLE 3: To see if the Town will appropriate the sum of \$88,000.00 for the maintenance of highways and bridges. The State of New Hampshire to furnish approximately \$33,782. in State Aid. The Town will raise the balance. (Approximately 54,218.) VOTE: Yes

ARTICLE 4: To see if the Town will raise and appropriate the sum of \$2,000. for the Capital Expenses of the Fire Department. VOTE: Yes

ARTICLE 5: To see if the Town will vote to raise and appropriate the sum of \$29,000. for the purchase of a 1990 4 wheel drive truck with plow and dump body for the use of the Highway Department. Money to be raised by withdrawal of \$18,000. plus interest to date from the previously established Capital Reserve Fund for the purchase of highway equipment, and to authorize the sale or trade of the 1980 GMC Highway Truck and snowplow (Approximate value: \$2,000). The Town to raise the balance (Approximately \$7,000) by taxes. VOTE: Yes

ARTICLE 6: To see if the Town will appropriate the sum of \$50,000. for the construction of a Highway Maintenance Facility on Town Highway land along Route 12A. Money to be raised as follows: \$10,000. from current years taxes, \$40,000 from a note for 5 years, annual payments of \$8,000 plus interest. (2/3 vote required) Moderator received a written request signed by 5 voters that Article 6 be voted on by secret ballot. VOTE: Yes/40 No/29 ARTICLE DEFEATED

ARTICLE 7: To see if the Town will vote to raise and appropriate the sum of \$2,000. for renovations to the Town Hall. VOTE: Yes

ARTICLE 8: To see if the Town of Langdon will send the following message to our representative and senators in Washington:

As Citizens of New Hampshire assembled at our Town Meeting and concerned over the present and future wellbeing of our Town, State, Nation and World, we call upon our representatives in Washington to work vigorously for substantial reductions in Military spending - spending for which taxpayers of our Town paid approximately \$424,714. last year, and to redirect our federal tax dollars toward such purposes as education, environmental protection, deficit reduction, farming, housing, health care, and welfare of the elderly and children.* MOTION MADE, SECONDED AND VOTED TO PASS OVER ARTICLE 8.

ARTICLE 9: To see if the Town of Langdon will send a message to the Legislature and Governor calling for a comprehensive toxics law requiring coordinated programs of planning, research and development, education, enforcement, and economic incentives to achieve toxics reduction by substitution with safer substances. * MOTION MADE, SECONDED AND VOTED TO PASS OVER ARTICLE 9.

ARTICLE 10: To see if the Town will vote to accept Trust Funds for the perpetual care of the Cemetary lots. VOTE: Yes

ARTICLE 11: To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes. VOTE: Yes

ARTICLE 12: To see if the Town will vote to authorize the Selectmen to sell property acquired by Tax Collector's Deed. VOTE: Yes

ARTICLE 13: To transact any other business that may legally come before said meeting.

1. Ben Porter made a motion that the Names of the Fire Department members who attended the Fire Training program in 1989 and the Members of the Police Department currently attending Police School be given by the Fire and Police Chiefs to be inscribed in the Records of the Town of Langdon. VOTE: Yes

2. Selectman Chairman, Robert Cunniff sent his regrets thru Bruce Cheeney for not being able to attend the meeting. He was called away on School business.

3. The Town expressed appreciation to the Community Club for the donation of 12 chairs to be used by the Town. The Community Club announced their plans to donate more chairs to the Town.

4. Irene Domini, State Representative, left broad-based tax questionnaires here at the Town Hall and urged voters to take a minute to complete the questionnaire and return it to her.

5. Dot Grout expressed her desire to see a Selectman at the School meeting in April. She stated only 42 voters from Langdon were at the meeting on March 10th. Bruce plans to attend the meeting in April and explained that he was unable to attend due to other Town commitments and work commitments. Usually, the Town is represented at the School meetings by Selectmen.

6. Pete Goodnough questioned page 32 of the Annual Report which showed money going to the Planning Board. This money is used to pay for certified letters and advertising of hearings which are required for any subdivision.

7. Bruce informed the Town of the many hours Ben Porter has given to the Town in the way of working with the appraisers while we are undergoing the revaluation. Mr. Porter received a standing ovation from the Town as an expression of their gratitude.

8. Discussion of Article 6 revived and several people expressed their feelings on the necessity of a Highway Garage. They felt that more research was necessary before the Town could appropriate the money. Ben Porter made a motion to Continue the present building committee, and request them to propose specific design features, construction materials, adequate site design and drawings and cost factors for garage construction, and to present same to the voters at a special town meeting at a date specified by the moderator and called by the selectmen.
VOTE: Yes

9. Susan Gates expressed a desire to revive article 8 which was passed over. Pat Breslend responded that the United States needed to have a strong military and the Town voted to pass over Article 8.

10. Erma Mason held the Community Club's quilt drawing. The winner was Bob Kasparzak.

VOTE: Yes

Meeting was adjourned at 9:20 p.m.

1990 REPORT OF THE PLANNING BOARD

The past year has seen many changes, some more welcome than others. The slowdown in the economy and the housing market have caused the applications for subdivision in Langdon to slow to almost none. Over the past twelve months two minor subdivisions and one annexation have been brought before the board. The slowdown has allowed the board to continue work on the update of the Town Master Plan. Work is nearing completion on the plan. The board would like to express its appreciation to Frank Sellers for all the work he has done to move this process along. It is our hope that copies of the completed document be ready for public inspection within two to three months.

One more bright spot in the past year has been the number of parcels of land that have had development rights purchased by the New Hampshire Land Trust. Development Rights to several of the largest farms in Langdon and neighboring towns have been purchased during last year, ensuing they will remain free from development for many years.

Your planning board looks forward to hearing your comments about the proposed Master Plan over the next year.

Large property owners (over 10 acres;not including building lots) should consider filing for Current Use for the 1991 tax year. The reassessment of property we underwent has caused the assessed value of the land to increase greatly. More information on Current Use can be obtained from the Selectmen.

REPORT OF TOWN FOREST FIRE WARDEN
AND
STATE FOREST RANGER

On April 22 we had to extinguish a 1/2 acre fire which was caused from a non permit burn. The cost of this fire was over \$300 and was paid by the person burning without the permit.

During Calendar Year 1990, the State of New Hampshire experienced an average number of wildfires. The three leading causes of these wildfires were fires kindled without a fire permit from the Forest Fire Warden, permit fires that escaped control, and rekindled fires. All of these fires are preventable, but ONLY with your help.

Please help your town and state forest fire officials with forest fire prevention. New Hampshire State Law (RSA 224:27 II) requires that, "No person, firm or corporation shall kindle or cause to be kindled any fire or burn, or cause to be burned any material in the open, except when the ground is covered with snow, without first obtaining a written fire permit from the Forest Fire Warden of the town where the burning is to be done."

Violations of A 224:27 II and other burning laws of the State of New Hampshire are misdemeanors punishable by fines of up to \$1000.00 and/or a year in jail and you are also liable for all fire suppression costs.

The State of New Hampshire, Division of Forests and Lands assisted many towns in wildland fire suppression during 1990, including a 262 acre fire in Moultonboro and several fires in Hooksett.

In 1990, the New Hampshire Division of Forests and Lands trained 844 local Wardens and Deputy Wardens in the Incident Command System (ICS), an incident management system for all types of emergencies. In 1991 Wardens will be trained in the use of Class A foam in wildfire suppression.
