TOWN WARRANT

The State of New Hampshire

To the inhabitants of the Town of Hart's Location, in the County of Carroll in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at The Notchland Inn, in said Hart's Location, on Tuesday, the ninth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.

3. To authorize the Selectmen to borrow sums of money on taxes due the Town of Hart's Location in the year nineteen thirty seven, by notes with interest. To be used in the payment of Town debt.

4. To see if the Town will vote to raise ninety-nine dollars and accept State Aid construction on Sawyer's River Road.

5. To vote to accept the report and cost on the Bartlett-Hart's Location Town line, as filed to date with the town records.

6. To see if it is expedient to revise the Constitution.

7. To see if this town will join other towns in Carroll County in an effort to further winter business or to take such other action as may benefit this town.

8. To transact all legal town business that may be necessary to come before said meeting.

HIGHWAY REPORT

The State Highway is the old tenth Turnpike and has always been State maintained.

The Town of Hart's Location has just completed its

third and final year of State Aid Construction on the Willey House Station Road. Now that the road is completed and has been accepted by the State Highway Department, it will be maintained by them in the future.

The Sawyers River road was put in shape this year and due to the school bus, is now maintained twelve months of the year, the snow plowing being done by the State Highway Department equipment.

SCHOOL REPORT

No schools maintained; the school tax is raised from the Town at the rate of \$3.50 per thousand, on its total valuation, which amount goes into the State School Equalization Fund of the State School Department and the department takes care of any needed education for this Town, due to the fact that the School District is unorganized.

Valuation is \$65,945.00 making the 1936 tax \$233.66.

This valuation will change during the year 1937 to \$50,489.00 because of land sales to the United States Forestry Department, therefore, lowering the above tax.

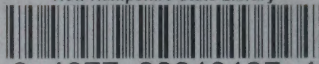
