REPORT OF THE SELECTMEN

1985 should be forever known as the year of the study committees. Last year's town meeting produced a record number of studies to be undertaken, some of which were rather major in their scope. The selectmen were pleasantly surprised to have so many qualified people come forth to participate on the newly formed committees. We are blessed with many talented people in Hancock who are willing to help when called upon in a time of need. With the formation of the Norway Pond Study Committee, Highway and Bridge Committee, Salary and Department Reorganization Committee, and Post Office Committee, the selectmen were able to have a wealth of information placed at their disposal to help in their preparation of this year's budget and warrant. It is an extremely useful base of information on which future plans can be made. The selectmen are very grateful to all those who participated on those committees, as well as all the members of the permanent committees who commit themselves to serve for years at a time.

We are also proud of the fact that despite declining revenues from the State and Federal government, we were able to announce a tax rate decrease for the first time in several years. A decrease in taxes without a decline in town services can only be attributed to the excellent work of our department heads, town employees and elected officials. We think we have some of the best. Because of their efforts, Hancock maintains the quality of life that makes long time residents and newcomers want to live within its borders.

TOWN WARRANT
The State of New Hampshire

To the Inhabitants of the Town of Hancock in the County of Hillsborough in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the TOWN HALL in said Hancock on Tuesday, the eleventh day of March next at 10 of the clock in the forenoon for ballot voting of Town Officers and all other matters requiring ballot vote; and, to meet at said FIRE STATION in said Hancock on Saturday, the fifteenth day of March next at one of the clock in the afternoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To see if the Town will raise and appropriate a sum not to exceed one hundred twenty thousand dollars (\$120,000) to modify the former John Hancock Grange building for use as a post office. This sum to be raised by borrowing. And furthermore, to see if the Town will authorize the Selectmen to lease said modified building to the U.S. Postal Service; or take any other action relating thereto.
3. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
4. To see if the Town will raise and appropriate the sum of eighty-nine thousand, seven hundred and fifty dollars (\$89,750) for the purchase of a new road grader. This money to be raised by borrowing; or take any other action relating thereto.
5. To see if the Town will raise and appropriate the sum of eighteen thousand dollars (\$18,000) for the purchase of a new one-ton dump truck and plow and to authorize the selectmen to sell the existing one-ton dump truck and plow. This money to be raised by borrowing; or take any other action relating thereto.
6. To see if the Town will raise and appropriate the sum of eight thousand dollars (\$8,000) for the purchase of a new sander for the highway department; the money may be raised by borrowing; or take any other action relating thereto.
7. To see if the Town will raise and appropriate the sum of fifteen hundred dollars, (\$1,500) to be supplemented by two thousand five hundred dollars (\$2,500) from gifts and donations to purchase and install playground equipment for a play area adjacent to the Town Office Building; or take any other action relating thereto.
8. To see if the Town will raise and appropriate the sum of fourteen hundred dollars (\$1,400) to purchase equipment for improving the water quality in the public swimming area of Norway Pond; or take any other action relating thereto.
9. To see if the Town will authorize the Selectmen to appoint a Norway Pond Commission consisting of at least three members, including one each from the Conservation Commission and The Recreation Committee, along with such other members as the Selectmen may deem necessary or desirable. This commission to act as advisors to the Selectmen and to the Town on matters pertaining to Norway Pond and to undertake such actions as have been previously directed by the Selectmen or the Town; or take any other action relating thereto.

10. To see if the Town will raise and appropriate a sum not to exceed eleven thousand two hundred dollars (\$11,200) for the purchase of a new police cruiser, and to authorize the selectmen to see the existing cruiser; or take any other action relating thereto.
11. To see if the Town will vote to raise and appropriate the sum of one thousand one hundred fifty-nine dollars (\$1,159) for membership in the Southwest Regional Planning Commission; or take any other action relating thereto.
12. To see if the Town will raise and appropriate the sum of twenty thousand dollars (\$20,000) for the reappraisal of the Town of Hancock. This sum to constitute approximately one-half of a total expense not to exceed forty thousand dollars (\$40,000), raised over a two-year period, the balance to be entered into the 1987 budget by the Selectmen; or take any other action relating thereto.
13. To see if the Town will raise and appropriate the sum of one thousand dollars (\$1,000) for the Library Improvement Reserve and Building Fund. This sum to be allowed to accumulate from year to year, or to be expended by the Library Trustees, or to be added to by gifts of money; or take any other action relating thereto.
14. To see if the Town will raise and appropriate the sum of two hundred dollars (\$200) for the support of the Grand Monadnock Arts Council; or take any other action relating thereto.
15. To see if the Town will raise and appropriate the sum of nine hundred fifty-one dollars and twenty cents (\$951.20) to support the Mental Health Program of the Monadnock Family and Mental Health Service; or take any other action relating thereto.
16. To see if the Town will vote to authorize withdrawal from the Federal Revenue Sharing Fund for use as a setoff against the following debt service:

17. To see if the Town will raise and appropriate the sum of three thousand seven hundred and eleven dollars (\$3,711.00) for the Monadnock Community Visiting Nurse Association to support the continuance of health services now being provided through an agreement with Home Health Care and Community Services; or take any other action relating thereto.
18. To see if the Town will vote to waive motor vehicle registration fees for former Prisoners of War in accordance with RSA 261:157-a; or take any other action relating thereto.
19. To see if the Town will raise and appropriate the sum of fifty dollars (\$50) for the support of the Women's Crisis Services of the Monadnock Region; or take any other action relating thereto.
20. To see if the Town will vote to authorize the Selectmen to adopt written welfare guidelines as required by Chapter 380 of the Laws of 1985 (copies of the full text of the proposed guidelines are on file with the Town Clerk); or take any other action relating thereto.

21. To see if the Town will vote to oppose the burial, storage, transportation, and production of high level radioactive waste in the Town of Hancock and State of New Hampshire; and to call upon Congress to conduct an independent investigation with full public participation into the feasibility and prudence of the U.S. Department of Energy's present plan to dispose of radioactive waste and into the Department of Energy's competence to carry out such a plan; or take any other action relating thereto. (By Petition)

22. To see if the Town will vote to authorize the selectmen to transfer tax liens and convey property acquired by the Town by tax collector's deed by public auction (or advertised sealed bid) or in such other manner as determined by the selectmen as justice may require; or take any other action relating thereto.

23. To see if the Town will vote to authorize the selectmen to borrow money in anticipation of taxes; or take any other action relating thereto.

24. To see if the Town will accept gifts and legacies left in trust for the Town; or take any other action relating thereto.

25. To hear the reports of auditors and committees heretofore chosen; or take any other action relating thereto.

16. To transact any other business that may legally come before said meeting.

SUMMARY OF 1985 TOWN MEETING MINUTES

- Article 1: Donald Lancey was elected Sexton for the ensuing year.
- Article 2: the Budget was accepted in the amount of \$460,275. Also, a committee is to be appointed by the selectmen to develop a salary schedule.
- Article 3: Ballot vote: yes - 155; no - 62
- Article 4: Ballot vote: yes - 183; no - 32
- Article 5: Ballot vote: yes - 167; no - 49
- Article 6: Ballot vote: yes - 151; no - 64
- Article 7: The Town voted \$95,000 for a new fire truck.
- Article 8: The Town voted \$7,000 to widen and repair Moose Brook Bridge on Depot Road.
- Article 9: The Town voted down funds for Monadnock Community Day Care.
- Article 10: The Town voted \$3,711 for Visiting Nurse Association
- Article 11: The Town authorized withdrawal from Revenue Sharing: \$8,525 as interest on the Fire Station note; \$1,139.15 as interest on the highway department building.
- Article 12: The Town authorized the selectmen to appoint a committee to seek proposals to provide suitable accommodations for a post office in the central area of town.
- Article 13: Town voted \$891.75 for Monadnock Family & Mental Health.
- Article 14: Town failed to approve funds for reopening and repairing the bridge over Moose Brook on Mill Road. Further, it was voted to have the selectmen, or their appointees, prepare an evaluation of the town's highway and bridge system.
- Article 15: Town authorized the selectmen to appoint a Norway Pond Study Committee to come in to the 1986 Town Meeting with recommendations.
- Article 16: Town voted \$2,147 for its share of painting the front wall of the Meeting House and tower and refurbishing the weathervane.
- Article 17: Town failed to approve funds for Grand Monadnock Arts Council.
- Article 18: Town voted to postpone consideration of the article to sell the Town's share of the iron bridge on Cavender Road, over the Contoocook River.
- Article 19: Town voted \$1,000 to the Library Improvement Reserve and Building fund.
- Article 20: Town authorized prepayment of property taxes per RSA 80:52-a.
- Article 21: Town authorized prepayment of Resident taxes per RSA 80:1-a.
- Article 22: Town voted to extend Class V status of Old Hancock Road to a turn-around opposite driveway of Wayne and Margaret Crockett.
- Article 23: Town authorized selectmen to transfer tax liens and convey property acquired by Tax Collector's deeds.
- Article 24: Town authorized the selectmen to borrow funds in anticipation of taxes.
- Article 25: Town voted to accept \$5,000 to be added to Harry E.D. Pollock fund at Hancock Town Library, plus \$700 in cemetery trust funds.
- Article 26: Town voted to accept reports of auditors and committees as printed in the Town Report.
- Article 27: A motion relative to the GRAM case being heard by the Board of Adjustment was voted down. Question of how to prevent further damage to the town bell was raised. There was mention of having the Planning Board elected; mention of setting up Capital Reserve Funds for equipment. The meeting was then adjourned.

A special town meeting was held relative to 4 sites proposed by the Hancock Post Office Committee set up under Article 12. It was voted to proceed toward acquiring the Grange building; obtain estimates to modify the Grange building for use as a post office; enter into negotiations with the U.S. Postal Service regarding this building. Hold a public hearing prior to Town Meeting, prepare a warrant article for necessary funds to implement one of the options discussed.

We have examined the combined financial statements and the combining fund and account group financial statements of the Town of Hancock, New Hampshire as of and for the year ended December 31, 1985, as listed in the table of contents. Our examination was made in accordance with generally accepted auditing standards and, accordingly, included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

As described in Note 1B, the combined financial statements referred to above do not include financial statements of the General Fixed Asset Group of Accounts which should be included to conform with generally accepted accounting principles.

In our opinion, except that omission of the General Fixed Asset Group of Accounts results in an incomplete presentation as explained in the above paragraph, the combined financial statements and the combining fund and account group financial statements referred to above, present fairly the financial position of the Town of Hancock, New Hampshire at December 31, 1985, in conformity with generally accepted accounting principles applied on a basis consistent with that of the preceding year.

Our examination was made for the purpose of forming an opinion on the combined financial statements taken as a whole and on the combining fund and account group financial statements. The accompanying financial information listed as supporting schedules in the table of contents is presented for purposes of additional analysis and is not a required part of the combined financial statements of the Town of Hancock, New Hampshire. The information has been subjected to the auditing procedures applied in the examination of the combined, combining fund and account group financial statements and, in our opinion, is fairly stated in all material respects in relation to the combined financial statements taken as a whole.

NOTES TO THE FINANCIAL STATEMENTS

December 31, 1985

NOTE I - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies employed in the preparation of these financial statements.

A. Fund Accounting

The accounts of the Town are organized on the basis of funds or account groups, each of which is considered a separate accounting entity. The operations of each fund are accounted for with a separate set of self-balancing accounts that comprise its assets, liabilities, fund equity, revenues, and expenditures, as appropriate. Government resources are allocated to and accounted for in individual funds based upon the purposes for which they are to be spent and the means by which spending activities are controlled. The various funds are grouped by type in the financial statements. The following fund types and account groups are used by the Town.

GOVERNMENTAL FUNDS

General Fund - The General Fund is the general operating fund of the Town. All general tax revenues and other receipts that are not allocated by law or contractual agreement to another fund are accounted for in this fund. From the fund are paid the general operating expenditures, the fixed charges, and the capital improvement costs that are not paid through other funds.

Special Revenue Funds - Special Revenue Funds are used to account for the proceeds of specific revenue sources (other than expendable trust or major capital projects) requiring separate accounting because of legal or regulatory provisions or administrative action. Included in this fund type are Federal Revenue Sharing, Conservation Commission, Water Department, Town Common Committee, Highway Equipment, Police Equipment, Town History, Recreation, Steeple and Town Clock, Payloader, Town Library and the Tennis Courts funds.

FIDUCIARY FUNDS

Trust Funds - Trust Funds are used to account for the assets held in trust by the Town.

B. Account Groups (Fixed Assets and Long-Term Liabilities)

All governmental funds and expendable trust funds are accounted for on a spending or "financial flow" measurement focus. This means that only current assets and current liabilities are generally included on their balance sheets. Their reported fund balance (net current assets) is considered a measure of "available spendable resources". Governmental fund operating statements present increases (revenues and

other financing sources) and decreases (expenditures and other uses) in net current assets. Accordingly, they are said to present a summary of sources and uses of available spendable resources during a period.

General fixed assets have been acquired for general governmental purposes and have been recorded as expenditures in the fund making the expenditure. These expenditures are required to be capitalized at historical cost in a General Fixed Asset Group of Accounts for accountability purposes. In accordance with the practices followed by other municipal entities in the State, the Town does not maintain a record of its general fixed assets and accordingly, a statement of general fixed assets, required by generally accepted accounting principles, is not included in this financial report.

Long-term liabilities expected to be financed from governmental funds are accounted for in the General Long-Term Debt Account Group. This account group is not a fund. It is concerned only with the measurement of financial position and not results of operations. Since they do not affect net current assets, such long-term liabilities are not recognized as governmental fund type liabilities. They are instead reported as liabilities in the General Long-Term Debt Account Group.

C. Basis of Accounting

The accounts of the General, Special Revenue, and Expendable Trust Funds are maintained and reported on the modified accrual basis of accounting. Under the modified accrual basis of accounting, sources of financial resources and assets are recognized when measurable and available to finance operations during the year. Uses of financial resources and liabilities are recognized when obligations are incurred from receipt of goods and services, when assessments are made by the State or in the case of judgments and claims against the Town, when there is a probability that such judgments and claims will result in liabilities, the amounts of which can be reasonably estimated. Exceptions to this general rule include: principal and interest on general long-term debt which is recognized when due. All Nonexpendable Trust funds are accounted for using the accrual basis of accounting.

D. Budgetary Accounting

General governmental revenues and expenditures accounted for in budgetary funds are controlled by a formal integrated budgetary accounting system in accordance with various legal requirements which govern the Town's operations. However, contrary to generally accepted accounting principles, it has not been the practice of the Town to adopt an annual budget for all Special Revenue funds.

The Town budget represents departmental appropriations as authorized by annual or special town meetings. The Selectmen may transfer funds between operating categories as they deem necessary. State Statutes require balanced budgets but provide for the use of beginning fund balance to achieve that end. In 1985, the beginning fund balance was applied as follows:

E. Encumbrances

Encumbrance accounting, under which purchase orders, contracts, and continuing appropriations (certain projects and specific items not fully expended at year-end) are recognized, is employed in the governmental funds. Encumbrances are not the equivalent of expenditures; and are therefore reported as part of the fund balance at December 31 and are carried forward to supplement appropriations of the subsequent year. The reserve for encumbrances at December 31 consists of the following:

F. Reserve For Elderly Liens

The Town provides monetary assistance to elderly residents for which it is allowed to record a lien against the resident's property in accordance with R.S.A 72:38A. The Town is entitled to recover these amounts from the sale proceeds of the resident's property or from the resident's estate. Since the timing of either event is indeterminable the entire balance of elderly liens receivable at December 31, 1985 is reserved as part of fund balance. Likewise, no revenues or expenditures have been recognized relative to these transactions. During the year, the Town provided \$1,762 in assistance under these arrangements. At December 31, 1985, total elderly liens receivable amounted to \$5,039.

G. Investments

Investments in all instances are stated at cost, or in the case of donated investments, at market value at the time of bequest or receipt.

H. Inventories

Inventory in the General and Special Revenue funds consists of expendable supplies held for consumption. The cost thereof has been recorded as an expenditure at the time individual inventory items were purchased.

I. Vacation and Sick Pay

The Town does not have a formal sick leave policy. Employees are allowed vacation leave of 1 week after 1 year of service and 2 weeks thereafter. The Town's policy is to recognize cost of sick and vacation leave only at the time payments are made. Any accumulated vacation leave is immaterial.

J. Taxes Collected For Others

The property taxes collected by the Town include taxes levied for the Contoocook Valley School District and Hillsborough County which are remitted to these governmental units as required by law. The ultimate responsibility for the collection of taxes rests with the Town. The payments are recorded as intergovernmental transfers.

K. Property Taxes

The National Council on Governmental Accounting, Interpretation 3, referring to property tax revenue recognition, requires disclosure if property taxes receivable, which are to be collected beyond a period of 60 days subsequent to December 31, 1985, are recognized on the balance sheet and not reserved. In accordance with the practice followed by other municipal entities in the State of New Hampshire, the Town of Hancock annually recognizes all tax receivables at the end of the fiscal year. The Town feels this practice of accrual is justified as it more appropriately matches the liability to the school district entity at December 31, with collections which are intended to finance these payments through June 30 of the following year.

Annually, the Town establishes and raises, through taxation, an amount for abatements and refunds of property and resident taxes known as overlay. All abatements and refunds are charged to this account. The amount raised in 1985 was \$3,493, and expenditures amounted to \$9,187.

As prescribed by law, the Tax Collector sells at tax sale all uncollected property taxes in the following year after taxes are due. The purchaser at tax sale has a priority tax lien on these properties and accrues interest at 18% per annum. Delinquent taxpayers must redeem property from tax sale purchasers.

Property is sold to the party who will accept a lien for the least undivided interest in the property for payment of taxes and related costs due. If property is not redeemed within the two-year redemption period, the property is tax-deeded to the lien holder.

L. Interfund Transactions

During the course of normal operations, the Town has numerous transactions between funds. The accompanying governmental and fiduciary fund financial statements reflect such transactions as transfers.

HANCOCK 1985

1985 was a year of studying and planning for Hancock. And it was, as it should be, a year of changes, both for individuals and the town as a whole.

Selectmen appointed a number of committees to explore various questions and concerns within the town--Norway Pond, town roads and bridges, a new post office location, salaries of all town employees and the reorganization of town departments.

Voters approved an appropriation of \$95,000 for a new pumper truck for the fire department.

Bob Fogg, water rent collector for 12 years was succeeded by Pat Query.

Doris Rogers, head librarian and Elsie Frank, retired librarian, were each honored at separate ceremonies on their retirement from many years of service with the Hancock library. Rogers was succeeded by Pat Briggs.

Allison Kerwin returned to Hancock after working for a year in a plant nursery in Australia. Ellena Weston returned from a two months summer job in China, where she worked as a livestock consultant for a California firm.

The Depot Association held a third successful travel raffle to continue the restoration of the historic railroad station.

A "Great Decisions" foreign affairs discussion group, coordinated by Brownie McKinley, met every other week during the winter and spring at the library.

Eleanor Briggs, founder of the Harris Center, announced the donation of a scenic easement on a 2,000 acre parcel of land in the Hancock highlands which will permanently protect that land for future development. Later in the year, Briggs received one of three Conservationist of the Year awards presented by the Society for the Protection of NH Forests.

Richard Amidon of Gram Corporation, assemblers of an aqueous cleaning and drying system for printed circuit boards, withdrew a proposed plan for construction of a building off Rte. 202 after a lengthy zoning board process which denied and later granted approval. A final ZBA decision dismissed the Gram Corp. petition "without prejudice." Subsequently, Amidon offered the 19-acre property to the Conservation Commission who is awaiting word on their application to the state for a 50% matching grant.

Shifting numbers in the school age population prompted the fall move of fifth as well as sixth graders from HES to PMS.

Wilder's Auto Service owners, Bud and Martha Wilder, leased the business to Bob Fogg, an employee of the garage for 22 years. The name was changed to Hancock Service Station, the name it bore prior to 1947.

The Hancock church organ will receive a thorough refurbishing at a cost of \$30,000.

The Hancock library received a \$5,000 gift in memory of H.E.D. Pollock and \$190,000 in the will of George "Hobie" Brooks.

A committee, chaired by Meade Cadot, was established to review the town's master plan and to make recommendations to the planning board.

Students at HES dedicated one of the school rooms in memory of the late Arthur Daniels.

The Old Home Day committee sponsored a trivia contest concerning historic facts about Hancock.

Terri Koziell received the Gold Award, Girl Scouting's highest award, for her service project involving a handicap awareness day at HES. The second highest honor, the Silver Award, was earned by Sarah Tillinghast for her revision of a town directory.

At a special town meeting in late September, voters directed selectmen to initiate proceedings to acquire the Grange building for use as a post office.

A sugar maple, designated state champion in 1980 by the SPNHF, and the

second largest in the nation, succumbed to old age at the Brooks' Side Farm of Dr. and Mrs. Owen Mathewson.

Rev. Hollis Hastings, pastor of the First Congregational Church, announced his retirement in May 1986.

The Norway Pond committee recommended four major changes in its report-removal of beaver dams to lower the surface level, purchase of two aerator/circulator devices, development of a second, unsupervised beach and creation of a permanent Norway Pond commission.

REPORT OF TOWN FOREST FIRE WARDEN
AND STATE FOREST RANGER

Between July 1984 and June 1985, we experienced more forest fires throughout our state than in any year in the last 50. Two of the leading causes of the 1,605 fires were children and fires kindled without written permission of a Forest Fire Warden. Both causes are preventable, but only with your help.

Please help our town and state forest fire officials with forest fire prevention. Contact your Forest Fire Warden for more information.

Enforcement of state timber harvest regulations is the responsibility of State Forestry officials. Our state has excellent timber harvest regulations; however, your assistance is needed.

If you know of a logging operation and suspect a state timber harvest law may be violated, call your Forest Fire Warden.

If you own forest land, you will become responsible for the timber tax payment starting April 1, 1986. This is a change in the Timber Tax Law that will impact all forest landowners. Contact your Board of Selectmen for timber tax forms.

HANCOCK FIRE DEPARTMENT

1985 was quite a year for the department. After over a year of looking at different fire trucks by the members of the department and projecting what our needs would be, the town voted to purchase a new engine. In August the town received a new Ford C800 pumper from Middlesex Fire Equipment. It features a 1000 gallon tank, a 1000 gpm pump and has top mounted controls. The pump is also internally heated from the engine water cooling lines. The firemen purchased approximately \$15,000 worth of hose and fittings from money that has been raised from the raffle and chicken barbecue. It was a happy day for all of us to see the truck arrive on August 10, at 8 a.m. At 12:00 noon it went on its first call.

We had 78 calls for the year. Three structure fires, 20 mutual aid calls, 2 chimney fires, 33 rescue calls, 2 false alarms, 8 calls for brush fires out of control, 10 miscellaneous calls. The fire at Bacas and the one at Fran's Auto Body tested the men's skills and ability. There was heavy fire showing at both places upon arrival. The fire was contained at both places and the houses were saved. A task that was not easy either time.

The worst call was one in May when we lost one of our fellow firemen in an auto accident. A night that we will not soon forget.

During the upcoming year we will be replumbing the tank truck and repairing some of the compartments on it. Also, we will be starting to refurbish the International pumper and install a new foam system on it. Both of these projects will be done with money that the department has raised.

LIBRARY TRUSTEES REPORT

The major activity of the Library Trustees during 1985 was the study of the need and the feasibility of building an addition to the Library to meet certain present and future needs. A thorough study had become necessary for two major reasons.

First, in a letter dated October 29, 1984, the Town Selectmen had directed the attention of the trustees to recommendation #2 from the report by the Town of Hancock Committee on Handicapped Discrimination. This recommendation read: "Library facilities need to be reviewed more specifically and any plans to build a library addition should include the needs of individuals with handicapping conditions. Of all the buildings reviewed, the library was seen as the one area where structural changes should be considered."

The second reason for conducting a study was the need to provide an answer to the increasing number of citizens, particularly private contributors, who wanted to know when work on the proposed addition would be undertaken.

To meet these needs, the trustees began a study by consulting the staff of the New Hampshire Library Department, by meeting with the Town of Hancock Committee on Handicapped Discrimination and by visiting the Peterborough, New Boston, Milford and Hampton libraries which had recently completed or were in the process of building library additions. The trustees also reviewed the situation with Emerson Greenaway, a leading New Hampshire library consultant.

As a result, the trustees concluded that building a library addition was necessary to meet the following needs:

1. Appropriate reading rooms for adults, young adults, and children.
2. An all-purpose room for use by civic, cultural, recreational and other appropriate town organizations for meetings, discussions and lectures.
3. An area for computers and video equipment.
4. A private work area for the library staff.
5. A secure area for rare volumes and valuable histories.
6. A storage area for library equipment and supplies.

Furthermore, the trustees concluded that certain practical factors made a new addition virtually a necessity. These factors included:

1. The need for providing physically handicapped persons with adequate access to the building and stacks as well as suitable toilet facilities.
2. The need to replace an antiquated heating system and remove the asbestos insulation on the present heating pipes.
3. The need for extensive repairs to the building roof.
4. The need for installing adequate and safe electrical wiring and lighting.

Although the need for a building addition was clearly indicated, it was not equally certain that sufficient funds could be obtained. An earlier study by the 1973 Library Space Committee had recommended establishing a Library Improvement and Reserve Fund. After accepting this recommendation, the 1974 Town Meeting and subsequent Town Meetings had contributed \$1,000 annually to this fund. As a result of these contributions plus substantial private donations, the fund totaled \$81,254.69 as of December 31, 1985.

However, in October 1981, an earlier group of trustees had obtained an estimate of \$204,900 as the cost of a building addition. In view of the substantial subsequent increases in building costs, it did not appear to the trustees that sufficient funds could be raised to justify undertaking the building of an addition at the present time.

On October 21, 1985, the trustees met with the Selectmen to review the results of the study. The selectmen recommended that the trustees select

CONSERVATION COMMISSION REPORT

During 1985 the Conservation Commission conducted an extremely successful clean-up day on May 4th. The actual clean-up was attended by approximately sixty adults and children with ice cream refreshment supplied by Mike and Lesley Cass. Additionally, many individuals took part by cleaning their own roads on an individual basis.

Waterscan, the commission's two-year project for gathering data about the water quality in six of our local lakes and ponds, has been completed. We have monitored thermal profiles, acidity, alkalinity, transparency depths and coloration at each location on a weekly basis. A report of the 1984 and 1985 waterscan activities including data will be available for review at the selectmen's office, town library and the Harris Center.

This year Tonya Dalhaus was sponsored to attend the annual Youth Conservation Camp.

Another major project by the commission was a proposal made to "The Land and Water Conservation Fund," for monies to purchase property from Mr. Richard Amidon. The property is that which was proposed for the construction site of a light industrial building. The proposal to the fund was denied but continuing efforts are ongoing to raise monies for the purchase.
