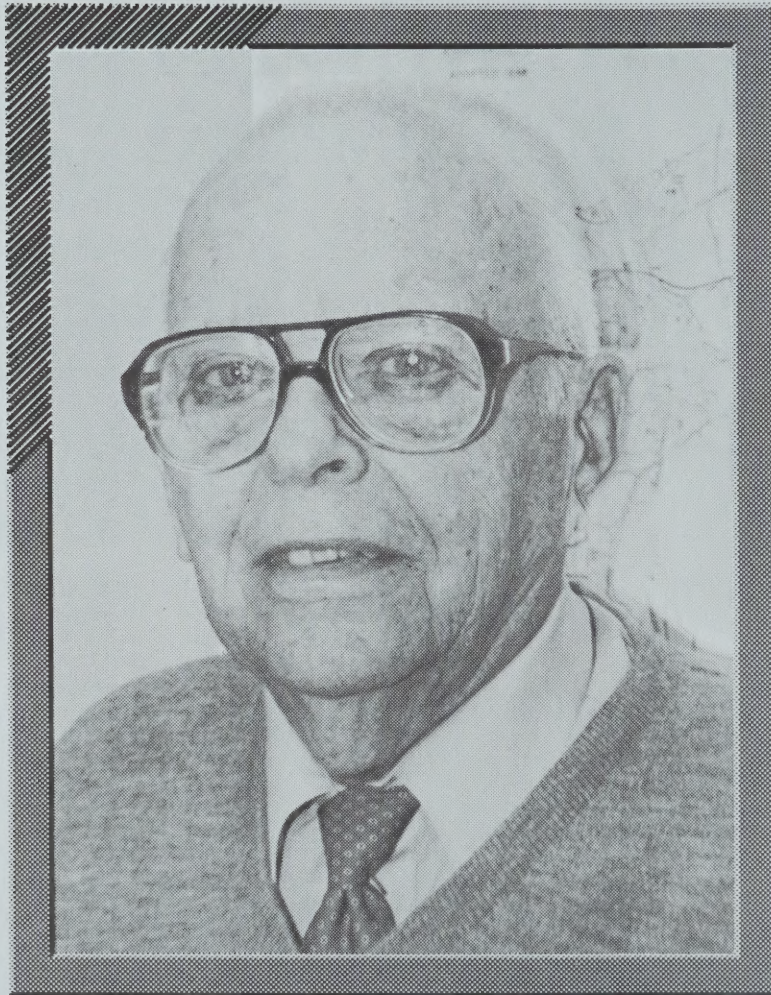

Report from the Meredith Board of Selectmen

To our citizens of Meredith:

As we report the close of 1996, we are pleased to provide a few reminders of another busy, productive and eventful year within our community.

Early in the year, volunteers joined together to work in the cold, starting on ice and ending in the frigid waters of Meredith Bay, to build a community walkway around Bay Point joining nearly 1/3 mile of your Town Parks. The walkway was enjoyed by many in this first year.

The Spring and Summer brought Community Park on Main Street and long awaited bathrooms for the public's convenience. A volunteer committee designed and oversaw construction of the first phase of the property. We are asking you to approve funding for the final phase this year, enhancing our historical Waukegan Canal, providing a one lane vehicle bridge to connect our parking areas and other enhancements. This project started with Latchkey Charities, Inc., a volunteer group of businessmen. One of the founders, Jim Sutherland, held a community vision for our downtown and Jim will be long remembered and missed by us all.

Adjacent land behind Prescott Park was obtained from the Woodman family. In 1997, we will be undertaking a master plan of Prescott Park, in conjunction with the InterLakes School District and other volunteers, to design additional recreational fields and linking the park directly with our schools.

Milfoil treatment of Meredith Bay is planned for early June to maintain our desirable downtown Lake Winnepesaukee waterfront.

We continue to financially plan for our future. We again propose expendable trust funds to meet our future needs in an affordable way.

Our municipal budget, as proposed, once again maintains the same municipal tax rate.

A major road project, Pleasant Street, requires bonding. Our last road bonding debt payment is in 1997. We propose this amount of funds for repayment of a Pleasant Street bond beginning in 1998.

EXECUTIVE SUMMARY

This project includes replacing 5100' of undersized water main, 450' of sagged sewer main, 4850' of underground drainage, rebuilding 1860' of existing sidewalk, building 3400' of new sidewalk and construction 5900' of Town road. The work would be bid for the 1998 season.

We are also proposing an innovative sewer extension project for Needle Eye Road and the nearby area of Route 3 South. This proposal called "Tax Increment Financing" pays for the public improvements with future property taxes raised by future growth within the district and not by our other properties in Town.

Perambulation of Town line borders began in 1996. State law requires this to be accomplished every 7 years; this project will continue in 1997.

This report mentions only a few of our town wide activities. Please review the Town Manager and other Departmental Reports to learn of further accomplishments.

And finally, we wish to thank you, as it is because of your interest as citizens, volunteers and our dedicated Town employees that Meredith's projects and tasks are successful. Meredith is what it is today because of everyone's involvement.

In closing, we have tried to address all issues brought before us, some take longer to address than others, however. We wish to thank you citizens for your support, confidence and patience, making it a rewarding pleasure to serve you.

Town Manager's Report

To the citizens of Meredith:

Once again, we close another busy year in Meredith; I wish to thank you for your input and support, especially our employees and many dedicated volunteers.

The Selectmen's and other Departmental Reports within this Annual Report discuss our many endeavors of 1996, Public Works especially.

A number of infrastructure improvements were undertaken in 1996 and planning completed for proposed work in 1997. The Wagon Wheel Trail pressure sewer betterment assessment was bid in late 1996, work began, but had to close down for the winter; the project will be completed in the Spring/Summer.

The concrete ramp at the Route 3 boat launch was replaced in late fall; installation of a similar ramp at our Shep Brown's Facility will be done in 1997.

Work continued on Reservoir Park this year; the first trail was completed with wetland foot bridges. Poison ivy delayed the opening, however. The permit approval for pesticide spraying from the NH Pesticide Board was delayed until late fall. Spraying will be accomplished in late Spring to allow for safe utilization of the trail. We continue to work with the one time \$19,019 timber cutting revenue allowance to develop this passive recreation area for your enjoyment.

Our request this year for the expendable trust fund for the Sand/Salt Storage Building will allow construction to commence after permitting. This building will allow for environmentally safe storage for our winter sand and salt; improve utilization and provide much safer employee and equipment conditions.

Our Route 3/25 Task Force continues to work on possible future road improvements while preserving or improving our community character, natural beauty and pedestrian safety. This process has taken longer than anyone imagined, but progress with NH DOT is being made.

Two road improvement projects will be undertaken in conjunction with the State of New Hampshire in the fall of 1997: Route 3 South and the intersections of Neal Shore and

Westbury Roads and the replacement of a drainage structure and sight distance improvements of Meredith Neck Road between Upper and Lower Meadow Farms.

The sewer project on Waukewan Street is finally planned to be constructed Spring/Summer of 1997. The street reconstruction will be in conjunction with this sewer project.

I wish to take this opportunity to welcome our new Fire Chief "Chuck" Palm. If you have not met Chuck yet, please do.

I have spoken with or worked with many of you citizens or taxpayers, but certainly not everyone. If you have any questions, opinions or concerns, please contact me at the Town Office, 279-4538.

In closing; although Meredith is a very diverse community, I truly enjoy working for and with you all. Thank you.

ARTICLE 2

Are you in favor of the adoption of Amendment No. 1 as proposed by the Planning Board for the Meredith Zoning Ordinance having to do with “Bed and Breakfast House” uses?

PURPOSE OF THE AMENDMENT: To allow “Bed and Breakfast House” as a permitted use in the Residential District; to require a Special Exception from the Zoning Board of Adjustment if building expansion is involved; and to replace “Lodging Houses” with “Bed and Breakfast House” as a permitted use in the Forestry/ Rural, Shoreline, Commercial/ Route 3 South and Central Business Districts..

ARTICLE 3

Are you in favor of the adoption of Amendment No. 2 as proposed by the Planning Board for the Meredith Zoning Ordinance having to do with “Recreational Vehicles”?

PURPOSE OF THE AMENDMENT: To prohibit the occupation of a “Recreational Vehicle” on *vacant* property. The amendment would permit the use of a “Recreational Vehicle” as an accessory use to an existing dwelling unit having utilities including septic or sewage disposal. This requirement would not apply to campgrounds, nor does it change existing provisions concerning duration of use (30 days per calendar year).

Are you in favor of the adoption of Amendment No. 3 as proposed by the Planning Board for the Meredith Zoning Ordinance having to do with structures damaged by accidental means?

ARTICLE 5

Are you in favor of the adoption of Amendment No. 4 as proposed by the Planning Board for the Meredith Zoning Ordinance having to do with “Personal and Professional Offices”?

PURPOSE OF THE AMENDMENT: To allow “Personal and Professional Offices” by Special Exception in the Residential and Shoreline Zoning Districts. The Special Exception requirement would not apply to “Home Occupations” but would apply in situations where a commercial office use exceeds home occupation standards.

ARTICLE 6

Are you in favor of adopting Amendment No. 5 as proposed by the Planning Board for the Erosion and Sedimentation Control Ordinance having to do with requirements for soil erosion and sedimentation control plans?

PURPOSE OF THE AMENDMENT: To require an approved soil erosion and sedimentation control plan for all *new* construction or lot conversion where “earth disturbing activity” is within 250’ feet of a lake or pond; to set forth a flexible framework for the determination of plan requirements; and to require certification from the landowner and contractor acknowledging responsibility to develop the property in accordance with the approved plan.

Are you in favor of adopting Amendment No. 6 as proposed by the Planning Board for the Meredith Zoning Ordinance having to do with “cultural uses”?

PURPOSE OF THE AMENDMENT: To define “Cultural Uses” to include galleries, theaters, museums, arts and craft production; and to allow “Cultural Uses” as permitted uses in the Central Business and Commercial/ Route 3 South Zoning Districts.

DELIBERATIVE SESSION

The Deliberative Session was opened at 7:00 PM at the ILHS Auditorium by Moderator Jollimore. Anne Jollimore Vice-Regent of DAR led the Flag salute.

Moderator Jollimore asked the non-voters to be segregated on the right. All questions to be directed to the Moderator giving name at the mike.

There will be no reconsideration unless the assembly overrules the Moderator on any one article at the time of voting on that article.

EXECUTIVE SUMMARY

ARTICLE 8

To see if the municipality will vote to create an expendable general fund trust fund under the provisions of RSA 31:19-a, to be known as the Employee Benefits Fund, for the purpose of severance, retirement, and accrued benefit payments and to raise and appropriate the sum of Thirty Four Thousand Dollars (\$34,000) toward this purpose and to appoint the Selectmen as agents to expend. Funding is already appropriated within the operating budget. RECOMMEND BY THE BOARD OF SELECTMEN

Article was moved by Selectman Hughes and seconded by Paul Lessard.

Mr. Jollimore explained the trust fund was for the purposes of severance, retirement and accrued benefit payments. The fund would be in the custody of Trustee of Trust Funds with the Board of Selectman as agents to expend. The funding is already appropriated within the operating budget. Mr. Russell said if the need arose, there would be a public hearing. The auditors had stated previously that this is an unfunded liability and should be corrected.

The Moderator declared the article passed in the affirmative with a unanimous voice vote.

ARTICLE 9

To see what sum the Town will vote to raise and appropriate for the necessary operational expenses of the Town for the ensuing year's budget.

The article was moved by Selectman Lessard and seconded by Selectman Mongo to raise and appropriate the sum of \$6,576,032.00 for the operational expenses of the Town. This includes the Water and Sewer Department which are enterprise funds and have no impact on the tax rate. The amount to be raised by taxes is \$3,752,270.00

No discussion.

Moderator declared the article passed in the affirmative by a unanimous voice vote.

ARTICLE 10

To see if the Town will vote to create an expendable general fund trust fund under the provisions of RSA 31:19-a, to be known as the Landfill Closure Fund, for the purpose of formally closing the Town owned Landfill on Jenness Hill Road and to raise and appropriate the sum of Seventy Five Thousand Dollars (\$75,000) toward this purpose and to appoint the Selectmen as agents to expend. RECOMMENDED BY THE BOARD OF SELECTMEN.

The article was moved by Selectmen Mongo and seconded by Selectman Hughes. Moderator Jollimore explained that this would create an expendable trust fund in the custody of the Trustees and the Board of Selectmen as agents to expend.

Manager Russell explained this amount was not to close the landfill but to start a fund so that in the future the closure cost of between half to three-quarter million dollars would not be a single year tax impact. There were questions and discussions from the floor in regard to the procedure of the actual closing. Moderator declared the article passed in the affirmative by unanimous voice vote.

EXECUTIVE SUMMARY

ARTICLE 11

To see if the Town will vote to create an expendable general fund trust fund under the provisions of RSA 31:19-a, to be known as the Sand/Salt Storage Building Fund, for the purpose of constructing a building to store sand and salt and to raise and appropriate the sum of One Hundred Thousand Dollars (\$100,000) toward this purpose and to appoint the Selectmen as agents to expend. **RECOMMENDED BY THE BOARD OF SELECTMEN**

The article was moved by Selectman Hughes and seconded by Selectman Lessard.

There was considerable discussion from the assembly regarding cost, type of construction, necessity and environment damage. Karen Sticht and Jack Carty spoke against the article, It was felt that the price was too high. Mr. Hughes stated that through the bid process that it was hoped that the cost would be less. Moderator declared the article passed in the affirmative with a voice vote. There were some nays.

ARTICLE 12

To see if the Town will vote to create an expendable general fund trust fund under the provisions of RSA 31:19-a, to be known as the Municipal Building Fund, for the purpose of providing additional Municipal Office space and to raise and appropriate the sum of Fifty Thousand Dollars (\$50,000) toward this purpose and to appoint the Selectmen as agents to expend. **RECOMMENDED BY THE BOARD OF SELECTMEN**

The article was moved by Selectman Lessard and seconded by Mrs. Mongo. There was some discussion as to the time table. Mr. Russell indicated that there was no current plan but we needed to start planning. Mr. David Sticht made a motion to amend the article to read “subject to the approval of Town Meeting.” Seconded by David Kuether.

Some discussion of the amendment. Amendment passed in the affirmative.

The article as amended was declared passed in the affirmative with a voice vote by Moderator Jollimore.

ARTICLE 13

To see if the Town will vote to create an expendable general fund trust fund under the provisions of RSA 31:19-a, to be known as the Public Works Dump Truck Replacement Fund, for the purpose of purchasing a dump truck and to raise and appropriate the sum of Forty Thousand Dollars (\$40,000) toward this purpose and to appoint the Selectmen as agents to expend. **RECOMMENDED BY THE BOARD OF SELECTMEN**

The article was moved by Selectman Mongo and seconded by Mr. Hughes.

Some discussion on the purpose of the trust fund articles. Mr. Lessard explained that the Board was trying to level-fund and not be jolted with large expenses.

Article passed in the affirmative by a unanimous voice vote.

ARTICLE 14

To see if the Town will vote to raise and appropriate the sum not to exceed Seventeen Thousand Dollars (\$17,000) to upgrade Dolloff Brook Road to Town specifications. Any cost (initial repairs and maintenance bond) relating to this project could be assessed to the property owners on that road. The betterment assessment is contingent upon the availability of clear deed title. If clear title is not available, said appropriation and betterment assessment shall become null and void. **RECOMMENDED BY THE BOARD OF SELECTMEN**

EXECUTIVE SUMMARY

It was moved by Selectman Hughes and seconded by Mr. Lessard to pass the article as read.

No discussion

Passed in the affirmative by a unanimous voice vote.

ARTICLE 15

To see if the Town will vote a "Special Warrant Article" to raise and appropriate the sum of Fifty Thousand Dollars (\$50,000) for the creation and construction of Community Park, Forty Thousand Nine Hundred Dollars (\$40,900) to be raised by taxation and Nine Thousand One Hundred Dollars (\$9,100) to be transferred to the General Fund from the Land Use Change Tax Fund. This will be a **non-lapsing** account per RSA 32:3, VI and will not lapse until the Park is completed or in two years following the end of this fiscal year, which ever is less. **RECOMMENDED BY THE BOARD OF SELECTMEN**

Selectmen Lessard made a motion to move the article as read. Seconded by Mrs. Mongo.

There was considerable discussion on the article. Paige Kuether spoke against the article. Mrs. Mongo and Mr. Lessard spoke in favor of the article.

Moderator Jollimore declared the article passed in the affirmative by voice vote. There were a few nays.

ARTICLE 16

To see if the Town will vote to raise and appropriate the sum of Thirty Six Thousand Seven Hundred Dollars (\$36,700) for the following purposes:

\$20,000 State Aid Reconstruction Program - 2 to 1 match for improvements to various roads under the State Aid Reconstruction Program, provided that the State of New Hampshire appropriates Forty Thousand Dollars (\$40,000); and

\$16,700 Community Enhancement Program - Safety and aesthetic improvements on Route 3 North.

RECOMMENDED BY THE BOARD OF SELECTMEN

Article was moved by Selectmen Mongo and seconded by Mr. Hughes.

Some discussion.

Article passed in the affirmative by a unanimous voice vote.

ARTICLE 17

To see if the Town shall recommend that the Board of Selectmen continue or discontinue the utilization of the Inventory of Taxable Property form.

Article was moved by Max Jenness, seconded by Helen Schnoebelen.

There was considerable discussion on this article.

Article passed to discontinue the inventory forms with a voice vote with a few nays.

The Town Meeting was adjourned at 8:20 PM by Moderator Jollimore after a motion from Mr. Hughes.

GENERAL GOVERNMENT

Assessing Department

Lena Watson Bolton, Assessor

An assessment update of all taxable properties in Meredith was completed this past fall by the Assessors Office. The new assessments were used for the 1996 warrant.

Besides the assessment update the Assessing Department updated its appraisal software and hardware. With the updated software, the Assessing Department has expanded its capability to provide information.

I have been concentrating on making information available to all property owners in Meredith. With this as my objective, I have made available at the library a list of all assessments. The list is printed in 3 different formats: by owner name, by street address and by map & lot. These lists will be updated as I update the counter books in the Assessing Office. Also, at the library for interested property owners is a booklet detailing current land use.

The State Legislature made some changes to the elderly exemption. The legislature repealed all of the existing elderly tax exemptions and replaced them with one uniform elderly exemption law. The law preserves local option to the same extent as prior law. Municipalities have the option of increasing the level of the exemption and setting higher income and asset limitations. At the 1997 Town Meeting, one of the warrant articles will be to modify the elderly exemption.

In closing, I would like to remind Meredith property owners that the Inventory of Taxable Property form is no longer required. The townspeople voted at the 1996 Town Meeting, Article 17, to discontinue the form in Meredith.

The year also marked one of increased activity as summarized below:

Total responses in 1994 = 230, 1995 = 214 & 1996 = 270

The majority of the increase can be attributed to a combination of motor vehicle accidents and alarm activations, many of which were Carbon Monoxide alarms. Fortunately almost all of the carbon monoxide activations were false; however, each of these types of calls is treated with caution by the Department as Carbon Monoxide poisoning is known in the emergency services as the "Silent Killer." The members of the Department would like to remind each of you to check your detectors frequently, both smoke and carbon monoxide, it only takes a couple of minutes a month to do.

Most of the Department members completed a variety of certified training courses during the year, including Emergency Medical, Driver and Pump Operations, Hazard Materials, Fire Fighter (both Levels 1 and Career) and Incident Command. In addition members also refreshed many of their emergency skills during regular Department training.

As in the past, we hope that you will join with us in extending our sincere appreciation to the local businesses, for allowing our members to leave their job assignments when the call arises, most notably: Meredith Village Savings Bank, Meredith Harley Davidson, Lakeside Plumbing, Village Canvas, and Meredith Plumbing & Heating. It is only with the support of these and other local businesses that a volunteer fire department can successfully exist.

We would like to take this opportunity to offer our services to the various organizations in the Town should you desire to have us visit one of your meetings to share some of our knowledge concerning smoke of carbon monoxide detectors, fire extinguishers or perhaps some other phase of the fire service. In closing, thank you all for your continued support and have a fire safe 1997.

1996 was an active and busy year for the Department of Public Works. Many accomplishments were realized through cooperative efforts of all municipal departments and the very dedicated employees within the Department of Public Works. Heavy demands were placed on employees and equipment in handling winter maintenance activities. The Public Works Department Employees thank you for your cooperation and understanding in handling the challenges of this unusual winter season.

The development in Community Park on Main Street was a direct result of intensive efforts and labor by both Community Park Committee members and Town employees. We look forward to continuing this project in 1997.

There were several road reconstruction projects completed in 1996:

Blake Road, which was reconstructed to a new gravel surface in 1995, was completed in 1996 with a new asphalt pavement overlay.

Windsong Place received drainage and gravel improvements along with a new asphalt overlay to the intersection at Serenity Lane.

Hemlock Drive received drainage and gravel improvements along with a new asphalt overlay from NH Route 104 to the intersection at Reservoir Road.

True Road received drainage and gravel improvements along with a new asphalt overlay from NH Route 25 to the intersection at Inter-Lakes Mobile Home Park.

Old Barn Road had a drainage culvert and catch basin installed. Gravel improvements and asphalt pavement overlay on this road is scheduled for 1997.

In closing, the employees of the Department of Public Works thank all of you for your continued support.

Recreation Department

The Parks and Recreation Department had a busy and successful year offering a variety of programs for all ages. The Department experienced a major increase in participation in many of the activities. The Summer Playground enrolled over 190 youths between the ages of 6-14. The Youth Soccer Program for Grades K-2 had almost 100 children who participated last fall.

The Waukegan Highlands Community Park, also known as the Reservoir Property, is expected to open in Spring 1997. We have neared completion of one trail leading to the pond. This trail is about 2000 feet long and has the highest degree of accessibility within the context of the overall trail plan. We obtained the necessary permits and constructed a 70 ft. elevated boardwalk to cross over some wetlands. We are hoping to open one other trail in 1997.

The Meredith Boy Scouts Troop #55 received an award for their Elm Tree Program and plan on making a small donation to the park project. We are looking for individuals/groups to work at the Park to help us in completing the trail system. Anyone interested should contact the Recreation Office.

The Community Center Committee presented the Selectmen with design plans for a three phase building at Prescott Park. The Committee is initially seeking approval of Phase 1, which consists of a multi-purpose room, game room, kitchen, offices, and meeting rooms.

Thank you to the community and to the other departments for the continued support and interest in Recreation. On behalf of the Meredith Parks and Recreation Department, thank you for making 1996 such a successful year.

Solid Waste Department

Barry Cotton, Director of Public Works

In 1996 a major ongoing legal dispute between the Sullivan County Solid Waste District and Wheelabrator Technologies was settled. This resulted in a substantial decrease in trash disposal costs for both the Towns of Meredith and Center Harbor. This savings should be realized during 1997.

The Pilot Project introduced last year with asphalt shingles has proven to be a very positive recycling program. This program will continue to strengthen in 1997.

A new waste oil furnace was installed at the recycling facility. This was a result of the Town of Meredith receiving a \$1500.00 grant from the State of New Hampshire Department of Environmental Services. This grant enables the Solid Waste Facility to enhance the collection and disposal of used motor oil collected on a regular basis at our facility.

Drop off locations for both brush and leaves are now located at the rear of the recycling facility. We ask that users of the facility please help us by not mixing contaminants in with leaves or brush. If you have any questions on proper disposal, please ask for assistance. I would like to remind the citizens who utilize the Solid Waste Facility that on May 31, 1997 facility use decals will expire. You may purchase a new decal after May 15th at the Municipal Office Building or the Solid Waste Facility.

In closing, I would like to thank the dedicated employees and all the citizens of both Meredith and Center Harbor for your continued support and cooperation.

Water and Sewer Departments

Robert Hill, Superintendent

The Water and Sewer Departments had a very active year. In addition to four water main breaks which were repaired, two main line water gates were removed and new replacement gates were installed, and a new water main gate was installed on Route 3 North. The Sewer Department oversaw the extension of sewer collection mains on Mill Street, Sunset Hill, and the Harbor Hill Campground. A dry hydrant was replaced at Winona Shores and a chlorination system was installed on Route 104 to provide a more stable chlorine residual in the Meredith Center water distribution system. Also, a new water main blow off was installed at the end of Bayshore Drive.

All EPA required lead, copper, nitrite, radiological, inorganic, synthetic and volatile services were repaired and four new water services were added. Along with routine maintenance, two new pump motors were installed at the Pollard Shores pump station. This year we video taped 3,400 feet of sewer mains. Fourteen major breaks were identified and repaired as a result. The initial phase of the sewer extension on Wagon Wheel Trail began with ledge blasting this fall. This project is scheduled to be completed in early summer of 1997.

In addition to numerous training seminars, the Department hosted the New Hampshire Water Works Association October meeting. On behalf of the Water and Sewer Department employees, I would like to thank you for your support.

SUPPORTED OUTSIDE AGENCIES

Inter-Lakes Day Care Center and Nursery School

Connie Pelletier, Director

We wish to thank the Town of Meredith for their continued support of our programs. Inter-Lakes Day Care Center and Nursery School is a private, non-profit fully licensed, non-denominational, tax exempt community child care agency incorporated in October 1971, and governed by a volunteer Board of Directors.

Our Center is open on a year round basis from 6:30 AM to 5:30 PM in one site and 6:00 PM in the other, making it possible for parents to maintain employment. Services include full and part time child care, morning preschool programs, summer day camp programs, and USDA approved hot meals and snacks. Through the State of New Hampshire under Title XX sliding fee scale tuition, based on income level and family size, is available for purposes of employment, training and pursuit of degree or certificate programs, job search and temporary disability.

Additional services include sponsorship of the Inter-Lakes Family Daycare Nutrition Program, a group of 43 licensed home day care providers who receive federal reimbursement from USDA by serving approved meals and snacks while providing care for children of working parents.

Lakes Region Association

The Lakes Region Association is a broad-based, non-profit tourism marketing organization representing the attractions, campgrounds, lodging, recreation, restaurants, retail and related service of central New Hampshire.

The Region's non-profit tourism marketing organization has had a very busy year distributing "Maps & Guides," "Winter Getaway Brochures," "Where To...Guides," and "Lakes Charts for Winnepesaukee, Newfound, Winnisquam and Ossipee." The Lakes Region Association also participated in the Lakes Region Heritage Round Table, Travel Council, Manchester Airport Advisory Board, Vacation in your Backyard Trade Show and Eastern States Exposition.

Lakes Region Community Services Council

Throughout 1996, the Lakes Region Community Services Council has continued to serve those Meredith residents who have a developmental disability. Services such as: residential, vocational, family support and transportation have long become an inherent part of their lives. Our transportation system "Greater Laconia Transit Agency" continues to serve the general public as well as the specific transportation needs of disabled individuals.

Funding from the Town of Meredith has been and will continue to be earmarked for support for this transportation system.

Lakes Region Family Service Association, Inc.

Lakes Region Family Service Association is a private, non-profit social service agency which offers supportive services to individuals and families from Meredith. The agency has been in existence for over 25 years in the Lakes Region. The mission of the agency is to strengthen and support families by offering programs that promote healthy relationships among adults, parents and their children. We are committed to offering accessible and affordable services to individuals throughout the Lakes Region.

The agency has five core programs. These include the Counseling Program, the Mediation Program, the Parent Aide Program, the Child Advocacy Program, and the Family Life Institute. We offer a wide variety of parenting groups, workshops, and therapy groups for children, adolescents, and adults.

Our Counseling Program offers services on a sliding scale basis and also accepts Medicaid and many insurances. There is no waiting list for services. Evening and Saturday hours are available. Parent-child and family mediations are offered free of charge, as are our child advocacy services (for children under the age of 18 who have been sexually abused and their families.) Divorce mediation is available at reasonable rates.

Over the last two years, we have been increasing our educational offerings to families at very affordable rates. We are conducting these throughout the region at locations which make attending more accessible. These services are not offered through the Family Life Institute. 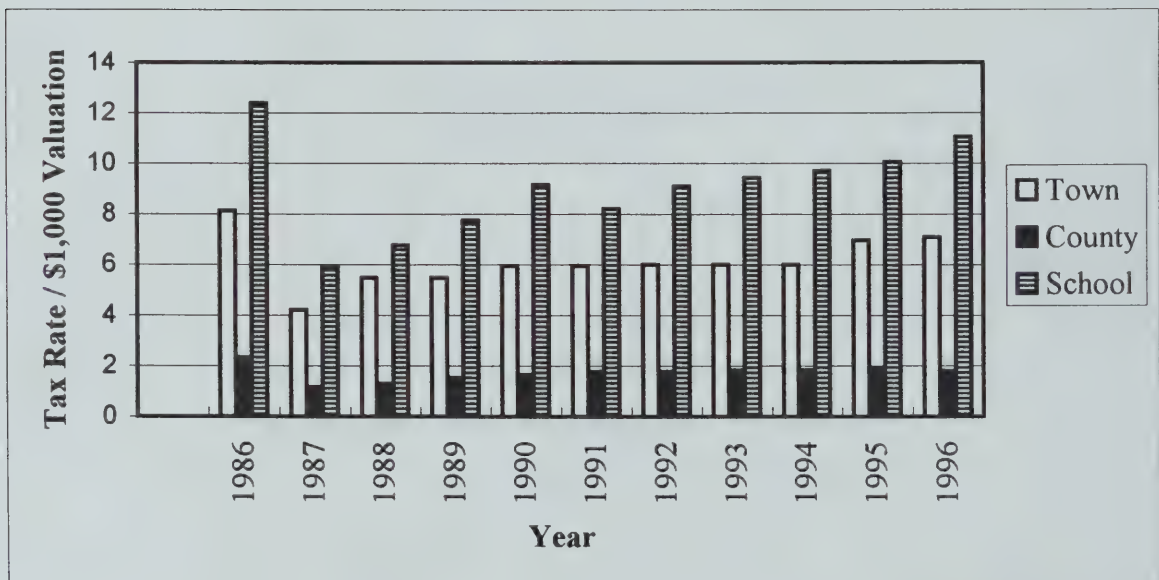

We have audited the accompanying general-purpose financial statements of the Town of Meredith as of and for the year ended December 31, 1995. These general-purpose financial statements are the responsibility of the Town's management. Our responsibility is to express an opinion on these general-purpose financial statements based on our audit.

We conducted our audit in accordance with generally accepted auditing standards and *Government Auditing Standards* issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the general-purpose financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the general-purpose financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall general-purpose financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

The general-purpose financial statements referred to above do not include the general fixed assets account group which should be included in order to conform with generally accepted accounting principles. As is the case with most municipal entities in the State of New Hampshire, the Town of Meredith has not maintained historical cost records of its fixed assets. The amount that should be recorded in the general fixed assets account group is not known.



INDEPENDENT AUDITOR'S REPORT ON THE INTERNAL CONTROL STRUCTURE BASED ON AN AUDIT OF GENERAL-PURPOSE FINANCIAL STATEMENTS PERFORMED IN ACCORDANCE WITH GOVERNMENT AUDITING STANDARDS

We have audited the general-purpose financial statements of the Town of Meredith, as of and for the year ended December 31, 1995, and have issued our report thereon, which was qualified as indicated therein, dated April 26, 1996.

We conducted our audit in accordance with generally accepted auditing standards and *Government Auditing Standards*, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the general-purpose financial statements are free of material misstatement.

The management of the Town of Meredith is responsible for establishing and maintaining an internal control structure. In fulfilling this responsibility, estimates and judgments by management are required to assess the expected benefits and related costs of internal control structure policies and procedures. The objectives of an internal control structure are to provide management with reasonable, but not absolute, assurance that assets are safeguarded against loss from unauthorized use or disposition, and that transactions are executed in accordance with management's authorization and recorded properly to permit the preparation of general-purpose financial statements in accordance with generally accepted accounting principles. Because of inherent limitations in any internal control structure, errors or irregularities may nevertheless occur and not be detected. Also, projection of any evaluation of the structure to future periods is subject to the risk that procedures may become inadequate because of changes in conditions or that the effectiveness of the design and operation of policies and procedures may deteriorate.

In planning and performing our audit of the general-purpose financial statements of the Town of Meredith for the year ended December 31, 1995, we obtained an understanding of the internal control structure. With respect to the internal control structure, we obtained an understanding of the design of relevant policies and procedures and whether they have been placed in operation, and we assessed control risk in order to determine our auditing procedures for the purpose of expressing our opinion on the general-purpose financial statements and not to provide assurance on the internal control structure. Accordingly, we do not express such an opinion.

We noted a certain matter involving the internal control structure and its operation that we consider to be a reportable condition under standards established by the American Institute of Certified Public accountants. Reportable conditions involve matters coming to our attention relating to significant deficiencies in the design or operation of the internal control structure that, in our judgment, could adversely affect the Town's ability to record, process, summarize, and report financial data consistent with the assertions of management in the general-purpose financial statements.

Independent Auditor's Report on the Internal Control Structure Based on an Audit of General-Purpose Financial Statements Performed in Accordance with Government Auditing Standards

A material weakness is a reportable condition in which the design or operation of one or more of the internal control structure elements does not reduce to a relatively low level the risk that errors or irregularities in amounts that would be material in relation to the general-purpose financial statements being audited may occur and not be detected within a timely period by employees in the normal course of performing their assigned functions.

Our consideration of the internal control structure would not necessarily disclose all matters in the internal control structure that might be reportable conditions and, accordingly, would not necessarily disclose all reportable conditions that are also considered to be material weaknesses as defined above. However, we believe the reportable condition described above is not a material weakness.

GENERAL FIXED ASSETS

The Town does not maintain a formal accounting system for fixed assets. However, the Town has initiated development of such a system. In general, accounting for fixed assets provides information for estimating the amount of insurance needed, covers responsibilities of stewardship involved in safeguarding the assets, and allows for depreciation to be estimated when applicable. An accounting of fixed assets is required for preparation of a complete financial report in accordance with generally accepted accounting principles.


We recommend that fixed asset accounting be implemented as part of the overall accounting system of the Town.

We also noted other matters involving the internal control structure and its operation or opportunities for better efficiency and/or cost savings that we have discussed with management or specific individuals involved. These matters include the following:

1. Capital Equipment and Improvements Fund - The fund balance of \$16,686 in this capital project fund has been in existence for sometime. We suggest that consideration be given to a transferring the balance to the newly created, Municipal Building Fund - Expendable Trust Fund, established at the 1996 Town Meeting.
2. Building Department - Fees Collected - Currently there is no control sheet utilized when fees are entered into the Town's cash register. We suggest that a control sheet be used which would categorize and total the monies collected. To this sheet, all the pre-numbered receipts could be attached as supporting documentation. These control sheets could then be used for reconciliation purposes.

This report is intended for the information of the management and the Town. However, this report is a matter of public record, and its distribution is not limited.

TO THE INHABITANTS OF MEREDITH QUALIFIED TO VOTE IN TOWN AFFAIRS:

You are hereby notified to meet at St. Charles Auditorium, 281 Daniel Webster Highway, in said Town on the second Tuesday of March next, March 11, 1997, from 7:00 AM until 7:00 PM for the casting of ballots; and at 7:00 PM, Wednesday, March 12, 1997, at the Inter-Lakes Junior/Senior High School Gym, 1 Laker Lane, in said Town to act on the following articles:

BALLOT ARTICLES TO BE ACTED UPON:

ARTICLE 1

To bring your ballots for:

- One (1) Selectman for three (3) years
- One (1) Trustee of Trust Funds for three (3) years
- One (1) Trustee of Trust Funds for two (2) years
- Three (3) Library Trustees for three (3) years

ARTICLE 2

Shall we modify the elderly exemptions from property tax in the Town of Meredith, based on assessed value, for qualified taxpayers, to be as follows: for a person 65 years of age up to 75 years, \$20,000; for a person 75 years up to 80 years, \$30,000; for a person 80 years of age or older \$40,000?

To qualify, the person must have been a New Hampshire resident for at least 5 years, own the real estate individually or jointly, or if the real estate is owned by such person's spouse, they must have been married for at least 5 years. In addition, the taxpayer must have a net income of not more than \$15,000 or, if married, a combined net income of less than \$20,400; and own assets not in excess of \$50,000 excluding the value of the person's residence."

ARTICLE 3

Are you in favor of adopting Amendment No. 1 as proposed by the Planning Board for the Meredith Zoning Ordinance having to do with "accessory uses?"

Purpose of the proposed amendment: To clarify that an accessory use must be a subordinate use, clearly incidental to and related to the principal structure, building or use of the land. Additionally, aircraft landings and takeoffs would not be permitted as an accessory use to a residential use.

ARTICLE 4

Are you in favor of adopting Amendment No. 2 as proposed by the Planning Board for the Meredith Zoning Ordinance having to do with "Maximum Lot Coverage?"

Purpose of the proposed amendment: To clarify the scope and intent of the existing definition and regulation of "Maximum Lot Coverage" to include gravel surfaces.

ARTICLE 5

Are you in favor of adopting Amendment No. 3 as proposed by the Planning Board for the Meredith Zoning Ordinance having to do with a comprehensive rewrite of the Wetlands Conservation District provisions?

Purpose of the Amendment: To simplify the ordinance by eliminating confusing and conflicting terminology; to reduce buffer and septic leach bed setback requirements based upon current wetland and soils science; to exempt certain small, isolated wetlands from local regulatory jurisdiction.

ARTICLE 6

Are you in favor of adopting Amendment No. 4 as proposed by the Planning Board for the Meredith Zoning Ordinance having to do with the front setback provisions in the Central Business District?

Purpose of the Amendment: To eliminate the flexible front setback provision which allows the front setback to be as minimal as that of the nearest building within 200 feet. Eliminating this provision will result in a standard 30 ft. front setback throughout this district.

ARTICLE 7

Are you in favor of adopting Amendment No. 5 as proposed by the Planning Board for the Meredith Zoning Ordinance having to do with administrative housekeeping?

Purpose of the amendment: To renumber articles, sections and paragraphs; to delete any duplications within the ordinance.

DELIBERATIVE SESSION

ARTICLE 8

To see if the Town will vote to (i) raise and appropriate the sum of One Million Four Hundred Thousand Dollars (\$1,400,000.00) for the purpose of water and sewer main replacements, improved underground drainage, reconstruction and construction of sidewalks, and road resurfacing on Pleasant Street; said appropriation to be inclusive of State or Federal grants-in-aid, or contributions from other sources; (ii) to authorize the issuance of serial bonds or notes in accordance with the provisions of the Municipal Finance Act, Chapter 33 , of the said appropriation, provided , however, that the total amount of bonds or notes to be issued shall be reduced by the amount of such grants-in-aid, or contributions from other sources; (iii) to authorize the Town Treasurer to make temporary borrowings, in accordance with the provisions of said Chapter, in anticipation of the receipt of the proceeds of said bonds or notes, and (iv)to authorize the Treasurer to determine the method and manner of sale of such bonds, notes, and temporary borrowings, as shall be in best interest of the Town, including the authority to enter into a Tax Regulatory Agreement containing such representations and covenants as are necessary to maintain such notes and temporary borrowings; to authorize the Selectmen and Town Manager to apply for and accept any or all State or Federal grants-in-aid, or other contributions in aid of the project and to expend the appropriation in accordance herewith. (Passage requires affirmative vote of two-thirds present and voting) **Recommended by the Board of Selectmen**

ARTICLE 9

To see if the Town will vote to (i) raise and appropriate the sum of Seven Hundred Seventy Six Thousand Dollars (\$776,000.00) for the purpose of building a Community Center at Prescott Park, said appropriations to be inclusive of contributions from other sources; (ii) to authorize the issuance of serial bonds or notes in accordance with the provisions of the Municipal Finance Act, Chapter 33, of the said appropriation, provided, however, that the total amount of bonds or notes to be issued shall be reduced by the amount of such grants-in-aid, or contributions from other sources; (iii) to authorize the Town Treasurer to make temporary borrowings, in accordance with the provisions of said Chapter, in anticipation of the receipt of the proceeds of said bonds or notes; and (iv) to authorize the Town Treasurer to determine the method and manner of sale of such bonds, notes and temporary borrowings, as shall be in the best interest of the Town, including the authority to enter into a Tax Regulatory Agreement containing such representations and covenants as are necessary to maintain such notes and temporary borrowings; to authorize the Selectmen and Town Manager to apply for and accept any contributions in aid of the project and to expend the appropriation in accordance herewith. (Petitioned by 25 or more legal voters of the Town of Meredith) (Passage requires affirmative vote of two-thirds present and voting) **Not Recommended by the Board of Selectmen**

ARTICLE 10

To see if the Town will vote to adopt New Hampshire RSA 162-K, allowing the Town Meeting to establish Municipal Economic Development and Revitalization Districts. Such districts allow public infrastructure improvements to be built or improved and any debt repaid by future tax increments within the proposed district; each proposed district shall have a development program and a tax increment financing plan prior to the Town Meeting approving a particular district. **Recommended by the Board of Selectmen**

ARTICLE 11

To see if the Town will vote to establish a developmental district entitled "Needle Eye and Route 3 South District", as shown with a development program and tax increment financing plan as presented. In addition, to require the Town Manager to serve as District Administrator per RSA 162-K:13 and grant administration powers as allowed by said statute; the Board of Selectmen (governing body) shall create a district advisory board and appoint three members, solely owners or occupants of real property within or adjacent to the district. Once such a district is established, the Board of Selectmen shall by resolution, delineate the powers and duties of the advisory board.

And further, to see if the Town will vote to (i) raise and appropriate the sum of Four Hundred Thousand Dollars (\$400,000.00) for the purpose of district infrastructure improvements; said appropriations to be inclusive of serial bonds or notes in accordance with the provisions of the Municipal Finance Act, Chapter 33, of the said appropriation, provided, however, that the total amount of bonds or notes to be issued shall be reduced by the amount of such grants-in-aid, or contributions from other sources; (iii) to authorize the Town Treasurer to make temporary borrowings, in accordance with the provisions of said Chapter, in anticipation of the receipt of the proceeds of said bonds or notes; and (iv) to authorize the Treasurer to determine the method and manner of sale of such bonds, notes and temporary borrowings, as shall be in the best interest of the Town, including the authority to enter into a Tax Regulatory Agreement containing such representations and covenants as are necessary to maintain such notes and temporary borrowings; to

authorize the Selectmen and Town Manager to apply for and accept any or all State or Federal grants-in-aid, or other contributions in aid of the project and to expend the appropriation in accordance herewith. Proposed revenue would include sewer access fees within the district and future property tax increments. (Passage requires affirmative vote of two-thirds present and voting) **Recommended by the Board of Selectmen**

ARTICLE 12

To see if the Town will vote to rescind the remaining bond authorization from the East Bluff Highlands Sewer Extension Improvement Project voted per Article 5 of the March 14, 1995 Town Meeting. The amount of the remaining bond authorization is Forty Nine Thousand Six Hundred Eighty Five Dollars and Ninety Two Cents (\$49,685.92). The project is now complete. **Recommended by the Board of Selectmen**

ARTICLE 13

To see if the Town will vote to discontinue, both layouts of Lang Street Extension , so-called(between Lake and Dover Street) dividing the Chase property, contingent upon planning and/or Zoning Board approval(s) of the project called "Chase House at Mill Falls" and requiring vehicular access to be provided by right of way to the adjoining side lines of lots Tax Map U-6, lots 77 & 105 (April 1, 1996 Tax Map version), currently provided by said Town Street; and further to provide or retain existing utility and drainage easements to the Town of Meredith and to allow public vehicle access between Dover and Lake Streets.

Provided that in the event of structure(s) being destroyed by fire or other acts and if any structure(s) remain vacant for a period of one year, such discontinuance shall become null and void by vote of the Board of Selectmen and the layout of 1862 shall be returned to the Town of Meredith.

ARTICLE 14

To see if the Town will vote to allow POW/MIA memorial statue #1 (as displayed) to be placed in Hesky Park.

ARTICLE 15

Are you in favor of banning the placement of any statues in Hesky Park? (Petitioned by 25 or more legal voters of the Town of Meredith)

ARTICLE 16

To see if the Town will vote to raise and appropriate the sum of Thirty Five Thousand Dollars (\$35,000.00) to be added to the Employee Benefits Expendable Trust Fund previously established. The Selectmen are agents to expend. Funding is already appropriated within the operating budget.
Recommended by the Board of Selectmen

ARTICLE 17

To see if the Town will vote to raise and appropriate the sum of Fifty Thousand Dollars (\$50,000.00) to be added to the Public Works Dump Truck Replacement Expendable Trust Fund previously established. The Selectmen are agents to expend. Funding is already appropriated within the operating budget.
Recommended by the Board of Selectmen

ARTICLE 18

To see if the Town will vote to raise and appropriate the sum of One Hundred Thousand Dollars (\$100,000.00) to be added to the Sand/Salt Storage Building Expendable Trust Fund previously

established. The Selectmen are agents to expend. Funding is already appropriated within the operating budget. **Recommended by the Board of Selectmen**

ARTICLE 19

To see if the Town will vote to appropriate the sum of Two Hundred Ninety Eight Thousand Three Hundred Twenty Nine Dollars and Thirty Six Cents (298,329.36) to be added to the Landfill Closure Expendable Trust Fund previously established. The sum of Seventy Five Thousand Dollars (\$75,000.00) to be raised by taxation and to authorize the transfer of the December 31, 1996 Fund Balance of Two Hundred Twenty Three Thousand Three Hundred Twenty Nine Dollars and Thirty Six Cents(\$223,329.36). The Selectmen are agents to expend. Funding is already appropriated within the operating budget. **Recommended by the Board of Selectmen**

ARTICLE 20

To see if the Town will vote to raise and appropriate the sum of Fifty Thousand Dollars (\$50,000.00) to be added to the Municipal Building Expendable Trust Fund previously established. Funding is already appropriated within the operating budget. **Recommended by the Board of Selectmen**

ARTICLE 21

To see if the Town will vote a “Special Warrant Article” to raise and appropriate the sum of Fifty Thousand Dollars (\$50,000.00) for the additional construction of Community Park. The sum of Thirty Eight Thousand Four Hundred Dollars (\$38,400.00) to be raised by taxation and Eleven Thousand Six Hundred Dollars (\$11,600.00) to be transferred to the General Fund from the Land Use Change Tax Fund. This will be a non-lapsing account per RSA 32:3, VI and will not lapse until the Park is completed or in three (3) years following the end of the fiscal year, which ever is less. Funding is already appropriated within the operating budget. **Recommended by the Board of Selectmen**

ARTICLE 22

To see if the Town will vote to raise and appropriate the sum of Thirty Six Thousand Seven Hundred Dollars (\$36,700.00) for the following purposes:

- \$20,000.00 State Aid Reconstruction Program -2 to 1 match for improvements to various roads under the State Aid Reconstruction Program, provided that the State of New Hampshire appropriates Forty Thousand Dollars (\$40,000.00) ; and
- \$16,700.00 Community Enhancement Program - Safety and aesthetic improvements on Route 3 North.

Funding is already appropriated within the operating budget. **Recommended by the Board of Selectmen**

ARTICLE 23

To see if the Town will vote to appropriate the sum of Six Thousand Five Hundred Dollars (\$6,500.00) for the purpose of Route 3 & 25 Planning. Funding is already appropriated within the operating budget. **Recommended by the Board of Selectmen**

ARTICLE 24

To see if the Town will vote to (i) raise and appropriate the sum of Ninety Thousand Dollars (\$90,000.00) for the purpose of a Sewer Collection Main on Westbury Road, providing that the property owners on Westbury Road authorize a betterment assessment on Ninety Thousand Dollars (\$90,000.00) plus interest; said appropriation to be inclusive of State or Federal grants-in-aid, or contributions from other sources; (ii) to authorize the issuance of serial bonds or notes in accordance with the provisions of the Municipal Finance Act, Chapter 33, of the said appropriation, provided, however, that the total amount of bonds or

notes to be issued shall be reduced by the amount of such grants-in-aid, or contributions from other sources; (iii) to authorize the Town Treasurer to make temporary borrowings in accordance with the provisions of said Chapter, in anticipation of the receipt of the proceeds of said bonds or notes; and (iv) to authorize the Treasurer to determine the method and manner of sale of such bonds, notes, and temporary borrowings, as shall be in the best interest of the Town, including the authority to enter into a Tax Regulatory Agreement containing such representations and covenants as are necessary to maintain such notes and temporary borrowings; to authorize the Selectmen and Town Manager to apply for and accept any or all State or Federal grants-in-aid, or other contributions in aid of the project and to expend the appropriation in accordance herewith. Proposed revenue would include landowner betterment assessments in the amount of \$90,000.00 as requested by the property owners. (Passage requires affirmative vote of two-thirds present and voting) **Recommended by the Board of Selectmen**

ARTICLE 25

To see what sum the Town will vote to raise and appropriate for the necessary operational expenses of the Town for the ensuing year's budget.

ARTICLE 26

To see if the Town will vote a "Special Warrant Article" to raise and appropriate the sum of Fifteen Thousand Dollars (\$15,000.00) for a local Main Street Program, provided that the Town is selected for inclusion in the New Hampshire Main Street Program. This will be a non-lapsing account per RSA 32:3, VI. The appropriation will not lapse for three (3) years. **Recommended by the Board of Selectmen**

ARTICLE 27

To see if the Town will vote to authorize the Selectmen to enter into a short-term lease purchase agreement in the amount of Ninety Thousand Dollars (\$90,000.00) payable over a two to three year term for the purpose of leasing a Dump Truck for the Department of Public Works. There is no funding requirement for this lease in the current year. **Recommended by the Board of Selectmen**

ARTICLE 28

To see if the Town will vote to raise and appropriate \$5,000 to support the Winnepesaukee Skating Club, anon-profit organization, in its efforts to construct an ice arena in Laconia to provide recreational opportunities for Lakes Region families, with said appropriation authorized pursuant to RSA 31:4. (Petitioned by 25 or more legal voters of the Town of Meredith) **Not Recommended by the Board of Selectmen**

ARTICLE 29

To see if the Town of Meredith will vote to raise and appropriate the sum of \$12,000.00 for the Youth Services Bureau's Court Diversion services for first offenders (an effective alternative to the juvenile court system) and other youth oriented programs, i.e. The Challenge Course and CHINS Diversion. (Petitioned by 25 or more legal voters of the Town of Meredith) **Not Recommended by the Board of Selectmen**
