

TOWN WARRANT

The State of New Hampshire

To the Inhabitants of the Town of Bristol in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Bristol on Tuesday, the tenth day of March, next at twelve of the clock noon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

Business meeting for action on all other articles will begin at 8 p.m.

- 3. To see what sum of money the Town will raise for the maintenance of Highways and Bridges for the year ensuing and make appropriations of the same.
- 4. To see if the Town will ask for Town Road Aid, and if so, raise and appropriate \$425.19; provided this amount is raised by the Town, the State will contribute the sum of \$2,834.60.
- 5. To see what sum of money the Town will vote to raise for the construction and Maintenance of Sewers for the ensuing year and make appropriation of same.
- 6. To see what sum of money the Town will vote to raise for the construction of sidewalks for the year ensuing and make appropriation for the same.

- 7. To see if the Town will vote to appropriate \$500. from the surplus in the Town treasury to cut brush on highways the same to be under the direction of the selectmen.
- 8. To see if the Town will vote to raise and appropriate twenty and seven-tenths cents. (20.7c), on each one hundred dollars of the current assessed valuation of the town, which is the sum of six thousand two hundred dollars (\$6.200.) said sum to be used by the Park Commission to establish, maintain and conduct a system of Public recreation; to equip, maintain and operate the playground instructors and supervisors as said commis-Community Center Bui'ding, to prepare, equip and maintain our public playground and employ such leaders, sion shall deem necessary. Said Park Commission may, from time to time, consult with the Community Center Council or its successors, provided however, that said Community Center Council shall act in an advisory capacity only.

9. To see if the Town will vote to authorize the Selectmen to negotiate for purchase of a suitable tract of land convenient to the center of the town, for use as a parking lot and to authorize and direct them to make said purchase if the same can be obtained at a cost of not to exceed \$5,000, said sum to be taken from the town's unexpended balances and surplus. And to see if the town will authorize and direct the town's Selectmen to remove the building and grade and improve the above mentioned let, when and if purchased, at a cost of not to exceed \$7,000, and to issue serial bonds or notes payable at a rate of not to exceed \$1,000, a year for the purpose of improving said parking lot, provided one can be obtained.

- 10. To see if the Town will vote to adopt the provisions of the Municipal Budget law, and repeal any prior vote in regard to a Budget Committee. (B) To determine the number of members at large of the Committee and to choose the same by ballot or to delegate the Moderator to appoint same.
- 11. To see if the Town will authorize the Selectmen to accept a relocation or part of the Batten road so-called, when completed to their satisfaction and the Town given a warranty deed of same and to discontinue the portion of existing highway which will be no longer used after the new highway has been accepted.
- 12. To see if the Town will vote to appropriate a sum not to exceed ten thousand dollars (\$10,000.00), for the purchased of a new 1,000 gallon tank truck, pumper and associated equipment for the use of the Fire Department; to raise said sum by borrowing on the credit of the Town through the issuance of serial notes or bonds, said notes or bonds to be signed by the Selectmen, countersigned by the Treasurer and sealed with the Town seal; and delegate to the Selectmen the discretion of fixing that date, maturities, denominations, interest or discount rate, the place of payment, the form and other details of said bonds or notes and of providing for the sale thereof.
- 13. If the Town votes to purchase a new tank truck, pumper and associated equipment as contemplated by article 12 in its present or any amended form, to see if the Town will vote to authorize the Selectmen to sell or otherwise dispose of the Reo 500 gallon tank truck pumper now in the service of the Fire Department for such consideration and upon such terms as the Se'ectmen shall deem to be in the best interests of the Town.

- 14. If the Town does not vote to purchase a new tank truck, pumper and associated equipment as contemplated by article 12 in its present or any amended form, to see if the Town will vote to raise and appropriate the sum of two thousand dollars (\$2,000.00) for the establishment of a capital reserve fund for financing the cost of acquisition of a new 1,000 gallon tank truck, pumper and associated equipment for the use of the Fire Department, said sum to be held and invested by the trustees of trust funds in accordance with the provisions of chapter 35, New Hampshire Revised Statutes, Annotated.
- 15. To see if the Town will vote to raise and appropriate a sum of money to gravel and oil the Frank Keezer road so-called from the Mayhew Turnpike to the Rotary Picnic Area, a distance of about a quarter (1/4) of a mile.
- 16. To see if the Town will vote to raise and appropriate the sum of Five hundred dollars (\$500.00) to the Newfound Region Chamber of Commerce for the purpose of publicizing and promoting the natural advantages and resources of the Town, in cooperation with other towns in the Newfound Region.
- 17. To see if the Town will vote to raise and appropriate the sum of \$306.00 which is 1/100 of 1% of the assessed valuation of the Town, to the Lakes Region Association for the purpose of publicizing and promoting the natural advantages and resources of the Town, in cooperation with other towns in the Lakes Region.
- 18. To see what sum of money the Town will vote to raise for the observance of Memorial Day and make appropriation of same.
- 19. To see if the Town will raise and appropriate a sum of money for the Laconia and Franklin Hospitals.
- 20. To see if the Town will vote to accept a bequest of \$1,000, from the Estate of Harry E. Stevens for cemetery purposes.

- 21. To see if the Town will vote to accept the State Mutual Fire Aid law.
- 22. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of Taxes.
- 23. To transact any other business that may legally come before said meeting.

Report of Board of Trustees

The customary activities of the Minot-Sleeper Library have been carried on during the past year, under the supervision of the Librarian, Miss Mary A. Rogers, and her assistant, Miss Nellie Ferrin. The Library is open each Monday, Wednesday and Saturday from 1 to 9 P.M.

The Librarian reports the following circulation of books: Adult fiction 9,417, non-fiction 1,076; Junior fiction 2,307, non-fiction 550; new books purchased 128; gift books 21; memorial books 2. Circulation from Bookmobile 918; from State Library 25; loaned to High School 40. Total circulation 14,333. Collected from fines \$54. Sale of History of Bristol \$20.

International Packings Corp. have contributed a Bookshe'f of American Studies consisting of 35 volumes to date.

In order to make more and better books available in the High School, the Library Trustees have designated the Bristol High School as a Branch Library. This enables the school to get books directly from the Bookmobie aid has laid the foundation for a circulating library where students may carry on effective research, use varied tools of learning and is also a source of recreational reading, all of which contributes to student development.

The income from the Minnie Maria Day-Jackman Fund supplies the Library Reading Room with these periodicals: American Heritage, Atlantic Monthly, American Girl, Animals, Better Homes & Gardens, Boys' Life, Coronet, Cosmopolitan, Field & Stream, Good Housekceping, Harpers, Holiday, Horticulture, Jack & Jill, Ladies' Home Journal, Life, Nation's Business, National Geographic (2 copies), Nature, New Hampshire

Profiles, Newsweek, Parents Magazine, Popular Hobbies, Popular Science, Reader's Digest (2 copies), Redbook, Saturday Evening Post, Scientific American, Science Digest, Sports, Time, Together, True Stories, U.S. News & World Report, Yankee, and the Bristol Enterprise.

The Chairman of the Board of Trustees, the Librarian and Assistant Librarian attended a regional librarians meeting last spring, in Rumney. The Librarians attended a similar meeting in Plymouth in November.

HEALTH REPORT

The following is a report of the activities conducted by the N.H. Department of Health, Bureau Public Health Nursing, for the town of Bristol for the year 1958.

A Salk Vaccine Clinic was held at the school June 2nd and 52 children received vaccine. My sincere thanks to the school personnel and the Bristol Woman's Club for their assistance at this clinic, also Dr. Greenan for his cooperation.

Home visits have also been made in Bristol and arrangements for children to attend diagnostic clinics at Concord and Laconia. Follow-up visits have been made on these cases for instructions to the mothers.

Plans are being made for a Pre-school Dental Fluorine program to be conducted in Bristol for children 3 to 6 years of age in the early summer if possible.

MUNICIPAL COURT

The Municipal Court of Bristol disposed of a large number of cases in 1958, though somewhat less than in 1957. 339 complaints were entered in 1958 as compared with 424 in 1957. An analysis of the nature of these cases is interesting, and in some instances disturbing.

289, or 85.25%, of the complaints were for motor vehicle violations, and 24 were for fish and game offenses. As usual unreasonable speed and crossing solid traffic lines comprised most of the motor vehicle offenses — 132 and 93 respectively — bearing witness to the impatience and carelessness of many drivers. It is notable that traffic records show a large proportion of accidents are caused by loss of control due to excessive speed, which vigilant police patrolling tends to minimize. We have good policing in this area. A disturbing increase occurred in convictions for driving while intoxicated, however, 13 in 1958 as compared to 2 in 1957. Newspaper reports seem to indicate that this offense is on the increase statewide

Fourteen convictions for petty larceny during 1958 attest to good police work in solving a series of thefts, and it is hoped that prompt imposition of penalties will discourage repetition of such criminal acts.

You are hereby notified to meet at the Town Hall in said District on the 5th day of March 1959, at eight o'clock in the afternoon, polls for balloting to be open from 8 o'clock to 9 o'clock or thereafter, to act upon the following subjects:

- 1. To determine and appoint the salaries of the School Board and Truant Officer, and fix the compensation of any other officers or agent of the district.
- 2. To hear the reports of Agents, Auditors and Committees in relation to any subject embraced in this warrant.
- 3. To choose Agents, Auditors and Committees in relation to any subject embraced in this warrant.
- 4. To see what sum of money the district will raise and appropriate for the support of schools, for the salaries of school district officials and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received from the state foundation aid fund together with other income; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.
- 5. To see if the district will vote to authorize the school board to make application for and to accept, on behalf of the district, any or all grants or other funds for educational purposes which may now or hereafter be forthcoming from the United States Government or from the State of New Hampshire.

- 6. To choose by non-partisan ballot all officers whose election by ballot is required by law.
- 7. To transact any other business that may legally come before said meeting.

SUPERINTENDENT, S REPORT

In the past year, Bristol school authorities have been engaged in studying the possibilities of forming a cooperative high school with the towns which send a considerable number of their pupils to the Bristol Memorial High Sshool. This study came about largely because of our increasing tuition rate. The law permits a district to charge its costs or the state average, depending on which is the lowest, to which may be added a 2 per cent rental fee for the building. As yet, Bristo! has not used the rental fee and has tried to keep its rate in a competitive position even though its costs have been slightly higher than the rate charged. Since the total received for high school tuition is a considerable amount, the voters in Bristol should realize that the loss of pupils from a single adjacent school district could make considerable change in this figure and that such is always a possibility. At the mement the co-op studies have ceased.

Once in a while I get the impression from the public that Supervisory Union No. 4 is made up of only a district or two. Actually we have nine districts in this union which circles the Cardigan Mt. and Newfound Lake area. Eight of these districts operate schools, it is 38 miles from the schools at either extremity, all reports must be made out for each of the nine districts, and there isn't too much correlation between the size of a place and the work involved. Only one other union has the doubtfu¹ distinction of having as great a number of districts. We work with only one secretary working 11 months of the year, and without assistant superintendents, helping teachers, and non-teaching principals, except in the case of Bristol Memorial High School, The state contributes \$4,000 which is more than in most unions, toward the intendent's salary. This amount, \$4,000, is based upon an equalized valuation formula. The above are facts and are submitted to you as such.

PART TIME TEACHER. The school board has put \$1800 in the budget in teachers' salaries in the hopes of hiring a part time teacher for the elementary school in order to try to do several things: 1. To permit Mr. Armstrong to have some free periods to assume greater responsibilities as a principal, to permit more testing of individual pupils, to be able to do more guidance and home visitation work: 2) to be able to have a few classes to help those not working up to capacity in a given subject, particularly reading. Obviously, almost any single one of the above items could take a great deal of time but we will be most grateful for a part time teacher in order to help our pupils.

MINIMUM STANDARDS. With the addition of Art Appreciation as an activity, Bristol Memorial High School now meets the "minimum standards." We have added a teacher to the high school which has strengthened both math and science teaching, permits Mr. Genetti to do more supervising, more guidance work, and has increased teacher supervision of the library. With the splendid cooperation of the library trustees we now operate a sub-station library at the high school which permits more economical use of money, increases greatly the number of books available to the high school, increases circulation of library books, and seems to make a lot of sense. We fee! that as a result of the minimum standards and by working closely with the men in the State Department of Education, we have improved the educational facilities for the pupils in this area. Probably no one has argued more strongly about certain details of these standards than I have with the "boys in the office" but we would be the first to admit that they've been a good influence. It is difficult to get better education by doing a poorer job on less and less. Our biggest problem is to offer beneficial educational programs to all the pupils of all the people. The day when public high schools had as its only function the preparation of "the select" for the Ivy League college disappeared 50 years ago, if it ever existed, and to return to this, even as a primary function, would eliminate a big majority of our pupils.

TEACHERS' SALARIES. Without comment are submitted the following facts about salaries: National average \$4,650; three highest: California \$5,925, New York \$5,800, Delaware \$5,700; New Hampshire \$3,967 or [2ad; below N.H. are Iowa, the "deep south", Nebraska, Vermont, Maine, North and South Dakota; Bristol's \$4,018.

NATIONAL DEFENSE ACT. Details of meeting the requirements of the National Defense act should be known by the time of our district meeting. Briefly stated, this act provides for federal funds at the state and local levels in certain areas of education such as mathematics, science, foreign languages and guidance, with matching funds required. It may be necessary to have special articles in the warrant in case we wish to take advantage of this law.

STATE BUILDING AID. This will total \$4,251.13 which is the only aid Bristol receives. While this is not a great amount for a single year, when spread over the lifetime of a bend issue it becomes a very material amount. Not many years ago there was no building aid at all. Local members of the legislature have worked hard for this from the beginning. It is a factor which has helped to maintain a very stable tax rate in Bristol in spite of rising costs of everything including education.
