SELECTMEN'S REPORT

Looking Back:

In March 2007 voters approved four capital budget items that were completed during the year: 1) a sidewalk on South Street between Front Street and Fourth Street, 2) a new highway truck and snow plow with sander, 3) a used pickup truck for the Fire Department and 4) a new gravel parking lot at the Fire Station to replace parking area taken for the fire station addition. The new equipped highway truck came in under budget at \$96,821 and the old truck was sold for \$7,000 in February 2008. The other items came in on budget.

Budget authorization for demolition of the Old Redmen's Club building and authorization for survey and legal cost required to place conservation easements on Scoutland were not undertaken because proposed costs exceeded budget appropriations. The 2007 budget appropriations were held in liabilities at the end of 2007 and additional budget requests for these two items appear in the 2008 Town Warrant.

Looking Ahead:

As in 2007, the 2008 Town Warrant presents voters with several important decisions that will impact 2008 tax rates and town development in the future. We encourage residents to review the School and Municipal Warrants posted in the Town Hall, the School, the Post Office, and on the Town Web site (www.rollinsford.nh.us/). Articles I-IV will be voted on by ballot at the Town Hall on March 11 between 10AM and 7PM. The remaining Articles will be acted on at the business session of the Town Meeting on Saturday, March 15 at the Rollinsford Grade School starting at 9AM. Voters who cannot vote on the first four Articles on March 11, may vote by absentee ballot obtained from the Town Clerk.

Article II proposed by the Planning Board to amend zoning ordinance is essentially the same as the 2007 warrant Article VI that failed to pass. This amendment places limits on some commercial and multiple family uses in the Suburban Residential zones and the Countryside Residential zone.

Article III proposed by the Planning Board is essentially a minor housekeeping correction that clarifies the difference between a home occupation and a home business as related to the number of permitted children in a child care operation.

Article IV is a petitioned Article, which is essentially the same as Article V in the 2007 warrant that was defeated by the voters. The Planning Board voted not to support this proposed Article after a public hearing was held as required by law. This Article will permit the establishment of single house lots that are accessed by private shared driveways, instead of on class V roads as is currently required. The Selectmen oppose Article IV as petitioned because the Planning Board has not analyzed the full consequences of this change in the zoning ordinance.

Preliminary analysis by the Board of Selectmen indicates that up to 250 new buildable lots would become possible immediately in Rollinsford on private shared driveways. This number would represent nearly a 30% increase in single family units. Currently, the Planning Board has not established standards for private shared driveways in the Subdivision Ordinance. The rate of growth could increase rapidly in the next few years. Public safety issues, impacts on schools, and public service impact must be researched and understood. Impacts on as-

sessed land values could force premature development. The Selectmen feel it is not appropriate to pass this Article before analysis of the environmental, fiscal, and quality of life issues in the Town are completed. Rollinsford is unique because of open space and small town amenities. A mistake in planning could lead to many unanticipated consequences that could not be corrected later. A rush to change our land use ordinances is unwise and unnecessary.

The proposed 2008 Municipal Budget calls for a total appropriation of \$1,919,984 (\$1,276,184 for the operating budget and \$643,800 for capital items). The proposed increase of \$145,677 in the municipal budget is offset by a revenue increase of \$146,597. Thus, the municipal tax rate is not expected to increase.

Employee benefits-health insurance, retirement contributions, fuel costs and a \$25,000 increase in the contingency line item accounts for most of the \$65,550 increase in the operating budget.

The police budget calls for the Police Chief to retire in June and return as Chief for 30 hours per week without health insurance offered by town. A new fulltime patrolman position is also proposed beginning in June 2008. The additional cost of the new patrolman's position would be offset by reductions in the Police Chief salary and reductions in part-time salaries and the overtime line item made possible by the additional patrolman. In the 2009 budget the salary budget would increase about \$10,000 when the new patrolman's position requires financing for the full year.

The \$82,500 increase in the capital budget reflects 2 new capital items for 2008. first, Article XIX proposes an appropriation of \$225,000 to finance a new equipment building and a salt shed to be built near the transfer station building on Jesse Doe Road. This would be financed with funds taken from the Highway Building Fund and town surplus. This item will be paid for with available funds, thus no bonding will be required. The second new capital item (Article XX) requests a \$128,000 appropriation to renovate the leaking Town Hall tower, which needs some significant repairs. Funds from the surplus is also proposed as the means to finance this cost. If the Highway Building is authorized by the Town Meeting, the present Highway Building and its lot on Silver Street would be sold and the revenue used to replace funds withdrawn from the surplus fund.

Article XXIII is a petition warrant article that calls for changing the name of Ross Road back to Old Wentworth Pasture. The Selectmen feel that any new street name that includes the name Wentworth is inappropriate for safety reasons. Rollinsford already has an existing house on a right of way called Wentworth Street that is recognized by the 911 system. The 911 system opposes establishing more than one street in a town that includes part of a name used elsewhere in town, because of possible confusion in dispatching fire, police and ambulance response in time of emergency.

Again Selectmen wish to recognize the many hours of service provided by unpaid volunteers who serve on Boards and Committees in the Town. Likewise, we recognized the contributions of the Police, Fire, Highway, Transfer Station and administrative employees.

You are hereby notified that the polls will be open from 10 a.m. to 7 p.m. at the Rollinsford Town Hall, on Tuesday, March 11, 2008 to bring in your ballot for the Town Officers to be elected in Article I, and to vote by ballot on Articles II – IV, and then to meet at the Rollinsford Grade School at 9 a.m. on Saturday, March 15, 2008 to act on the budget and other Articles in the Warrant.

ARTICLE I

To bring in your ballots for:

- One (1) Selectman and Overseer for the Poor for three (3) years.
- Town Clerk for one (1) year.
- Town Treasurer for one (1) year.
- Chief of the Fire Department for one (1) year.
- Moderator for (2) years.
- Three (3) members of the Budget Committee for three (3) years.
- One (1) Trustee of the Trust Funds for three (3) years.
- One (1) Trustee of the Library Trust for three (3) years.
- One (1) Trustee of the Cemetery Trust for three (3) years.
- One (1) Supervisor of the Checklist for six (6) years.
- One (1) Supervisor of the Checklist for four (4) years.
- One (1) Supervisor of the Checklist for two (2) years.

ARTICLE II

Are you in favor of the adoption of Amendment No. 1 as proposed by the Planning Board for the Rollinsford Zoning Ordinance as follows: To amend Table 6.9 in relation to uses allowed in various Zoning Districts. Specifically to amend the allowed uses in the Suburban Residential 1 (SR1), Suburban Residential 2 (SR2) and the Country Residential (CR) Districts to limit certain non-residential and multi-family uses currently permitted in these rural residential districts?

ARTICLE III

Are you in favor of the adoption of Amendment No. 2 as proposed by the Planning Board for the Rollinsford Zoning Ordinance as follows: To amend Section 8.20A relating to home occupations to modify the number of children in a child care operation from "4 or less" to "3 or less" and Section 8.20B relating to home business ordinances to modify the number of children in a child care operation from "4 or less" to "6 or less"?

ARTICLE IV

Are you in favor of the adoption of Amendment No. 3 as proposed to amend Section 8.7.7 of the Rollinsford Zoning Ordinance as follows: This proposed amendment would allow having a shared driveway in a cluster subdivision. The

main conditions would be that the parcel has to be a minimum of 10 acres. All created new parcels would be required to be 5 acres; they could not be further subdivided and could only be used for single-family dwellings. the construction and maintenance of the driveway would not be the responsibility of the Town. the driveway would be required to be built in accordance with the driveway standards as stated in the Subdivision Regulations. No more than five dwellings would be allowed to use a shared driveway and the total length of the shared portion of the driveway would not be allowed to exceed on half mile. (NOTE: The full text of this proposed amendment is available to the public in the voting room)? BY PETITION (The Rollinsford Planning Board does not support Amendment No. 3)

ARTICLE V

To choose all other necessary Town Officers for the ensuing year.

ARTICLE VI

To see if the Town will vote to appropriate the sum equal to all revenues in excess of fifty thousand dollars (\$50,000.00) that may be received from the Hydro Electric Plant to be placed in the Town's Hydro Electric Fund. The first \$50,000.00 or any lesser amount that may be received will be used as offset against Town Budget expenditures (Majority vote required)

ARTICLE VII

To see if the Town will vot to raise and appropriate the sum of fifteen thousand dollars (\$15,000) and authorize the withdrawal of \$15,000 from the Land Trust Fund Capital Reserve to finance land survey and related expenses that may be incurred in assisting private land owners who donate Conservation Easements and/or to purchase options to buy critical lands the town wish to protect for open space or conservation uses. (Majority vote required)

ARTICLE VIII

To see if the Town will vote to raise and appropriate the sum of thirty thousand dollars (\$30,000) to be added to the Equipment Capital Reserve Fund previously established. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

ARTICLE IX

To see if the Town will vote to raise and appropriate sixty thousand dollars (\$60,000) for road reconstruction and drainage upgrades. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

ARTICLE X

To see if the Town will vote to raise and appropriate three thousand six hundred dollars (\$3600) for cemetery capital improvements. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

ARTICLE XI

To see if the Town will vote to raise and appropriate the sum of twenty thousand dollars (\$20,000) to be added to the Land Trust Fund previously established. Twenty thousand will be transferred from the Land Use Change Tax Fund to fund this appropriation. The Budget Committee and Selectmen recommend

this appropriation. (Majority vote required)

ARTICLE XII

To see if the Town will vote to raise and appropriate twenty five thousand dollars (\$25,000) and authorize the withdrawal of this amount from the Hydro Reserve Fund to be used as revenue to offset taxes in the 2007 budget. (Majority vote required)

ARTICLE XIII

To see the Town will vote to raise and appropriate twenty thousand dollars (\$20,000) to be placed in the Re-evaluation Capital Reserve Fund to be used for the Town property re-evaluation in 2010. The Budget Committee and the Selectmen recommend this appropriation. (Majority vote required)

ARTICLE XIV

To see if the Town will vote to raise and appropriate fifty thousand dollars (\$50,000) to add to the Highway Building Capital Reserve Fund that was established to hold money for the future construction of new highway buildings near the transfer station. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

ARTICLE XV

To see if the Town will vote to raise and appropriate fifty thousand dollars (\$50,000) to renovate the second floor of the Town Hall and to authorize the acceptance of private gifts and/or private grants to fund the renovation. (Renovation will not be undertaken until required gifts or grants have been received.) The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

ARTICLE XVI

To see if the Town will vote to raise and appropriate ten thousand dollars (\$10,000) to fund survey and legal costs associated with preparation of conservation easements on the Scoutland Conservation area currently owned by the Town and zoned for conservation uses and to authorize the withdrawal of \$10,000 from the Land Trust Capital Reserve Fund. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required) (This will be added to \$10,000 carried over from 2007 for this purpose)

ARTICLE XVII

To see if the Town will vote to raise and appropriate Twelve thousand two hundred dollars (\$12,200) to lease a new police cruiser that will replace the Ford cruiser scheduled to be retired. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

ARTICLE XVIII

To see if the Town will vote to raise and appropriate ten thousand dollars (\$10,000) for demolition of the Old Redman Club Building. (This will be added to \$10,000 carried over from 2007). The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

ARTICLE XIX

To see if the Town will vote to raise and appropriate two hundred twenty-five thousand dollars (\$225,000) to build a new Highway Building and a new salt shed on Jesse Doe Road near the Transfer Station Building. the revenue for this appropriation would be \$150,000 and interest removed from the Highway Building fund, and approximately \$75,000 taken from Town Surplus Funds. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

ARTICLE XX

To see if the Town will vote to raise and appropriate one hundred twenty-eight thousand dollars (\$128,000) for repair and renovation of the Town Hall tower to repair leaks and structural deficiencies. Funds for the renovation would come from surplus town funds Recommended by the Selectmen and Budget Committee. (Majority vote required)

ARTICLE XXI

To see if the Town will vote to raise and appropriate ten thousand (\$10,000) to seal leaks in the Town Hall basement, and to replace flooring damaged in the basement. the Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

ARTICLE XXII

To see if the Town will vote to raise and appropriate the budget committee recommended sum of one million two hundred seventy-six thousand one hundred eighty-four dollars (\$1,276,184.00) for general municipal operations. This article does not include capital articles addressed above. (Majority vote required)

To see if the Town will vote to change the name of Ross Road to Old Wentworth pasture. BY PETITION. (Majority vote required)

Gentlemen:

In planning and performing our audit of the financial statements of the Town of Rollinsford for the year ended December 31, 2006, in accordance with auditing standards generally accepted in the United States of America, we considered Town of Rollinsford's internal control over financial reporting as a basis for designing our auditing procedures for the purpose of expressing our opinion on the effectiveness of the Town's internal control. Accordingly, we do not express an opinion on the effectiveness of the Town of Rollinsford's internal control

Our consideration of internal control was for the limited purpose described in the proceeding paragraph and would not necessarily identify all deficiencies in internal control that might be significant deficiencies or material weaknesses. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant.

A control deficiency exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent or detect misstatements on a timely basis. A significant deficiency is a control deficiency, or combination of control deficiencies, that adversely affects the entity's ability to initiate, authorize, record, process, or report financial data reliably in accordance with generally accepted accounting principles such that there is more than a remote likelihood that a misstatement of the entity's financial statements that is more than inconsequential will not be prevented or detected by the entity's internal control. We consider the following deficiencies to be significant deficiencies in internal control:

Monthly Journal Entries

The Bookkeeper prepares monthly journal entries, adjustments, corrections or reclassification entries. These entries are then posted to the general ledger.

It is recommended that the Selectmen review the monthly entries and sign that the entries were reviewed and approved. This was recommended in the prior year report.

Purchase Orders

It was noted that some department heads are ordering goods/services before the purchase orders have been reviewed and approved by the selectmen.

It is recommended that department heads issue purchase orders to the selectmen for approval before goods/services are fulfilled. This would ensure that the selectmen are reviewing and approving the expenditures and department

heads are controlling their expenditures within the approved budget.

Cemetery Funds

The trustee of trust funds maintains a spreadsheet containing the names and amount paid for perpetual care of lots. When compared to the investments handled by the bank, there is a difference. The MS-9 report agrees to the bank amounts. This difference has been ongoing for years.

It is recommended that a reconciliation be done by the trustees and the selectmen to resolve this difference.

Conservation Commission

During the audit, it was noted that invoices could not be found to support certain expenditures.

It is strongly recommended that invoices be reviewed and approved before reimbursement checks are issued.

Fixed Assets

The Town does not maintain records of general fixed assets such as property and equipment with a life expectancy exceeding one year. The recording of fixed assets would fulfill the need to provide for physical dollar value control, and establish accountability for general government capital expenditures over the year.

With the recording of fixed assets, the related depreciation could be determined on an annual basis for the purpose of measuring the total cost of governmental services and evaluating the efficiency of programs. This was recommended in the prior year report.

They also spend the entire day at the Rollinsford Family fun day showing the kids what kind of skills they need to be a firefighter and giving them a chance to try it out for themselves, and in the evening hours are on standby during the fireworks display and dismantling of the equipment. The town is very lucky to have the dedication of these outstanding firefighters and the commitment that they have to this town.

ROLLINSFORD POLICE DEPARTMENT

Our overall activity continues to increase. We saw a significant increase in burglaries and domestic violence related assaults. 4348 calls for service were generated through the Strafford County Sheriff's Department Dispatch Center.

The majority of our times is spent on criminal investigations, follow ups, and administrative duties, as a direct result of the increase in the calls for service. As a result, less time is spent on patrol deterring the aggressive, drunk, and speeding driver.

Corporal Kristian Kerkensen continues to serve as the department's member to the Strafford County Accident Reconstruction Team. We have utilized their services for two major accidents and a crime scene. The Corporal is currently presenting his first DARE instruction to the students at the Rollinsford Grade School. We wish him and the students the best with the program.

The Town continues to be actively involved in the Pandemic Flue emergency response planning as well all hazards planning. Periodically, we will issue bulletins via the Grade School newsletter and the local newspaper.

If you know someone who is elderly, alone, housebound, has limited mobility issues, is on oxygen, or has other serious medical issues, you may call the Chief and have that person added to our Emergency Check List. In the event of a sustained power outage, storm or other unusual event, the police department will call or stop by the residence to check on the welfare of the individuals on the list and make whatever arrangements necessary, should they need further assistance.

We continue to check homes while the occupants are away on vacation, etc. To be added to the list, just call the station a few days before you leave, provided a little contact information, and while you are away, the officers will check the doors and windows to your home to make sure they are secure and look for attempted or actual break-ins or damage.

Always, lock the doors and windows to your home while away, even if you are just leaving for a few minutes. Always lock the doors to your vehicles, even if you park them in your driveway. There is an element within town that will take advantage of this and rummage through your vehicle if left unlocked.

Should you see or hear anything suspicious or unusual, please call us immediately, no matter how trivial you might think it to be.

The Rollinsford Police Benevolent Association continues to work hard at providing funding to many local youth and sport related organizations and events.

Many thanks to the citizens of Rollinsford for your past and present support I would also like to thank the town officials, elected and appointed members of the fire and highway departments, town committees, and the Rollinsford Grade School

community for their continued support of the police department. The Town of Rollinsford is unique in that it has such a group of dedicated individuals (paid and volunteer) that care so much about this community. When we all work together, only good things can happen.

ROLLINSFORD HISTORICAL COMMITTEE

The Rollinsford Historical Committee was particularly busy in 2007 in its appointed role of preserving and celebrating the town's historic heritage.

It's biggest project was in the replacemnt - again - of the footbridge spanning Fresh Brook. The floodwaters resulting from the severe northeasterly storm that peaked in coastal New Hampshire early on the morning of April 16, 2007, washed out the timber footbridge permitting Newichawannock Trail (also known as Fresh Creek Road) to cross this sizable brook. The timber bridge had been rebuilt in the fall of 2005 and survived without harm the so-called Mother's Day storm on May 14, 2006, although much debris was deposited at the bridge site. The 1.5 mile undeveloped track is one of Rollinsford's most popular hiking trails because of the pastoral beauty and historical ambience it offers. It crosses Fresh Brook not far upstream from Fresh Creek, much of which is now a pond following the construction downstream in Dover of the earthen causeway to allow passage of Gulf Road.

After a good deal of motor and foot reconnaissance, as well as telephone inquiries, the washed-out bridge was located on the shore of Cochecho Country Club. The country club management and supervisory staff were open to whatever course the Town of Rollinsford wished to take. After much discussion, the historical committee decided to sell the bridge to the country club and rebuild the footbridge from the abutments up. Committee members and town resident Dennis Drake, long a committee supporter and volunteer, poured new concrete atop the abutments and built stringers are now six feet above the mean level of the brook, providing that leeway of safety from future storms of the sort that seem to be occuring each spring.

An inaugural hike was held on Sunday, October 14, 2007, to display the new bridge and acquaint those who had not yet hiked the trail with its beauty and history. More than 30 residents and non-residents availed themselves of the opportunity. Some of the hikers opted to continue to St. Albans Cove on the Salmon Falls (Newichawannock) River.

On December 5, 2007, Michael Togias drove up from Massachusetts to present "The Indian Wars of New England", an event co-sponsored by the New Hampshire Humanities Council. In a good-neighbor gesture, American Legion Post No. 47 made its meeting hall available for the public lecture. As with the bridge hike, this presentation garnered a good attendance.

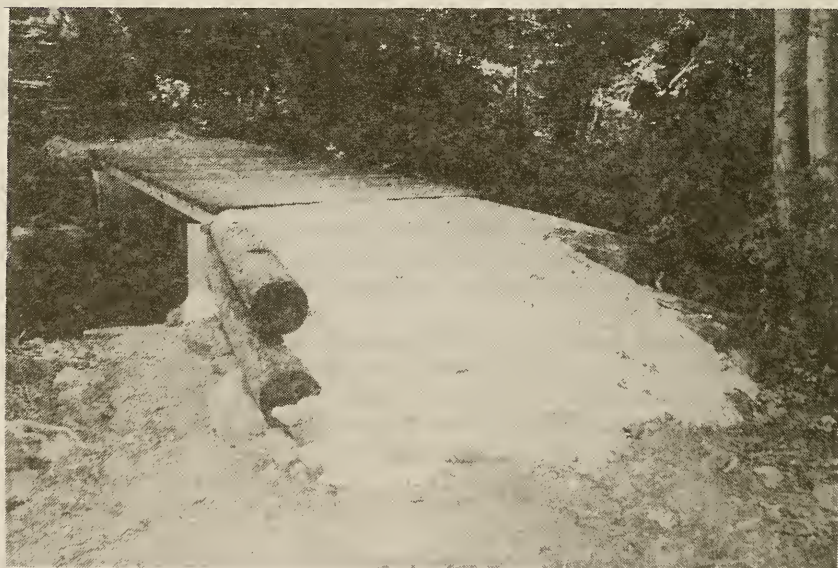

ROLLINSFORD CEMETERY TRUSTEES 2007 REPORT

In 2007 the trustees expended \$14,498.22 from the cemetery operating budget for Old Town, New Town and Doe cemeteries. The trustees expended \$60.00 of the operating budget for the yearly Memorial Day clean up in the Doe Burial Ground. The trustees expended \$1,167.25 from the Old Town and New Town capital budget for the repair of roadways and the repairing of broken stones. Total Cemetery operating and capital expenses for 2007 was \$15,665.47. Total cemetery expenses that the town pays. \$7,959.86. Total cemetery expenses that are paid from the perpetual care trust fund. \$7,705.61.

In 2007 a total of twelve graves were sold in New Town cemetery, for a total of \$4,200.00. The town of Rollinsford received \$2,100.00 and \$2,100.00 went into the perpetual care trust fund. In 2007 the town repurchased a two grave lot in New Town and later resold it.

In 2007 an additional four lots were added to the perpetual care list with a total of \$2,400.00 added to the perpetual care trust funds.

In 2007 the town received \$50.00 in tomb rental.

In 2007 a spring grave cleanup was conducted through volunteer labor.

In 2007 approximately twenty six grave stones were uplifted, leveled and reset in Old Town cemetery. Some of the gravestones were cracked and needed to be repaired with epoxy and then reset. This work was accomplished through volunteer labor.

In 2008 the trustees are hoping to continue this project.

The trustees would like to thank Dennis Drake for the many hours of volunteer labora that he put in on the Old Town gravestone project.

The trustees would also like to thank Charisse Baker, Pam Morgan and Beverly Dionne from the town office for the many hours that they put in working on cemetery business throughtout the year.

The Rollinsford Cemetery trustees would also like to thank all Rollinsford taxpayers for supporting the town cemeteres.

REPORT OF FOREST FIRE WARDEN AND STATE FOREST RANGER

Your local Forest Fire Warden, Fire Department, and the State of New Hampshire Division of Forests & Lands work collaboratively to reduce the risk and frequency of wildland fires in New Hampshire. To help us assist you, please contact your local Forest Fire Warden or Fire Department to determine if a permit is required before doing ANY outside burning. Under State law (RSA 227-L:17) a fire permit is required for all outside burning unless the ground is completely covered with snow. The New Hampshire Department of Environmental Services also prohibits the open burning of household waste. Citizens are encouraged to contact the local fire department or DES at 1-800-498-6868 or www.des.state.nh.us for more information. Safe open burning requires diligence and responsibility. Help us to protect New Hampshire's forest resources. For more information please contact the Division of Forests & Lands at (603) 271-2214, or online at www.nhdfi.org.

Fire activity was very busy during the spring of the 2007, particularly late April into early May. As the forests and fields greened up in later May the fire danger decreased. However, a very dry late summer created very high fire danger again from August into September, with fire danger reaching very high on Labor Day weekend. Even the dry conditions, the acreage burned was less than half that of 2006. The largest forest fire during the 2007 season burned approximately 26 acres on the side of Wantastiquet Mountain in Chesterfield during the month of May. Our statewide system of 16 fire lookout towers is credited with keeping most fires small and saving several structures this season due to their quick and accurate spotting capabilities. Many homes in New Hampshire are located in the wildland urban interface, which is the area where homes and flammable wildland fuels intermix. Several of the fires during the 2007 season threatened structures, a constant reminder that forest fires burn more than just trees. Homeowners should take measures to prevent a wildland fire from spreading to their home. Precautions include keeping your roof and gutters clear of leaves and pine needles, and maintaining adequate green space around your home of flammable materials. 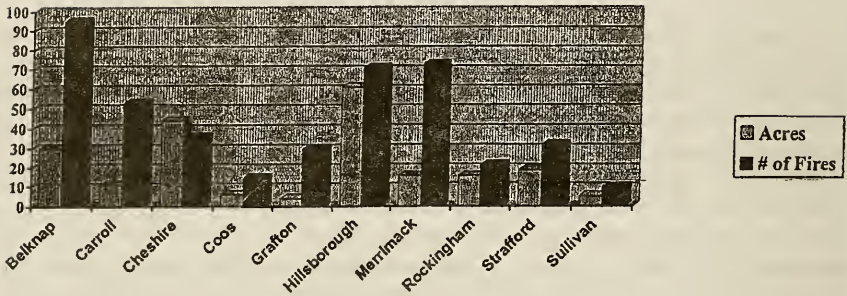

Edmund Jansen was the Moderator. Mr. Jansen called the meeting to order at 7:08 p.m.

1. To chose by vote the necessary officers of the said District as follows:

A. MODERATOR - Normand Giroux nominated Edmund Jansen. Dennis St. Hilaire seconded the motion. There were no other nominations. Edmund Jansen was elected Moderator.

B. CLERK -Dennis St. Hilaire nominated Gailann StHilaire. Beverly Dionne seconded the nomination. There were no other nominations. Gailann StHilaire was elected Clerk.

C. TREASURER - Dennis St.Hilaire nominated Julie Gosselin. Clement Michaud seconded the nomination. There were no other nominations. Julie Gosselin was elected Treasurer.

Officers' Report

The Commissioners have had another busy year.

Selling your home, please notify the District. There have been some probelms in the past, so to avoid legal problems, please call the office **before** your closing date at 742-8124 on Tuesdays and Fridays.

WATER

Several changes have had to be made to the arsenic treatment facility. District has added another automatic valve for backwashing. Backwashing can cause discolored water, therefore the District will try backwashing at night to see if it will alleviate the problem. Our arsenic limit has gone from .05 to .01. Our last test was .005 which is below the limit. The District was just notified that the State is adopting a revised discharge policy for arsenic and the District has until March 31, 2007 to reply in writing with our design and schedule.

General Sullivan well runs approximately 80% of the time with Porter well

running the remaining 20%. There was a water break on South St. in February, the road will be repaired in the spring.

Reminders

Disposing of chemicals or gas in the ground is hazardous to our water supply.

Leaking toilets can be very costly. It can triple or quadruple your normal water bill.

SEWER

The District replaced the sewer line on Scoutland Road. State grant has been finalized and approved by Governor & Council.

The District is also in the process of upgrades to the new facility for automation by adding a scada system and new drainage pumping

There is on going updating of the old equipment and many new mandatory testing procedures by the State and EPA.

Reminders

Sump pumps overload the system. They CANNOT be hooked into the sewer lines. This is a fineable offense.

3. To authorize the Commissioners to raise and appropriate the operating budget of \$528,840.00 attached and proposed by the Commissioners for the year 2007. (Approved by the Budget Committee)

Clement Michaud made a motion to accept. Beverly Dionne seconded the motion. All were in favor. The motion was accepted.

4. To see if the District will approve the additions, deletions, and/or changes to the Ordinances of the District as submitted by the Commissioners.

There were no changes to the Ordinances.

5. To transact any other business that may legally come before said meeting.

There was no other business to discuss.

Clement Michaud made a motion to adjourn. Rosemairie St. Hilaire seconded the motion. The meeting was adjourned at 7:16 p.m.

To the voters of the Rollinsford School District:

In November 2007, I began negotiations with the Rollinsford Teachers Association. We have negotiated a two year agreement, which the public will be voting on at the March 8th School district meeting. The agreement outlines that in year one the teachers will receive 3% increase in pay and the Nurse will receive additional 2.5% in the effort to bring her to 100% of the pay scale. In year two the teachers will receive 3.5% increase and the Nurse will receive an additional 2.0%

We are investigating our space needs at the Grade School and held a public meeting in January to outline what we have been working on. Our plan was to add to six classrooms to the existing school. With the public feedback we are now also looking at the possibility of building a new school. We have a warrant article to spend up to \$55,000.00 for a feasibility study working with Dan Bisson and removing these funds from the capital improvement funds. We hope to have a report by early fall and will hold a school district meeting to decide on what plan we will work with. Please become involved with this project the more opinions from town residents the more informed we all will be on what the right direction to take for our grade school.

We are not proposing any capital improvements to our school this year. With the budget committee's reduction of the \$50,000.00 we need to put on hold our projects. The only item that will be done is the boiler room door as this was a fire safety recommendation.

In closing, I would like to thank all the volunteers that help our every day at the Rollinsford Grade School. I would also like to thank the teachers and principals at the Rollinsford Grade School, Somersworth Middle School, Somersworth High School and the administration staff at the SAU56. Together we must continue to make a difference in the education of our children.

PRINCIPAL'S REPORT

To the Residents of Rollinsford:

The School Improvement Team (S.I.T.) at Rollinsford Grade School continues to make great progress! We are in our sixth year of seriously looking at our school and considering recommendations for improvement. The S.I.T. is made up of the supt. of schools, principal, guidance counselor, teachers, para professionals, parents and community members. In the past we have initiated school wide changes in how we view and teach the writing process. This year we are examining Differentiated Instruction (D.I.) Response to Intervention (R.I.T.), and Technology Integration.

We are also celebrating a yearlong theme: GOING GREEN! With the help of our school Green Team, we are emphasizing and implementing practices that help us reduce, reuse and recycle in order to be more Earth friendly! With that in mind, each month we celebrate green days by symbolically dressing in green. In addition to recycling plastic, aluminum and newspapers, we have begun to recycle paper. Volunteers bring this paper to the transfer station each month. We have held a poster contest and the cover design of this year's yearbook is a green theme. At our monthly assemblies the children have serenaded us with green songs which they have written while in music classes.

All students in grades 3,4,5, & 6 take 'Measures of Academic Progress' in September and May. MAP tests are unique in that they are adaptive tests taken on a computer. This means that the test becomes more difficult as questions are

answered correctly. When a student incorrectly answers a question, the test becomes easier. Therefore, students take a test specifically created for their learning level. MMAP testing is a powerful tool for monitoring student growth over time.

We have an active Web Development Group. Fifth and sixth graders, teachers, the principal and Tom Lebel, our volunteer web master, meet monthly to make sure that our web site is up to date. Check us out at www.rollinsford.k12.nh.us.

Our School has once again been designated a Blue Ribbon School by the New Hampshire Partners In Education. We were knowledgeable because we have a well documented and dynamic volunteer program. This award recognizes the power and impact of volunteers at our school.

This will be the eleventh full year of the Community Helpers Program. While participating in this community service oriented program last year, students logged over 3,000 service hours! This program absolutely has the potential to make Rollinsford and the world a better place. We are proud that it is a part of the Rollinsford Grand School "experience".

Finally, we are saying goodbye this year to one of our beloved teachers. After devoting the past twenty six years to educating the children of Rollinsford, Arlene Boucher has decided it is her time to retire. I know that I speak for many former students, parents and colleagues when I say, "MISS BOUCHER, YOU WILL BE GREATLY MISSED! YOU HAVE MADE A DIFFERENCE IN THE LIVES OF MANY AND WILL NOT SOON BE FORGOTTEN!"

TO DETERMINE AND APPOINT THE SALARIES OF THE SCHOOL BOARD (CHAIR \$1200, TWO (2) MEMBERS AT \$1000 EACH), TRUANT OFFICER (\$40), MODERATOR (\$50), DISTRICT CLERK (\$50), TREASURER (\$650), SUPERVISOR(S) OF THE CHECKLIST, (THREE (3) AT \$15 EACH) FOR A TOTAL OF \$4,035.00. Charlie Dionne made a motion to accept ARTICLE 1 as written, and Charles Putnam seconded. There was no discussion. Voice vote. Motion carried.

Article 2. TO HEAR THE REPORTS OF AGENTS, AUDITORS, COMMITTEES OR OFFICERS CHOSEN AND PASS ANY VOTE RELATING THERETO. Mike Jacobson moved to accept Article 2 and to waive the reading of any of the reports. Michael Rollo seconded. No discussion. Voice vote. Motion carried.

Article 3. TO CHOOSE AGENTS, AUDITORS AND COMMITTEES IN RELATION TO ANY SUBJECT EMBRACED IN THIS WARRANT. Larry Larkin moved to accept Article 3 as written, and Charles Putnam seconded. There was no discussion. A voice vote carried the motion.

Article 4. TO SEE IF THE SCHOOL DISTRICT WILL RAISE AND APPROPRIATE THREE MILLION, EIGHT HUNDRED SEVENTY-NINE THOUSAND, ONE HUNDRED THIRTY-FIVE DOLLARES (\$3,879,135.) FOR THE SUPPORT OF SCHOOLS, FOR THE PAYMENT OF SALARIES FOR THE SCHOOL DISTRICT OFFICIALS AND AGENTS, AND FOR THE PAYMENT OF STATUTORY OBLIGATIONS OF THE DISTRICT, AND TO AUTHORIZE THE APPLICATION AGAINST SAID APPROPRIATION OF SUCH SUMS AS ARE ESTIMATED TO BE RECEIVED TO THE DISTRICT; THE SCHOOL BOARD TO CERTIFY TO THE SELECTMEN THE BALANCE BETWEEN THE ESTIMATED REVENUE AND THE APPROPRIATION, WHICH BALANCE IS TO BE RAISED BY THE TAXES IN THE TOWN. Mr Putnam moved to accept Article 4 as read. Mr. Jacobson seconded. Carleton Spencer wanted to know how many kids the additional \$50,000 in the special education budget would be covering. Denise Knowles asked that Mr Marquis, the Special Education Director, be allowed to address the meeting. Mr Marquis cited privacy and confidentiality issues as the reasons he would not identify the number of students being served. Charles Putnam stated he believed the information Mr Spencer requested was not a gross invasion of privacy. Mrs. Knowles agreed that in this size community, the family or families would be too obvious. It was also stated the percent of the number of students identified is 13%, which is less than the state average. A voice vote carried the motion.

Article 5. TO SEE IF THE SCHOOL DISTRICT WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF UP TO \$25,000 TO BE PLACED IN THE SCHOOL BUILDING IMPROVEMENT CAPITAL RESERVE FUND PREVIOUSLY ESTABLISHED, WITH SUCH AMOUNT TO BE FUNDED FROM THE YEAR END

UNDESIGNATED FUND BALANCE SURPLUS AVAILABLE JULY 1 OF THIS YEAR.
Mr Putnam moved the article. Larry Larkin seconded. Mr. Larkin then asked if this only happened when there was a surplus. Yes. A voice vote carried the motion.

Article 6. TO TRANSACT ANY OTHER BUSINESS THAT MAY LEGALY COME BEFORE THIS MEETING. Jay Roy used this time to honor Paula Woolley for her service to the school and the community, as did Mrs. Knowles. Mrs. knowles also introduced Gary Fjeld as the new school board candidate Mr. Connolly moved to adjourn. Mr. Jacobson seconded. Voice vote carried the motion.

Charlie Dionne, seconded by Ron Chabot, moved the question as written. There was No Discussion on this article. Article VIII carries. (Voice Vote)

ARTICLE IX

To see if the Town will vote to require the Road Agent to establish a manned checkpoint at the entrance to the Transfer Station to ensure that each vehicle entering the facility has valid entry permit and that tipping fees are properly assessed and collected before entry is allowed. (By petition)

Motion to accept as read by Larry Larkin, seconded by Richard Wasson. Richard Wasson motioned to have Article IX defeated. Robert Cullen asked if this would require another person at the transfer station. Carlton Spencer discussed the issue of putting stickers on the lower left corner of vehicle windshield, no reason to put a manned gate at the entrance of the transfer station. Larry Larkin discussed the reason for petition, as well as complaining about the local businesses disposing of large amounts of trash going into transfer station not from our town. Jim Jalbert questioned the percent of tonnage going into the transfer station yearly. Ed Jansen answers saying it is less than 3%. Mr Jalbert also expresses his concern about the number of cars that would be lined up in front of his business on Jesse Doe Road. Dan Marquis started and submitted petition. He addressed the last two comments and stated facts from a past selectmen's meeting regarding the disposal of Construction and demolition (C&D) debris. Rollinsford is generating the most amount of C&D debris in all the towns that Lamprey takes debris from. 2001-0 tons, 2002-60 tons, 2003-150 tons, 2004-164 tons, 2006-271 tons. Jessie Aikman questioned how much can we burn and do we still burn. Ed Jansen responded stating that the state as of 2001 you can only burn C&D debris. Cost to dispose C&D debris is \$78/ton plus hauling. It is currently costing the town to dispose of the C&D debris. There is a public hearing to discuss a new fee structure on April 11, 2007. Discussion continued on the difference between trucks and cars, as well as stickers being handed around among one another. Commercial Company's having their own stickers now being addressed and fees will be adjusted accordingly. Another area which is not going well is recycling, townspeople are not recycling. Richard Wasson stated that stickers must match the plate on the vehicle. Michelle Catellier commends the Transfer Station and the well done job they are doing. Ginny Bannon states that the stickers are not being checked regularly. Al Dionne discussing that checking of stickers was not done efficiently but this is changing for the better. Transfer Station employees currently working towards making the system more effective. Dan Marquis points out that it is costing the town money to haul. (Defeated)

ARTICLE X

To see if the Town will vote, pursuant to RSA 202-A:6, to elect a Board of Library Trustees consisting of three (3) persons to be the governing board of the

Rollinsford Public Library. "The library trustees shall have the entire custody and management of the public library and of all the property of the town relating thereto, including appropriations held pursuant to RSA 202-A:11,III, but excepting trust funds held by the town...Such trustees shall serve staggered three year terms or until their successors are elected and qualified. There may be no more than three (3) alternates as provided in RSA 202-A: 10. (By Petition)

Motion to accept as read by Larry Larkin, seconded by Ron Chabot. Richard Wasson, seconded by Beverly Dionne motioned to withdraw Article X. No discussion (Withdrawn)

ARTICLE XI

To see if the Town will permit the selectmen to appoint three residents to hold the office of Trustees of Rollinsford Public Library until the election of 2008, at which time candidates would run for staggered terms. (By Petition)

Salme Perry (Petitioner) and Nelson Lawry moved to withdraw the article. No discussion (Withdrawn)

ARTICLE XII

To see if the Town will vote, pursuant to RSA 202-A:4-d, to authorize "the public library trustees to accept gifts of personal property, other than money, which may be offered to the library for any public purpose, and such authorization shall remain in effect until rescinded by a vote of town meeting.

"Prior to the acceptance of any gift valued at over \$5,000 the public library trustees shall hold a public hearing on the proposed acceptance.

"No acceptance of any personal property under the authority of this section shall be deemed to bind the town or the library trustees to raise, appropriate, or expend any public funds for the operation, maintenance, repair, or replacement of such personal property." (By petition)

Motion to accept as read made by Larry Larkin, seconded by Sandy Bonin to accept Article XII. Jessie Aikman questioned where all this stuff will be stored until a Library is established. Sandy Bonin addressed question stating that people are currently storing items at their homes. Richard Wasson wants town property excluded and not conveyed. Ayes Carry (Voice Vote)

ARTICLE XIII

To see if the Town will vote to authorize the Selectmen, in consultation with the Conservation Commission, to place Tax Map 2, Lot 3 (i.e., the approximately 100 acre Town owned Scoutland property which is currently zoned as Conservation) under a development rights to a grantee organization whose purpose is to act as a conservation easement holder) and to expend funds from the Land Trust Fund to finance land survey, appraisals, and other related expenses incurred in placing the properties under a conservation easement. (By petition)

Motion to accept as read made by Nelson Lawry, seconded by Jesse Aikman. Dan Marquis explains this goes back to 2004 when it was voted and approved and this is just a continuation to put the land into a conservation easement. Richard Wasson just reminding all that it is not currently being developed. Mike Rhodes questioning the 100 acres and if the town had an opportunity to sell and profit from the 100 acres does this eliminate that possibility. It is explained by the Steve Roberts that it is like selling your house. It is a permanent transfer. Though the town would still own the land it just would be transferring its right to develop the land for commercial or industrial purposes. It still could be used for agricultural, forestry or Wildlife Management. The town could then sell the entire fee interest which is the entire property subject to the easement. Elizabeth Marcotte expresses the importance of having an opportunity to save it reflects positively on

the Town of Rollinsford. Carlton Spencer expressing his concern to use money to have it surveyed when it should be left alone and it need no boundaries. Michele Small wants to know if the town is keeping the property for an investment or are they holding it to preserve it or use it for future school or other use. Ed Jansen says it is important to have it surveyed for a legal description to be able to pass over into an easement. Richard Marquis explains that the land is currently zoned conservation and it does not help it long term. An easement would put it into permanent conservation land. Charlie Putnam voices concern that this land is at risk in the future and noted that this is the best conservation land on the Salmon Falls River in Strafford County. He believes that the towns' people consistently want to conserve this land. Joe Caouette points out that several conservation agencies would like to use this land and we want to save it. Robin Aikman expresses that generations of families have grown up here and think it is very important to save it. Ed Jensen wants people to understand that there is other land available if a school is needed. Nelson Lawry expresses that we should save this beautiful land. Ayes Carries (Voice Vote)

ARTICLE XIV

To see if the Town will vote to appropriate the sum equal to all revenues in excess of fifty thousand dollars (\$50,000.00) that may be received from the Hydro Electric Plant to be placed in the Town's Hydro Electric Fund. The first \$50,000.00 or any lesser amount that may be received will be used as offset against Town Budget expenditures (Majority vote required)

Motion to accept as read made by Carlton Spencer, seconded by Ron Chabot, No discussion Ayes Carry (Voice Vote)

ARTICLE XV

To see if theTown will vote to raise and appropriate the sum of fifteen thousand dollars(\$15,000) and authorize the withdrawal of \$15,000.00 the same from the Land Trust Fund Capital Reserve to finance land survey and related expenses that may be incurred in assisting private land owners to donate Conservation Easements and/or to purchase options to buy critical lands the town may wish to protect for open space or conservation uses. (Majority vote required)

Motion to accept as read made by Charlie Dionne; seconded by Larry Larkin No discussion Ayes carry (Voice Vote)

ARTICLE XVI

To see if the Town will vote to raise and appropriate the sum of thirty thousand dollars (\$30,00) to be added to the Equipment Captial Reserve Fund previously established. The Budget Committee and Selectman recommend this appropriation. (Majority vote required)

Motion to accpet made by Carlton Spencer; seconded by Charlie Dionne No discussion Ayes Carry (Voice Votes)

ARTICLE XVII

To see if the Town will vote to raise and appropriate sixty thousand dollars (\$60,000) for road reconstruction and drainage upgrades. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Richard Wasson, seconded by Nancy Dionne. Mr. Nylund wants to know which roads are going to be repaired. Al Johnson explained Jessie Doe Road, section of Highland Avenue, section of Sligo Road, 500' of sidewalk and Granite curbing on South Street. Ayes Carry (Voice Vote)

ARTICLE XVIII

To see if the Town will vote to raise and appropriate two thousand six hundred dollars (\$2600) for cemetery capital improvements. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Richard Wasson seconded by Charlie Dionne Mr. Cullen wants to know if it is being put out to bid? Marc Couture explains where the money is going; road repair, and to buy back graves from families that are not being used. Ayes Carry (Voice Vote)

ARTICLE XIX

To see if the Town will vote to raise and appropriate the sum of twenty thousand dollars (\$20,000) to be added to the Land Trust Fund previously established. Twenty thousand will be transferred from the Land Use Change Tax Fund to fund this appropriation The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Richard Wasson, seconded by Carlton Spencer. No Discussion Ayes Carry (voice vote)

ARTICLE XX

To see if the Town will vote to raise and appropriate twenty five thousand dollars (\$25,000) and authorize the withdrawal of this amount from the Hydro Reserve Fund to be used as revenue to offset taxes in the 2007 budget. (Majority vote required)

Motion to accept as read made by Beverly Dionne, seconded by Charlie Putnam No Discussion. Ayes Carry (Voice Vote)

ARTICLE XXI

To see if the Town will vote to establish a Re-evaluation Capital Reserve Fund under the provisions of RSA 35:1 for the purpose of the re-evaluation in 2010 and to raise and appropriate \$20,000 to be placed in this fund. The Budget Committee and the Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Carlton Spencer, seconded by Nancy Dionne. Dan Marquis asked for an explanation of the cost of the last reevaluation. Ed Jansen explained the cost and is expecting the next reevaluation to be more money so they are planning for the future. Ayes Carry (Voice Vote)

ARTICLE XXII

To see if the Town will vote to raise and appropriate one hundred thousand dollars (\$100,000) to purchase a new highway truck equipped with a snow plow, and to authorize the withdrawal of \$100,000 from the Equipment Capital Reserve Fund to finance this expenditure. The Budget Committee and the Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Beverly Dionne, seconded by Ron Chabot. Mr. Cullen wants to know why we need a new truck. Al Dionne explains that the truck being replaced is 22 years old and the next one in line is three years younger and also explains that these monies will include the truck, sander and other attachments. Mr Cullen wants to know the mileage on the truck. Al Johnson explains that it did not work when they bought the truck. James Jalbert explained that he does all the inspections for the town and the current truck will not pass inspection. Nelson Lawry would like to know what percent of the roads is state plowed. Al Johnson explained that he plows 25 miles of road in Rollinsford. Richard Salvatti wants to know if we will be putting additional funds in this account. Ed Jansen says no. Ayes Carry (voice Vote)

ARTICLE XXIII

To see if the Town will vote to raise and appropriate fifteen thousand dollars (\$15,000) to purchase a used 4 wheel drive pickup truck and snow plow for the Fire Department, and to authorize the withdrawal of \$15,000 from the Equipment Capital Reserve Fund to finance this expenditure. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Carlton Spencer, seconded by Larry Larkin. Dan Marquis would like to know why we need a snow removal truck for the Fire Department. Several people explained the many reasons why, for example to plow path if fire in the woods, to assist South Berwick with a water rescue. We house their boat in our station. Ayes carry (Voice vote)

ARTICLE XXIV

To see if the Town will vote to raise and appropriate fifty thousand dollars (\$50,000) to add to the Highway Building Capital Reserve Fund that was established to hold money for the future construction of new highway buildings near the transfer station. The Budget Committee and the Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Richard Wasson, seconded by Michele Small. Dan Marquis would like to know where and when regarding the new Highway building. Ed Jansen said that we need to get \$150,000 before this topic is even discussed. If and when we do the salt shed the Highway building should be done at the same time. The salt shed alone will cost \$100,000. Mr Cullen would like to know the size, and will it accommodate all the vehicles. Al Johnson explained that there is currently an EPA issue with the current Salt and Sand pile. The EPA said that it has to be moved and cleaned up. James Jalbert explains that this is an ideal time to relocate the highway dept to a new location. The longer we wait to build the more expensive it is going to cost the town. Carlton Spencer expresses how Al Johnson goes above and beyond his job specifications. Ayes carry (Voice Vote)

ARTICLE XXV

To see if the Town will vote to raise and appropriate one hundred fifty thousand dollars (\$150,000) for facilities improvement at the Fire Station and authorize the receipt and expenditure of a Federal Grant in the amount of \$142,500, with the remaining \$7,500 to be raised by taxation. The Budget Committee and Selectmen recommends this appropriation. (Majority vote required)

Motion to accept as read made by Denise Knowles, seconded by Rob Chabot. Denise Knowles explains where the grant money is going; Primal vent system, Emergency generator, fire alarm activation system, fire station sprinkler system. Town will put in a small portion of this money. Ayes carry (Voice Vote)

ARTICLE XXVI

To see if the Town will vote to raise and appropriate six thousand five hundred dollars (\$6,500) to excavate and fill with gravel the base for parking spaces adjacent to the Fire Station. (This parking area would replace spaces lost when the addition was added to the Fire Station) The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Carlton Spencer, seconded by Richard Wasson. No discussion. Ayes Carry (Voice Vote)

ARTICLE XXVII

To see if the Town will vote to raise and appropriate ten thousand dollars (\$10,000) to repair water leaks in the Town Hall tower and to seal leaks in the

basement, and to replace flooring damaged in the basement. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Ron Chabot, seconded by Charlie Dionne. Sonny Foss expresses his concern regarding the condition of the Police Department and the hazardous working conditions for the Police Department staff as well as the town hall staff. This was discussed last year and wants to know what was done? Chief Ducharme explains that the selectmen are the ones handling this problem. Ed Jansen, states that there was a study done and that Chief Ducharme is in charge of this study. Chief Ducharme explains that there was a report done and states that there is an airborne mold issues with in the whole building that is being generated from the evidence room area. This is effecting not only the police department but all the employees in the whole building because it is in the central air system. There is also physical mold on the walls in the police department which was not addressed in the study. Nelson Lawry wants to know if the poor construction work on the town hall is the result of our problem and if the issue is going to be addressed? Elizabeth Marcotte and Dan Marquis express concern that at last year's town meeting this was addressed and assumed taken care of? We were supposed to hire a consultant with the \$10,000 to report on the water problem. Nelson Lawry wants his question answered. Ed Jansen stated that the water is coming from the tower on top of the Town Hall. Ed Jansen is also states that the mold is not a health risk at this time and until we address the water issue we can not undertake the mold issue. Al Dionne explains that the contruction done on the town hall was not completed in a satisfactory manner. The town went through arbitration and held back money and then signed off not to sue them in the future to avoid court proceedings. Richard Wasson reiterates that the issue of water has been discussed repeatedly for several years at the town hall meeting. Laura Smith would like to know what happened to the money that was not paid to the Consturction Company and is it possible to form a committee to move forward with this issue. Al Dionne states that rain is not pouring into the building, every time it rains; Al Dionne continues to say that you can not get just anyone to fix the tower. The company hired has a great reputation and he recommends that we stick with them. He continues to keep contact and work with the company. He hopes they will come this spring. Ginney Bannon has asked if there are any dehumidifiers downstairs, and recommends that the police station uses dehimidifiers to help with the mold issue. Dan Marquis states that we need to find out how severe the health and safety issue is, regarding the mold. \$10,000 was put back into the general fund and Ed Jansen knows that \$10,000 is not enough money to do the project but it is a place to start if more money is necessary then the town will pay it. Ayes carry. (Voice Vote)

ARTICLE XXVIII

To see if the Town will vote to raise and appropriate fifty thousand dollars (\$50,000) to renovate the second floor of the Town Hall and to authorize the acceptance of private gifts and/or private grants to fund the renovation. (Renovation will not be undertaken until required gifts or grants have been received.) The Budget Committee and the Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Carlton Spencer, and seconded by Jessie Aikman. Larry Larkin wants to know if \$50,000 dollars is going to be enough. And will this issue be revisited year after year. Richard Salvatti is saying that \$50,000 is not going to be enough and that we are just in the beginning stages of pricing out the future cost of the second floor balcony. Nelson Lawry is wondering if the renovation of the second floor would be halted due to the condition of the tower and should we put that on hold till the water issue is addressed. Mrs Putnam

wants clarification whether the money is coming from grants and outside sources or if some of it coming from the town budget. Article XXVIII was amended to read as follows: To see if the Town will vote to raise and appropriate fifty thousand dollars (\$50,000) to renovate the second floor of the Town Hall with private gifts and/or private grants to fund the renovation. (Renovation will not be undertaken until required gifts or grants have been received.) The Budget Committee and the Selectmen recommend this appropriation. Motion to accept Article as amended made by Charlie Putnam and seconded by Nancy Dionne. No further discussion. Ayes carry (Vote Vote) Voting on Article XXVIII as amended. Ayes carry (Voice Vote)

ARTICLE XXIX

To see if the Town will vote to raise and appropriate ten thousand dollars (\$10,000) to fund survey and legal costs associated with preparation of conservation easements on the Scoutland Conservation area currently owned by the Town and zoned for conservation uses and authorize the withdrawal of \$10,000 from the Land Trust Capital Reserve Fund. Not recommended by the Budget Committee. The Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Dan Marquis, seconded by Richard Wasson. No discussion. Ayes carry. (Voice vote)

ARTICLE XXX

To see if the Town will vote to raise and appropriate twelve thousand two hundred dollars (\$12,200) for the final lease payment on the police cruisers. The Budget Committee and Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Carlton Spencer, seconded by Richard Wasson. Dan Marquis would like to know the purpose of this and Ed Jansen explains that it is the final payment for the cruisers. Ayes Carry. (Voice vote)

ARTICLE XXXI

To see if the Town will vote to raise and appropriate ten thousand dollars (\$10,000) for demolition of the Old Redman Club Building. The Budget Committee and the Selectmen recommend this appropriation. (Majority vote required)

Motion to accept as read made by Beverly Dionne, seconded by Carlton Spencer. Mr Cullen wants to know why it is not put out to bid. Mr Jansen explains that it is timely and costly for a small town to put out to bid. The town will take the lowest local bid and keep it local. Mr. Cullen wants to know if we can do a controlled burn, the reply is no because it is to close to the St. Hilaire Home. Also it has asbestos roof which is hazardous to the surrounding community. Gail St. Hilaire is also concerned for the safety of her home. Ayes Carry. (Voice Vote)

ARTICLE XXXII

To see if the Town will accept the road in the Carr sub-division (off Main Street), as a Town road, and to accept Ross Circle as the name of the road. (Majority vote required)

Motion to accept as read made by Richard Wasson, seconded by PaulConnolly. Laurie Smith from Settlement Circle expresses that her family and the other living on Settlement Circle would like to keep the name Settlement Circle and not have to change all their paperwork again. Marc Couture would like to know whether the Town is responsible or the developer to put up the street lights for Settlement Circle. Ed Jansen states that the Developer is responsible to tell all buyers that the name was going to change. Jeff Sanders resident of Settlement Circle states that he was informed about the change but still like to keep the name as it is. Mr PaulConnolly moves to amend the article. Mrs Sanders made a

motion to amend article XXXI! to read as follows; To see if the Town will authorize the selectmen to accept the road in the Carr sub-division (off Main Street), as a Town road. Motion to accept as amended was made by Carlton Spencer and seconded by Richard Wasson. Mrs Putnam moves to terminate the discussion. Ayes carry. (Voice Vote) Voting on Amendment. Ayes Carry. (Voice Vote) Ginny Bannon is proposing a second amendment to article XXXII to read as follows; "To see if the Town will authorize the selectmen to accept the Carr sub-division (off Main Street), as a Town road, and to accept Settlement Circle as the name of the road. Motion to accept the second amendment as read by Mr. Sanders, seconded by Denis Knowles. Ayes Carry. (voice vote)

ARTICLE XXXIII

To see if the Town will accept the road in the Wentworth Pasture sub-division (off Portland Avenue) as a Town road, and to accept Pasture Road as the name of the road. (Majority vote required)

Motion made to accept as read by Mr. Paul Connolly and accepted by Mr. Nyland. Bob Cullen wants to know how many houses are going into the sub-division. Charlie Putnam confirms that there are six going in and currently there are three houses built there. Mr Spencer Carlton makes a motion to amend Article XXXIII to read as follows; To see if the Town will authorize the selectmen to accept Pasture road in the Wentworth Pasture sub-division (off Portland Avenue) as a Town road, and to accept Ross Circle as the name of the road. Motion to accept made by Charlie Dionne seconded by Richard Wasson. Marc Couture concerned that there are not lights on this street either and also is concerned about the deceleration lane. Motion to accept amendment of Article XXXIII as read accepted. Ayes Carry

ARTICLE XXXIV

To see if the Town will vote to raise and appropriate the budget committee recommended sum of \$1,213,007.16 for general municipal operations. This article does not include special or individual articles addressed. (Majority vote required)

Motion to accept as read made by Charlie Dionne, seconded by Paul Connolly. No discussion. Ayes carry. (voice vote)

ARTICLE XXXV

To see if the Town will vote to authorize the Selectmen to sell to the highest bidder, the surplus equipment and vehicles owned by the Town. (Majority vote required)

Motion to accept as read made by Larry Larkin, seconded by Mr. Salvatti. No discussion. Ayes carry. (voice vote)
