# TOWN WARRANT The State Of New Hampshire

To the Inhabitants of the Town of Wentworth, in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Wentworth on Tuesday, the fourteenth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.
- 3. To see if the town will vote to raise money sufficient to secure State Aid on State Aid Construction.
- 4. To see how much money the town will vote to raise and appropriate for town highways and bridges.
- 5. To see how much money the town will vote to raise and appropriate for Street Lights.
- 6. To see how much money the town will vote to raise and appropriate for the support of the Library.
- 7. To see what action the town will take in regard to raising or appropriating money for the support of a doctor, in cooperation with the adjoining towns, and appoint any committee relating to this article.
- 8. To see if the town will vote to discontinue certain portions of the town highway known as the Baker's Pond road, between Wentworth and Orford, the use of such portions of highway being no longer required by reason of the relocation of said highway
- in the course of the reconstruction of same; and to authorize the Selectmen to petition the Superior Court for its consent to such discontinuance if-

such procedure is necessary, and to do all other things necessary in connection therewith.

- 9. To see what action the town will take in regard to raising or appropriating a sum of money to build a tramp house or make some provision for the care of tramps.
- 10. To see what action the town will take in regard to disposing of property bought for taxes by town and which town is to have tax deed this year.
- 11. To see if the town will vote to discontinue the highway in said town leading from Waldron place so called in South Wentworth to Neal D. Johnson place so called on Ellsworth Hill.
- 12. To see if the town will vote to discontinue that portion of road at each end of the old covered bridge known as Moosilauke Trunk Line, the use of such portions of highway being no longer required by reason of the relocation of said highway; and to authorize the Selectmen to petition the Superior Court for its consent to such discontinuance if such procedure is necessary.
- 13. To see if the town will vote to discontinue the Highway leading from Peter Veaudry place so called to George Morrison place so called on Saunders Hill.
- 14. To see if the town will vote to authorize the Selectmen to hire money if necessary.
- 15. To transact any other business that may legally come before said meeting.

## REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Citizens and School Board of the Wentworth School District:

I hereby submit my third annual report as Superintendent of Schools of the district.

#### Instruction

Several changes have occurred in the teaching staff of the district since the last report. Leonard J. Smith of Newport, a Keene Normal School graduate, is teacher at the village grammar room, and Alice B. Bewley of the primary room. Marion Downing of Wentworth is at the Foster School and Victoria Charras of Manchester is at the Buffalo School. The fundamentals in Arithmetic have been checked and remedial work prescribed.

The enrollment of the Buffalo School has decreased considerably so that in the event of crowding at the village school the scholars on the East side might well be transported there. This seems to be a good temporary arrangement until definite provision can be made for consolidation. The village school has about all the pupils that can be efficiently handled in the present building.

## **Property**

During the summer George F. Plummer of Ashland very kindly consented to give and deed approximately one-quarter acre of land for a play ground at the Buffalo School and same has been fenced. A new toilet was built and the shingling of the school completed together with some minor repairs inside. The shed of the village school and one side of the school building were shingled during the past summer. The primary room ceiling was repaired at the same time.

#### Conclusion

The budget has been prepared with special reference to low cost without encroaching on the efficiency of the instruction. Although state aid has decreased, the amount asked for is \$477.21 less than last year.

During the year fire drills have been organized and insisted upon throughout the district. The attendance for the district was above the state average and that of Atwell Hill superior, particularly in consideration of the climate and the fact that so many of the pupils do not live conveniently near the school.




