

General Information

The Town of Goffstown was named for Colonel John Goffe, an early settler, soldier and civic leader. It was incorporated on June 17, 1761.

Goffstown is located in Hillsborough County, nine miles west of the City of Manchester on NH Route 114; north of Bedford on NH Route 114; east of New Boston on Route 13; south of Weare on NH Route 114. Sixteen miles to Concord, the New Hampshire state capital.

The population of Goffstown is approximately 12,300 according to the NH Office of State Planning, July, 1983.

Our type of government is the annual open Town Meeting; three-man Board of Selectmen; sixteen-member Budget Committee. The tax rate as of 1984 is \$96.90 per thousand dollars at 27% equalized valuation.

Voter registration qualifications — must be 18 years of age and a citizen and resident of Goffstown; voter registration with Supervisors of the Checklist and Town Clerk. New registrations accepted up to ten days prior to elections. Absentee ballots are available for qualified voters of Town and State primary and general elections.

Fire permits are issued at Fire Stations, and must be picked up in person between 7:30 am and 5:00 pm.

Town Hall is located at 16 Main Street in the center of Goffstown Village. Office hours are Monday, Tuesday and Friday from 9 am to 4:30; Wednesday from 9 am to 12 noon and Thursday from 9 am to 4:30 pm and from 6 pm to 8 pm.

Dog licenses expire on April 30 of each year. A dog must be licensed at 3 months; rabies certificate required. Fees: Male, \$6.00; neutered male, \$3.50; female, \$6.50; spayed female \$3.50. A penalty of \$1.00 per month is assessed as of June 1. Licenses are available in the Town Clerk's office located in the Town Hall. Automobile registration is renewable in birth month, available from Town Clerk's office to residents. Resident tax receipts required. Auto renewal decals available for an additional fee of \$1.50 to N.H. residents.

The Town of Goffstown has adopted semi-annual collection of taxes. The first payment is due July 1; second payment due Dec. 1 at the Tax Collector's office in the Town Hall. Property is assessed as of April 1.

A zoning ordinance is in effect controlling the land uses in Commercial, Industrial, Residential, Agricultural, Flood Plain and Conservancy Open Space Zones. The Building and Zoning Dept. is located in Town Hall, also.

Full-time Highway Dept. located at the end of Depot Street in Goffstown Village. Rubbish pickup once a week, schedules available at the Selectmen's and Town Clerk's offices in Town Hall. The town dump is located off Laurier Street in Pinardville, open 8 am to 5 pm except Sundays and holidays. A dump sticker is required; available from the Town Clerk's office.

The Goffstown Police Dept. is located downstairs in the Town Hall; entrance at the rear of the building.

The Parks and Recreation building is on Mast Road in Goffstown Village. There are two supervised playgrounds with excellent programs; two public swimming pools; six public tennis courts, athletic fields and an outdoor ice-skating area.

The public schools consist of two elementary schools, grades 1-4; one middle school, grades 5 and 6; Goffstown Jr. and Sr. High School, grades 7-12. The School Dept. offices are located in the White Building, at the end of School Street in Goffstown Village.

He began his career in 1958 and oversaw the growth of the department from 3 full-time officers to 17. He aggressively pursued federal grant monies in the 1970's to aid the Town in coping with its expansion, and was instrumental in efforts to upgrade the quality of law enforcement as a profession.

Active in the NH Chiefs of Police Association, Chief Wike served as its president from 1977-1978. Under his direction, the Goffstown Police Department became one of the most highly respected departments in the state.

Chief Wike resides in Goffstown with his wife, Rolande.

Selectmen's Report 1984

1984 WAS AN EXTREMELY BUSY YEAR!

This statement seemed to permeate every report, every comment, every chance remark concerning this past year. Because the idea of "busy-ness" was so prevalent, we decided to make it the theme of our 1984 Town Report.

This report contains all of the required budgetary and statistical data, department head reports and other information pertinent to the affairs of the Town.

Nineteen eighty-four saw many changes in Goffstown; changes which contributed to our "busy-ness".

Robert Wike, our Police Chief of nineteen years, retired and Stephen Monier was appointed our new Chief. Dennis Sarette was named Building Official and Health Officer upon the retirement of Francis "Corky" Gaudreault, and Janet Bartels became our new librarian when H. Donley Wray resigned from that position.

For the past several years, the Goffstown Communications Center handled the dispatching for Hillsborough County; however, in 1984 the County decided to do their own dispatching, necessitating scheduling and personnel changes in that department.

A portion of Mast Road from Haig Street to Marion Street was widened and reconstructed, and a new culvert was installed by the NH Dept. of Public Works and Highways, making that area safer and providing a better line-of-sight to the traffic lights at the Goffstown Plaza.

A site for the new Post Office was finally located on Church Street, on the property of the former Kendall-Hadley plant. The development will house the Post Office, a bank and professional offices, and will be known as Kendall-Hadley Plaza. The change which has made the biggest impact on Town employees was the installation and implementation of the new computer system. The Computer Study Committee and the Selectmen put in many hours of work before the final choice was made. The equipment arrived in August, and data input began as soon as possible. The voter checklist for the September primary was the first utilization of the computer, and as you all know, the second half 1984 tax bills were run off on the new system.

Restaurants, restaurants! Seems as though every month or so saw the grand opening of yet another restaurant, especially in the Pinardville area. Each one of these required a great deal of work and time on the part of the Building Dept., the Planning Board, the Board of Adjustment and the Selectmen's and Assessor's offices.

Building in general hit an all-time high, as reflected by the figures shown in the Building Official's report. The Town of Goffstown realized its greatest increase in the tax base this past year. The Industrial Council has been meeting often and working long hours in an effort to continue expanding the tax base.

Through all of this activity and "busy-ness" we owe a great debt of gratitude to the many volunteers who serve on the various boards and committees, and to the dedicated employees of the Town.

Most of all, we would like to express our thanks to you, the citizens and taxpayers, for making Goffstown such a pleasant, friendly community.

1985 Goffstown Town Warrant

To the inhabitants of the Town of Goffstown in the County of Hillsborough, State of New Hampshire, qualified to vote in Town affairs and to the inhabitants of the School District in the Town of Goffstown qualified to vote in School District Affairs:

You are hereby notified to meet at the Goffstown High School in said Town on Tuesday, the 12th day of March at six o'clock in the forenoon, to act on the following subjects:

The polls will open at 6:00 a.m. and close at 6:00 p.m. at the Central Polling Place and will open at 6:00 a.m. and close at 6:00 p.m. in the Fifth District at Bartlett School.

You are hereby notified to meet at the Goffstown High School, Saturday, March 16, 1985, at 1:00 p.m. where the business meeting will take place.

None of the articles in the warrant, except those relating to the election of officers and those covering questions on the ballot shall be considered during the time that the polls are open.

ARTICLE 1

To choose all Town Officers, Trustees and Commissioners and School District Officers for the ensuing years, including a member of the Board of Selectmen for three (3) years.

ARTICLE 2

Are you in favor of the adoption of Amendment No. 1 as proposed by the Planning Board for the Town Zoning Ordinance as follows: To change Map 18, Lot 59, from a classification of Residential 2-Commercial Zone, to a classification of Commercial Zone. (By Official Ballot).

ARTICLE 3

Are you in favor of the adoption of Amendment No. 2 as proposed by the Planning Board for the Town Zoning Ordinance as follows: To create a new Article IV(0), amending the Town Zoning Ordinance to provide comprehensive and consistent multi-family regulations; a copy of which is on file at the Town Clerk's Office and the Selectmen's Office. (By Official Ballot).

ARTICLE 4

Are you in favor of the adoption of Amendment No. 3 as proposed by the petition of voters to change the zoning on Map 18 Lot 39 from Industrial to Commercial, in that all adjacent land is zonedCommercial. (By Official Ballot) (Approved by the Planning Board).

ARTICLE 5

Are you in favor of the adoption of Amendment No. 4 as proposed by the petition of voters to amend Article III B... Additional Definition of the Goffstown Zoning Ordinance by adding the definition:

"Public Sewerage and public sewer

As used in this zoning ordinance, the terms public sewerage and public sewer shall mean the sewage disposal system that is constructed and maintained by a municipality and not one privately owned or constructed." (By Official Ballot) (Not Approved by the Planning Board).

ARTICLE 6

Shall the non-partisan ballot system for the election of town officers be adopted by this town? (By Official Ballot) (By Petition).

ARTICLE 7

To see if the Town will vote to raise and appropriate the sum of Five Million Three Hundred Seventy-Five Thousand (\$5,375,000.00) Dollars for the purpose of constructing Phase I, so-called, of the Town's municipal sewerage system including, without limitation (i) payment for the construction of interceptors, disposal, pumping and other facilities within the Town; (ii) payment of the Town's share of expenses heretofore incurred by the City of Manchester for sewerage facilities already constructed within said City as will benefit the Town; (iii) payment of the Town's share of the expenses that will be incurred in connection with the construction of sewerage facilities within said City of Manchester as will benefit the Town; and (iv) the payment of necessary incidental expenses including, without limitation, the costs, including legal expenses, of acquiring easements and other interests in land, the establishment of reasonably required contingency funds, the payment of interest during construction, the payment of costs incurred in issuing the bonds described below and the payment of engineering costs; Two Million Five Hundred Fifty-Nine Thousand Five Hundred Sixty-Three (\$2, 559, 563.00) Dollars of such amount, representing the State's One Million Six Hundred Seventy-One Thousand Four Hundred Forty-Eight (\$1,671,448.00) Dollars share of said Project and the Town's Eight Hundred Eighty-Eight Thousand One Hundred Fifteen (\$888,115.00) Dollars share of said Project, to be raised through the issuance of bonds or notes by the Town under and in compliance with the Municipal Finance Act, RSA 33, as amended, the Selectmen being authorized to issue and negotiate such bonds or notes and to determine the rate of interest thereon, the maturity and the other terms and provisions thereof as may be in the best interests of the Town; and to contract for, accept and appropriate any and all federal aid, presently estimated at Two Million Eight Hundred Fifteen Thousand Four Hundred Thirty-Seven (\$2,815,437.00) Dollars, State Aid, presently estimated One Million Six Hundred Seventy-One Thousand Four Hundred Forty-Eight (\$1,671,448.00) Dollars, and any other aid or grants for said Project, the Selectmen and/or the Sewer Commissioners being authorized to take all steps necessary to cause the Town to comply with the terms and conditions of such aid including those contained in 33 USC #1251 et seq., as amended, and RSA 149-B, as amended, and to take any other action or pass any other vote relative thereto. (Recommended by the Budget Committee).

ARTICLE 8

To see if the Town will vote to raise and appropriate the sum of Two Thousand (\$2,000) Dollars, to help defray the cost of the Elderly Nutrition Program within the Town. (By Petition) (Recommended by the Budget Committee).

ARTICLE 9

To see if the Town will vote to raise and appropriate the sum of Seven Thousand and Fifty-Seven (\$7,057) Dollars to be paid to the Visiting Nurse Association and Home Health Agency of Greater Manchester, Inc., to defray the costs of the agency's activities in the Town. (By Petition) (Recommended by the Budget Committee).

To see if the Town will vote to raise and appropriate the sum of Eighty-Three Thousand Eight Hundred Twenty-Two (\$83,822) Dollars for a new street lighting system. (Recommended by the Budget Committee).

ARTICLE 11

To see if the Town will vote to raise and appropriate the sum of Eighteen Thousand (\$18,000) Dollars for one (1) four-wheel drive pickup truck equipped with radio and plow. (Recommended by the Budget Committee).

ARTICLE 12

To see if the Town will vote to raise and appropriate the sum of Forty-Five Thousand (\$45,000) Dollars for one (1) dump truck equipped with radio. (Recommended by the Budget Committee).

ARTICLE 13

To see if the Town will vote to raise and appropriate the sum of Four Thousand Six Hundred Ten (\$4,610) Dollars for the purpose of microfilming municipal records. (Recommended by the Budget Committee).

ARTICLE 14

To see if the Town will vote to raise and appropriate the sum of One Hundred Thousand (\$100,000) Dollars for a new fire truck. (Recommended by the Budget Committee).

ARTICLE 15

To see if the Town will vote to raise and appropriate the sum of Ten Thousand (\$10,000) Dollars for an engineering study and layout of Depot Street. (Not recommended by the Budget Committee).

ARTICLE 16

To see if the Town will vote to appropriate and authorize the withdrawal from the Revenue Sharing fund established under the provisions of the State and Local Assistance Act of 1972, for use as setoffs against budgeted appropriations for the specific purposes and in amounts indicated herewith, or take any other action hereon.

ARTICLE 17

To see if the Town will vote to raise and appropriate the sum of Two Hundred Fifty-Seven Thousand Eight Hundred Sixty-Two (\$257,862) Dollars for the purpose of constructing an Emergency Operations Center within the Police Department; 50% of this amount to be reimbursed to the Town from the Federal Emergency Management Agency. (Recommended by the Budget Committee).

ARTICLE 18

To see if the Town will vote to authorize the Selectmen to construct a police station for a sum not to exceed Four Hundred Eighty-Eight Thousand Nine Hundred Thirty-One (\$488,931) Dollars, or take any other action in relation thereto. (Recommended by the Budget Committee).

ARTICLE 19

To see if the Town will vote to authorize the Selectmen to accept a deed from Hillsborough County for seven (7) acres of land, more or less, identified as Map 6 Lot 39-1.

ARTICLE 20

To see if the Town will vote to authorize the Selectmen to sell a portion of Map 6 Lot 39-1 to a developer approved by the Industrial Council.

ARTICLE 21

To see if the Town will vote to authorize the Selectmen to negotiate a twenty-five (25) year lease with the Goffstown School District for a six (6) acre tract of land, more or less, at Barnard PARK.

ARTICLE 22

To see if the Town will vote to pass an ordinance requiring all dogs to remain on owner's property, or be restrained at other times. (By Petition).

ARTICLE 23

To see if the Town will vote to authorize the Selectmen to plow the following areas which municipal records fail to determine are public roadways:

Montreal Street; Alley between Goffstown Hardware and Paint Store; Winnie Miles' Driveway; Naser Place off Gorham Pond Road; Plimpton Road off Tibbetts Hill Road; Weilbrenner's Place off Tibbetts Hill Road; Kidder Court and Mrs. Tarr's off Henry Bridge Road (two short gravel roads on hill off Harry Brook); Riverside Drive (Lynchville Park by Volkmann); Millette Road, Lynchville Park; Welch Farm Road off Shirley Hill Road; Riverview Park Road and two side roads from bottom of the hill or paved section to end of gravel sections); Dumont Park Road; Up-Away Farm (Stanhope's) off Route 13 north just beyond Snook Road; Story Road (Mrs. Clapp's) off Gorham Pond Road.

ARTICLE 24

To see if the Town will vote to raise and appropriate the budget submitted by the Budget Committee in the amount of Ten Million Sixty-Four Thousand Three Hundred Eighty-Two (\$10,064,382) Dollars.

Note: This budget will be predicated by estimated revenues in the amount of Seven Million Three Hundred Thirty-Five Thousand One Hundred Fifty-Eight (\$7,335,158) Dollars and will relate an estimated amount to be raised by taxes of Two Million Seven Hundred Twenty-Nine Thousand Two Hundred Twenty-Four (\$2,729,224) Dollars. County Tax and School District Commitment not included. (Recommended by Budget Committee).

To see if the Town will vote to authorize the Selectmen to borrow from time to time, such sums of money in anticipation of taxes as may be needed to meet the necessary running expenses of the Town.

ARTICLE 26

To see if the Town will vote to authorize the Selectmen to apply for, receive and expend money from any other governmental units or private sources to be used for purposes for which the Town may legally appropriate money; provided (1) that such grants and other monies do not require the expenditure of other Town funds, (2) that a public hearing shall be held by the Selectmen prior to the receipt and expenditure of such grants and monies; and (3) that such items shall be exempt from all provisions of RSA 32 relative to limitation and expenditure of Town monies, all as provided by RSA 31:95-b.

ARTICLE 27

To see if the Town will vote to authorize the Selectmen to administer or dispose of any real estate acquired by the Town through Tax Collector's deed, purchase, prescription or gift.

ARTICLE 28

To hear the reports of Town Officers, Auditors and Committees and to pass any vote relating thereto.

ARTICLE 29

To transact any other business that may legally come before said meeting.

1984 Town Meeting Minutes

The 1984 Goffstown Town Meeting was called to order Saturday, March 17, at 1:15 p.m. at the Goffstown High School gymnasium by MODERATOR RODNEY L. STARK. Cub Scouts from Pack 99 Jeff McKay, Matt McKay, Mike Baines and Chris Ferris presented the colors followed by the Pledge of Allegiance. Moderator Stark introduced the officials present: Selectmen Robert L. Wheeler, John C. Sarette, Elmer B. Nickerson, Business Administrator David Crowell, Accountant Ruth Gage, Assistant Moderator Gossett McRae and Town Clerk Elaine Emerton. Also introduced were the Budget Committee members followed by reading and explaining the rules and procedures of the Town Meeting.

Selectman John Sarette spoke on the importance of the volunteerism featured on this year's Town Report cover, the silhouettes of Bill McKinnon and Henry Foucher, saluting them for all their time and effort given in the study of the computer system use for the Town and the study of the bi-annual property tax billing. Also, thanks to: Scott Braly, Richard Duclos and Sandy Duncan who were also on the Computer Study Committee.

Selectmen interjected an announcement of a baked bean supper tonight at the Goffstown Methodist Church. Moderator Stark read the preface to the Articles of the 1984 Town Warrant. A motion was made to dispense with reading articles in advance.

ARTICLE 1

To choose all Town Officers, Trustees and Commissioners and School District Officers for the ensuing years, including a member of the Board of Selectmen for three years.

The action: Robert L. Wheeler nominated CLINTON RISING for Cemetery Trustee. Voice vote in the affirmative.

Nominations for Fire Warden (2-year term) for remainder of term of Donald Girard — PAUL LAPERLE by F. Desrochers, DOUGLAS TOWER by D. Sterling. A statement was made that the nominations should be of 5th District residents. EMILE FILTEAU nominated by R. Wike — Mr. Filteau declined nomination. A standing vote was taken for above two nominations.

LAPERLE 142 - TOWER 27. LAPERLE announced winner.

Nominated for full 3-year term: MARCEL YERGEAU 108 LAURENT LAMY 19 DOUG TOWER 33 YERGEAU winner.

ARTICLE 12

To see if the Town will vote to authorize the Selectmen to purchase the Moore Hospital Building for an amount not to exceed One Hundred Eighty-Eight Thousand Dollars (\$188,000.00) to be paid to Hillsborough County in ten (10) equal installments; and to raise and appropriate the sum of Eighteen Thousand Eight Hundred Dollars (\$18,800.00) for the first installment, subject to the condition that a private developer be found to develop the Moore complex (Recommended by Budget Committee)

Re: Purchase of Moore Building — \$188,000.00. Town to raise and appropriate first installment of \$18,800.00.

Moved by Robert L. Wheeler with explanation of condition of building.

Question — Any developer interested in developing?

Answer - Yes, four developers.

Question - Of development of remaining acres.

Answer - Would help expand tax base for Goffstown.

Many pro and con comments — against the traffic, cost — for tax base, re-location of Police Department and emergency communications and possibly Court to this building — questionable as State now involved in Court.

Question — pertaining to Article 13 to raise \$222,658.00 for emergency operations within Police Department if located in Moore Building. If Article 12 passes, will Article 13 also?

Police statistics were stated about the crime rate being down in Goffstown and why do we need to expand police facilities.

Question — of how much frontage is involved and will the 99 years lease be rent free?

Answer — Current frontage is from driveway to driveway and 99 years lease is for \$1.00.

Steve Monier of the Police Department stated that he is involved in a study with no plans to expand the Police Department at present, even though complaint activity is up 13%. The Comprehensive Plan for Goffstown has stated that the Police Department be located in a geographically good location. Should be storage room and a garage for working on the vehicles. Police Department looking for a better facility for operations. Question of what percentage of the building would be utilized by Police Department — approximately 20% — the developer to develop the whole building; there

are several approaches for rest of the building, depending on the developer. The Selectmen stated they are more in favor of commercial development and declined to release names of the four developers interested (they were asked not to.) The question if this project feasible at present or perhaps should wait another year?

Comments that the land itself is valuable — building can be renovated — no developer has propositioned to tear building down. Another resident recommended voting down Article and waiting. Robert L. Wheeler stated that the developer will not develop the building unless the Town owns it.

Moderator Stark stated that voting on this Article will be by written ballot. Question — Why?

Answer — Because the dollar amount is over \$100,000.

Other comments were made about the location zoned as Agricultural, the sewerage goes into a septic facility (lagoon) owned by the County and then percolates into the river.

Selectman Nickerson not in favor of this Article.

Town Counsel Ray Cloutier stated that he is familiar with Town and County government and is in favor of purchasing the facility "a good buy at this price."

John Webster commented that on November 6, 1982, the Selectmen stated "that the Town is not in the Real Estate business."

A member of the Budget Committee agrees with the first part of the Article — does not agree with the Police Department concentration in this building; not enough information on this issue.

Paper balloting proceeded at 2:55 p.m.

Paper balloting closed at 3:55 p.m.

VOTE - YES 178 NO 146

Moderator declared the Article passed and entertained the motion to skip for the moment Articles 13 and 14 — so voted.

ARTICLE 15

To see if the Town will vote to raise and appropriate the sum of Five Thousand Dollars (\$5,000.00) to restore the 1930 Seagraves Fire Truck which the Town voted to retain at the 1970 Town meeting. (Recommended by Budget Committee)

RE: 1930 Seagraves Fire Truck — \$5000.00.

Selectmen Nickerson recommended that the Fire Department purchase.

VOTE on Article: YES - few NO - loud. Article defeated.

ARTICLE 16

To see if the Town will vote to authorize the Selectmen to dispose of the 1930 Seagraves.

RE: Disposition of the 1930 Seagraves Fire Truck.

Selectman Nickerson recommended turning it over to the Selectmen to dispose of - YES - Unanimous. PASSED.

To see if the Town will raise and appropriate the sum of Sixty-Three Thousand Dollars (\$63,000.00) for one (1) fully equipped dump truck with full hydraulics, including one 11-ft. wing, one 2-way radio and one sander body, complete and ready to work; Six Thousand Seven Hundred Dollars (\$6,700.00) to be withdrawn from the Highway Capital Reserve Fund and Fifty-Six Thousand Three Hundred Dollars (\$56,300.00) to be raised by taxes. (Recommended by Budget Committee.

RE: Dump Truck purchase. \$63,000.00.

Moved by Selectman Nickerson and explained that cost is \$4,500 less than in last year's Warrant because of purchase of a separate plow during the past year.

VOICE VOTE: YES - unanimous. PASSED.

ARTICLE 18

To see if the Town will vote to raise and appropriate the sum of One Hundred and Forty Thousand Dollars (\$140,000.00) as its share of the cost of the Mast Road reconstruction project. (Project #MG-M-5175 from Joffre Street to Moose Club Park Road) (Recommended by Budget Committee)

RE: Mast Road reconstruction — \$140,000.00.

Selectman Robert L. Wheeler recommended and explained why this should be done, Bartlett Corner Curve improvement.

VOICE VOTE: YES - unanimous. PASSED.

ARTICLE 19

To see if the Town will vote to raise and appropriate the sum of Seven Thousand Fifty-Seven Dollars (\$7,057.00) to be paid to the Visiting Nurse Association-Home Health Care Agency of Greater Manchester, Inc. to defray the costs of the agency's activities in the town. (By Petition) (Recommended by Budget Committee)

RE: Visiting Nurse Association - \$7057.00.

Selectman Robert L. Wheeler explained services performed this past year.

VOICE VOTE: YES - unanimous. PASSED.

ARTICLE 20

To see if the Town will vote to raise and appropriate the sum of Eight Thousand Dollars (\$8,000.00) for a parcel of land which runs from a point parallel to Station 415 on Depot Street, to land currently owned by the Town of Goffstown commonly known as the Highway Shed area; and a parcel of land beginning Seventy-Five (75) feet from the intersection of Main Street and Depot Street, westerly Two Hundred Seventy (270) feet, thence southerly Twelve (12) feet to Depot Street, thence easterly to the beginning point. The area of land is approximately Sixteen Thousand Four Hundred (16,400) square feet. The purpose is to acquire title to Depot Street. (Recommended by Budget Committee)

RE: Land on Depot Street title. \$8,000.00.

Selectman Robert L. Wheeler moved Article and explained if not purchased from Larry Brown, owner, it possibly would go into litigation. Mr. Brown purchased the Depot building, the strip of land all the way to the cemetery from the B & M Railroad. Some discussion.

VOICE VOTE: YES - unanimous. PASSED.

ARTICLE 21

To see if the Town will vote to raise and appropriate the sum of One Thousand Dollars (\$1,000.00) to help defray the cost of the Elderly Nutrition Program within the town. (By Petition) (Recommended by Budget Committee)

RE: Elderly Nutrition Program. \$1,000.00.

Selectman Nickerson moved with explanation of the meals and programs for the elderly.

VOICE VOTE: YES - unanimous. PASSED.

ARTICLE 22

To see if the Town will vote to raise and appropriate the sum of Seventy-Three Thousand Three Hundred Sixty Dollars (\$73,360.00) for an improved computer system. (Recommended by Budget Committee)

RE: Computer System. \$73,360.00.

Selectman Sarette moved and explained how Town departments would benefit with more efficiency — the Computer Committee members contacted several computer companies for Town's best needs.

VOICE VOTE: YES - loud. NO - one. PASSED.

Moderator stated that Article 13 would now be considered.

ARTICLE 13

To see if the Town will vote to raise and appropriate the sum of Two Hundred Twenty-Two Thousand Six Hundred Fifty-Eight Dollars (\$222,658.00) for the purpose of constructing an emergency operations center within the Police Department if located in the Moore Building; 50% of this amount to be reimbursed to the Town from the Federal Emergency Management Agency. (Recommended by Budget Committee)

RE: Emergency Operations Center in Police Department. \$222,658.00.

Moved by Robert L. Wheeler — explained that the grant application as one utilizing a "soft match" — \$111,000.00 to be reimbursed to the Town from the Federal Emergency Management Agency.

Advantages of the operations explained by Officer Steve Monier.

VOICE VOTE: YES - loud NO - not quite as loud

Moderator declared Article PASSED.

ARTICLE 14

To see if the Town will vote to authorize the Selectmen to negotiate a one year's extension of the option to purchase the Moore Building.

Moderator ruled that this Article be dismissed. Consented by VOICE VOTE — DISMISSED.

To see if the Town will vote to raise and appropriate the sum of Twenty-Three Thousand Seven Hundred Eighty Dollars (\$23,780.00) for monitoring wells at the Sanitary Landfill. (Recommended by Budget Committee)

RE: Monitoring wells at Sanitary Landfill. \$23,780.00.

Moved and explained by Selectman Sarette - required by law.

VOICE VOTE: YES - loud NO - few. PASSED.

ARTICLE 24

To see if the Town will vote to appropriate and authorize the withdrawal from the Revenue Sharing fund established under the provisions of the State and Local Assistance Act of 1972, for use as setoffs against budgeted appropriations for the specific purposes and in amounts indicated herewith, or take any other action hereon.

To see if the Town will vote to raise and appropriate the sum of Four Thousand Ninety-Two Dollars (\$4,092.00) to complete the full payment to retrofit Henry Bridge; Two Thousand Forty-Six Dollars (\$2,046.00) to be reimbursed by the State. (Recommended by Budget Committee)

RE: To retrofit Henry Bridge. \$4,092.00.

Moved and explained by Selectman Robert L. Wheeler — \$2,046.00 to be reimbursed by the State — more concrete was used than was originally estimated.

VOICE VOTE: YES - loud NO - few. PASSED.

ARTICLE 26

To see if the Town will vote to raise and appropriate the sum of Nineteen Thousand Four Hundred Fifty Dollars (\$19,450.00) for the purchase of three (3) acres more or less to expand the Shirley Hill Cemetery. (Recommended by the Budget Committee)

RE: Land for Shirley Hill Cemetery expansion. \$19,450.00.

Moved and explained by Selectman Nickerson — three acres are available, it is necessary to expand the cemetery — the sale money will be used to pay the present owner's taxes.

VOICE VOTE: YES - loud NO - few. PASSED.

ARTICLE 27

To see if the Town will vote to raise and appropriate the sum of Ten Thousand Dollars (\$10,000.00) for an engineering study and layout plan for Depot Street. (Not recommended by Budget Committee)

RE: Depot Street study. \$10,000.00.

Pro and con comments and discussion regarding an engineering study and layout plan for Depot Street and feasibility.

VOICE VOTE: YES - few NO - loud. DEFEATED.

ARTICLE 28

To see if the Town will vote to raise and appropriate the sum of Two Thousand (\$2,000.00) for the Interpretive Nature Trail Identification Project of the Conservation Commission; and to authorize the Selectmen to apply for, accept, and expend federal Land and Water Conservation Fund Grant funds, or other federal or state funds which may be available for this project to reduce the cost to the town. (Not recommended by Budget Committee)

RE: Nature Trail Project. \$2,000.00.

Explained by Chairman Conservation Commission Diana Sterling. Federal Funds and grants are available to develop trails for hiking, cross-country skiing, snowmobiling, etc.

VOICE VOTE: YES—loud NO—few. Moderator declared the vote was two-thirds, which was needed for Federal Grant. PASSED.

ARTICLE 29

To see if the town will vote to raise and appropriate the sum of One Thousand Dollars (\$1,000.00) to hire a Yield Tax Consultant to advise the selectmen on timber being harvested. (Recommended by Budget Committee)

RE: Yield Tax Consultant Services. \$1,000.00.

Moved and explained by Selectman Sarette that Bedford and Dunbarton utilize this service with good financial returns. "Intent to Cut" forms are on record at Town Hall. The service would determine actual amount of timber being harvested rather than a "guesstimate" and would bring in a good money return to town.

VOICE VOTE: YES - louder than NO'S. PASSED.

ARTICLE 30

To see if the Town will vote to raise and appropriate the budget submitted by the Budget Committee in the amount of Three Million Seven Hundred Ninety-Two Thousand Eight Hundred Fifty Dollars (\$3,792,850.00).

Note: This budget will be predicated by estimated revenues in the amount of One Million One Hundred Eighty Thousand Seven Hundred Sixteen Dollars (\$1,180,716.00) and will relate an estimated amount to be raised by taxes of Two Million Six Hundred Twelve Thousand One Hundred Thirty-Four Dollars (\$2,612,134.00). County Tax and School District Commitment not included. (Recommended by Budget Committee)

RE: Town Budget. \$3,792,850.00.

Moved and explained by Selectman Robert L. Wheeler to adjust amount to: \$3,789,850.00 due to \$5,000.00 (Article 15) and \$1,000.00 (Article 29) passed.

Amendment to this Article by Evelyn Connor:

"I make a motion to reduce the budget by \$2,000.00 from the Selectman's salary and expenses" totalling \$6,000.00. (\$2,000.00 each Selectman.)

Pro and con discussion — Selectmen work for low salaries, comparison figures from other communities, (also with Administrative Assistants.) They give of their personal time and self-employment points considered.

Question moved — AMENDMENT VOTE — YES — very few NO — loud. AMENDMENT DEFEATED.

VOICE VOTE on budget article YES — unanimous. (Final figure \$3,789,850.00). PASSED.

ARTICLE 31

To see if the Town will authorize and direct the Selectmen to review considerations through the Tri-County Solid Waste Management District, which may involve participation with CITIZENS/ VICON Resources Recovery Project or any other solid waste project consistent with the District Plan.

RE: Tri-County Solid Waste Management District.

Moved and explained by Selectman Robert L. Wheeler.

VOICE VOTE: Unanimous. PASSED.

ARTICLE 32

To see if the Town will vote to discontinue a certain portion of a Class VI Town road known as Old New Boston Road from the point where it intersects New Boston Road to a point where it meets a lane situated between lands presently owned by Piper and Monier, a distance of approximately Six Hundred Fifty (650) feet. (By Petition)

RE: Old New Boston Road.

Moved and explained by Selectman Nickerson.

Comments by Mr. Arnold Piper — in favor of discontinuing a certain portion of this Class VI road.

VOICE VOTE: YES - unanimous. PASSED.

ARTICLE 33

To see if the Town will vote to require the Selectmen to put out for competitive bid or quote, the summer paving contract. Further, that the Selectmen be required to accept the lowest qualified bid or quote. (By Petition)

RE: Summer paving contract by bid.

Explained by Town Counsel Ray Cloutier that the lowest bid is not always the best "qualified" bid. Mr. Cloutier cited previous court case. "Qualified" means posting of a bond.

VOICE VOTE: YES-2 or 3 NO-Unanimous. DEFEATED.

ARTICLE 34

To see if the Town of Goffstown will change the method used to elect the members of the Board of Fire Wardens. That the candidates shall appear on the written ballot and will no longer be elected by voice, standing, or by a show of hands. (By Petition)

RE: Election of Board of Fire Wardens.

Discussion and question re: district residence of members still agreed to follow and honor the 1st and 5th districts locations. Also will be elected according to the partisan election system — Republican and Democratic ballots.

VOICE VOTE: YES - louder than NO'S. PASSED.

ARTICLE 35

To see if the Town of Goffstown shall call upon the Governor and Executive Council, its State Representative(s) and State Senator to promptly convene a Special Session of the Legislature for the sole purpose of preventing the imposition of huge cost increases in electric rates resulting from the Seabrook Nuclear Power Plant of the citizens, business, schools, and agencies in the Town of Goffstown, and to direct the Selectmen to promptly notify our above listed elected officials of the Town's desire. (By Petition)

RE: Legislative Special Session for "Seabrook" rates.

Legislator Holly Abrams spoke in favor of special session — to limit liabilities of our sky rocketing electric rates — original Seabrook estimate of \$970,000,000. now estimated to be \$9 billion for construction. Legislator Alice Knight stated no need for special session. Legislator and Selectman Nickerson also against special session. Other comments discussed long range repercussions resulting from Seabrook Nuclear Power Plant, another statement that in no way would there be a sole issue at a special session — it would be a "political ploy" in a political year — a "free ride" for politicians. Moved question by loud AYE'S.

ARTICLE - VOICE VOTE - YES - loud NO - louder.

Request for standing vote.

Counters Ken Wall, Frank Desrochers, Albert Baines, Donna Kelly, Corky Gaudreault and Bill Parkinson, previously sworn in, counted vote.

YES - 32 NO - 108. ARTICLE DEFEATED.

ARTICLE 36

To see if the Town will authorize the Selectmen to borrow from time to time, such sums of money in anticipation of taxes as may be needed to meet the necessary running expenses of the Town.

RE: Authorizing Selectmen to borrow money.

Moved and explained by Selectman Robert L. Wheeler — no discussion.

VOICE VOTE - PASSED unanimously.

ARTICLE 37

To see if the Town will authorize the Selectmen to apply for, receive and expend money from any other governmental units or private sources to be used for purposes for which the Town may legally appropriate money; provided (1) that such grants and other monies do not require the expenditure of other Town funds, (2) that a public hearing shall be held by the Selectmen prior to the receipt and expenditure of such grants and monies; and (3) that such items shall be exempt from all provisions of RSA 32 relative to limitation and expenditure of Town monies, all as provided by RSA 31:95-b.

RE: Applying for grants etc. by Selectmen.

Moved by Selectman Robert L. Wheeler. No discussion.

VOICE VOTE: PASSED unanimously.

To see if the Town will vote to authorize the Selectmen to administer or dispose of any real estate acquired by the Town through Tax Collector's Deed, purchase, prescription, or gift.

RE: Selectmen to administer or dispose of Real Estate.

Moved by Selectman Nickerson. No discussion.

VOICE VOTE - PASSED unanimously.

ARTICLE 39

To hear the reports of Town Officers, Auditors, and Committees and to pass any relating thereto.

RE: Hearing of reports, etc. NONE.

ARTICLE 40

To transact any other business that may legally come before said meeting.

Any other business.

The year 1984 showed a marked increase in the department's call for services. The department responded to 748 calls as compared to 678 calls in 1983.

In 1984 we continued our Fire Prevention program as well as inspections of schools, nursing homes, commercial buildings, apartments and single family dwellings. Included in these inspections are life safety items such as exits, exit lighting, alarm systems and sprinkler systems. Many hazards have been eliminated by our inspections of chimneys, wood and coal stoves, fireplaces and oil burning equipment.

The Fire Dept. has been charged with the responsibility of administering the new "unvented space heater" laws and the new smoke detector laws as passed by the State legislature. We issued 80 unvented space heater permits this year. We will be inspecting occupancies for compliance of the smoke detector laws this coming year. This new law requires all residential buildings to have smoke detectors as required by the State of New Hampshire Fire Code that went into effect Nov. 8, 1984. Anyone with questions concerning this law may contact this department. These laws will help insure the safety of all New Hampshire residents.

The Goffstown Fire Department has three stations, the East Goffstown station, the Pinardville station and the Village station. The Pinardville and Village stations are manned from 7:30 am to 5 pm seven days a week. All stations rely on call firefighters to fill the rosters in each of the stations. Anyone interested in serving the community as a firefighter should contact the department.

EMERGENCY MEDICAL SERVICES

The Goffstown Emergency Medical Services has seen a continued growth over the last year. This is as it has been since the emergency ambulance service was implemented in 1980. An increase of 26 medical emergencies were handled by the Goffstown Fire Department over the 1983 total, for a total of 350 calls for medical aid.

Nine new Emergency Medical Technicians were trained and registered with the National Registry of EMTs. They are all currently active members of the department. Many of our EMTs were recertified in 1984, as is necessary every two years.

At no time has a stronger sense of commitment been felt by our personnel and staff to providing a quality EMS system. Many of our personnel have functioned as volunteer rescue squad members for almost five years. In light of the fact that this is double the average length of time an EMT remains active in New Hampshire, we have an outstanding record.

Again, the Goffstown Emergency Medical Services Association will be paying the expenses this year. Major items are also purchased by this funding organization. A multi-channel portable radio, pediatric anti-shock trousers, and four new tires were added to increase our capability and safety. This vital service has been supported by individuals, patients and other organizations since 1978. It was created by contributions and continues to operate by the donations given by those who feel this is a necessity for our community.

The Fire Department wishes to thank all its members, their families and all the citizens of Goffstown for their support this past year.

REPORT OF THE TOWN FOREST FIRE WARDEN AND STATE FOREST RANGER

Our first forest fire prevention law was enacted by our State Legislature 90 years ago. This early law set in place a cooperative forest fire prevention and suppression effort between city and town governments and State government. It simply stated that no open fire could be kindled, when the ground is free of snow, without the written permission of the town/city Forest Fire Warden. This law also stated that anyone kindling a fire without written permission shall be liable for the damage caused and subject to a \$1000 fine.

During the past 90 years, this law has worked so well that it has remained unchanged. All open fires when the ground is not covered with snow must be authorized by the local Forest Fire Warden. Persons kindling a tire without a permit when one is required are liable for damages caused, fire suppression costs and subject to a \$1000 fine.

This cooperative fire prevention law has contributed significantly to our nationally recognized annual forest fire loss record.

Highway Department

The Highway Dept. which employs 27 people, is composed of four sections; Highway, Sanitation, Sewage Treatment plant and Cemetery section. These sections have their individual responsibilities, which change according to work schedules and seasons.

Highway activities vary according to the circumstances. Catch basins, culverts and sewers need cleaning and repair. Cold patching of holes is done during the spring and fall, with hottopping (a more permanent repair) during the summer.

Street sweeping, cleaning the edges of roads, driveway permits and inspections, maintenance of departmental buildings, installation and removal of air conditioners at Town Hall, putting up and taking down voting booths during elections, stockpiling of sand at the Highway garage, inspections of new road construction, clearing away debris after auto accidents, picking up dead animals from Town roads and cleaning of litter in public areas are some of our regular duties.

Other responsibilities include inspection of new subdivision roads and driveways, installing new street signs and making and repairing of street signs in our paint shop. During snowstorms, in addition to sanding, salting and plowing, we must also maintain our rigid schedule of refuse collection.

The Sanitation section collects refuse daily, Monday through Friday, excluding holidays; with double pick-ups the day following a holiday. A second truck is required on Monday and Wednesday because of the increased volume of trash on those days. The landfill is open Monday through Saturday from 8 am to 5 pm except holidays. Resident stickers are required for admittance. These are available in the Town Clerk's office. The Sewage Treatment plant is supervised by one operator throughout the year. Sewerage problems and new construction are handled through the Highway Dept. office, which is open from 7 am to 3:30 pm, Monday through Friday. New sewerage connections are available through the Building Dept. in Town Hall.

Interments and cemetery care are handled by a supervisor and one employee, except during the spring and summer when extra help is hired for summer maintenance.

We have received delivery of our new plow/dump truck with slide-on sander. The Mast Road project near Goffstown Plaza is progressing rapidly, and is expected to be completed in the spring. We are in the process of clearing trees and stumps from rights-of-way in the Paige Hill and Locust Hill areas to accommodate the increases in traffic and for the safety of school buses and large trucks.

The Highway Department wishes to thank the taxpayers, Selectmen, Heads of Departments and all of their employees for their cooperation and thoughtfulness during the year.

A special thanks to the Highway Dept. employees and their families for their unselfish dedication this past year.

Our deepest appreciation goes to two of our employees, Lloyd Bailey, Sr. our general foreman and engineer; and Clarence Normand, grader operator, who have retired after many years of service. Thank you, gentlemen.

Police Department

1984 was a significant and memorable year for the Goffstown Police Department.

In July, Chief Robert J. Wike retired from law enforcement after 26 years of dedicated service to the community. He served 19 of those years as our Chief of Police, and oversaw the growth of the department from 3 full-time sworn officers in 1965 to a current authorized force of 18 sworn officers.

His legacy was to leave a police department which established its reputation for excellence in service to our citizens. All of us in the department will continue to dedicate ourselves to furthering those goals which will insure the safety and well-being of our community.

It is well known that the unchecked growth of crime in rapidly growing suburban areas can detrimentally effect the quality of life in our community.

For this reason, we have placed a heavy emphasis in 1984 on planning for future growth, and in the development of programming efforts, in concert with the community, which will prevent crime before it occurs.

The following such programs were initiated and/or continued this year:

A. Officer Friendly — A Sears-Roebuck Foundation sponsored program. Officers visit each classroom in grades K-4 emphasizing crime prevention and safety, and explaining the role of the police officer in society.

During the first visit to the schools, Sgt. Michael French and Officer Susan Lebel reviewed particular prevention skills aimed at reducing the risk of child abductions. Concerning that issue, the Goffstown Police Department and the Goffstown Clergy Association, along with other concerned groups, are exploring the feasibility of further development of a more comprehensive community-wide Child Safety Program, to offer more information and assistance to parents, teachers, and children. A community organizational meeting held at the Goffstown High School on January 8, 1985 generated support for such efforts and should result in positive measures to protect our most important resource — our children. The Goffstown School Board has heartily endorsed efforts in this area.

B. Increased DWI & Alcohol Countermeasures Program — In August, the Town of Goffstown and the Goffstown Chemical People Task Force received a \$9,000 grant from the New Hampshire Highway Safety Agency to combat drunk driving in the community.

Submitted by the Police Department, the bulk of the monies were made available to allow stepped up patrols on week-ends and during holiday periods to get the impaired driver off our highways. Over 60% of all fatal automobile accidents involve alcohol.

In addition to increased enforcement, the Chemical People Task Force worked very hard in developing and generating an increased awareness of the hazards of drinking and driving, in the hopes that this would prevent someone from driving drunk. The Task Force is to be commended for its efforts.

This is one example of a very important principle in preventing crime. That is the recognition that crime is not just a police problem, it's everyone's problem, and that only by working together as a community can your law enforcement agency be effective.



"Officer Friendly" is a valuable and positive program to students in grades K-4, and is now in its ninth year.

POLICE SERVICE

Good police service is basically good patrol service.

We noted an astounding trend by mid 1984. The combined workload in calls for service (complaints) and in arrests had increased 55% over the same period in 1983. This has placed a tremendous burden on each and every full-time and part-time officer, dispatcher and civilian employee within the department.

Our part-time officers' force is to be commended for their excellent work and assistance to the regular officers. Without a contingent of dedicated and well-trained special officers, it would be impossible to adequately carry out our patrol functions, in meeting the demands for service. All of these men and women must donate several hours of free time each month, and must purchase their own equipment.

COMMUNICATIONS

In the early spring of 1984, the Hillsborough County Communication Center was no longer contracted through the Town of Goffstown; hence our communication staff dropped from 9 fulltime personnel to 6 full-time personnel. This left, on most shifts, a single dispatcher to handle all radio and telephone communications, complaint taking, and information processing.

Our department still, however, does contractual dispatching on a fee basis for Litchfield Police Department, New Boston Police Department and the New Boston Fire Department. As well, we dispatch full-time for our own fire department. Needless to say, the Communication Center, as the "hub" of any department, was very busy during 1984 and our dispatchers have performed admirably under the conditions.

RECORDS

Every call for service or arrest generates paperwork which must be categorized and filed for future use. Many reports are required by State or Federal law. This can become an everburgeoning problem, which, if not properly controlled, can quite literally bury a department.

The purchase during 1984 of the new computer system has greatly aided our information processing for all divisions, and as it becomes fully operational in 1985, promises to streamline and economize our complaint taking, reporting and filing systems.

Our Records personnel have devoted themselves to this economization and must be commended for "keeping up" with the increased flow.

FUTURE PROJECTS

One of the highlights of 1984 was the work towards the utilization of the Moore Building purchased from the County at the last Town Meeting; providing that a suitable private developer could be found to develop that area with the prospect of a new police facility being built at that site.

It is our hope that this project will move forward swiftly in 1985, since the current proposal from the selected developer creates the potential to locate a police facility and Emergency Operations Center (Communications) at minimal financial impact to the community.

A move to this area of the community by the police dept. is in keeping with both comprehensive plans dating back to 1967, since it is centrally located, in a valuable area now controlled by the County.

A pre-application grant has been tentatively approved by the Federal Emergency Management agency for the Operations Center, and would be in addition to the funds being provided by the developer.

It is evident that the current facility in the Town Hall basement is inadequate, and not readily accessible to all of our residents. It is encumbent upon all of us to plan ahead and assess how these needs can be met in the most cost-effective manner.

The prospect of acquiring valuable property and a needed facility at minimal cost is indeed an exciting one.

As your new Chief of Police, I wish to thank all of those citizens who have assisted in maintaining a safe and secure community for the betterment of all.

You have my assurance that the entire Police Department will continue to do the same in an ethical and professional manner.

We process permits for electrical work, plumbing, mechanical work and new signs.

Applications for the Board of Adjustment and enforcement of zoning and sub-division regulations, are also handled through this office.

We hope that everyone will allow us to lead them through the proper steps of approval in this day and age of increased paperwork involved in building and zoning.

We would like to remind everyone that a permit is required by our zoning ordinance and the B.O.C.A. code for all work except items of maintenance or repair.

Industrial Council

The Goffstown Industrial Council has been working diligently to find ways to broaden the tax base of Goffstown.

Years ago, the Council was instrumental in having the water line installed on Daniel Plummer Road. Since then the area has seen an orderly growth of clean, small industrial buildings. This industrial growth has helped us in keeping taxes down.

Our current project is the development of the Moore General Hospital complex. Hopefully we shall see the development of this property in progress such that within a year or so we will realize tax benefits from this fine piece of property. Our long range goals are to recommend that areas of the Town be rezoned as industrial land, assist in acquiring the necessary utilities for these areas, and then promote the development of these areas with clean and orderly industrial units.

The Selectmen tell us that over fifty percent of all industrial development that exists in Goffstown has taken place in the last four and a half years. This tends to keep tax increases within manageable limits and allows our educational and municipal services to be delivered at the current high level.

Civil Defense

The Goffstown Civil Defense organization continues to maintain a readiness posture which enables the community to respond effectively during any manmade or natural disaster. Insuring that the emergency operations plan is kept up to date is a major responsibility in that regard.

During 1984, portions of the plan were utilized during several days of flooding along the river area of Pinardville. Under the direction of Stephen R. Monier, and Deputies Brad O'Neil and Edward Tuthill, the Civil Defense Unit of the town, serves as a focal point of coordination of emergency response, as well as a vital link to State and Federal disaster assistance. The Civil Defense organization has been working closely with the State and Federal organizations of the Federal Emergency Management Agency in the possibility of obtaining grant monies for a new emergency operations center located within a police facility, if that facility is constructed during 1985.

The Town of Goffstown benefits greatly from participation in the reimbursement program with the Federal Government, and all costs involved in Civil Defense, including equipment purchases are matched by the Federal Emergency Management Agency through the reimbursement program.

Librarian's Report

The year 1984 was a busy one, bringing many changes to the Goffstown Library. In early April, librarian H. Donley Wray announced his resignation to the Board of Trustees effective June 30.

In July, I assumed the role of librarian along with co-workers Betsy Elliot, Helen Leahy, Chris McSweeney and the Trustees, to continue and expand library services.

The renovation of the North Room was completed this summer, augmenting shelf space and necessitating the rearrangement of books and other materials. In addition to housing the young adult fiction collection the North Room also contains large print books, poetry, story collections and the classics.

The former Young Adult Room now has a variety of uses, serving as reference room and periodical reading room.

The number of current fiction and non-fiction available to adult readers has been increased with the addition of the McNaughton collection — over two hundred books available on a leased basis, and continually being changed. Many reference books have been updated and new titles purchased to improve the effectiveness of the materials available for research. The adult record collection has been expanded and audio cassettes have been introduced.

Library materials have been supplemented through the use of inter-library loans, borrowed from the other libraries in the Hillstown Cooperative of which Goffstown is an active member. Additionally, many non-fiction materials were requested through the NH State Library and received from public and academic libraries throughout the state. Our library has also inter-libraryloaned out of state. Our collection of large print books has been supplemented through the NH State Library for the Handicapped, and the Manchester City Library.

The Children's Library, under the direction of Betsy Elliot has been expanding its book and magazine collections. Non-print has also been introduced by a children's record collection and the circulation of book and cassette kits for beginning and advanced readers.

Programs for children continued with the Saturday film series and its expansion to a Saturday showing at Bartlett School. Preschool storytimes also continued with the addition of an afternoon session.

The summer reading program involved over fifty children. The library has been scheduling special children's activities after school on a monthly basis.

Nineteen eighty-four heralded the organization of a Friends of the Goffstown Library group to support and extend library services. The Friends and the Trustees sponsored a well-attended Holiday Open House in December, and are planning to make it an annual event.

We wish to thank the many people who have shown an interest in the library through their fine donations of books, magazines and time, and look forward to another year of growth in the programs and services we offer to Goffstown residents.

Planning Board

We wrote in our 1983 report that "1983 has been an extremely busy year". Little did we know how active we would be in 1984.. no doubt, the most active year since the Planning Board's inception in 1961.

We have been meeting an average of three times a month, with most meetings lasting until midnite. In addition, several members have attended special meetings and seminars sponsored by the N.H. Municipal Association. The Board is becoming familiar with the new complex "Land Use Laws" of New Hampshire which became effective on Jan. 1, 1984.

Four major projects were accomplished during 1984 by the Board:

- Printing and updating Zoning books.
- Adoption of Goffstown Planning Board Rules of Procedure.
- 3. Changing of several major zoning laws.
- 4. Printing and updating new sub-division books.

Along with its normal work on sub-divisions, site plan reviews, C.I.P. studies and review of the Goffstown Master Plan, we hope to accomplish several other items during 1985:

- 1. Further update the subdivision regulations.
- Study the possible need to update the Goffstown Master Plan per RSA 674:2.
- Meet with all property owners in the Main St., Church St., Depot St. block when the Post Office is completed to plan traffic flow and parking in the area.
- 4. Coordinate a plan to number all properties in Goffstown.

The Planning Board tried to be fair in all its decisions in 1984, but with over seventeen million dollars' worth of construction in Residential/Commercial/Industrial areas; over 30 public meetings and numbers of consultations ... not all citizens in a fast growing area will be happy. We try to do what is best for ALL our citizens ... in ALL sections of Town.

I would like to thank the entire Board for its tireless work under very trying circumstances — we have had excellent attendance with some meetings every other night, and every week on several occasions.

Southern New Hampshire Planning Commission

Goffstown's membership in the Southern New Hampshire Planning Commission provides the Selectmen and the Planning Board with access to a variety of extremely cost-effective staff services that are available to help them deal with numerous planning and planning-related concerns.

Staff services rendered under the Commission's local assistance program consist of (1) those which the Commission believes are important enough to warrant a general notification of all member communities and (2) those which are specifically requested by municipal officials in accordance with locallydetermined priorities.

Local assistance services provided to the Town of Goffstown during the past year included:

- Provided the Goffstown Historic District Commission with Historic Preservation Fund financial assistance to help continue historic/cultural resources surveys in the Goffstown Village and Grasmere areas;
- Provided the Planning Board with recommendations regarding the notification of abutters for site plan review purposes;
- Advised the Zoning Board of Adjustment concerning the notification of condominium residents as abutters;
- Assisted the Board of Selectmen in their efforts to obtain Federal/State assistance with a bridge repair problem;
- Advised the Selectmen's office regarding 1984 Community Development Block Grant program requirements;
- At the request of the Administrative Assistant reviewed Federal rental housing rehabilitation program guidelines;

- Advised the Planning Board regarding procedures for handling a proposed subdivision involving a landlocked parcel;
- Updated the Town road map at the request of the Board of Selectmen;
- At the request of the Industrial Council, reviewed the industrial zoning provisions, the Goffstown Comprehensive Plan, and presented staff recommendations on the establishment of an industrial park zone;
- Reviewed the Subdivision and Site Plan Review Regulations for adequacy and consistency;
- Co-sponsored the Municipal Law Lecture Series attended by several Goffstown officials;
- Co-sponsored the Natural Resources Lecture Series conducted by the Strafford and Rockingham counties Conservation Districts and Cooperative Extension Service to which Goffstown officials were invited; and
- Provided the Planning Board with a suggested schedule for the notice and conduct of public hearings pertaining to proposed amendments to the zoning ordinance to be considered by the March, 1985 annual Town meeting.

The Visiting Nurse Association Home Health Agency of Greater Manchester, Inc.

Founded in 1897 the Visiting Nurse Association has an 87 year history of providing home health care services to the greater Manchester community. The service area includes Auburn, Bedford, Candia, Goffstown, Hooksett, and Manchester, with limited services to Amherst, Milford, and Mont Vernon. VNA is accredited jointly by the National League for Nursing and the American Public Health Association. It carries Medicare and Medicaid certification and receives partial program funding from the Greater Manchester United Way.

0

VNA home nursing aide services are available 7 days a week and 24 hours a day, with other services provided on a regular schedule. The Home Care Program which includes services to terminally ill continues to be the program serving the largest number of residents.

VNA is committed to providing necessary services to people who are financially unable to pay the usual fees. Fees are explained to our patients at the first visit to the home and adjustments are made on an individual basis. The Agency has also continued to provide Immunization clinics and adult health screening programs, including Blood Pressure screening and Foot Care Clinics to the community. Other programs include the Occupational Health Services Program and the Parent-Child Health Program which includes the Teenage Pregnancy Program. Walk-in Blood Pressure Screening, health counseling and teaching are provided Monday-Friday from 1-4 at the office at 194 Concord Street in Manchester.

Town appropriations are a vital part of the funds which make these services possible. This past year 2,337 units of home and community service were rendered to 234 residents.

Some of these services for people who were unable to pay were paid for in part by the town appropriation of \$7,057, various grants, United Way, donations, and solicitations. The Town of Goffstown is represented on the VNA Board of Directors by Alice Knight.

Historic District

The primary purpose of Historic District Commissions is to promote historic preservation. Cultural survey forms are completed on houses over fifty years of age, thus documenting the history of each town. These surveys give the Commissions an overview of the cultural heritage of their towns and also provides the State Historic Preservation Office with documentation of the state's historic resources, since copies of the survey forms are placed on file in Concord.

The Goffstown Historic District Commission is in the third year of this project, and we have sent fifty completed forms (with photos) on houses in Goffstown Village and the outlying areas to Concord. We have also sent fifty "draft" forms (without photos) on houses in Grasmere to Concord.

We are now completing additional forms by adding photos and documentation. Volunteer surveyors are working in Grasmere and other areas which have not yet been surveyed. In the near future, we will begin a Pinardville survey.

In March, 1984, the Goffstown Historic District Commission proposed a zoning change to include a historic district of 24 houses in the traffic circle area, South Mast and Main Streets, in Goffstown Village. This was not approved by the voters. However, there was considerable interest in historic preservation displayed. In July we sent our first Goffstown Historic District Newsletter to owners of surveyed properties. It was well received, and we expect to continue the newsletters. Copies of completed survey forms were sent to homeowners in January, 1985.

We are continuing active participation in the N.H. Association of Historic District Commissions. Commission members from all over the state meet to discuss mutual problems and to participate in workshops on preservation.

The Goffstown Historic District Commission has received federal grants through the State Historic Preservation Office in 1983 and 1984. The funds are primarily used for taking photographs of the surveyed homes, printing the photos, copying and mailing.

We welcome volunteer help in our historic preservation work in Goffstown.

March 19, 1984

The Annual Meeting of the Goffstown Village Precinct was held at the Goffstown Upper Elementary School on March 19, 1984 and was called to order at 7:30 P.M.

It was moved and seconded and so voted to dispense with the reading of the warrant and take up each article in order.

ARTICLE I

Gordon Jackson was elected as Moderator Pro Tem and was sworn in by Hedley Pingree. Isabelle Gilbert was then elected as Clerk and was duly sworn in by the Moderator, Gordon Jackson.

ARTICLE II

Gardner Lamson was nominated and elected as Water Commissioner to serve a five year term.

ARTICLE III

It was moved, seconded and so voted to accept the report of the budget committee and to appropriate the sum of Eighty Five Thousand One Hundred Dollars (\$85,100.00) for the ensuing year.

ARTICLE IV

It was moved, seconded and so voted to allow the Board of Water Commissioners the right to borrow in excess of One Thousand Dollars (\$1000.00) for any emergency that may arise.

ARTICLE V

Chairman James Ackerman referred to his report which was published in the Annual Town Report.

ARTICLE VI

Mr. Ackerman made reference to the fact that the Fire Department has made a few suggestions to be incorporated in the new book of rules, one suggestion being that new hydrants should be installed 800 feet apart rather than 1000 feet apart, and also to maintain, if possible, ten pounds per square inch of water pressure in all hydrants, which is the equivalent of 530 gallons per minute.

There being no further business to come before the meeting, it was moved and seconded and so voted to adjourn the meeting at 7:39 P.M.

Water Commission

The Selectmen have declared the theme for this year's annual report to be "It's been a busy year". Well, the Goffstown Water Precinct has indeed had a busy year. We purchased the buildings that were used as living quarters for the fire tower personnel from the State, and they were subsequently moved to the chlorine building area.

In recent months, the Board purchased a 1½ acre tract of land on High Street. The site is to be used to build a 500,000 gallon cast in-place concrete water storage tank, which will be underground. This is another effort of the Board to improve water service.

The Board has entered into a contract with a Forester to oversee the select cutting of the water shed. This is the first time that this has been done in twenty nine years. Basically, this is a land management project.

In 1955 former Board members voted to install two gravel packed wells on land north of the West Lawn Cemetery. This year well number one was cleaned and the motor rewound. Well number two will be cleaned in 1985.

Due to the fact that there was a considerable amount of vandalism at the chlorine building, the Board had a cyclone fence with a row of barbed wire on the top installed.

Water usage for the year was as follows: the precinct used 37,287,750 gallons from the chlorine plant; 25,395,150 gallons from the gravel packed wells. There were three breaks, fifteen new services, no freeze-ups, and forty five meter replacements.

The aim of the Board of Water Commissioners, again this year, is to provide safe drinking water and to continue to improve the system.

In August 1984, 2000 feet of 6-inch water main on North Mast Street was cleaned, and as of December 1984, over 5000 feet of main has been cleaned on North Mast. Results have been very good, since a hydrant that had been getting 200 gallons a minute is now getting 600 gallons a minute.

Our apologies to the people in that area for the rust problems. We are working on this and have consulted with engineers who are advising us on proper procedures to correct the problem. Despite the rust problems, main cleaning has proven to be an inexpensive method compared to replacing mains, \$2.00 perfoot cost as opposed to \$20.00 per foot for main replacement.

A big thank you to the Highway Department for all of their help throughout the year, and also to the Fire, Police and Recreation departments for their assistance.

Sewer Commission

The year 1984 was an extremely busy one for the Sewer Commission. Mr. Robert Merrill passed away suddenly when it appeared he was well on his way to recovery from a stroke. Mr. Merrill will be sorely missed by the Commission and the Town. His loss, coupled with the resignation of Alan Gifford was felt deeply by the Commission members.

John Davis was appointed to complete Mr. Merrill's term, and was later elected to office. Paul LaPerle was appointed to complete Mr. Gifford's term.

Our chief task was to finalize an Intermunicipal Agreement with the City of Manchester for treatment of the Town's sewage by July 1, 1984. Negotiations with the City have been progressing slowly since 1979. They consisted of numerous meetings with the Sewer Commission's attorney, representatives of the City of Manchester and representatives of the New Hampshire Water Supply and Pollution Control Commission. Pressure to complete the agreement was intense, since we were working continually with the threat of a sewer ban by the State. However, the July 1 date passed without an agreement, and the Town was ordered to a "show cause" hearing in Concord. After due deliberation, the State body granted an extension to January 1, 1985. As of this writing, Dec. 1984, the agreement is still not completed.

During the year, we were also involved with attempting to get the Town interceptor program started. The latest information from the State lists Goffstown to receive funding approximately in October 1985 to begin work on the first phase of this program. This first phase includes an interceptor from the County complex to the Manchester line to pick up all sewage flow from the County and all of Pinardville and transmit it to a hook-up with the Manchester system. This commission was also charged with reviewing Town costs for our portion of Manchester's west side sewerage facilities and our portion of the Manchester treatment plant.

We will again seek approval from the townspeople to fund the Interceptor program this year. Also, the funding of the Town's share of facilities within Manchester will be sought. Both are required by State and Federal regulations.

In 1984, we also began the long process of rehabilitating the Town's existing sewer facilities. Church St. piping was cleaned and TV'd, and is in the process of being sealed. Also Mast Rd. at the intersection of College Road. As part of a permit to discharge into the Town's system, we required the developers of Highwood Village to clean a portion on Warren Ave. The inspection revealed necessary corrective work was required, and this was completed by the developer. This year, the Commission has again requested funds to continue rehabilitating the Town's sewerage facilities.

Finally, this past year brought a large increase in sewer permits, and requests for sewer permits, due largely to a need for housing in southern New Hampshire.

This Commission would like to express our thanks to Ray Kenison of the Town Highway Department, for his diligence and untiring efforts on behalf of the Sewer Commission and the citizens of the Town.

A motion was made by Kenneth Diaz, and seconded, to accept Article 3 as read. Motion carried by a voice vote.

ARTICLE 4

To see if the School District will raise and appropriate the sum of One Hundred Twenty Thousand Dollars (\$120,000) for roof repairs at Upper Elementary School and Goffstown Area High School or take any other action in relation thereto. (Recommended by the Budget Committee)

A motion was made by Dallas Mahoney, and seconded, to accept Article 4 as read. Following a brief discussion, the motion was carried by a voice vote.

ARTICLE 5

To see if the School District will raise and appropriate the sum of Twelve Thousand Dollars (\$12,000) to purchase and install an intercom system at the Goffstown Area High School or take any other action in relation thereto. (Recommended by the Budget Committee).

A motion was made by Donna Kelly, and seconded, to accept Article 5 as read. After some discussion Wayne Jones moved to amend the article to read that the School Board and Goffstown Area High School administration seek to involve high school students in the installation of equipment for this project. The amendment was defeated on a voice vote. The original article was voted on and was carried by a voice vote.

ARTICLE 6

To see if the School District will raise and appropriate the sum of Six Thousand Dollars (\$6,000) for library books; said \$6,000 to be withdrawn from the Mildred Stark fund. (Submitted by Petition) (Recommended by the Budget Committee).

A motion was made by Allen Gamans, and seconded, to accept Article 6 as read. Carried by a voice vote.

ARTICLE 7

To see what sum of money the District will vote to raise and appropriate for the support of schools, for the payment of salaries for school district officials, and agents, and for the payment of statutory obligations of the District.

A motion was made by Tupper Kinder that the District raise and appropriate Five Million, Five Hundred Seventy-Six Thousand, Two Hundred Eighty Dollars (\$5,576,280.00) which sum includes all previously passed special articles, for the support of schools, for the payment of salaries for School District officials, and Agents, and for the payment of statutory obligations of the District. Following a discussion, Donna Kelly moved to amend the motion to a figure of Five Million, Six Hundred Fifty-Eight Thousand, Nine Hundred Forty Six Dollars (\$5,658,946.00). The amendment was passed by a standing vote. Yes: 109. No: 57.

ARTICLE 8

To transact any other business that may legally come before this meeting.

Superintendent Paradis and members of the School Board answered questions from the audience concerning the citation on asbestos received from the Environmental Protection Agency on March 12th.

Motion was made and seconded to adjourn. Meeting adjourned at 10:35 p.m.

Members of the School Board Goffstown School District

We have examined the combined financial statements of the funds and account group as indexed, of the Goffstown School District as of and for the fiscal year ended June 30, 1984. Our examination was made in accordance with generally accepted auditing standards and accordingly, included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

As is the general practice with many New Hampshire municipalities, the Goffstown School District has not maintained a record of its general fixed assets and accordingly, a statement of general fixed assets, required by generally accepted accounting principles, is not included in this financial report.

In our opinion, except that the omission of the financial statements described above results in an incomplete presentation, as explained in the preceding paragraph, the combined financial statements referred to above present fairly the financial position of the Goffstown School District as at June 30, 1984 and the results of its operations for the year then ended, in conformity with generally accepted accounting principles applied on a basis consistent with that of the preceding year.

Our examination was made for the purpose of forming an opinion on the combined financial statements taken as a whole. The supporting schedules listed in the index are presented for the purposes of additional analysis and are not a required part of the combined financial statements of the Goffstown School District. The information has been subjected to the auditing procedures applied in the examination of the combined financial statements and, in our opinion, is fairly stated in all material respects in relation to the combined financial statements taken as a whole.

REPORT OF THE SUPERINTENDENT OF SCHOOLS TO THE SCHOOL BOARD AND CITIZENS OF GOFFSTOWN

I herewith submit my 1985 Report concerning the public schools of Goffstown.

The 1984-85 school year is significant because pupils entering school this year will complete their college educations in the 21st century. When the technological advancements which have taken place in the last 20 years are examined, it is easy for us to be awed by the responsibility of preparing youth to live in a century that will make educational demands we can only incompletely imagine. It therefore seems appropriate to report to the citizens of Goffstown on the efforts being made to develop curricula that will prepare our children for life in a high tech society.

It is reasonable to speculate that there will be virtually no occupational endeavor in which individuals will not in some way need to interact with computers. We have taken a careful approach to computer education so that sound educational decisions can be made that will not be influenced by fads that come and go. We believe that it would be irresponsible to leap into huge expenditures for computers before establishing an approach that is flexible enough to accommodate the rapid technological change that is certain to take place. At the same time it is equally irresponsible to be immobilized by caution and thus fail to meet our commitment to the pupils who will be graduating in the near future and who need to be prepared for a world in which computers are playing an important role.

It is with the above mentioned considerations that all 5 districts in S.A.U. #19 are working on a computer plan that will tulfill our responsibilities to both pupils and taxpayers. The plan encompasses 5 basic steps:

- Identify the computer applications that will be necessary and relevant for successful entry into a high tech society. To this end, we believe that computers will continue to be used to manage data, to perform calculations and to make the editing process in writing more efficient. All of our pupils should be given skills in at least these areas. Many other areas are being considered. Some of these include the computer as an instructor, a communications network and a simulator.
- 2. Once applications have been identified, specific skills that we wish our pupils to attain will be identified. Attached to these skills will be the grade level of instruction and the degree of mastery expected.
- 3. Once applications and skill expectations have been identified, specific categories of software will be identified as those most effective in achieving stated learning objectives.
- Based on identified software, hardware will be selected that can run the identified software. Hardware that is selected may vary depending upon the software application.
- Because implementation will be costly, the district will establish an implementation schedule which allows for the distribution of costs over several years while guaranteeing that priority areas for staff training and pupil instruction are implemented first.

In the process of implementation it is certain that new applications will be discussed. Each of these can be routed through the above 5 step process so that computer education in Goffstown will remain up to date. We believe that the above approach is a sensible one that will long serve the Goffstown School District. This year's budget as well as future budgets will include allocations for computer education. We look forward to your support in preparing our children for the future.

I wish to express my appreciation for the assistance and cooperation provided me by the administrators, teachers, School Board, and citizens of Goffstown. Without this assistance and cooperation, many of the things accomplished would have been left undone, and I look forward to another prosperous year—a year of continued cooperation.

GOFFSTOWN ANNUAL SCHOOL HEALTH REPORT September 1983 - June 1984

The goal of the school health services is to develop programs that are: (1) responsive to the health needs of students; (2) relevant to the child's ability to profit from the educational experiences; and (3) stimulating for a positive health concept and health behavior.

We want school nursing to become an action program, rather than a reaction program. Ninety percent of a school nurse's caseload involves dealing with healthy, developing students. We can assure their continuing in a normal health-developing pattern through the use of increased periodic screenings and checkpoints at selected intervals.

Our school nurses respond to the needs of students in community involvement by sponsoring programs such as SADD, now in its second year of involvement with alcohol and drug awareness. Excellent assemblies have been held, with appropriate speakers and film presentations.

We appreciate the generous support given to us from "The Chemical People." Students are also preparing an educational program that will be offered to appropriate grades.

The Future Medics are involved with sponsoring the Bloodmobile, as well as the pre-school vision and hearing program conducted by the State Department and the local Lions Club.

Only through close cooperation of staff and administration, and through communication, can the health goals of our school system be met. We wish to thank all those concerned for their contribution in serving the health needs of the children in Goffstown.

BARTLETT ELEMENTARY SCHOOL Leon J. Cote, Principal

Education at Bartlett School has dramatically changed, since the advent of the Federal Mandates, which requires educating the handicapped population starting at the age of three in an environment of least restriction.

Bartlett School is presently a certified district school where students from other school districts within our School Administrative Unit are assigned to be educated. Students from these other school districts are assigned on a tuition basis.

Mrs. Anne Marie Kalinski, with her classroom assistant, Mrs. Gretchen Rockefeller, have a classroom educating the three to five year olds assigned to her through the School Administrative Unit C.O.R.E. Evaluation Team, under the direction of Dr. Elizabeth O'Reilly, Special Needs Director.

Students having somewhat the same difficulty that are within the first grade age range are assigned to Sr. Mary-Elizabeth Leonard, who with her assistant, Mrs. Judy Capobianco, are responsible for their education.

Students in the upper age range who can be mainstreamed whenever possible within the grade levels offered at Bartlett School are assigned to Mrs. Denise Forest. She is responsible for educating her students and preparing them for their next level of education at the Upper Elementary School.

Assisting the students within the Handicapped Program on a daily basis are: Mrs. Jeanne Paskevich - Speech Language Pathologist, Mrs. Dina Berger - Speech Language Therapist, and Mrs. Cindy Hendrick - Occupational Therapist.

Mrs. Shelley Lefebvre, who is the Elementary School Speech Language Therapist, assists with those students mainstreamed at various grade levels.

With a continued increase in enrollment within the six year old category, Mrs. Karen Frisbie, has been hired to assist Sr. Mary-Elizabeth Leonard, with the strong possibility of splitting that classroom within the very near future.

Also teaching in the Special Education area is Mrs. Kathy Proulx, who is the Chapter I person, a Federally subsidized program, presently used to teach those regular students, grades one through four, who have been coded and have difficulty in the mathematics area.

Mrs. Joanne Perreault is in charge of the Resource Room and is responsible for those students in grades one through four having difficulties within the Language Arts area.

The regular education program comprises of three first grade teachers, Mrs. Linda Mack, Mrs. Arlene Tetrault, and Miss Patricia Albanese. The second graders are taught by, Mrs. Jane Hayes and Mrs. Lee Duncan. The third grade teachers are Mrs. Mary Marden and Mrs. Leila Lavigne. The fourth grades are taught by Miss Priscilla Letendre and Mr. Roland Biron.

Mrs. Lee Duncan serves as Head Teacher for Bartlett School, in that Mr. Leon Cote, Principal, continues to assume the responsibilities of both Bartlett School and Maple Avenue.

Mrs. Jeannine LaRoche is our School Nurse and is responsible for student health concerns.

Mrs. Linda Chakas is the school secretary whose area of responsibility is diverse and fluctuates with the daily operations of the school.

Mrs. Cecile Lampron, Head Cook, with her assistant, Mrs. Lorraine Pinard, are responsible for preparing and serving a nutritious balanced meal to the students.

Mr. Michael Lencki is our custodian and is in charge of maintaining and cleaning Bartlett School. His expertise and efforts are very much appreciated.

The Bartlett School Community Club continues to be an integral part of Bartlett School and we are thankful for their assistance in the operation of not only the library, but the many projects and programs which they not only support financially but physically assist in carrying them through to a successful conclusion. We are ever grateful to this great club.

As you can see, education continues to change, is costly, and we thank the citizens of Goffstown for their continued support. You are always invited to visit your school.

MAPLE AVENUE ELEMENTARY SCHOOL Leon J. Cote, Principal

Maple Avenue Elementary School continues to use all available space for its present educational programs, making it extremely difficult to venture into any additional programs requiring space. Consideration should be given at some future date to expand the facilities so that we could not only meet the minimum standards for library services and art but also expand in the areas of educating the handicapped closer to their home.

The elementary schools are beginning to incorporate computers and computer science within their curriculum. Many of the teachers are taking computer training courses, and with the necessary hardware and software, will be able to introduce their students to the use of the computer. With limited space available, computers are placed on carts and used within the existing classrooms. The computer task force will be continuously working to upgrade and improve computer education in the elementary schools.

The basic educational program at Maple Avenue Elementary School is offered in a self-contained classroom setting utilizing the classroom teachers' creativity and expertise. We presently have four first grades taught by Mrs. Gail Barker, Mrs. Diane Carlisle, Head Teacher, Mrs. June Ekdahl and Mrs. Irene Willey. Second grade is taught by Mrs. Jean Walker, Miss Beverly Sarette, Mrs. Margaret Battey and Mrs. Rebecca Audley. Third grade is taught by Mrs. Deborah Prive, Mrs. Louise Draper, Mrs. Denise Morris and Mrs. Linda Forcier. Mrs. Jane Mahoney, Mr. Jeffrey Stevens, Mrs. Mary Hammond and Mrs. Beverly Steenbergen are our fourth grade teachers. Staffing the resource room is Mrs. Mary Knittel and in the remedial reading is Miss Ruth Powers. Mrs. Kathleen Lisk is our Chapter I person, giving supplemental help in mathematics to those students in need. Assistance is given throughout the grade levels by utilizing itinerants who work with students in small groups or on a one-to-one basis. Those teachers include Mrs. Shelley Lefebvre, Speech Therapist, Mrs. Cheryl Terban, Guidance, Miss Kathleen Drake, Music and Mrs. Betty Perkins, Gym.

The students in grades three and four are experiencing their first year in reading at the achievement levels; that is, moving out of their self-contained classroom during reading time in order to be with students of equal capabilities in reading.

Maple Avenue Elementary School has a very capable educational team and the Stanford Achievement scores on a national level reflect their high degree of success in motivating students.

The school office is supervised by Mrs. Diane Clapp who works closely with the School Nurse, Mrs. Janet McKay. The cafeteria is headed by Mrs. Patricia Bonjorno, assisted by Mrs. Gladys Hunter and Mrs. Evelyn Rose. They are in charge of serving the students a well-balanced nutritious meal on a daily basis.

The care and upkeep of our building is in the capable hands of Mr. John MacDougall, head custodian. He is assisted by Mr. George Harradon and Mr. Alden Harradon, who have collectively given many years to Maple Avenue School.

We are thankful to our excellent volunteer library staff, under the able direction of Mrs. Helene Phillips. Their dependability and care and upkeep of our library is commendable.

We thank the citizens of Goffstown for their continued support and we invite them to visit our school anytime.

UPPER ELEMENTARY SCHOOL

William H. Brendle, Principal

The Upper Elementary School this year has an enrollment of 303 students in grades 5 and 6 combined. Our enrollment after a decline four years ago is on the increase in spite of the original predictions that it will decrease.

Our present staff consists of fourteen classroom teachers: Grade 5 - Mrs. Allegrone, Mrs. Davis, Mrs. Sweetman, Miss Charleston, Mrs. Clark, Mrs. Manchester, and Mr. Campbell. Grade 6 - Mrs. Rousselle, Miss Slater, Mrs. Carroll, Mrs. Quimby, Mr. Vorbeau, Miss Sinclair and Mr. Warren. We have a resource room teacher, Mrs. Mary Davis, and a Chapter I Aide, Mrs. Martel. Our intermediate Special Education teacher is Sharon Thompson and her aide is Carolyn Wagner.

A number of itinerant teachers serve our school; Miss Drake in music, Mrs. Perkins in Physical Education and Cheryl Terban as a guidance counselor. Other services are speech therapy and occupational therapy.

The Upper Elementary has established a school store this year. Mrs. Sweetman, a fifth grade teacher, is in charge of this store. The store is open on Tuesday and Thursday each week during the students' recess and study periods.

Items carried in the store are: assignment books, book covers, erasers, folders, and black markers. All of the items sold are imprinted with the school name. We first attempted to get volunteer parents to run our store but were not successful. At this point we asked for student volunteers under the direction of Mrs. Sweetman and have been most successful. The students sell the items and do the bookkeeping involved, resulting in a good learning experience.

Our Library at school is open to the students each day from 9:00 to 11:30 and 1:00 to 2:30. We have approximately 2900 books in our library at present. The students are allowed to take out books on a one or two-week basis. Children's magazines and reference books are also on hand. The library is staffed by volunteers and this year include: Barbara Lally, Edna Holstead, Jo Beebe, Pat Merrill, Linda Decker, Alice Phelps, Susan Osburn, Libby Wason, Joyce Phelps, Mary Clapp and Margaret Bennett.

Phyllis Manchester is the Upper Elementary teacher in charge of the library. She does the staffing by enlisting services of volunteers. Mrs. Manchester also orders the new books for our library based upon student interest and teacher requests.

This year we have three teacher committees at our school. Our social committee plans all our social gatherings and activities at school. Our assembly committee is responsible for our assembly program for the school year. Thus far this year we have had six programs.

The playground committee is studying the possible improvements which can be instituted to make our playground more functional. We have constructed four new foursquare courts on the playground for this year.

Our public relations committee is responsible for articles in the local newspaper as well as the school's paper, "Elementary News". I feel this committee has greatly improved our communication with parents regarding school activities and programs.

Curriculum Study - this year we in the elementary schools will undertake a curriculum study in science. Each year a different subject area is studied resulting in a review and update of each subject area every five years.

The committee will be composed of three teachers at each grade level, one to six. The committee members are selected from the Goffstown Elementary Schools, New Boston, and Dunbarton.

The committee will establish an evaluation criteria in an effort to judge materials from a common goal. Materials will be obtained from all publishers who have science texts and materials. These materials will be reviewed and discussed each week and evaluated by the established instrument.

When all available materials have been reviewed, the materials most highly related will again be reviewed in an effort to determine the materials most appropriate for our school system. Based upon these findings materials will be purchased in science for the 1985-86 school year.

GOFFSTOWN AREA JUNIOR/SENIOR HIGH SCHOOL William H. Marston, Principal

Last September the State Board of Education adopted New Minimum Standards for Approval of New Hampshire Public High Schools, grades 9-12. The implications for our high school have been under review by building level administration and staff with final recommendations yet to be made to your office and the Goffstown School Board. Because these new minimum standards will have an immediate, as well as long range, impact on our high school, this annual report will dcal primarily with those areas of the new standards that affect us the most.

The new standards grant all New Hampshire high schools with a grace period from September 1985 to June 1989 to comply. However, specific new requirements are mandated to be effective in September of 1985.

Early review of the new requirements indicated a need for additional faculty in the areas of math, science, health, guidance and social studies. These requests have already been made in the budget projections for the 1985-86 and 1986-87 school years. Beginning in September, courses which will be awarded one unit of credit shall be scheduled to meet for at least 150 clock hours of instructional time per year. Utilizing our current schedule, we will have to schedule 50 minute classes per day. This year our academic classes are scheduled to meet 47 minutes per day. Keeping our same seven period day, next year's school day will have to include an additional 21 minutes of instructional time, exclusive of passing and lunch time.

In June of 1989 our seniors — next year's freshmen — will be required to have a minimum of 19% credits to earn a diploma. Our current requirement is 17 credits; however, 77% of the Class of 1983 graduated with 19 or more credits while 59% graduated with 20 or more credits. 72% of the Class of 1984 graduated with 19 or more credits and 56% graduated with 20 or more.

Three credits selected from at least two of the following fields will be required. We currently offer courses in all areas. Arts education Foreign Language Practical Arts (Business education, Industrial Arts, and Home Economics) Vocational education

Four credits selected from any of the school's course offerings will be required.

Although our high school reflects well in terms of meeting a large number of the new standards, we will be seriously challenged to provide additional required classes in computer science, health, basic business and economics, and arts education. Although approximately 70% of our graduates earn more than two credits in mathematics in four years and approximately 75% earn two or more science credits, we will be seriously taxed to provide additional classes with current levels of staffing.

Although our school district has developed extensive written policy dealing with virtually every aspect of the school's areas of responsibility, the new standards require that we develop written policy and/or procedures for dealing with a number of areas. In reviewing our written policies and practices, there is a need to update and/or expand in several areas. We also need to write formal policy regarding additional graduation requirements, homework, study skills instruction, identifying and providing for the gifted and talented student, correspondence and alternative education experience, instructional procedures and co-curricular opportunities, career education, safety education, assignment procedures for all in-coming students, a process for determining the effectiveness of the educational program and instructional practice that goes beyond existing accountability process, and a procedure for assisting teachers in the selection use and interpretation of appropriate diagnostic and assessment instruments.

Inherent in the new standards is the emphasis on providing New Hampshire's high school youth with assurances that they will receive the quality education essential to effective citizenship and an opportunity to develop his or her unique talents and interests.

Meeting these new standards will require a dedicated, creative and competent school administration and faculty, as well as a strongly supportive and involved community.

In addition to meeting the requirements of the new standards, the high school is beginning to prepare for self study in anticipation of an accreditation review in the fall of 1987 by the New England Association of Schools and Colleges. This preparation will ultimately involve both the junior and senior high school faculties, representatives of the student body, parent group and school board. The actual self-study will take approximately oneyear-and-a-half to complete and will require a commitment of time and energy on the part of all involved. To be accredited by The New England Association indicates that a school is achieving to a measurable degree those things it states in a written philosophy is important for students. The willingness by a school to involve itself in self-study and to submit itself to objective review by outside professional peers is the beginning, rather than the end of a process. The process communicates to the entire educational community a commitment to the on-going attempts for self improvement.

During the next several years, Goffstown will face many challenges in dealing with the complex issues of public education. Realizing that young people are our most important resources can provide the rationale and motivation to meet the challenge successfully.

In concluding this report, I would again extend sincere thanks to Superintendent Paradis, Assistant Superintendent Greenbaum, Mr. Johnstone and Dr. O'Reilly for their support, understanding and leadership. My special thanks to the fine teaching faculty at the Area High School for their daily commitment to meeting student needs and interests, and a warm thank you to the parents for their interest, involvement and support.
