THE STATE OF NEW HAMPSHIRE TOWN OF LANGDON TOWN WARRANT

To the inhabitants of the Town of Langdon, County of Sullivan, in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Town Hall in said Langdon on Tuesday, the twelvth day of March, at twelve of the clock noon until six p.m.. Regular business meeting will be held at seven p.m.

Article 1. To choose all necessary officers for the ensuing year.

Article 2. Are you in favor of adopting Amendment #1 as proposed by the Planning Board of the Town of Langdon to amend Part 1, Paragraph B, Number 1 of the Building Code for the Town of Langdon to read: "Permits will be issued in three (3) parts. (1) A permit will be required for all dwellings foundations. (2) Upon completion of said foundation and approval of same by the building inspector, a permit will be issued for the superstructure. (3) A Certificate of Occupancy will be obtained from the building inspector before the building shall be occupied."

Article 3. Are you in favor of adopting Amendment #2 as proposed by the Planning Board of the Town of Langdon to amend Part 1, Paragraph E, Preamble of the Building Code for the Town of Langdon to read: "A permit to be issued by the road agent for permanent or temporary access or alteration to an access to and from Town roads or public right-of-way, will be required."

Article 4. Are you in favor of adopting Amendment #3 as proposed by the Planning Board of the Town of Langdon to amend Part 1, Paragraph E, Number 1 of the Building Code for the Town of Langdon to read: "1. Access permit fee will be \$10.00 except for temporary permits issued to commercial or industrial applicants."

Article 5. Are you in favor of adopting Amendment #4 as proposed by the Planning Board of the Town of Langdon to amend Part 1, Paragraph E, Number 2 of the Building Code for the Town of Langdon to read: "Temporary permits will be granted to commercial or industrial applicants upon proof of acceptable letter of credit or bond sufficient to insure the return of the area to its original condition. A nonrefundable fee of \$50 will be required when application is made to the road agent."

Article 6. Are you in favor of adopting Amendment #5 as proposed by the Planning Board of the Town of Langdon to delete Part 1, Paragraph E, Number 3 of the Building Code for the Town of Langdon.

Article 7. Are you in favor of adopting Amendment# 6 as proposed by the Planning Board of the Town of Langdon to amend Part 2, Paragraph I of the Building Code for the Town of Langdon to read: "All plumbing construction will be installed by a plumber licensed in New Hampshire and conform to the Basic Building Codes (BOCA), as amended."

Article 8. Are you in favor of adopting Amendment #7 as proposed by the Planning Board of the Town of Langdon to amend Part 2, Paragraph J of the Building Code for the Town of Langdon to read: "All electrical wiring will be installed by an electrician licensed in New Hampshire and conform to the Basic Building Codes (BOCA), as amended."

Article 9. Are you in favor of adopting Amendment #8 as proposed by the Planning Board of the Town of Langdon to amend Part 10, (Enforcement) of the Building Code for the Town of Langdon to read: "Whoever violates any of the provisions of the above regulations shall be punished upon conviction by a fine of not less than \$10 per day but not more than \$100 per day for each day of violation."

Article 10. Are you in favor of adopting Amendment #9 as proposed by the Planning Board of the Town of Langdon to amend Section 1 of the Board of Licensing to read: "The Board of Licensing of the Town of Langdon shall consist of the Board of Selectmen. One member of the Board of Licensing will be appointed to serve as secretary of the Board of Licensing. The secretary for the Board of Selectmen shall be responsible for supplying application forms, publishing notices, receiving funds and securing such information as the Board shall require."

Article 11. Are you in favor of adopting Amendment #10 as proposed by the Planning Board of the Town of Langdon to amend the Preamble to the Zoning Ordinance for the Town of Langdon, New Hampshire to include as the last sentence: "The Town of Langdon Zoning Board of Adjustment may use and refer to any and all Federal and State regulations which it deems will be helpful and necessary."

Article 12. Are you in favor of adopting Amendment #11 as proposed by the Planning Board of the Town of Langdon to amend Section V, Paragraph B of the Zoning Ordinance of the Town of Langdon to read: "Upon request of the petitioner, the Board will call a public hearing. Cost of advertising in local papers, notification of abutters, posting of notices and all other costs will be borne by the petitioner. The Board of Adjustment will hold a public hearing within thirty (30) days of petition. A decision will be rendered within twenty (20) days of public hearing. (New Hampshire Revised Statutes Annotated 155-E:7)"

Article 13. Are you in favor of adopting Amendment #12 as proposed by the Planning Board of the Town of Langdon to amend Section V. Paragraph F. of the Zoning Ordinance of the Town of Langdon to read: "Before removal of soil, rock, sand, gravel, loam or similar material, a special exception must be received from the Board of Adjustment, including payment of all fees and costs. When removal of material is completed, sufficient grading must take place to allow covering with not less than 4 inches of top soil and seeding with suitable crop cover, except where ledge rock is exposed. The Board of Adjustment shall require the posting of a sufficient bond with the Town Treasurer to insure compliance. The Board is authorized to consult with any recognized authority it deems necessary before setting the requirements. The Board may include any such conditions as they deem necessary to protect the interests of the Town and its citizens."

Article 14. Are you in favor of adopting Amendment #13 as proposed by the Planning Board of the Town of Langdon to make the following amendments to correct typographical errors, correct RSA numbers and bring the Town in compliance with changes in the State Statute:

Building Code: Part 5, Paragraph B - delete reference to section 2C

Building Code: Part 5, Paragraph C - last sentence - change "which" to "while"

Building Code: Part 5, Paragraph F - delete in first sentence - "shall conform to Paragraph 2C or"

Zoning Ordinance: Preamble - change "Chapter 31:60-89 to RSA 672-677"

Zoning Ordinance: Definitions, Paragraph C - change "NH RSA 1955 Chapter 31: Paragraphs 66-76" to "RSA 673:3"

Zoning Ordinance: Amendments, paragraph A - change "Chapter 31, RSA" to "RSA 47:26"

Article 15. Shall we adopt the provisions of RSA 40:13 to allow official ballot voting on all issues before the Town of Langdon. (By petition)

The Selectmen recommend this appropriation.

Article 17. To see if the Town will vote to raise and appropriate the sum of \$100,000 for the maintenance of highways and bridges. The State of New Hampshire to furnish approximately \$36,000 in State Aid. The Town will raise the balance. (Approximately \$64,000).

The Selectmen recommend this appropriation.

Article 18. To see if the Town will vote to raise and appropriate up to the sum of \$48,000 to purchase a new Highway Truck and authorize the withdrawal of twelve thousand dollars (\$12,000) from the Capital Reserve fund created for Highway Equipment. The balance of thirty six thousand (\$36,000) is to come from general taxation.

The Selectmen recommend this appropriation.

Article 19. To see if the Town will vote to raise and appropriate the sum of \$3500 for the Capital Expense of the Fire Department.

The Selectmen recommend this appropriation.

Article 20. To see if the Town will vote to purchase tires, a radiator, and gauges for the Fire Department and raise and appropriate the sum of \$1700 for this purpose. The Selectmen recommend this appropriation.

Article 21. To see if the Town will vote to establish a Capital Reserve Fund under the provisions of RSA 35:1 for the purpose of a Fire/Rescue Truck and to raise and appropriate the sum of ten thousand dollars (\$10,000) to be placed in this fund.

The Selectmen recommend this appropriation.

Article 22. To see if the Town will vote to purchase and replace the light bar on the Ford cruiser, purchase a body armor vest, and a hand gun for the Police Department and to raise and appropriate the sum of \$1400 for this purpose. Selectmen recommend this appropriation.

Article 23. To see if the Town will vote to indefinately authorize the Selectmen, until specific rescission of such authority, to accept on behalf of the Town of Langdon gifts, legacies, and devises made to the Town in trust for any public purpose as permitted by RSA 31:19.

The Selectmen recommend approval of this article.

Article 24. To see if the Town will raise and appropriate the sum of \$600 for the purchase of a push lawnmower.

The Selectmen recommend this appropriation.

Article 25. To see if the Town will vote to raise and appropriate the sum of three thousand (\$3000) to replace the Lower Cemetery Fence and authorize the withdrawal of one thousand dollars (\$1000) from the Capital Reserve Fund created for that purpose. The balance of two thousand dollars (\$2000) is to come from general taxation.

The Selectmen recommend this appropriation.

Article 26. To see if the Town wishes to amend the existing agreement under Section 218 of the Social Security Act by excluding the services performed by election workers for a calender year in which the remuneration paid for such services is less than \$1000.

The Selectmen recommend approval of this article.

Article 27. To see if the Town will vote to allow the Selectman to sell Town property.

The Selectmen recommend approval of this article.

Article 28. To see if the Town will vote to authorize prepayment of taxes, and to indefinately authorize the Tax Collector, until specific rescission of such authority, to accept payment in prepayment of taxes after April 1st of any tax year. (RSA 80:52-A)

The Selectmen recommend approval of this article.

Article 29. To see if the Town will vote to authorize a discount of 2% if 50% of the prior years tax assessment is paid after April 1, 1996 and by June 30, 1996.

Article 30. To transact any other business that may legally come before said meeting.

The meeting was called to order by the Moderator, Robert Cunniff, at 7:00 p.m. The Pledge of Allegiance was said.

Article 1: To choose all necessary officers for the ensuing year. This was completed during the day. The moderator asked to dispense with reading the warrant. All agreed.

Article 2: To see if the Town will appropriate and authorize the Selectmen to use the income, estimated to be \$101,930 from:

by \$100. (Amendment motion/second/vote: YES) (Article 2
motion/second/vote: YES)

Article 3: To see if the Town will vote to raise and appropriate the sum of \$100,000.00 for the maintenance of highways and bridges. The State of New Hampshire to furnish approximately \$36,000 in State Aid. The Town will raise the balance. (Approximately \$64,000) A question was raised as to whether we are getting part-time work for a full-time budget. Answer: we are spending more for materials and less for salary. Did the Town ask for a full-time road agent? Yes. Why do we have only part-time people now? The two part-time people are working very well and there are less salary costs (Approx. \$15,000/year). Comment: The work isn't being done completely. Answer: There has been sickness, and this is an unsupervised position. (Article 3 motion/second/vote: YES)

Article 4: To see if the Town will vote to raise and appropriate the sum of \$3500 for the Capital Expense of the Fire Department. This article has the approval of the Selectmen. Discussion: Last year's money was spent for personal gear. This year the plan is to buy 2 Airpacks. We now have 6 new Airpacks and several old ones which are not certifiable. Last year the regular budget was overspent, but the Capital Expense was underspent by about the same amount. (Article 4 motion/second/vote: YES)

Article 5: To see if the Town will vote to change the dollar compensation paid annually to our elected Selectmen of \$600 and \$700 for the Chairman, be raised to \$1000 and \$1200 respectively. (By petition) Discussion: There are increased telephone expenses, travel, and time spent out of the office on Town business. (Article 5 motion/second/vote: YES)

Article 6: To see if the Town will vote to raise and appropriate the sum of \$88,600 for the paving of Crane Brook Road (phase II). Funds to be raised by bank notes or municipal bond, and paid over a three year period. This special article has the approval of the Selectmen, and requires a 2/3 vote for acceptance. Discussion: The current status is that the road has had the pavement torn up, has been widened and gravelled. This article provides for asphalt paving. The average width of Acworth's Crane Brook Road pavement is 19.1'. The State roads are generally 20' - 21.5' wide. Is there a need for the wear coat? Prices for road widths and base coat depths were presented per F.W. Whitcomb Co. An amendment was suggested calling for a 2.5" base coat, 21'wide with cost not to exceed \$60,000. Pros and cons of pug-mill mix followed. Amendment and second withdrawn. Amendment: To see if the Town will vote to raise and appropriate the sum of \$60,000 for the paving of Crane Brook Road with a 2.5" base coat and width to be determined by the road agent. Funds to be raised by bank notes or municipal bond, and paid over a three year period. (Article 6 motion made on amended article/second/Ballot vote: 76 votes cast, 13 NO, 63 YES)

Article 7: To see if the Town will vote to raise and appropriate the sum of \$45,500 for the surfacing of Crane Brook Road (phase II), using alternate surfacing materials (i.e., pug-mill mix). Funds to be raised by bank notes or municipal bond, and paid over a two year period. This article requires a 2/3 ballot vote for acceptance. This article has the approval of the Selectmen. (Article 7 motion made to pass over/seconded/vote: YES)

Article 8: To see if the Town will vote to establish a Capital Reserve Fund under the provisions of RSA 35:1 for the purpose of Highway Heavy Equipment, funded from the budget surplus (RSA 35:11) up to \$10,000. Discussion: The Selectmen suggest continuing to use \$15,000/year for equipment from the Highway budget (continue grader payment amount). The current status of the trucks was presented. The Town has a Capital Reserve Fund for Highway Equipment which was established in 1991. (Article 8 motion/second/vote: 25 NO, 44 YES)

Article 9: To see if the Town will vote to accept Trust Funds for the perpetual care of the Cemetary Lots. (Article 9 motion/second/vote: YES)

Article 10: To see if the Town will raise and appropriate the sum of \$500 to be placed in a Capital Reserve Fund for the purpose of replacing the picket fence at the Lower Cemetery. This article has the approval of the Selectmen. Discussion: We are looking to build a white wooden fence. Lumber costs are approx. \$1,500. (Article 10 motion/second/ vote: YES)

Article 11: To see if the Town will vote to allow the Selectmen to sell Town property. Discussion: The Fire Department Jeep and the Crane Brook property are probable items. The process for selling the land is determined by state regulations. (Article 11 motion/second/vote: YES)

Article 12: To transact any other business that may legally come before said meeting.

- a. Twice a year tax billing. Discussion: We always need to borrow money at mid-year. The school objects to our often paying late. Is quarterly billing legal? (Article 12 a consensus: YES)
- b. Ammendment of building code regarding frontage and acreage. Discussion: Master Plan and Building Code history and recent Jewett Road dilemma. Zoning possibilities, tax and school and economic impacts considered. (Article 12b straw vote indicates support for increases to lot size and frontage requirements.)

- c. The formation of a Solid Waste Committee.

 Discussion: We need to look at the possibility of a permanent site for our Solid Waste operation. (Article 12c 4 volunteers offered to serve on the committee.)
- d. A personal opinion expressed concern about the political involvement of some of the Boards during the current elections.
- e. Thanks to Lucien Beam for serving as Selectman for and additional year.
- f. The Stokes Committee granted \$21,250 in scholarships, \$14,950 for tax relief and \$1,550 toward medical expenses.
- g. Thanks to Linda Campbell to filling in as Town Clerk and School Board representative last year.

Article 13: To allow accounts. (Article 13 motion/seconded/vote: YES)

The quilt raffle was won by Helen Koss.

Motion was made to adjourn/second/vote: YES. Meeting adjourned at 9:15 PM.

Again - No brush fires in 1995 - Thanks to all of you.

Your cooperation with the written permit and calling me when no permit is needed is much appreciated.

At the present time, if you need to call in a brush/woods fire, please use 352-1100. Hopefully, sometime in the future the State emergency number will be correctly on line so that we can use it.

In calendar year 1995, our three leading causes of fires were: children, non-permit fires not properly extinguished, and smoking materials.

Violations of RSA 224:27 II, the fire permit law, and the other burning laws of the State of New Hampshire are misdemeanors punishable by fines of up to \$2,000 and/or a year in jail. Violators are also liable for all fire suppression costs.

To aid your Forest Fire Warden, Fire Department and State Forest Fire Officials, contact your local Warden or Fire Department to find out if a permit is required. This also helps to prevent unnecessary response to a controlled burn.

We want to continue to work closely with our First Response Squads. In 1996 we again want to continue to provide the highest level of care possible to you and your families. This means working closely with the Fire and Rescue Squads, our schools, and encouraging citizens to participate in emergency medical trainings, continually improving the training of our staff and purchasing the most cost-effective equipment available.

Once again, we wish to take a moment to clarify a point in reference to how to call for an ambulance. If a call is received by our dispatcher, we will respond an ambulance and notify Keene Mutual Aid to tone the Rescue Squad, when appropriate. If Keene Mutual Aid receives the call, they will tone the Rescue Squad and LeFevre Ambulance automatically responds an ambulance. Therefore, either method will result in the dispatching of both Rescue and ambulance.

Our special thanks go to the Langdon Fire and Rescue Squad for their assistance during the past year. Also, we would like to take this opportunity to again invite members of your squad to participate in our monthly training sessions.

BUILDING INSPECTOR'S REPORT

The year 1995 witnessed the construction of five new homes, an increase of three over the previous year. Activities in the areas of home and farm improvements showed continued growth. Building permits earning four hundred dollars (\$400) of income were as follows:

- 9 Foundation Permits
- 5 Residential Dwellings
- 3 Dwelling Additions
- 5 Residential Garages
- 1 Porch Addition
- 5 Tool Sheds/Storage
- 1 Pole Barn
- 2 Horse Barns & Facilities

Activities and events over the past year bears evidence that Langdon's minimal building code requirements fall short of the Town's best interests and the requirements to be in compliance with State laws. At present the Building Code does not require an occupancy permit. More and more lending agencies are requiring occupancy permits for home mortgage approval. The Town, as well, should be assured that a dwelling or addition to a dwelling meets all health and safety requirements before occupancy is permitted. The Selectmen and the Planning Board have also been asked to consider a construction application for the conversion of an existing space. A prime example for a conversion permit would be to convert an attached garage to some kind of living quarters requiring heat, electricity or plumbing.

It seems the more changes and demands that are made of us, the more we like to tell it like it use to be.

1995 REPORT OF THE PLANNING BOARD

We again have full membership on the Planning Board and good attendance at our meetings. Several people have graciously donated their time and energy to serve the Town on this Board.

This past year the Planning Board has acted on three requests for Subdivision, creating seven new lots.

The Board has also worked very hard this past year to review and update the Building Code Regulations, holding several extra work sessions to complete the review in time for presentation of changes at the Town Meeting. We had the assistance of the Zoning Board, Building Inspector and Selectmen for several of the items.

A brief rundown of these proposed changes includes under "General Provisions",

- (1) Adding an occupancy permit which will resemble a check-off list of items already covered in our building codes, such as electrical and plumbing completed with names and license number of installer, driveway entrance complete, smoke detectors installed, chimneys, furnaces, stoves etc. properly installed and an approved septic system and water supply. These are all safety issues for the protection of our citizens.
- (2) Require a permit before making significant alterations to existing access to Town roads so the road agent may address safety, drainage, slope, etc. to proposed changes as well as to new accesses.
- (3) Bring our fees up to date with fees adopted by the Selectmen 7/31/95
- (4) Update the requirements for permanent or temporary access to and from Twon roads for commercial or industrial use, to reduce the damage to roads.

Under "Regulations on Dwellings"

(5) Require the plumber or electrician to be licensed in New Hampshire.

Under "Board of Licensing"

(6) Allow the Secretary for the Selectmen to perform certain duties on their behalf.

Under "Zoning Ordinance" Preamble

(7) Enable the Zoning Board of Adjustment to use and refer to any and all Federal and State Regulations it deems helpful and necessary.

Under "Zoning Ordinance" Commercial Industrial (8) Allow more time for posting notices for Public Hearing and for rendering a decision and will then conform to Planning and Land Use Regulations.

(9) Allow the removal of the words "Commercial" and "Bond" and changes "usual fee" to "payment of all fees and costs." This section pertains to a special exception before removal of soil, rock, sand, gravel or loam or similar material for commercial/industrial purposes and authorizes the Zoning Board to consult with recognized authorities before setting requirements.

Other items allow a little more flexibility in the enforcement of regulations, deleting a reference to a foundation requirement that does not conform to Planning and Land Use Regulations, and correcting references to RSA's which have been changed by the State, and one typographical error in the prior printing of the Building Codes of 1988.

Also, a special Thank You to William Doran for his years of service on the Planning Board, both as a member and as chairman of the Board. His knowledge and generous help will be missed.
