THE STATE OF NEW HAMPSHIRE.

*To the Inhabitants of the Town of Errol qualified to vote in
Town affairs:*

You are hereby notified to meet at the Town House in said Errol on Tuesday, the tenth day of March next, at ten of the clock in the forenoon, to act upon the following subjects :

1. To choose all necessary town officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation of the same.

3. To take the sense of the qualified voters whether the alterations and amendments of the constitution proposed by the constitutional convention shall be approved.

4. To see if the town will vote to divide the town into highway districts according to Chapter 29, Laws of 1899.

5. To raise such sums of money as may be necessary for the repairs of highways and bridges for the ensuing year.

6. To raise such sums of money as may be necessary for the support of schools for the ensuing year.

7. To see what sums of money the town will vote to raise for the public library for the ensuing year.

8. To see what action the town will take in regard to the road laid out by the Selectmen around Errol Hill, so called, and how much money they will raise for the same.

9. To see if the town will appoint three Cemetary Trustees, also appropriate money for their use for the ensuing year.


