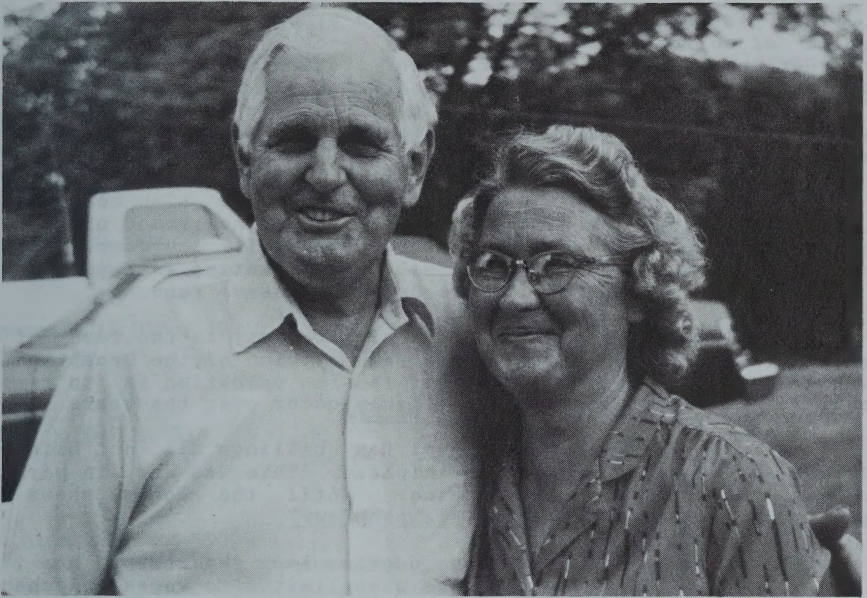

State of The Community

This year the Board of Selectmen is proposing to resolve the problem of solid waste disposal by seeking support for the construction of a solid waste transfer station/recycling center to be located at the Highway Department on Route 132 north. At this point a permit application has been submitted to the State and a preliminary design has been completed. The new facility should be operational in the fall.

While preparing for the new facility we have also been working on the closure of the existing landfill. A final round of testing, required for approval of the closure plan, will be completed this year. As in past years the board will be requesting an appropriation of \$40,000 to the Landfill Closure Capital Reserve Fund.

During 1991 the re-valuation of all property in the Town of New Hampton will be done by the Appraisal Division of the Department of Revenue Administration. The goal of the re-valuation is to resolve inequities in valuation which inevitably occur over the years.

The first year of semi-annual tax billings did not bring the decrease in interest expenses anticipated. This was due, in part, to the hard times we are experiencing. Until the economy shows some improvement cash flow will remain a problem.

With regard to the operating budgets, each department has tried to "hold the line". Increases have been limited to wages and changes in services such as the move from a landfill to a transfer station/recycling center.

Finally, there are several warrant articles included as "By Request" because the Board of Selectmen felt they were deserving of your consideration.

MARCH 13, 1990

To the inhabitants of the Town of New Hampton in the County of Belknap in the State of New Hampshire, qualified to vote in Town Affairs:

You are hereby notified to meet at the New Hampton Town House on Tuesday the 13th day of March 1990 at 10:00 o'clock in the forenoon to cast your ballots for Town Officers and for questions required by law to be on the ballot. The polls to close no later than 7:00 PM.

The remainder of the warrant will be acted upon at New Hampton Town House, Saturday March 17, 1990 at 10:00 o'clock in the forenoon.

Town Clerk, Cynthia Hallberg, was disqualified from performing duties as an election official in the election because of RSA 658:24. Moderator T. Holmes Moore appointed Deputy Clerk, Katherine Seavey to perform Town Clerk duties.

The polls were opened by the Moderator T.H. Moore at 10:00 AM for the purpose of balloting for Town Officers and for questions required by law to be on the ballot.

The polls closed at 7:00 PM. The officers in charge of the meeting were given supper before counting the ballots. The supper was beef stew, rolls and cakes.

MODERATOR, T.H. MOORE, OPENED THE RECESSED MEETING OF MARCH 13th AT 10 O'CLOCK A.M.

TROOP 518 BOY SCOUTS PRESENTED THE FLAG. WE GAVE SALUTE TO THE FLAG AND SANG "AMERICA THE BEAUTIFUL" LED BY T.H. MOORE.

REVEREND MARY POTTER GAVE THE INVOCATION.

THE MODERATOR GAVE SELECTMAN, HORACE (RED) BOYNTON THE FLOOR AT THIS TIME. SELECTMAN BOYNTON GAVE A SPECIAL THANK YOU TO LARRY BLOOD FOR ALL OF HIS HELP WITH OUR NEW COMPUTERS.

NEXT, SELECTMAN RED BOYNTON GAVE A WONDERFUL SPEECH ON OUR RETIRING TAX COLLECTOR, ED HUCKINS. RED SAID THAT WORDS CANNOT EXPRESS ALL HIS DEDICATION AND SERVICE TO THE TOWN. HE HAS BEEN A HELP TO EVERYONE WHO HAS ASKED ABOUT TAXES, HISTORY, LEGAL QUESTIONS, DIRECTIONS, PERSONAL AND HAS EVEN BEEN KNOWN TO GIVE OUT TENNEY MOUNTAIN SKI CONDITIONS. WE WOULD ALSO LIKE TO THANK JEANETTE FOR ALL HER HELP AND HER APPRECIATION. NOT TO MENTION ED'S GENEROUS DONATION TO THE TOWN OF \$14,000. RED PRESENTED ED WITH A PLAQUE FOR 30 YEARS OF SERVICE TO THE PEOPLE OF THE TOWN OF NEW HAMPTON, AT WHICH POINT THERE WAS A STANDING OVATION AND EVERYONE KEPT CLAPPING UNTIL MR. HUCKINS HAD REACHED THE STAGE TO ACCEPT THE PLAQUE. MR. HUCKINS THANKED EVERYONE WHO CONTRIBUTED TO HIS LONG YEARS AS TAX COLLECTOR. AFTER A SHORT SPEECH MR. HUCKINS RECEIVED ANOTHER STANDING OVATION.

THE MODERATOR READ THE RESULTS OF THE MARCH 13, 1990 ELECTIONS. THE MODERATOR GAVE A BRIEF RESUME OF HIS PROCEDURES FOR VOTING AT THIS MEETING. THE MODERATOR STARTED THE MEETING BY READING THE WARRANT.

TO THE INHABITANTS OF THE TOWN OF NEW HAMPTON, NEW HAMPSHIRE IN THE COUNTY OF BELKNAP, QUALIFIED TO VOTE IN TOWN AFFAIRS:

YOU ARE HEREBY NOTIFIED TO MEET AT THE NEW HAMPTON TOWNHOUSE ON TUESDAY, THE 13TH DAY OF MARCH NEXT AT TEN OF THE CLOCK IN THE FORENOON TO CAST YOUR BALLOTS FOR TOWN OFFICERS AND FOR QUESTIONS REQUIRED BY LAW TO BE ON THE BALLOTS. POLLS TO CLOSE NOT LATER THAN 7:00 P.M.

THE REMAINDER OF THE WARRANT WILL BE ACTED UPON AT THE NEW HAMPTON TOWN HOUSE, SATURDAY, MARCH 17, 1990 AT 10:00 A.M.

ARTICLE #1 - TO RAISE SUCH SUMS OF MONEY AS MAY BE NECESSARY TO DEFRAY TOWN CHARGES FOR THE ENSUING YEAR AND MAKE APPROPRIATIONS OF THE SAME.

RED BOYNTON MADE MOTION TO RAISE THE SUM OF \$360,000 AND IT WAS SECONDED BY BILL CLEMENT.

RED EXPLAINED THE MOTION AND AFTER A SHORT DISCUSSION THE MODERATOR REREAD ARTICLE #1 AND IT WAS TO CLOSE BETWEEN THE YES AND NO VOTES. THE MODERATOR THEN CALLED THE BALLOT CLERKS. THERE WERE 58-YES AND 64-NO.

ART ROSENBERGER MADE A MOTION TO APPROPRIATE \$320,000 TO DEFRAY TOWN CHARGES FOR THE ENSUING YEAR. THIS WAS SECONDED BY KEN TORSEY. AFTER A LONG DISCUSSION RON MAGDICH MADE A MOTION TO REDUCE THE \$320,000 TO \$318,890 AND IT WAS SECONDED BY HOPE CLEMENT. THERE WAS A DISCUSSION ON THE AMENDMENT. THE MODERATOR ASKED THOSE WHO WERE IN FAVOR OF ELIMINATING THE CONSERVATION COMMISSION OF \$1110 PLEASE SO SIGNIFY BY SAYING AYE. THEY AYES HAD IT. FRANCES MAINERI MADE A PREEMPTED MOTION TO CALL THE QUESTION. THE MODERATOR SAID WE HAD TO VOTE ON THAT BECAUSE IT IS A NON-DEBATABLE MOTION AND REQUIRES A 2/3 VOTE TO CARRY. BOB FISCHER SECONDED TO STOP THE DEBATE. A 2/3 VOTE WAS CARRIED WITH A YES VOTE.

THE MODERATOR REREAD THE QUESTION: TO RAISE THE SUM OF \$318,890 TO DEFRAY TOWN CHARGES FOR THE ENSUING YEAR AND MAKE APPROPRIATIONS OF THE SAME. THE ARTICLE WAS ACCEPTED WITH AN UNANIMOUS AYE VOTE.

ARTICLE #2 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$20,875 FOR THE SUPPORT OF THE FIRE DEPARTMENT.

BILL CLEMENT MADE THE MOTION TO RAISE THE SUM OF \$20,875 AND IT WAS SECONDED BY KEVIN LANG.

BILL EXPLAINED THE MOTION AND AFTER A SHORT DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN UNANIMOUS AYE VOTE.

ARTICLE #3 - TO SEE IF THE TOWN WILL VOTE TO CHANGE THE CAPITAL RESERVE ACCOUNT TITLED "TO PURCHASE FIRE TRUCK" TO READ "TO PURCHASE FIRE EQUIPMENT" AND AUTHORIZE THE EXPENDITURE OF \$5,000 FOR SUCH EQUIPMENT.

BILL CLEMENT MADE THE MOTION AND IT WAS SECONDED BY DAVE BOYNTON. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN UNANIMOUS AYE VOTE.

ARTICLE #4 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$4,000 FOR THE PURCHASE AND RECONDITIONING OF A 1974 AMBULANCE, TO BE USED AS A RESCUE VEHICLE.

THE MOTION WAS MOVED BY BILL CLEMENT AND SECONDED BY HOPE CLEMENT. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN UNANIMOUS AYE VOTE.

ARTICLE #5 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$133,542.28 FOR THE SUPPORT OF THE POLICE DEPARTMENT.

THE MOTION WAS MOVED BY CHIEF DOUG SALMON AND SECONDED BY BARBARA CHASE. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN UNANIMOUS AYE VOTE.

ARTICLE #6 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$11,600 TO HIRE AN ADDITIONAL FULL TIME POLICE OFFICER, AS OF JULY 1, 1990.

THE MOTION WAS MOVED BY CHIEF SALMON AND SECONDED BY BOB SIMPSON. CHIEF SALMON AND SECONDED BY BOB SIMPSON. CHIEF SALMON MADE A MOTION TO AMEND THE ARTICLE TO READ "TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$6,300 TO HIRE AN ADDITIONAL FULL TIME POLICE OFFICER, AS OF OCTOBER 1, 1990." BOB SIMPSON SECONDED THE AMENDMENT.

AFTER A LONG DISCUSSION THE MODERATOR REREAD THE AMENDED ARTICLE AND IT WAS PASSED WITH AN UNANIMOUS AYE VOTE.

ARTICLE #7 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$3,000 FOR THE OUTSTANDING BALANCE DUE ON THE MUNICIPAL DATA SYSTEMS SOFTWARE FOR THE POLICE DEPARTMENT.

THE MOTION WAS MOVED BY BOB FISCHER AND SECONDED BY CHIEF SALMON. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN UNANIMOUS AYE VOTE.

ARTICLE #8 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$236,520 FOR THE SUPPORT OF THE HIGHWAY DEPARTMENT; THIS FIGURE INCLUDES \$49,640 HIGHWAY BLOCK GRANT AID.

THE MOTION WAS MOVED BY GORDON HUCKINS AND SECONDED BY BILL CLEMENT. AFTER A LONG DISCUSSION DANA TORSEY MADE A MOTION TO MOVE THE QUESTION AND CHARLIE JOYCE SECONDED IT. THE MODERATOR SAID WE HAD TO VOTE ON THAT BECAUSE IT IS A NON-

DEBATABLE MOTION AND REQUIRES A 2/3 VOTE TO CARRY. A 2/3 VOTE WAS CARRIED WITH A YES VOTE.

THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN AYE VOTE.

ARTICLE #9 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$100,000 FOR RESURFACING OF TOWN ROADS.

THE MOTION WAS MOVED BY GORDON HUCKINS AND SECONDED BY HORACE BOYNTON. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN AYE VOTE.

ARTICLE #10 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$34,000 FOR THE PURCHASE OF A NEW HIGHWAY 1 TON DUMP TRUCK WITH SPREADER AND PLOW.

THE MOTION WAS MOVED BY GORDON HUCKINS AND IT WAS SECONDED. GORDON MADE A MOTION TO AMENDED THE ARTICLE TO READ "TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$31,078 FOR THE PURCHASE OF A NEW HIGHWAY 1 TON DUMP TRUCK WITH SPREADER AND PLOW." AND IT WAS SECONDED. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE AMENDED ARTICLE AND IT WAS NOT PASSED.

ARTICLE #11 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$38,000 FOR THE REPLACEMENT OF THE BLAKE HILL ROAD BRIDGE OVER PRESCOTT BROOK.

CHET BUTCHER ASKED TO REWORD THE ARTICLE. CHET MADE A MOTION TO "SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$25,672 FOR THE REPLACEMENT OF THE BLAKE HILL ROAD BRIDGE OVER PRESCOTT BROOK." IT WAS SECONDED BY RICHARD HALLBERG, JR.

AFTER A LONG DISCUSSION THE MODERATOR REREAD THE AMENDED ARTICLE AND IT WAS TO CLOSE BETWEEN THE YES AND NO VOTES. THE MODERATOR THEN CALLED THE BALLOT CLERKS. THERE WERE 64-YES AND 60-NO. THE YES VOTES HAVE IT.

ARTICLE #12 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$27,940 THIS YEAR FOR WIDENING AND GRAVELING OF STRAITS ROAD FROM THE END OF PAVEMENT BY LOWER FOREST POND FOR DISTANCE OF .4 MILES (TO BE COMPLETED IN THE YEAR 1991 WITH PAVING.)

THE MOTION WAS MOVED BY JIM VIEN AND SECONDED BY CINDY OSSOLA. AFTER A LONG DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS NOT ACCEPTED.

ARTICLE #13 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$25,000 TO REPLACE JACKSON POND ROAD BRIDGE.

THE MOTION WAS MADE BY RED BOYNTON AND SECONDED BY JUNE SMITH. RED MADE A MOTION TO AMEND THE ARTICLE TO READ "TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$17,860 TO REPLACE JACKSON POND ROAD BRIDGE." THE SECOND ACCEPTED THE AMENDED ARTICLE. AFTER A LONG DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS ACCEPTED WITH A UNANIMOUS AYE VOTE.

AFTER A SHORT DISCUSSION LARRY BLOOD MADE AN AMENDMENT TO THE ARTICLE TO READ - "TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$1,500 FOR THE REPAIR OF MAIN STREET." THE MODERATOR REREAD THE AMENDMENT AND IT WAS PASSED WITH AN AYE VOTE.

THE ARTICLE NOW READS - "TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$1,500 FOR THE REPAIR OF MAIN STREET; THE STATE TO CONTRIBUTE A TOTAL OF WHICH IS UNKNOWN.

THE MODERATOR REREAD THE AMENDED ARTICLE AND IT WAS NOT ACCEPTED.

ARTICLE #15 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$2,500 FOR THE CONSTRUCTION OF THE SIDEWALK OVER DICKERMANS POND BRIDGE ON ROUTE 132S.

THE MOTION WAS MADE BY GORDON HUCKINS AND SECONDED BY RED BOYNTON. AFTER A LONG DISCUSSION LARRY BLOOD MADE AN AMENDMENT TO THE ARTICLE. THE AMENDMENT READS - "TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$2,500 FOR THE CONSTRUCTION OF THE SIDEWALK OVER DICKERMANS POND BRIDGE ON ROUTE 132, IF LEGAL TO AUTHORIZE THE SELECTMEN TO WITHDRAW THE FUNDS FROM THE MAIN STREET REPAIR ESCROW FUND." THE AMENDMENT WAS SECONDED. THE MODERATOR REREAD THE AMENDMENT AND IT WAS ACCEPTED WITH AN AYE VOTE. AFTER NO FURTHER DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN AYE VOTE.

ARTICLE #16 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$82,635 FOR THE REVALUATION OF THE

TOWN BY THE APPRAISAL DIVISION OF THE DEPARTMENT OF REVENUE ADMINISTRATION FOR 1991; FURTHERMORE TO AUTHORIZE THE WITHDRAWAL AND EXPENDITURE OF \$35,879.52 PLUS INTEREST AT THE TIME OF WITHDRAWAL, FROM THE REAPPRAISAL CAPITAL RESERVE FUND FOR THIS PURPOSE.

THE MOTION WAS MADE BY RED BOYNTON AND SECONDED BY BILL CLEMENT. RED MADE A MOTION TO AMEND THE \$35,879.52 PLUS INTEREST TO READ \$40,374.19 PLUS INTEREST AND IT WAS ACCEPTED BY THE SECOND, BILL CLEMENT. AFTER A SHORT DISCUSSION THE MODERATOR REREAD THE AMENDED ARTICLE AS FOLLOWS:

TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$82,635. FOR THE REVALUATION OF THE TOWN BY THE APPRAISAL DIVISION OF THE DEPARTMENT OF REVENUE ADMINISTRATION FOR 1991; FURTHERMORE TO AUTHORIZE THE WITHDRAWAL AND EXPENDITURE OF \$40,374.19 PLUS INTEREST AT THE TIME OF WITHDRAWAL, FROM THE REAPPRAISAL CAPITAL RESERVE FUND FOR THIS PURPOSE. THE ARTICLE WAS PASSED WITH AN AYE VOTE.

ARTICLE #17 - TO SEE IF THE TOWN WILL VOTE TO WITHDRAW FROM THE PEMI-BAKER SOLID WASTE DISTRICT, A REGIONAL SOLID WASTE IMPLEMENTATION DISTRICT, PURSUANT TO RSA 53:B. FURTHERMORE, TO SEE IF THE TOWN WILL VOTE TO BECOME A SINGLE TOWN SOLID WASTE IMPLEMENTATION DISTRICT IN ACCORDANCE WITH RSA 53:B.

THE MOTION WAS MOVED BY BOB JEFFERS AND SECONDED BY BOB FISCHER. BOB JEFFERS MADE A MOTION TO AMEND THE ARTICLE TO READ "TO SEE IF THE TOWN WILL VOTE TO WITHDRAW FROM THE PEMI-BAKER SOLID WASTE DISTRICT, A REGIONAL REFUGE DISPOSAL DISTRICT, WHICH THE TOWN VOTED TO JOIN AT TOWN MEETING ON MARCH 18, 1989, PURSUANT TO NEW HAMPSHIRE RSA 53:B. THE SECOND ACCEPTED THE AMENDMENT. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE AMENDED ARTICLE. THIS ARTICLE REQUIRED A BALLOT VOTE. THERE WERE 91 BALLOT VOTES CAST. 90-YES AND 1-NO.

ARTICLE #18 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$90,000 FOR THE PURCHASE OF LAND FOR A SOLID WASTE TRANSFER SITE AND TO GIVE THE BOARD OF SELECTMEN AUTHORIZATION TO NEGOTIATE AND PURCHASE THE LAND, FURTHERMORE TO AUTHORIZE THE WITHDRAWAL AND EXPENDITURE OF \$40,000 PLUS INTEREST FROM THE TRANSFER STATION CAPITAL RESERVE FUND FOR THIS PURPOSE.

BOB JEFFERS MADE A MOTION TO AMEND THE ARTICLE TO READ "TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$90,000 FOR THE PURCHASE OF LAND FOR A SOLID WASTE TRANSFER SITE AND FOR DEVELOPMENT OF THAT SITE AND TO GIVE THE BOARD OF SELECTMEN AUTHORIZATION TO NEGOTIATE AND PURCHASE, FURTHERMORE TO AUTHORIZE THE WITHDRAWAL AND EXPENDITURE OF

\$40,000 PLUS INTEREST FROM THE TRANSFER STATION CAPITAL RESERVE FUND FOR THIS PURPOSE. THIS WAS SECONDED BY CHANGE PARKER.

AFTER A LONG DISCUSSION ART ROSENBERGER MADE A MOTION TO REDUCE THE \$90,000 TO \$40,000 AND IT WAS SECONDED BY BILL CLEMENT. BILL OBER MOVED TO LAY THIS ARTICLE ON THE TABLE WHICH WAS SECONDED. THE MODERATOR SAID WE HAD TO VOTE ON THAT BECAUSE IT IS A MON-DEBATEABLE MOTION WHICH REQUIRES A 2/3 VOTE. YES - 82, NO - 18. THE YES VOTES HAVE IT. THE ARTICLE WAS LAYED ON THE TABLE WHICH WILL RESULT IN A RECESSED TOWN MEETING.

ARTICLE #19 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$40,000 AND TO PLACE SAME IN THE LANDFILL CLOSURE CAPITAL RESERVE FUND.

CHET BUTCHER MADE A MOTION TO LAY THIS ARTICLE ON THE TABLE AND IT WAS SECONDED BY HOPE CLEMENT. A 2/3 VOTE IS REQUIRED. YES - 25, NO - 71. THIS VOTE WAS NOT VOTED TO LAY ON THE TABLE. JUNE SMITH MADE A MOTION TO CONTINUE THE DEBATE AND BOB JEFFERS SECONDED. AFTER A SHORT DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH A AYE VOTE.

IT WAS SECONDED BY KEN KETTENRING. THE MODERATOR READ THE ARTICLE AND IT WAS PASSED WITH AN AYE VOTE.

THE MOTION WAS MOVED BY BOB FISCHER AND SECONDED BY BILL CLEMENT. AFTER A LONG DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN AYE VOTE.

THE MOTION WAS MOVED BY BOB FISCHER AND SECONDED BY NORMA JEAN MOORE. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN AYE VOTE.

ARTICLE #24 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$1,500 FOR THE SUPPORT OF THE NEW HAMPTON COMMUNITY KINDERGARTEN.

THE MOTION WAS MOVED BY BOB FISCHER AND SECONDED BY BOB DONNELLY. AFTER A SHORT DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN AYE VOTE.

ARTICLE #25 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$2,639.74 FOR THE YOUTH SERVICES BUREAU'S COURT DIVERSION SERVICES FOR FIRST OFFENDERS (AN EFFECTIVE ALTERNATIVE TO THE JUVENILE COURT SYSTEM) AND OTHER YOUTH ORIENTED PROGRAMS, i.e. THE CHALLENGE COURSE, THE YOUTH COMPANION PROGRAM AND SHORT-TERM COUNSELING.

THE MOTION WAS MOVED BY BOB SIMPSON AND SECONDED BY BILL ROBERTS. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE QUESTION AND IT WAS PASSED WITH AN AYE VOTE.

ARTICLE #26 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$1,524 TO PARTICIPATE IN HOUSEHOLD HAZARDOUS WASTE COLLECTION.

THE MOTION WAS MOVED BY RED BOYNTON AND SECONDED BY CHRISTINE HOWARD-CROWLEY. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE QUESTION AND IT WAS PASSED WITH AN AYE VOTE.

ARTICLE #27 - TO SEE IF THE TOWN WILL VOTE TO RAISE AND APPROPRIATE THE SUM OF \$5,000 FOR THE PURCHASE OF CONSERVATION EASEMENT/DEVELOPMENT RIGHTS IN OUR TOWN ON A MATCHING FUND BASIS WITH THE STATE AND PLACE IN THE CAPITAL RESERVE FUND FOR THIS PURPOSE.

THE MOTION WAS MOVED BY DAVE ERLER AND SECONDED BY BILLY HUCKINS. AFTER A SHORT DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS DEFEATED.

ARTICLE #28 - TO SEE IF THE TOWN WILL VOTE TO HAVE SEMI-ANNUAL COLLECTION OF TAXES. TO BEGIN IN 1990, PURSUANT TO RSA 76:15A.

THE MOTION WAS MOVED BY RED BOYNTON AND SECONDED BY DOT NOAKES. AFTER A SHORT DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS TO CLOSE BETWEEN THE YES AND NO VOTES. THE MODERATOR THEN CALLED THE BALLOT CLERKS. THERE WERE 50-YES AND 29 - NO VOTES.

ARTICLE #29 - TO SEE IF THE TOWN WILL VOTE TO CHANGE THE TERM OF THE ROAD AGENT FROM ONE (1) YEAR TO THREE (3) YEARS PURSUANT TO RSA 231:62-A.

THE MOTION WAS MOVED BY GORDON HUCKINS AND SECONDED BY DOUG SMITH. AFTER A SHORT DISCUSSION THE MODERATOR REREAD THE QUESTION. THIS VOTE ALSO HAD TO BE A BALLOT VOTE. THERE WERE 66 BALLOT VOTES CAST. 38 - YES, AND 28 - NO.

ARTICLE #30 - TO SEE IF THE TOWN WILL VOTE TO ESTABLISH AN HISTORIC DISTRICT COMMISSION AND DETERMINE THE NUMBER OF MEMBERS AND METHODS OF THEIR ELECTION OR APPOINTMENT PURSUANT TO RSA 673, 674, AND 675, ET SEQ.

THE MOTION WAS MOVED BY BILLY HUCKINS AND SECONDED BY HOPE SWAIN. AFTER A LONG DISCUSSION THE MODERATOR READ THE QUESTION AND IT WAS DEFEATED.

ARTICLE #35 - TO SEE IF THE TOWN WILL VOTE TO AUTHORIZE THE SELECTMEN TO BORROW MONEY IN ANTICIPATION OF TAXES.

THE MOTION WAS MOVED BY RED BOYNTON AND SECONDED BY BOB JEFFERS. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN AYE VOTE.

ARTICLE #36 - TO SEE IF THE TOWN WILL VOTE TO AUTHORIZE THE
SELECTMEN TO DISPOSE OF PROPERTY ACQUIRED BY TAX
COLLECTOR'S DEEDS.

THE MOTION WAS MOVED BY BOB JEFFERS AND SECONDED BY RED
BOYNTON. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE
ARTICLE AND IT WAS PASSED WITH AN AYE VOTE.

ARTICLE #37 - TO SEE IF THE TOWN WILL VOTE TO AUTHORIZE THE
SELECTMAN TO TRADE OR SELL ANY UNUSABLE EQUIPMENT OR
MATERIALS.

THE MOTION WAS MOVED BY BOB FISCHER AND SECONDED BY RED
BOYNTON. AFTER A BRIEF DISCUSSION THE MODERATOR REREAD THE
ARTICLE AND IT WAS PASSED WITH A AYE VOTE.

ARTICLE #38 - TO TRANSACT ANY OTHER BUSINESS THAT MAY LEGALLY

IF THERE IS NO OTHER BUSINESS TO COME BEFORE THIS MEETING, A
MOTION WAS MADE TO LAY ARTICLE #'S 18 & 20 ON THE TABLE. WE

MODERATOR, T.H. MOORE, OPENED THE RECONVENED MEETING WHICH WAS A RESULT OF THE RECESSED ANNUAL TOWN MEETING OF MARCH 17, 1990 BY READING THE WARRANT:

TO THE INHABITANTS OF THE TOWN OF NEW HAMPTON, NEW HAMPSHIRE IN THE COUNTY OF BELKNAP, QUALIFIED TO VOTE IN TOWN AFFAIRS:

YOU ARE HEREBY NOTIFIED TO MEET AT THE NEW HAMPTON TOWN HOUSE ON SATURDAY, JUNE 9, 1990 AT TEN OF THE CLOCK IN THE FORENOON.

GIVEN UNDER OUR HANDS AND SEAL THIS 24TH DAY OF MAY IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND NINETY. ROBERT W. JEFFERS AND ROBERT A. FISCHER, SELECTMEN OF THE TOWN OF NEW HAMPTON. THE SELECTMEN CERTIFY THAT THEY GAVE NOTICE TO THE INHABITANTS WITHIN NAMED, TO MEET AT TIME AND PLACE AND FOR THE PURPOSE WITHIN MENTIONED BY POSTING UP AN ATTESTED COPY OF THE WITHIN WARRANT AT THE PLACE OF MEETING WITHIN NAMED AND A LIKE ATTESTED COPY AT THE FIRE STATION BEING A PUBLIC PLACE IN SAID TOWN, ON THE 25TH DAY OF MAY, 1990.

EVEN THOUGH THIS IS A RECESSED MEETING, THERE ARE NO FORMAL OPENING CEREMONIES.

REVEREND MARY POTTER GAVE THE INVOCATION.

THE MODERATOR EXPLAINED THAT ONLY THOSE PEOPLE WHO WERE ON THE CHECKLIST AS OF THE DATE OF THE LAST MEETING ARE ELIGIBLE TO VOTE IN THIS MEETING. ANYBODY WHO HAS BEEN ADDED TO THE CHECKLIST SINCE THE MARCH MEETING IS NOT ELIGIBLE TO VOTE.

THE MODERATOR CONTINUED, WE ARE HERE TO DISCUSS ARTICLE #18 WHICH WAS LAYED ON THE TABLE TO BE BROUGHT UP AT THIS RECESSED MEETING.

THE MODERATOR REREAD THE ENTIRE ARTICLE #18 FROM THE MARCH 17, 1990 MINUTES.

FIRST A VOTE WAS NEEDED TO TAKE THE ARTICLE OFF THE TABLE. A MOTION WAS MADE BY HOPE CLEMENT AND IT WAS SECONDED. THERE WAS A UNANIMOUS AYE VOTE TO TAKE THE ARTICLE OFF THE TABLE. THE ARTICLE WAS NOW OPENED FOR DISCUSSION. WE ARE DISCUSSING THE AMENDMENT MADE BY ART ROSENBERGER TO REDUCE THE \$90,000 TO \$40,000. ART ROSENBERGER MADE A MOTION TO WITHDRAW THE AMENDMENT AND THE 2ND ACCEPTED THE WITHDRAWAL. BILL CLEMENT WAS NOT PRESENT AND HOPE CLEMENT ACCEPTED IN HIS PLACE.

WITH THE AMENDMENT WITHDRAWN WE ARE NOW DISCUSSING THE AMENDED ARTICLE MADE BY ROBERT JEFFERS AND SECONDED BY CHANGE PARKER.

CHANGE PARKER SPOKE AND AFTER A LENGTHY DISCUSSION THE MODERATOR ASKED IF THERE WAS ANY FURTHER DISCUSSION AND SINCE THERE WAS NONE THE MODERATOR REREAD THE ARTICLE # 18 AND IT WAS NOT PASSED.

ARTICLE #20 - THE MODERATOR REREAD THE ENTIRE ARTICLE FROM THE MARCH 17, 1990 MINUTES. A MOTION WAS NEVER MADE IN THE FIRST PLACE AND A MOTION WAS NEEDED NOW TO TAKE THE ARTICLE OFF THE TABLE. BOB JEFFERS MADE THE MOTION AND BOB FISCHER SECONDED. AFTER A SHORT DISCUSSION THE MODERATOR REREAD THE ARTICLE AND IT WAS PASSED WITH AN AYE VOTE.

THE MODERATOR SAID THE SELECTMEN WANT TO RECONSIDER ARTICLE #1 AND A MOTION NEEDS TO BE MADE TO RECONSIDER AND NEEDS TO BE MADE BY SOMEONE WHO VOTED FOR THE INITIAL MOTION.

THE MODERATOR REREAD ARTICLE #1 FROM THE MARCH 17, 1990 MINUTES. RED BOYNTON MOVED TO RECONSIDER AND IT WAS SECONDED. ALL THOSE IN FAVOR OF RECONSIDERING ARTICLE #1, IT WAS PASSED WITH AN AYE VOTE. RED MADE A MOTION TO AMEND THE ARTICLE TO READ \$360,400 AND IT WAS SECONDED.

AFTER A LONG DISCUSSION LARRY BLOOD MADE AN AMENDMENT TO REDUCE THE AMOUNT TO \$359,400 AND IT WAS SECONDED. THE DISCUSSION CONTINUED FOR QUITE SOMETIME. THE MODERATOR REREAD THE AMENDED QUESTION AND THE AMENDMENT WAS CARRIED WITH AN AYE VOTE.

KEN TORSEY MADE A MOTION TO HAVE THE QUESTION BE A BALLOT VOTE AND IT WAS SECONDED BY CHET BUTCHER.

THERE WERE 139 VOTES CAST - 82 YES, 57 NO. THE MODERATOR DECLARED THE VOTE IN THE AFFIRMATIVE.

THE MODERATOR ASKED IF THERE WERE ANY FURTHER BUSINESS TO COME BEFORE THE MEETING.

SELECTMEN, RED BOYNTON SAID THAT THE FISH AND GAME DEPARTMENT CAME TO THE SELECTMEN SEVERAL WEEKS AGO AND THEY ARE INTERESTED IN PURCHASING A SECTION OF THE SHORELINE OF THE VRANORSEY PROPERTY WHICH IS DIRECTLY ACROSS FROM APPLE TREE HOMES.

YEARS AGO WHEN 104 WAS BUILT THEY CHANGED THE ROAD AND THERE IS A SECTION OF LAND ON THE OLD 104 THAT WAS DEEDED BACK TO THE TOWN. THE FISH AND GAME DEPARTMENT HAS FUNDING FROM THE FEDERAL GOVERNMENT TO PURCHASE LANDS FOR PUBLIC ACCESS TO THE LAKES. THIS IS ONE AREA THE FISH AND GAME DEPARTMENT IS LOOKING INTO PURCHASING AND THEY FEEL THAT IT WOULD BE BENEFICIAL NOT ONLY TO THE TOWN BUT TO THE STATE. IN DOING SO, THEY FOUND THAT THE TOWN OF NEW HAMPTON OWNS TITLE TO THE OLD ROUTE 104 RIGHT-OF-WAY. IT IS A LITTLE STRETCH OF LAND THAT THE TOWN OWNS AND IS ABSOLUTELY OF NO USE. WE (SELECTMEN) DIDN'T HAVE TIME TO POST NOTICES SO THAT WE COULD GO TO THE TOWNSPEOPLE FOR AN OFFICIAL VOTE. HOWEVER, WHAT WE WOULD LIKE TO DO IS HAVE A NON-BINDING VOTE TO SEE IF THE TOWN WOULD BE WILLING TO TRANSFER THE TITLE OF THAT RIGHT-OF-WAY BACK TO THE STATE TO CLEAR UP THE TITLE SO THAT THEY

CAN PURCHASE THE LAND AND PUT IN PUBLIC LAUNCHING FACILITIES. IT WAS FIRST AND SECONDED. THE MODERATOR MENTIONED TO KEEP IN MIND THAT THIS IS A NON-BINDING VOTE. THIS IS AN ADVISORY SORT OF THING FOR THE SELECTMEN.

AFTER A SHORT DISCUSSION THE MODERATOR ASKED IF THERE WERE ANY MORE QUESTIONS, SEEING THAT THERE IS NONE ALL THOSE IN FAVOR OF LETTING THE SELECTMEN GIVE THEM (FISH AND GAME DEPARTMENT) THE OPTION PLEASE SIGNIFY BY SAYING AYE. THE AYE VOTE WAS UNANIMOUS.

THE MEETING WAS ADJOURNED AT 12:40 P.M.

The State of New Hampshire

To the inhabitants of the Town of New Hampton, New Hampshire in the County of Belknap, qualified to vote in Town affairs:

You are hereby notified to meet at the New Hampton Town House on Tuesday, the 12th day of March next at eleven of the clock in the forenoon to cast your ballots for Town Officers and for questions required by law to be on the ballots. Polls to close not later than 7:00 P.M.

The remainder of the warrant will be acted upon at the New Hampton Town House, Saturday, March 16, 1991 at 10:00 A.M.

1. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same.
2. To see if the Town will vote to raise and appropriate the sum of \$130,600.00, for the construction of a Solid Waste Transfer Station/Recycling Center and to give the Board of Selectmen authorization to negotiate and enter into necessary contracts, furthermore, to authorize the withdrawal and expenditure of \$40,000.00 plus interest from the Transfer Station Capital Reserve Fund for this purpose. Also, to authorize the issuance of not more than \$90,600.00 of notes in accordance with the provisions of the Municipal Finance Act(RSA Chapter 33) and to authorize Town Officials to issue and negotiate such notes and to determine the rate of interest thereon. (BALLOT VOTE REQUIRED)
3. To see if the Town will vote to raise and appropriate the sum of \$248,577.00 for the support of the Highway Department; this figure includes \$49,227.00 Highway Block Grant Aid.
4. To see if the Town will vote to raise and appropriate the sum of \$100,000.00 for resurfacing of Town roads.
5. To see if the Town will vote to raise and appropriate the sum of \$30,000.00 for the purchase of a new Highway Department dump truck.
6. To see if the Town will vote to raise and appropriate the sum of \$5,000.00 for the purchase of a waste oil furnace for the Highway Department. (BY REQUEST)

7. To see if the Town will vote to raise and appropriate the sum of \$152,532.00 for the support of the Police Department.

8. To see if the Town will vote to raise and appropriate the sum of \$16,400.00 for the purchase of a new Police Cruiser fully equipped.

9. To see if the Town will vote to raise and appropriate the sum of \$34,076.00 for the support of: Fire Department \$28,626.00, Forest Fires \$2,750.00, and Emergency Medical Service \$2,700.00.

10. To see if the Town will vote to raise and appropriate the sum of \$17,500.00: \$11,000.00 for purchase of protective equipment, \$2,500.00 for the purchase of paging devices, \$2,500.00 for the purchase of self contained breathing apparatus, and \$1,500.00 for the purchase of spare air cylinders for the Fire Department.
(BY REQUEST)

11. To see if the Town will vote to raise and appropriate the sum of \$6,000.00 for the purchase of overhead doors for the Fire Department. (BY REQUEST)

12. To see if the Town will vote to raise and appropriate the sum of \$1,868.00 for the purchase of a Motorola Mt 1000 portable radio for the Fire Department. (BY REQUEST)

13. To see if the Town will vote to raise and appropriate the sum of \$1,400.00 for Fire Department Training Equipment including a Camcorder, VCR training tapes, slide project and cassette tape deck. (BY REQUEST)

14. To see if the Town will vote to raise and appropriate the sum of \$40,000.00 and to place same in the Landfill Closure Capital Reserve Fund.

15. To see if the Town will vote to raise and appropriate the sum of \$25,873.52 for the support of Regional Associations; Community Action Program \$4,012.00; Bristol Community Center \$3,191.00; Lakes Region Planning Commission \$1,534.00; Newfound Area Nursing Association \$6,821.00; Newfound Ambulance Service \$7,438.20; Youth Service Bureau \$2,877.32.

16. To see if the Town will vote to raise and appropriate the sum of \$1,500.00 for the support of the New Hampton Community Kindergarten.

17. To see if the Town will vote to raise and appropriate the sum of \$400.00 for the support of the hospitals: Mary Hitchcock Memorial Hospital, Franklin Regional Hospital, Lakes Region General Hospital, Speare Memorial Hospital.

18. To see if the Town will vote to raise and appropriate the sum of \$1,498.00 to participate in Household Hazardous Waste Collection.

19. To see if the Town will vote to raise and appropriate the sum of \$6,110.00 for the purchase of Computer Hardware and a cash receipts Software Program for the Town Clerk and Tax Collector's office. (Recommended by the Selectmen and Town Auditors)

20. To see if the Town will vote to accept as a Town maintained road, that section of road known as Seminole Avenue, off Waukegan Road. (BY REQUEST)

21. Shall we adopt the provisions of RSA 72:43-f for the adjusted elderly exemptions from property tax? These statutes provide for the following exemptions, based on assessed value, for qualified taxpayers: for a person 65 years of age up to 75 years \$10,000; for a person 75 years of age up to 80 years, \$15,000; for a person 80 years of age or older, \$20,000. To qualify, the person must have been a New Hampshire resident for at least 5 years; own the real estate individually or jointly, or if the real estate is owned by his spouse, they must have been married for at least 5 years. In addition, the taxpayer must have a net income of less than \$10,000 or if married, a combined net income of less than \$12,000, and own net assets of \$30,000 or less excluding the value of the person's residence. (BALLOT VOTE REQUIRED)

22. To see if the Town will vote to abandon that portion of land off Old Route 104 located between the Northeasterly shore of Pemigiwasset Lake, and the Southwesterly side of the new Route 104 on land owned by Peter DeJager, Sr.

23. To see if the Town will vote to authorize the Selectmen to request that New England Telephone conduct a feasibility study for 911 service. Such study to be completed at no cost to the Town.

24. To see if the Town will vote to authorize the Board of Selectmen to apply for, accept and expend, without further action by town meeting, money from the State, Federal or other Governmental unit or a private source which becomes available during the year, in accordance with RSA 31:95-b.

25. To see if the Town will vote to authorize Selectmen to dispose of property, acquired by Tax Collector's deeds, by public auction, advertised sealed bid, or as justice may require, pursuant to RSA 80:80.

26. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes.

27. To see if the Town will vote to authorize the Selectmen to trade or sell any unusable equipment or materials.

28. To transact any other business that may legally come before this meeting.

New Hampton Police Department 1990 Annual Police Report

We are in the new section of the Town Office Building which is the second floor. The entire floor is occupied by the Police Department. It took longer than I had planned to actually get into the new office space. However, we are in and I have not forgotten about the open house. I will have this when the weather is a little better and some of the finer things are finished inside. This new space is so much more usable and we are not in each others way. We were forever moving things from place to place downstairs and now most everything has its own place and does not need to be moved. We have an actual booking area where we can photograph and fingerprint and even if needed, secure a person while we do the booking process and hold him until a bail commissioner arrives. The officers have plenty of work area. They can store their own belongings here without them being in the way of someone else or getting them taken or mislaid. We now have an evidence room and have started a new evidence keeping system. This is an office area with a dual purpose, for the supervisor and interviews. I have my own office. There is also plenty of room for the secretary and for the records to be kept in files. We also have a bathroom within the locked section of the station. In the foyer, there are two public bathrooms. The last room is a multi-purpose room which is for meetings, training and also contains a small kitchen. We have been very fortunate to have had people donate items to the department. I am going to have a plaque of appreciation made and this will be displayed in the foyer of the station.

For two years I have been trying to fight against becoming an administrator. Simply stated, that means most or all of my work week would be inside the station and partaking in other duties that I am responsible for. I guess that time has come, I am spending between three and four days a week at those duties only and not out on the road. I will continue to try and spend as much time as I can out on the road, however.

We have seen a rise in crimes against persons and property this past year. I don't foresee an end to it in the near future either. With the economy the way it is I feel there will be a large number of thefts, burglaries and even assaults. We also have seen and heard a lot about the drugs in this area becoming even more prevalent. In 1989-1990 we apprehended one drug manufacturer here in Town. We have also been active on a number of other cases in Town.

Since last Town Meeting, there have been some changes. Stephen Pruzick has been replaced by Robert Estes from the

Sanbornton Police Department. He comes to us with years of experience. Our newest member of the department who was hired on October 1, 1990 is in the Police Academy right now and is doing very well. He has completed this department's new eight week training program. I believe Brian Peno will make a very good police officer for this department and for the Town of New Hampton.

A project that I started on my own time and then brought up to the full-time members of the department and the Board of Selectmen, is a new arm patch design for our uniforms. I did this for a number of reasons. First of all, I felt that we needed something that would be unique to our Town and our Town only. As you will see at Town meeting, I will have at least a photocopy of what the patch will look like, if not the patch itself. Just an idea of what is on the patch, we have the Town House and the Church, and the monument with the Pemi River and mountains in the background. Also the year "1777", in which this Town was established.

Over the past 10 plus years that I have been a Police Officer here in this Town, over 7 of those years as Chief of Police, I have seen many changes. Many of these changes have been in the department itself and also as many or more have been within the boundaries of our Town. I can not help but feel very fortunate to be part of all this, and I have to say THANK YOU to all the residents in this Town of ours. The support and help is what makes this Town so great. I do hope that this will continue for many years to come.

New Hampton Fire Department 1990 Report

1990 has shown a change in leadership for the Fire Department. In April 1990 Chief Clement resigned from the position of Fire Chief. I have since been appointed to the position by the Selectmen. Chief Clement takes with him many years of dedicated service to the Town of New Hampton, and we at the Fire Department wish him and Hope the best of luck.

The New Rescue vehicle(17x1) was placed in service this past year and has been found to meet all the requirements we had hoped for. The rescue vehicle allows us to carry more equipment in a more orderly fashion and also to provide better service to the townspeople.

On the subject of the 1974 International fire engine, it is scheduled to be replaced in 1994. At this time the truck is showing signs of deterioration which will require some repairs in the near future.

In the last few years the Department has proposed to put on an addition to the existing fire station, however due to the changing economy we have decided to place this proposal on hold for now and reevaluate the necessity of this addition. We have in fact installed a wood stove in the meeting room to try to cut down on the cost of heating fuel; materials, time and cost were donated by the membership.

This years operating budget shows an increase due to the increased membership enrollment. In the last few months we have seen it almost double, and with these new members comes a bigger demand on training and equipment. We have proposed several warrant articles to the town in order to update and improve our services.

We thank the community for all it's support and contributions this past year. I would also like to thank all the members of the department for their countless hours of voluntary work and training for the Town of New Hampton and to all the women for their generous support.

Forest Fire Warden 1990 Report

1990 was a mild forest fire season for the Town of New Hampton. Several members responded to a large fire on Red Hill in Moultonboro this past year and assisted Mutual Aid companies with control and extinguishment of this fire. Several fires in town were contained and extinguished before being allowed to gain much headway. This allowed us to update our response equipment and stay within the budget. We were able to purchase 5 new back pumps, 10 headlamps for nighttime firefighting and 500 feet of forestry hose.

This past year saw the closing of the Belknap fire tower on Belknap Mountain in Gilford. It is feared that this move by the State might have an adverse effect in the upcoming brush fire season. The area towns are trying to get the State to reconsider its decision and hopefully we will see it reopened at some point and time in the future.

Please help our town with forest fire prevention. By New Hampshire State law(RSA 224:27) no person, firm or corporation shall kindle or cause to be kindled any fire, except when the ground is covered with snow, without first obtaining a written permit from the Forest Fire Warden of the town where the burning is to be done. Remember you are responsible for suppression costs and can also be fined. Only you can help prevent forest fires.

New Hampton Highway Department

1990 Report

Again this year I wish to thank the Town for their support in our road rebuilding project. In 1990 we rebuilt and shimmed approximately 2 1/2 miles on the Winona Road side of Dana Hill Road. In addition, 1 inch of top mix was added to the road rebuilt in 1989, which includes Town House Road and this end of Dana Hill Road. Rebuilding our roads is one of the true investments we can make in our town which pay back visible dividends. We can now plow these roads much cleaner and they require less sand and salt to maintain for winter safety. Also, think of the savings each of us receives in less wear and tear on our vehicles.

This year, I am asking you to continue your support of our road rebuilding program. I know this is going to be very hard for some of us to justify with the economy the way it is, but can we really afford not to do this project which pays for itself and benefits every citizen of this Town.

This year, using the Highway Block Grant money(\$49,227.46), along with the \$100,000.(same as last two years), I am proposing the following:

1. To finish rebuilding the middle of Dana Hill Road.
2. To add 1 inch top mix to 1990 rebuilding project.
3. To start rebuilding on the far end of Blake Hill Road. We estimate we can rebuild from Coolidge Woods Road to Pete Hoyt's Farm(Old Ness Farm).

I know this will be a difficult decision to make this year. I hope after due consideration you will agree this is a program we should continue.

Also this year, I am asking to have the 1985 Ford F-350 replaced. New trucks have gone up \$1,100.00 over last year and we put \$3,500.00 in repairs for this well worn, hard working truck. If you add these figures, you will see it cost a lot to keep this truck an additional year. It's been a good truck, but now it is time to retire it.

As most of you know, we received considerable damage during the August 1990 storms. I applied for and received funding from the Office of Emergency Management to help pay for this road repair. We received \$28,453.00 from the Federal Government. An additional \$4,560.00 is expected from the State upon completion of the audit.

The two new bridges which you voted to build in 1990 were constructed entirely of wood. They look very natural in their country settings. I hope many of you have had a chance to see them.

Our faithful crew still remains the same: Sam, Stan, Doug, Bill(part-time), and myself. I wish to again thank them for their genuine caring.

Also, I wish to thank all of you for your support this past year. Sometimes, you have had to put up with inconvenience during our road rebuilding project. I hope you feel the results were worth the trouble. Also, I wish to thank the landowners on the far end of Dana Hill Road who cooperated, so that we could do the job right.

I hope you will feel we did make a difference this past year and will continue to support your Highway Department.

Solid Waste Committee

1990 Report

The Solid Waste Committee had another busy year in 1990. Activities centered on revisions to the Town's Solid Waste Plan and planning for the Transfer Station/Recycling Center to be constructed in 1991.

Revisions to the Solid Waste Plan, submitted to the State Department of Environmental Services in January, were made in response to questions resulting from their initial review. The response to the DES completed by the deadline and the Plan is again being reviewed by them. Approval is expected by summer of 1991.

The other major project involving the Solid Waste Committee has involved working with the Selectmen and an engineer on the development of the permit application and a preliminary design and for a Transfer Station/Recycling Center. This facility is to be located on Highway Department property on Route 132 north.

Current plans call for the new facility to be in operation by the fall of 1991. Final design of the Transfer Station/Recycling Center will be completed when money is appropriated for development of the site. Hauling, disposal and recycling proposals will be evaluated as construction begins. Finally, the Committee will be planning an educational program in preparation for the opening of the new facility.

Recycling will be a major component of the new facility and can be a means to reduce overall operating costs. The current recycling program which includes voluntary separation of glass, aluminum and scrap metal has brought additional revenues to the Town. An expanded program at the transfer station/recycling center will not only offer additional revenues but will reduce hauling and disposal costs. These goals can only be reached with your support.

New Hampton Solid Waste Committee

New Hampton Conservation Commission

The Conservation Commission had a busy year in 1990. Members put in lots of time and legwork following up Wetlands Board applications. Because the State Wetlands Board is, as usual, overworked and understaffed, it depends on comments by local people to help make decisions. Commission members visited every Wetlands Board application site to see first-hand what the proposed project involved, then made recommendations to the State board. Besides regular monthly meetings, members attended other workshops and conferences. Deputy Chair Dave Erler attended the New England Interstate Water Pollution Control Commission Conference in June and was the New Hampton representative on the Squam Watershed Committee. Treasurer Lillian McCrelis and member Grita Antoni attended some of the Lakes Region Planning Commission meetings, but New Hampton still has no permanent commissioner on this important planning body. Chair Clare Eckert attended Household Hazardous Waste meetings at the LRPC and helped coordinate a third successful regional collection day. Dave and member Bill Huckins spent a rainy Saturday with soil scientist Mark Jacobs, learning about new requirements for Prime Wetland designation.

The New Hampton Conservation Area saw lots of activity too, starting with a major clean-up. Clare, Dave and Grita collected a pick-up load of trash, and Clare went back for another load from the damaged shelter site with help from her brother Jim and her dad Jim Sr. Dave conducted the 4th Grade Wetlands Class field trip in which 30 students participated. In May he led a bird walk, but the June "Hidden Critters" walk was rained out. He and Change Parker did a bird census and clean-up of Kelley Island, counting 18 species of which 12 were nesting.

Lay Water Monitoring continued through the winter with help from local school children. Kevin Lang became interested in helping with the monitoring of Pemi Lake. Outgoing Chair Pat Schlesinger was a co-recipient of the Governor's Volunteer of the year award for her work in conducting water testing in 1989- Congratulations Pat!

Lacking Chairperson duties, Pat devoted more of her time to the Pemigewasset River. As President of the Pemi River Council she nominated the Pemi for designation under the New Hampshire Rivers Management and Protection Program. Even more exciting, last summer President Bush signed into law the Pemi River Wild and Scenic Study Act.

Other broad conservation projects are in the works in Town: Dave headed the Land Conservation Investment Program Committee which was set up to take advantage of State matching funds for the protection and preservation of important natural resources in local municipalities. The Town received conservation easements on properties belonging to Hope Swain and John Merrill, whose

lands lie along the Pemi River and the proposed New Hampshire Heritage Trail area.

Dave and Bill put on a few miles conducting their spring peeper survey, resulting in an impressive map of wet areas in Town. This map helped Dave locate wetlands for his inventory; after three years of visiting each large wetland, he completed the Town's Wetlands Inventory, presenting the Selectmen and the Planning Board with a detailed report, typed by his wife Brenda and including aerial photographs, of nearly 70 of the most important wetlands in Town. It is hoped the Planning Board will be able to use the inventory to protect crucial wet areas as development continues in New Hampton.

Although we were unable to sponsor students who wanted to attend the Youth Conservation Camps held by the Society for the Protection of New Hampshire Forests due to budgetary confusion, we hope to be able to locate interested high school students for this summer's camps. We would like to add this activity to our agenda for a busy and productive 1991.

New Hampton Planning Board Report

The following report summarizes decisions made by the New Hampton Planning Board on behalf of the town and its residents during the fiscal year 1990. This past year has been quite busy considering the continuing inactivity of the real estate market.

The New Hampton Planning Board has conducted a review process for 15 subdivisions involving 646 acres for a total addition of 41 lots. Fees collected for 1990 totaled \$1,351.80. Currently, there are in excess of 142 vacant lots on the market in New Hampton, NH.

Capital Improvements Program for 1989-1994 is available for constituent review at the Town Office. This document is being updated for the six year period 1991-1997 and will continue to monitor the need for significant cost items, thus being a decision-making tool which can serve to stabilize the tax burden.

During 1990 specific policy hearings were held regarding Floodplain Ordinance, Road Specifications, Fire Protection Regulations and Conservation Easements. In 1991 Site Plan Review Regulations, Master Plan update, Capital Improvements Program, and a Growth Management Ordinance will be some of the planning policy concerns addressed by the Planning Board.

A substantial amount of the testimony at our meetings comes from professional non-residents who are typically very well informed with a variety of planning and development skills. We invite and encourage any resident land owner and/or citizen to participate in the dialogue defining planning issues. It is important to remember that the activities of the New Hampton Planning Board exist for the singular purpose of providing a structured public forum for the discussion of issues involving the development of land in the Town of New Hampton, N.H.

Our regular meetings are held on the third Tuesday of the month at 7:00 PM at the Town Office and are open to the public.

During 1990 NANA experienced a 50% increase in numbers of visits provided in the home by the nurses, the physical therapist and the homemaker/home health aides. We have noted a dramatic increase in individuals attending our health clinics. This, we feel, is a direct result of higher unemployment. Many more are without health insurance and unable to pay for services.

Town appropriations help us meet these needs. We continue to offer our skilled services on a twenty-four hour basis.

Without ongoing town support many of these services would not be available to residents in the Newfound Area.

Its collections reach out to the casual reader, the student, the hobbyist, and the researcher. The breadth of lending opportunities reflects the growing number of media in which communication occurs in this technologically expanding world, and its exhibits reflect the collections and skills of the past and present. Public programs touch our lives as well as those of our children and our parents, and reflect an ongoing concern for responsive subject choices and our local historic memory.

The library offers a broad selection of the best materials available in the wide variety of formats - books for adults, students, and for young children, current magazines and newspapers, large print books, audio cassettes, filmstrips, art prints, puzzles, microfilm, and a very popular and rapidly expanding collection of videocassettes.

Service to children has long been a cornerstone of library business. Activities include a two-day-a-week preschool library "club", preschool storyhour, classroom visits from local school children, and a summer reading club for readers and pre-readers, too.

For adults the programs range from lectures to films to book discussion series. Many community groups make use of the generous meeting room space, and exhibit cases and art gallery show off the many talents and wide interests of area residents.

The rich traditional values that have so long identified the quality of services provided at Gordon-Nash Library are now being blended with a thoughtfully developing state of the art computerized system that identifies this institution with standards dictated by the technical age in which we live. Our goal of providing excellent library services to residents, scholars, and sojourners alike remains constant.

State Representatives Report

The 1991 legislative session promises to be one of the most trying in recent memory, as the current economic recession is resulting in a state budget deficit and pressure to increase taxes to make up the red ink. It is clear that difficult decisions must be made about services the state provides and about the way we tax our citizens and businesses.

We are disappointed to report that state education aid is, once again, down from the previous year. Our town now receives zero state foundation aid funds. This lack of state assistance puts increased pressure on property taxes. New Hampshire ranks 50th of the 50 states in state aid to education, a fact we are trying to change.

State aid to municipalities – long considered a "sacred cow" – also is on the chopping block as the state tries to balance its books. Unfortunately, any reduction in financial assistance to towns will result in higher property taxes. We are working to ensure that such state assistance is not reduced. New Hampshire's property taxes already are the highest in the nation per capita, and we will fight to see that the state does not balance its budget on the backs of the property taxpayer or through "back-door" fee increases.

However, we believe the state must provide basic human services, funds to protect our natural resources, and a strong economic development program. With proposals calling for elimination of an immunization program for school children, gutting the tourist promotion budget vital to our region, and the closing of profitable liquor stores, we will scrutinize the state budget carefully and only vote for taxes that are fair. We also will monitor legislation calling for a progressive income tax designed to raise revenue for property tax relief, and welcome your thoughts on the subject.

County taxes also are on the rise. As members of the county delegation, we are pushing for a "bare bones" county budget that provides adequate public safety as well as human services for the elderly and low-income citizens that need it most.

For the first time in history, however, county taxpayers will be paying for the operation of Gunstock Recreation Area. Although final figures are not available at this time, it appears that approximately \$600,000 will be added to the county budget because of the skiing and camping facility's inability to meet its bond payments. This will be reflected in an increased county tax rate on your property tax bill this year.

We continue to be concerned about environmental issues in the wake of Earth Day. Rep. Steven Maviglio has sponsored legislation that calls for a

wide range of measures to protect water quality in our lakes, rivers, and streams. This includes increasing the septic setback to 125 ft., requiring minimum lot sizes and building standards, and banning the clearcutting of trees and vegetation along shorelands. In addition, the long-awaited nomination of the Pemigewasset River to the New Hampshire Rivers Management and Protection Program also is under review by the legislature. A speed limit for boats and limitations on billboard construction also have been proposed.

Enhanced 911 emergency service for our town also may become a reality in the near future, thanks to legislation filed by Rep. Tom Salatiello. The House already has approved the bill, which calls for a committee to evaluate the costs and logistics, the first step in obtaining E-911 service.

We have introduced a variety of other legislation on subjects ranging from funding Meals-on-Wheels to legislative ethics. We will keep you informed of the progress of these bills through our newsletter (posted in the town offices and mailed to those requesting it) and through area newspapers.

We also hold "office hours" in the town office and meet with the selectmen on a regular basis. We truly appreciate your input on matters before the legislature. Please do not hesitate to contact us to share your views, or if you need assistance with a state or county agency.
