

TOWN MEETING 1982

The meeting was called to order by Moderator John J. Colony III at 10:10 a.m.

Warrent read and polls opened under Article 1: To choose all necessary Town Officers for the year ensuing.

The meeting stood at recess until 7:15 when called to order again.

Prayer by the Rev. Mary B. Upton.

Continuing under Article 1: Gloria Richardson was elected Trustee for Trust funds for 3

Article 2: To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same.

A motion to take up Article 2 after Article 15 passed.

Article 3: To see if the Town will vote to authorize the selectmen and Town Treasurer to borrow money on the credit of the Town in anticipation of taxes.

A motion to accept Article 3 as printed, passed.

Article 4: To see if the Town will vote to raise and appropriate the sum of \$50.00 for the support of the Monadnock Region Association, or take any other action relating thereto.

A motion to accept Article 4 as read, passed.

Article 5: To see if the Town will vote to raise and appropriate the sum of \$100.00 in support of the Grand Monadnock Arts Council.

A motion to accept Article 5 as read, passed.

Article 6: To see if the Town will vote to raise and appropriate the sum of \$428.00 in support of the Monadnock Family and Mental Health Services.

A motion to accept Article 6 as read, passed.

Article 7: To see if the Town will vote to raise and appropriate the sum of \$2,356.00 in support of the services of the Monadnock Community Visiting Nurse Association, Inc.

A motion to accept Article 7 as printed, passed.

Article 8: To see if the Town will vote to raise and appropriate the sum of \$763.00 as the Town's share for the studies and operations of the Southwestern New Hampshire Regional Planning Commission.

A motion to accept Article 8 as printed, passed.

Article 9: To see if the Town will vote to authorize the Selectmen to apply for, negotiate for, contract for, accept and do all things necessary to obtain such Federal, State or other assistance (financial or otherwise) as may be available to the Town.

A motion to accept Article 9 as read, passed.

Article 10: To see if the Town will vote to appropriate and authorize withdrawal from the Federal Revenue Sharing Fund for use as setoffs against budget appropriations in the amount indicated; further to authorize the Selectmen to make pro-rata reductions in the amounts if estimated entitlements are reduced or take any action hereon:

Appropriation

Estimated Amount \$6,300.00

Highway Maintenance

A motion to accept Article 10 as printed, passed.

Article 11: Shall the Citizens of Harrisville ask members of the New Hampshire Congressional delegation to support or co-sponsor a resolution in the U.S. Congress to:

Request the President of the United States to propose to the Soviet Union that the United States and the Soviet Union adopt a mutual freeze on the testing, production, and deployment of nuclear weapons and of missiles and new aircraft designed primarily to deliver nuclear weapons, with verification safeguards satisfactory to both countries. (By petition)

It was moved and seconded to amend this Article to read nuclear and biological weapons. Original motion as amended accepted.

Article 12: To see if the Town will vote to raise and appropriate the sum of \$3,500.00 to make necessary repairs to the International Fire Truck.

A motion to accept Article 12 as printed, passed.

Article 13: To see if the Town will vote to authorize and empower the Board of Selectmen to hire and appoint the Chief of Police effective March 9, 1982. The office of Constable to continue to be filled by ballot vote until such time as appropriate action taken to change by vote at a future Town Meeting. This article is to establish and clarify the separation of the two positions of Chief of Police and Constable.

A motion to accept Article 13 as read, passed.

Article 14: To see what sum of money the Town will vote to raise and appropriate to be placed in a Sinking Fund and to be added to in subsequent years by vote of the Town. Purpose of the Fund would be to replace the present Town owned Police Cruiser. These funds raised under provisions of the Capital Reserve Act of 1943 Chapter 160 as amended.

A motion to accept Article 14 with the amount of \$2,500.00 to be placed in the Sinking Fund, passed.

Article 15: To see if the Town will vote to raise and appropriate a sum not to exceed \$112,500.00 to construct a new Fire Station. Funds to be raised as follows: To raise \$22,500.00 in 1982 by taxes; the balance of \$90,000.00 to be raised by the issuance of nine equal notes of \$10,000.00 each, the first note coming due in 1983 and one note coming due each year for a period of eight years thereafter. To further authorize the Selectmen to determine the date and place of payments of such notes and to determine the rate of interest thereon and to take such other steps as may be necessary to negotiate such notes as shall be to the best interest of the Town of Harrisville.

A motion to accept Article 15 as read required a 2/3 majority vote by paper ballot. Article 15 was defeated.

Total ballots cast 154 88 yes 66 no

Returning to Article 2: Warren Thayer discussed the budget for the Town for the year 1982. A motion was made to accept the budget as explained was passed.

Article 16: To vote by ballot on the adoption of amendments of the Town of Harrisville Zoning Ordinance and Zoning Map as proposed by the Town Planning Board and filed with the Town Clerk February 5, 1982.

Considerable discussion about the problem the Town still faces about the Fire Station followed.

A motion was made that there be a committee appointed to study the cost of renovating the two existing Fire Stations.

That motion was amended to read that there be a committee appointed to present a side by side comparison of the cost of renovating the two existing buildings and the cost of a new building.

The motion as amended passed.

The polls will be open from 10:00 a.m. to 8:30 p.m.

To the inhabitants of the Town of Harrisville in the County of Cheshire in said State, qualified to vote in Town affairs:

You are hereby notified to meet at Wells Memorial School in said Harrisville on Tuesday the eighth day of March, next at Seven of the clock in the afternoon to act upon the following subjects:

Article 1. To choose all necessary Town Officers for the year ensuing.

Article 2. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same.

Article 3. To see if the Town will vote to authorize the Selectmen and the Town Treasurer to borrow money on the credit of the Town in anticipation of taxes.

Article 4. To see if the Town will vote to raise and appropriate the sum of \$50.00 for the support of the Monadnock Region Association or take any other action relating thereto.

Article 5. To see if the Town will vote to raise and appropriate the sum of \$200.00 in support of the Grand Monadnock Arts Council. (By Petition)

Article 6. To see if the Town will vote to raise and appropriate the sum of \$428.00 in support of the Monadnock Family and Mental Health Services.

Article 7. To see if the Town will vote to raise and appropriate the sum of \$2,495.00 in support of the services of the Monadnock Community Visiting Nurse Association, Inc.

Article 8. To see if the Town will vote to raise and appropriate the sum of \$823.00 as the Town's share for the studies and operations of the Southwestern New Hampshire Regional Planning Commission.

Article 9. To see if the Town will vote to accept \$200.00 received from Gottfried Steigmann for care of cemetery lot.

Article 10. To see if the Town will vote to authorize the Selectmen to apply for, negotiate for, contract for, accept and do all things necessary to obtain such Federal, State or other assistance (financial or otherwise) as may be available to the Town.

Article 11. To vote by ballot on the adoption of three amendments to the Harrisville Zoning Ordinance as proposed at hearings held November 30, 1982, and February 1, 1983, and filed with the Town Clerk February 3, 1983.

Article 12. To see if the Town will vote to go on record in support of immediate actions by the Federal Government to control and reduce acid rain which is harmful to the environment and economy of Harrisville and to the health and welfare of the people of Harrisville.

These actions shall include:

- Reduce by at least half the major cause of acid rain, sulfur dioxide emissions by the year 1990.
- 2. Conclude negotiations and adopt a treaty with the government of Canada that will commit both nations to this goal.

The record of the vote on this article shall be transmitted to the New Hampshire Congressional Delegation and to the President of the United States. (By Petition)

Article 13. To see if the Town will vote to appropriate and authorize withdrawal from the Federal Revenue Sharing Fund for use as setoffs against budget appropriations in the amount indicated; further to authorize the Selectmen to make pro-rata reductions in the amounts if the estimated entitlements are reduced or take any other action hereon:

Article 14. To see if the Town will vote to discontinue that portion of the Old Chesham-Harrisville Road that was transferred to the Town by action of the State of New Hampshire July 2, 1954, and to now let it revert to the present adjacent property owners, Steven and Eunice Powers. This article would rescind action taken under Article 8, Section B, Town Warrant dated March 8, 1960.

Article 15. To see if the Town will vote to raise and appropriate a sum up to \$7,500.00 to provide architectural design and site planning services for the purpose of obtaining construction bids for a new fire station on Town owned lot purchased by the Town from Cersosimo Lumber Company in 1982.

Article 16. To see if the Town will vote to raise and appropriate a sum not to exceed \$125,000.00 to construct a new fire station. Funds to be raised as follows: to raise \$35,000.00 in 1983 by taxes; the balance of \$90,000.00 to be raised by the issuance of nine equal notes of \$10,000.00 each, the first note coming due in 1984 and one note coming due each year for a period of eight years thereafter.

To further authorize the Selectmen to determine the date and place of payment of such notes and to determine the rate of interest thereon and to take such other steps as may be necessary to negotiate such notes as shall be to the best interest of the Town of Harrisville.

Article 17. To hear reports of Agents, Committees or Officers chosen and pass any vote related thereto.

Article 18. To transact any other business that may legally come before this meeting.

AUDITORS' OPINION

Board of Selectmen
Town of Harrisville, New Hampshire

Dear Members of the Board:

We have examined the various Financial Statements of Ralph Bemis, Tax Collector for the year ended December 31, 1982 as listed in the accompanying Table of Contents. Our examination was made in accordance with generally accepted auditing standards and, accordingly, included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

As described in the Note to the Financial Statements the Tax Collector's policy is to prepare Financial Statements on the basis of cash receipts and disbursements; consequently, certain revenue and related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying Financial Statements are not intended to present financial position and results of operations in conformity with generally accepted accounting principles.

In our opinion, the Financial Statements referred to above present fairly the assets and liabilities arising from cash transactions of Ralph Bemis, Tax Collector as of December 31, 1982 and the revenue collected and expenses paid during the year then ended, on the basis of accounting described in the Note to the Financial Statements, which basis has been applied in a manner consistent with the preceding period.

THE HARRISVILLE CONSERVATION COMMISSION

The Harrisville Conservation Commission meets the first Monday of each month at 7:45 p.m. at the Selectmen's office. Meetings are open to the public and anyone is welcome to attend. We are currently looking for new members.

The HCC has been working on the following issues: Dump Recycling, Opposing B-3 Highway, Conservation Agreements, and expressing our views on the Harrisville Pond Association.

Dump Recycling Tom Wheeler presented to the selectmen a model of a proposed dump plan. Mr. Wheeler is very active in the Monadnock Energy Project, an organization working for a regional recycling plant. Also, we are presently working with the Southwest Regional Planning Commission concerning Harrisville's role in the recycling process in the Monadnock Region.

Opposing B-3 We presented our views to the NH Department of Public Works and Highways on the proposed B-3 By-Pass. The Commission presented comments and criticisms on the DEIS on the following points: Watershed Areas (including the town spring), Wetlands, Wilderness Areas, Wildlife and Farmlands. Given the stated choices of the DEIS, the HCC favored the No-Build option. No-Build does the least amount of harm to our environment.

Conservation Agreements The Commission helped propose a Conservation Agreement with the Town and a private party to protect the forests, wildlife and historic features of the property.

Harrisville Pond Association We presented our views to the State Water Board on the water level of Harrisville Pond. We asked that all groups involved with the water level of the pond work together to find an agreeable solution for all those concerned.

1983 The biggest single issue to be dealt with this year, with many other Town organizations, will be the Town Dump. Our time is running out with our open dump policies. Please help us to serve you. Please send your ideas or comments to the Commission via the Selectmen's Office, or express your ideas at our next meeting.

MARL-HARRIS FIRST AID AND EMERGENCY SQUAD, INC. 1982 SERVICE REPORT

For the period January 1 through December 31, Marl-Harris made 113 calls. Of these 72 were emergency, 23 were non-emergency or transfers. We responded to 11 highway accidents with 19 patients. There were 4 standbys and 3 no transports. We transported patients to Peterborough, Concord, Hanover and Westwood Nursing Home. 22 of the total runs were made to Harrisville.

Our ambulance is starting its third year and has 9000 miles on it. It has passed all inspections as has the equipment.

We wish to thank the police and fire departments for their help and cooperation. We sincerely appreciate it.

Your contributions and donations in memory of loved ones and friends are certainly appreciated and help us remain self supporting. During our 12 years of service we have not used any of your tax dollars.

With the continual emphasis on accidental and motor vehicle accidents, we have purchased new extraction devices for use on neck and spinal injuries, and the necessary sizes of cervical collars for these injuries.

These pieces of equipment, as well as a new portable suction unit, will enable us to provide better patient care.

Any resident of Marlborough or Harrisville interested in becoming a member of the ambulance squad is invited to attend a squad meeting on the first Wednesday of the month, or contact a squad member, so first aid training can be arranged.

We again remind all residents of Marlborough and Harrisville to call 352-1100 if they need emergency service of any kind.

REPORT OF HARRISVILLE FOREST FIRE WARDENS AND STATE FOREST RANGER

Forest fire prevention, our business, your business, good business! This slogan has been the motto of the N.H. Division of Forests and Lands, Forest Fire Service since 1909 when the first forest fire laws were passed by the Legislature.

These laws set in place a cooperative forest fire protection program of State and local forest fire personnel that has, in the past 75 years, established New Hampshire as a leader in forest fire prevention and control. Our annual acreage loss to forest fires of one-half acre per fire is the best in the nation. This fire record has come about through the cooperative efforts of our state/town forest fire protection program. The state provides detection of fires, training for local forest fire wardens, low cost forest fire suppression equipment to local fire departments, and technical advice at the fire ground. Local governments provide the volunteer fire fighters who are appointed as wardens and deputy wardens and who respond quickly to suppress reported forest fires.

This program has resulted in a steady decline in annual acres lost to forest fires since 1910 when the average fire burned 33 acres compared to the modern day loss of one-half acre per fire.

Only by the continued cooperation of the State/towns and our entire citizenry can this record be maintained.

REPORT OF HISTORIC HARRISVILLE, INC.

For Historic Harrisville, 1982 was a year of excavation and reconstruction at "Blake's Blacksmith Shop", the former Winn Boathouse. Roberta Wingerson of Nelson, a professional contract archaeologist, volunteered two weeks of her time and together with Harrisville volunteers sifted through the Blacksmith Shop site. Artifacts included iron hardware, glass bottles, clay pipes and pottery shards. After the excavation, exterior construction began on the building and you may have noticed its new straightened look, new roof, new windows, and coat of paint.

Also in 1982, the "Harrisville Rural District" was determined eligible for listing on the National Register of Historic Places. The 1400 acre Rural District extends, very approximately, from #4 Hill to Eastview and would enjoy federal protection as a historic site, but would not affect the town established and administered Historic District.

Historic Harrisville is a public, non-profit foundation and we welcome anyone to our meetings which are usually held on the last Saturdays of April and October.

Looking back on this past year, the Library was a busy place indeed. There were woodcarving and weaving displays, as well as exhibits on sports, gardening and cooking. The Alphabet received special attention this Spring, while this Summer, many of us were surprised to see our Library "inhabited" by most of our local "critters".

Children were active patrons as they participated in a Valentine contest and our Summer Reading Program, "Buried Treasure". Story Times on Wednesdays and the Film Program on Saturday mornings were popular. The highlight of the Family Film Program was the American Short Story Series, co-sponsored by the New Hampshire Council for the Humanities. Patrons were able to keep abreast of acquisitions and activities through the Library page and Calendar of the Newsletter.

Our annual Library Tea and Book Sale was well attended, notwithstanding the change in day and the fact that it was held earlier than usual. Through the generosity of our Friends, the Library has had the outdoor lighting system renovated and the supply of Library note paper replenished. Everyone has benefited from these gifts. Thank you, Friends.

With the help of our Volunteers, the Library hours were expanded to include two mornings each week this Summer. This additional convenience was greatly appreciated by patrons. A sincere "Thank you" to all of our Volunteers.

Circulation for the year was 7355, a slight increase over last year's. The Book Van from Concord supplied us with 362 volumes from the State collection. An additional 48 books were borrowed through the State Inter-Library Loan System, while 73 books were borrowed from local Libraries in response to patron requests. Long term loan of 189 fiction titles was provided by the Peterborough Town Library. This past year we added 207 volumes and withdrew 223. The volumes in our Library now total 4807.

With much regret we accepted the resignation of Sue Mickiewicz. Martha Temple replaces Sue as Assistant Librarian.

HARRISVILLE POLICE DEPARTMENT REPORT FOR 1982

1982 can be regarded as a routine year for the Police Department.

There were a moderate number of traffic violations for which we had a 90% conviction rate overall. Motor vehicle accidents were high at 37 recorded for the year. Of the total, about 50% can be partially attributed to ice or snow conditions. Fortunately, very few involved any personal injury.

Criminal complaints varied widely and a number of arrests were made in these matters.

The cruiser needed a few repairs during the year but it continues to be an asset to this department for which we are grateful. We also added a resuscitator and a blanket to the cruiser's emergency equipment.

I would like to express my appreciation to the other Officers who help keep this department running smoothly and to the Townspeople for their continued support.

Once again, the number for all police assistance is 352-1100.

HARRISVILLE ROUTE 101 COMMITTEE REPORT

1982 was an important year in the Route 101 Dublin By-pass project. In October the *Draft Environmental Impact Statement* (DEIS) was released, a 600 page document purported to be an in-depth analysis of the entire project area. Our Committee found little in the study to indicate that the state highway department had "done its homework" in regards to how a road through Harrisville would impact our town. To help in the preparation of the DEIS, we had submitted to the highway planners a list of 27 detailed questions and we were told that they would be addressed. Of our 27 questions, only one was anwered to our satisfaction and 16 were completely ignored. We do not yet know why we are being left out of the planning process but we suspect that we have raised questions that the highway planners would rather overlook.

To assist us in evaluating the DEIS, we contracted with the engineering firms of Bolt Beranek and Newman (acoustics) and Weston Designers/Consultants (underground water sources on Beech Hill). Their reports indicated many shortcomings and deficiencies in the DEIS. We incorporated their findings in our statement submitted at the official Corridor Hearing held November 18-19. At that meeting, our testimony on behalf of the town included our recommendation that the "No Build" alternative be adopted by the state and that improvements to the safety hazards of Route 101 in Dublin be undertaken on the existing roadway at once.

During 1983, we expect the state will make a decision on the future of this project. We believe that the unstated desire of the highway planners is and always has been to build a long by-pass of Dublin through our town. Much opposition, including our own, to that idea has developed, however, and it is certainly possible that the public's opinion may be able to outweigh that of the highway planners and a determined group of people in Dublin. Although such a decision is possible, we think it is only wise to plan for a worst case outcome.

SCHOOL WARRANT

STATE OF NEW HAMPSHIRE

To the inhabitants of the School District in the Town of Harrisville qualified to vote in District affairs:

You are hereby notified to meet at the Wells Memorial School in said District on the 8th day of March, 1983, 10:00 o'clock in the forenoon to bring in your votes for the election of school district officers. The polls will be open at 10:00 a.m., nor close not earlier than the time of closing the polls for the election of town officials.

Article 1. To choose all necessary school district officers in said District:

A Moderator for the ensuing year.

A Clerk for the ensuing year.

A member of the school board for the ensuing three years.

A member of the school board for the ensuing two years.

A Treasurer from July 1, 1983 for the ensuing year.

An Auditor for the ensuing year.

You are hereby further notified to meet at the Wells Memorial School in said District on March 8, 1983, at 6:00 p.m. to act upon the following:

Article 1. To hear the reports of agents, auditors, committees or officers chosen, and pass any vote relating thereto.

Article 2. To see if the District will vote to authorize the school board to make application for, and accept and use in the name of the District, such advances, grants-in-aid, or other funds for educational purposes as may now or hereafter be forthcoming from the United States Government, the State of New Hampshire, or any department or agency thereof, or any federal, state or private agency.

Article 3. To see if the District will authorize the school board to establish a Capital Reserve Fund as provided in Chapter 35 of the 1955 Revised Statutes Annotated for the State of New Hampshire, and any amendments thereto. Said fund to be used for the financing of all or part of the cost of the construction, reconstruction, or acquisition of a specific capital improvement, or the acquisition of a specific item or specific items of equipment, or the construction, reconstruction, or acquisition of a type of equipment; expenditures from said fund shall be exercised only by majority vote of the legal voters at an annual meeting under a proper article in the warrant; and to see what sum of money the district will vote to raise and appropriate to deposit in said fund.

Article 4. To see if the district will authorize the school board to transfer all or any portion of its unencumbered surplus funds, if any, remaining on hand at the end of the fiscal year, June 30, 1983, to the Capital Reserve Fund established by the District at its annual meeting held on March 8, 1983, under Article 3.

Article 5. SUPERINTENDENT'S REPORT

Our five town districts of School Administrative Unit 29 are saddened by the loss of Dr. Bernard Ellis to Connecticut. Dr. Ellis accepted a superintendency in Suffield, Connecticut, in November. His four years with us did much to improve the quality of education. In addition to the many administrative functions he provided the schools and the school boards on a day to day basis, he will best be remembered for his work in improving the language arts and math curriculum. We will continue to plan and implement an updated health curriculum recently started which was very important to Dr. Ellis and his staff.

The results of the New Hampshire School Administrative Unit 29 accountability assessment program, May of 1982, clearly shows that our town districts do a good job in teaching the basic subjects of math, English language arts and New Hampshire and United States history and government with few exceptions. These test scores do vary from year to year, based upon the ability of any one given class. The school administration and teachers are closely analyzing the results of these tests to determine weaknesses and strengths in providing our children the necessary minimal competencies as established by our accountability plan.

We recognize a need to examine more closely our social studies programs which reflect some deficiencies in New Hampshire and United States history and government. The scores below indicate the average percentage score in the three subject areas. These test results are not intended to reflect and measure one school against another, but rather to provide our individual school boards, administration, and staff with data to properly analyze present school curriculum against established minimum competencies which appear to be appropriate.

PRINCIPAL'S REPORT December 1982

As I am entering the winter of my second year at Wells Memorial, I am pleased to report that our school is functioning very well. We presently have 55 students enrolled in grades 1-6, and another 13 are taking advantage of Kindergarten and Readiness classes at the Harrisville School.

There has been much progress in the instructional areas of our classrooms. A math program is being piloted in grades 5 and 6, spelling instruction has been coordinated between grades 1 through 6, and we are among the leaders in utilizing microcomputers in our classrooms. Since the purchase of our PET Commodore microcomputer last year, students have had the opportunity to operate and program the computer. Teachers have devoted many hours to learning this new skill so that it may best be applied in their classrooms.

Many parents and grandparents have joined us during the day as classroom volunteers. They have been involved in projects that have assisted our students, and their contribution is very welcome. It is hoped that this program will continue to expand so that anyone interested in working closer with the school may do so.

We continue our cooperative relationship with the Harrisville School. A report of the Kindergarten Study Committee last year concluded that the program of the Harrisville School was the best of those available locally. We should take great pride in that finding, which insures emphasis on early childhood education will be continued.

Some of the major events of the past year have included school trips to the ocean, and up Mt. Monadnock. Both activities served as culminations to oceanography and geology studies. A cold frame has been constructed on the playground with hopes of an early crop in the spring. The School Fair was again a success, demonstrating how school and community can work together.

Our students are faring very well in comparison with their peers. They have consistently scored above the norm on both local and national tests. Take pride in the achievements of your school and please join us in making the Wells Memorial School the best possible learning environment.

REPORT OF THE SCHOOL NURSE

Our school year got off to a good start. Head checks were done the first week of school with no evidence of head lice. Height and weight measurements were done for all students and recorded. Vision testing was done for grades 1 and 2 during October and November. In November and December, vitamin information was given to all students with discussion periods following. This program went well. Due to the fact that first and second graders have a difficult time grasping information, a different program was conducted for them. Their program consisted of filmstrips showing Winnie the Pooh and Friends discussing good nutrition and what a balanced diet is. The filmstrips were very basic and easy to understand.

In cooperation with Dr. McMurphy, our school physician, the school's first aid supplies are being updated. Along with the annual resupplying of bandaids, tongue blades, disinfectants, and miscellaneous materials, we will be ordering new equipment and supplies recommended by Dr. McMurphy. One of the most expensive of these items is a backboard which can also be used as a stretcher. The pattern comes from the Red Cross in Keene and the labor is being donated to us by the Cheshire Vocational Center at Keene High School.

Annual fourth grade physicals are tentatively scheduled to be conducted by Dr. McMurphy by February 18, 1983. A series of programs about the five senses will be held during the months of March and April. At the end of April, or the beginning of May, we will have our annual dental program. Our dental hygenist, Lyn Noonan, works very well with the students. I feel this is a very necessary program.

In May, the State of New Hampshire Bureau of Health and Welfare will conduct vision and hearing screening of preschool children in Harrisville. Posters will be placed around town so that parents of preschool children will be aware of this screening. This program has been very successful in the discovery of vision and hearing problems in these children.

Before the end of each school year, I like to talk with the students about summer safety. We discuss bike and swimming safety, care of sunburns, insect bites, etc. I feel that a review of these subjects is worthwhile.

I enjoy working with the students and conducting the health programs. This gives me a chance to get to know the students better and vice versa. I am also very appreciative of the help and cooperation received from Mr. Hemingway and the teachers of Wells Memorial School. They make my job much easier and more enjoyable.
