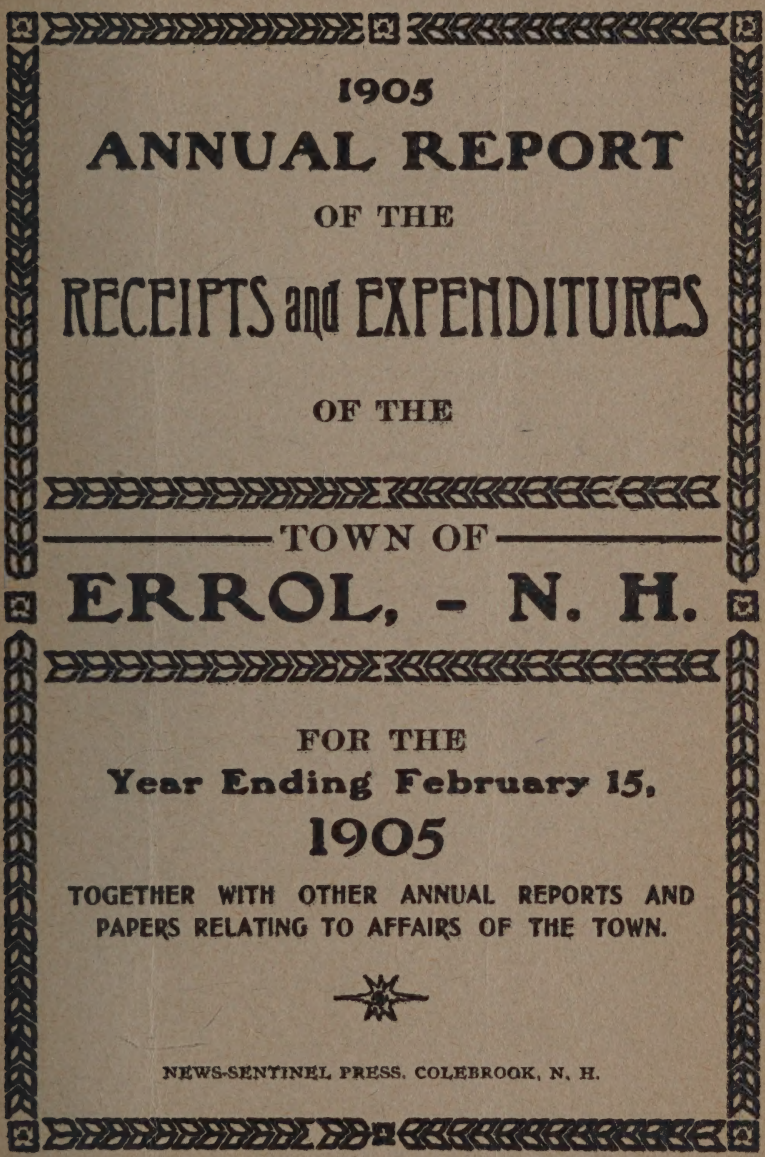

WARRANT.

The State of New Hampshire.

To the inhabitants of the Town of Errol, qualified to vote in town affairs.

You are hereby notified to meet at the Town House in said Town on the second Tuesday of March next, at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary town officers, agents and auditors for the ensuing year.

2. To raise such sums of money as may be necessary to defray town charges for the year ensuing, and make appropriations for the same.

3. To raise such sums of money as may be necessary for the repairs of highways and bridges for the ensuing year.

4. To raise such sums of money as may be necessary for the support of school for the ensuing year.

5. To see what sum of money the town will vote to raise for the public library for the ensuing year.

6. To see if the town will vote to exempt from taxation for a term of years any manufactory that may be brought here either steam, water or electricity within two years time.

7. To see if the town will vote to build a town hall.

8. To see what sums of money the town will vote to raise for the same and to choose such agents, committees and auditors as may be necessary.

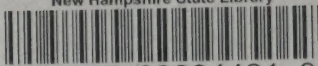
