

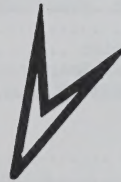

T O W N W A R R A N T

The State of New Hampshire

To the Inhabitants of the Town of Lyme in the County of Grafton in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Laura Barnes School Auditorium in said Lyme on Tuesday, the fourteenth of March next, at nine o'clock in the forenoon, to act upon the subjects hereinafter mentioned. The polls will be open at said meetingplace until six o'clock in the afternoon for reception of your ballots.

- ARTICLE 1. To choose all necessary officers for the ensuing year.
- ARTICLE 2. To see if the Town will authorize the Selectmen to purchase the land and buildings on the west side of High Street now owned by the State, and appropriate \$5,000.00 from the Revenue Sharing Account for this purpose. (Recommended by the Budget Committee)
- ARTICLE 3. To see if the Town wishes to change the term of the elected office of Town Clerk from one year to a three year term. (If voted in the affirmative the election of a Town Clerk in March 1979 would be for a three year term.)
- ARTICLE 4. To see what action the Town will take upon the budget submitted by the Budget Committee.
- ARTICLE 5. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes for the ensuing year.
- ARTICLE 6. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired through Tax Collector's deeds.
- ARTICLE 7. To see if the Town will authorize the Selectmen to apply for, contract for, and accept from the Federal or State governments or subdivisions thereof, or from private corporations or individuals, funds, equipment, services or grants-in-aid relative to relief from disaster, or for any purpose consistent with public need and benefit.
- ARTICLE 8. To hear the reports of Agents, Auditors, or Committees, or other officers heretofore chosen, and pass any vote relating thereto.
- ARTICLE 9. To see if the Town will vote to authorize the prepayment of taxes and to authorize the Tax Collector to accept payments in prepayment of taxes, in accordance with the provisions of New Hampshire Revised Statutes Annotated 80:52-a.
- ARTICLE 10. To see if the Town will vote to elect the members of the Town Planning Board to office as provided by New Hampshire Revised Statutes Annotated 36-4. (By petition)
- ARTICLE 11. To see if the Town will vote to provide for the election of a three-person committee of taxpayers of the Town of Lyme to serve as the appointing authority to appoint members of the Town Zoning Board of Adjustment, if and when such Board of

Adjustment shall be created by any zoning ordinance of the Town and to annually reappoint members of the Board of Adjustment, hold hearings, and fill vacancies, all as provided by New Hampshire Revised Statutes Annotated 31:67. Each member of the appointing authority shall be elected by majority vote at Town Meeting. The Town shall initially elect one member for a one-year term, one member for a two-year term and one member for a three-year term. Thereafter, the term of an elected member of the appointing authority shall be three years. (By petition)

ARTICLE 12. To see if the following shall be adopted as the new Personnel Policy of the Town of Lyme.

1. Hiring of Town Help:

- 1.1 The Town Road Agent shall make his recommendations to the Board of Selectmen and they (the Board and the Road Agent) shall decide the need for such hiring. The Road Agent shall do no such hiring unilaterally except to relieve temporary emergency situations.
- 1.2 Each new employee shall be on a six month trial period. At the end of the trial period the employee's work record shall be evaluated and, if found satisfactory by the Road Agent and the Board of Selectmen, the new employee shall be considered a regular full time employee.
- 1.3 A new employee shall not receive any benefits as listed below until after this satisfactory six month period. Only after this period will he be considered a full time employee.

2. Holidays:

- 2.1 The Town of Lyme shall observe the following holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving and Christmas.
- 2.2 All full time employees shall be paid for these holidays.
- 2.3 If in case of any emergency - to be determined by the Road Agent and the Selectmen - work must be performed on a paid holiday, the full time employee will be paid at his regular rate of pay in addition to receiving eight (8) hours pay for the holiday.
- 2.4 If a holiday should fall on an employee's scheduled vacation, the employee will be paid an extra day's pay.

3. Vacations:

- 3.1 A full time employee of the Town of Lyme shall receive 1 week's paid vacation after his first full year of employment; 2 weeks after 3 years, and 3 weeks after 5 years. A full time employee's first year shall be calculated from the date he was hired if he worked regularly during his 6 months trial period.

- 3.2 Vacation must be taken in the year following its having been earned.
- 3.3 Vacation cannot be taken without the approval of the Road Agent who shall work out a satisfactory schedule well in advance with each employee.

4. Sick Leave:

- 4.1 A regular full time employee will be paid at his base rate for 8 hours for each day he is absent because of illness starting the fourth day thru the seventh day. Starting on the eighth day he will be covered by the insurance policy described in Paragraph #8.3 below.
- 4.2 In order for the full time employee to collect any sick pay as described in Paragraph #4.1 above he may be required to present a doctor's certificate attesting to his illness.

5. Dismissal and Grievances:

- 5.1 No employee may be fired without just cause.
- 5.2 The Board of Selectmen and the Town Road Agent shall make the decision on dismissal of any full time employee.
- 5.3 Any full time employee shall have the right to state his case before a Grievance Committee which shall be appointed by the Chairman of the Budget Committee and consist of the Chairman and at least two other members of the Budget Committee.

6. Town Road Agent:

- 6.1 The elected Town Road Agent shall have all waiting periods waived and be considered a full time employee at the time of his election.
- 6.2 The elected Town Road Agent shall have 2 weeks paid vacation each year starting his first year in office. He shall have 3 weeks paid vacation after he has served as Road Agent for 5 years.
- 6.3 Dismissal of the elected Town Road Agent shall be taken care of as described in the State Statutes 254.9.

7. Base Rates of Pay:

- 7.1 The following will be the base rates of pay. Any subsequent cost of living increases will be based on these rates:
 - A. Trainees on six months' trial period - \$3.50/hour
 - B. General Laborer full time employee including truck drivers - 3.65/hour
 - C. 2nd Class Heavy Equipment operator including loader/back hoe - 3.75/hour

- D. 1st Class Heavy Equipment operator
including grader operator - 3.95 - 4.50/hour
- E. Town Road Agent - 5.00/hour

- 7.2 The above rates will become effective on April 2, 1978. Cost of living adjustments, if any, will be determined by the Board of Selectmen and the Budget Committee each year and become effective on the first Sunday in July. The amount of the adjustment will coincide with the percentage change in the cost of living for the previous calendar year as determined by the Federal Government.
- 7.3 Every six months (as close to January 1st and July 1st as possible each year) there will be a review by the Road Agent and the Board of Selectmen of each employee's base rate classification and, if this performance evaluation warrants, a change in classification will become effective at that time.
- 7.4 Overtime will be paid at the rate of time and one-half after 40 hours' work in any regular 7 day pay period.
- 7.5 The seven (7) day pay period will run from Sunday thru Saturday, and pay checks will be issued each week on Wednesday covering the previous Sunday thru Saturday period.
8. Additional Benefits:
- 8.1 In addition to Workmen's Compensation Insurance each full time employee will be covered by Blue Cross-Blue Shield. The Town will pay the full cost of this insurance. A special pamphlet which discusses these benefits is available to each employee; however, the coverage is for the full cost of hospitalization in a semi-private room for up to 120 days, major medical insurance up to \$1,000,000.00, and with equal coverage for dependents where applicable.
- 8.2 The Town also will pay the full cost of a Group Life Insurance policy for each full time employee. This policy provides \$10,000.00 of life insurance payable to the beneficiary chosen by the employee in the event of death from either occupational or non-occupational causes, whether natural or accidental.
- 8.3 In addition to the policy described in 8.2 above the Town will pay the full cost of a Group Disability Insurance Policy which will cover all full time employees. This policy provides approximately 66-2/3% of a disabled employee's wages payable in the event of accident or sickness starting with the first day of a non-occupational accident and the eighth day in the event of sickness. (It should be noted here that occupational accidents are covered by Workmen's Compensation Insurance which is paid for in full by the Town.) It should also be noted that all payments received from this policy are tax free.

Please note that a pamphlet describing in detail the

benefits of both the Group Life and Group Disability policies is available and should be read by each employee. These policies are under the sponsorship of the New Hampshire Municipal Association. (See Paragraph 8.6)

- 8.4 The Town will include all full time employees who elect to participate in the New Hampshire Retirement System, which system is provided for by RSA 100-A (supp.) for the employees of the Town, in accordance with Chapter 134, to be effective July 1, 1978.
- 8.5 The Town will automatically deduct from an employee's pay check the employee's share of the cost of pension plans, federal income and social security taxes.

8.6 Group Life Insurance --

All full time employees are covered for \$10,000 of Group Life Insurance. Benefits under this plan are payable in the event of death from both occupational and non-occupational causes, whether natural or accidental. The amount of Life Insurance is automatically reduced by 50% following the insured's 65th birthday.

Disability Insurance --

These policies have been written to provide approximately 66-2/3% of a disabled employee's wages as reported to us as of April 1, 1978. The benefits are further adjusted to the nearest \$10.00 per month. We will request a current reporting of salaries on an annual basis for the purpose of making necessary adjustments each July 1st, thus enabling us to maintain the 66-2/3% level. Individual adjustments will not be allowed.

Under the terms of this policy, benefits will be payable in the event of accident or sickness starting with the first day in the event of a non-occupational accident and the eighth day in the event of sickness. Benefits will continue for the duration of total disability, subject to a maximum of 5 years for a non-occupational accident. Sickness benefits will be continued for the duration of total disability for the full amount of indemnity, not to exceed a period of 12 months. Should disability from sickness continue beyond 12 months, the sickness benefits will be reduced by 50% and continue for the duration of total disability, subject to a maximum of 18 additional months. Included with this policy is an Accidental Death Benefit in the amount of \$5,000 which is both occupational and non-occupational in scope.

It should be understood that all full-time employees must be covered, and an application should be submitted within 30 days of date of hire. Full-time employees shall be interpreted to mean all those who work a minimum of 30 hours per week and earn \$1,800 per year. It is further provided that future employees will be included for Disability Insurance

only if they are under age 60 at the time they would otherwise be eligible.

ARTICLE 13. To transact any further business that may legally come before the meeting.

ARTICLE 1. To choose all necessary officers for the ensuing year.

ARTICLE 2. To see if the Town will authorize the Selectmen to purchase the land and buildings on the west side of High Street now owned by the State, and appropriate \$5,000.00 from the Revenue Sharing Account for this purpose. (Recommended by the Budget Committee)

The Article was voted in the AFFIRMATIVE on a voice vote.

ARTICLE 3. To see if the Town will vote, in accordance with State guidelines, to have all Town property and all properties subject to the property tax, professionally reassessed within the next three years and establish a reserve account for this purpose. (Recommended by the Budget Committee)

The Article was voted in the AFFIRMATIVE on a voice vote.

ARTICLE 4. To see if the Town wishes to exclude from its Social Security Plan services of election officials and election workers for a calendar quarter in which the remuneration paid for such services is less than \$50.00.

The Article was voted in the AFFIRMATIVE on a voice vote.

ARTICLE 5. To see what action the Town will take upon the budget submitted by the Budget Committee.

An amended budget figure of \$291,553.99 was voted by voice vote.

ARTICLE 6. To see if the Town will authorize the Selectmen to borrow

money in anticipation of taxes for the ensuing year.

The Article was voted in the AFFIRMATIVE on a voice vote.

- ARTICLE 7. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired through Tax Collector's deeds.

The Article was voted in the AFFIRMATIVE on a voice vote.

- ARTICLE 8. To see if the Town will authorize the Selectmen to apply for, contract for, and accept from the Federal or State governments or subdivisions thereof, or from private corporations or individuals, funds, equipment, services or grants-in-aid relative to relief from disaster, or for any purpose consistent with public need and benefit.

The Article was voted in the AFFIRMATIVE on a voice vote.

- ARTICLE 9. To hear the reports of Agents, Auditors or Committees, or other officers heretofore chosen; and pass any vote relating thereto.

An amendment to the Conservation Commission report (complete details available at Town Clerk's office) was voted in the AFFIRMATIVE on a voice vote.

The original Article was voted in the AFFIRMATIVE by voice vote.

- ARTICLE 10. To see if the Town will vote to allow the Town Clerk to register voters.

The ARTICLE was voted in the AFFIRMATIVE by voice vote.

- ARTICLE 11. To see what action the Town will take on the following proposition:

Shall the provisions for absentee ballot for the election of Town officers be adopted by this Town? (By petition)

This Article was voted in the AFFIRMATIVE on the Official Ballot.

- ARTICLE 12. To transact any further business that may legally come before the meeting.

A desire to investigate and further consider the matter of nuclear production and the construction of the Seabrook plant resulted in a show of hands: expression YES = 43; NO = 23.

The other concern under this Article dealt with the dipping of smelt in Clay and Trout brook and Post Pond. On a voice vote the meeting supported a resolution through a petition to the State of New Hampshire that would prohibit dipping for 90 days.

The meeting adjourned at 10:37 A.M.

To the Inhabitants of the Town of Lyme in the County of Grafton in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Laura Barnes School auditorium in said Lyme on Tuesday, July 26, 1977 at 7:30 o'clock in the evening to act upon the subjects hereinafter mentioned:

- ARTICLE 1. To see if the Town will vote to authorize withdrawal from undistributed surplus and appropriate the sum of Twenty Thousand Dollars (\$20,000) to cover the deficit incurred as a result of repairing damage to roads and culverts caused by the flooding on March 13 and 14, 1977. (Recommended by Budget Committee)
- ARTICLE 2. To see if the Town is in favor of the Lyme Retirement Community home, so-called. (By petition)
- ARTICLE 3. Will the Town vote to elect members of the Planning Board as now provided for in RSA 36:4 Supp. (By petition)
- ARTICLE 4. Will the Town vote to require the Lyme Conservation Commission to ask the Town for its approval before that Commission acquires property which will then be removed from the tax rolls? This requirement shall not, however, apply in the case of outright gifts to the Town whether or not said gifts are made through the Conservation Commission. (By petition)
- ARTICLE 5. We, the undersigned residents of Lyme, New Hampshire, do request that both the Selectmen and Planning Board hold public hearings on any major rebuilding or resurfacing road project prior to construction. (By petition)
- ARTICLE 6. To see if the Town will vote to require the Board of Selectmen to hold a public hearing before changing the use of any Town-owned property. (By petition)
- ARTICLE 7. Will the Town vote to instruct its Board of Selectmen to enable the Town Treasurer to pay all legitimate bills as rapidly as possible in order to keep the Town's credit as good as it was until a year or so ago. (By petition)

REPORT OF THE POLICE DEPARTMENT

Requests for police service increased by 10% in 1977 over those recorded in 1976. This should not be considered as a negative situation but rather that more citizens are availing themselves of police department assistance.

Results of our traffic safety program are most encouraging in that there were approximately the same number of speeding citations issued for all of 1977 as were issued for just six months of 1976. In addition, accidents investigated were down to 17 this year from 26 in 1976.

Another favorable trend has been the marked decrease in reported incidents of vandalism in Lyme. It is hoped that with continued vigilance and awareness by the public, this downward trend in these unnecessary and costly activities will continue.

The number of residents requesting periodic checks of their vacant residences has shown a decline this year, and residents are once again reminded that this service is available for the asking. However, we are unable to be responsive if we are not aware of the vacancy. This is especially true of residences which are vacant for extended periods; it is necessary that requests for house checks be renewed on an annual basis.

Probably the most serious situation in Lyme, as in many communities, is the use of liquor and drugs by our youth. A considerable effort has been coordinated by the Youth and Recreation Committees, together with the police, and it is hoped that the plans for 1978 will help alleviate this unfortunate condition. The overall problem, however, is not one that can be resolved by a few committees but rather one that needs the support of the entire community. Of a special need is assistance by concerned citizens in support of the several efforts which the town will be promoting in the coming year. To date there have been far too few volunteers working toward an improved youth program.

Although the financial report shows that the police department overspent the town appropriation for 1977, we were fortunate to have available income from outside sources which more than made up for the over-expenditure, which was caused in part by several unanticipated reverses. In 1978 we will not have the outside income available to us; however we are planning to live within the same basic appropriation we received from the town for 1977.

As cited in a recent Valley News issue, the Lyme Library continues to be one of the libraries in the state with above average per capita circulation. School circulation figures continue high and account for about 43% of the total. The library is open approximately 17-1/2 hours a week for school use.

In addition to the teaching staff, Aide Norma Randall provides invalua-

able help in the library program, particularly in encouraging student reading. A new, more individualized method of training in library use was begun this fall for students in Grades 3-8. Using material from the "NOW" Library Media Center by Mary Margrade, students are assigned exercises at learning stations in the library, based on pre- and post-evaluation tests which reveal weaknesses in certain skills. Elsie McCarthy and Barbara Roby have been volunteer assistants during these sessions. Films are also shown as part of the library program.

Last spring the library was fortunate to have a full-time volunteer, Jody Ruhle, a recent college graduate with teaching experience, who assisted students, helped with needed reorganization of materials, back cataloguing, and Book Week displays.

The library summer program included a paper airplane fly-in, two puppet workshops with Chris Brown, nature crafts with Julia O'Hara, and some book reading sessions, as well as a book check-out at Post Pond.

The Lyme Center Branch Library at Miss Gladys Gaylord's home continues to serve the community and the kindergarten. Julia Elder, Assistant Librarian, opens the library on Thursday mornings from 10-11. Appointments may be made with Miss Gaylord to use the library at other times.

Ralph Balch retired this year from the Board of Trustees after more than fifty years of service to the library. Our sadness was tempered somewhat by Ralph's selection for 1977 Trustee of the Year by the New Hampshire Library Trustees' Association. The award ceremony in North Conway was well attended by Lyme representatives and the trip there afforded the opportunity for Ralph's first journey over the Kancamagus Highway. Our sincere thanks and appreciation go out to Ralph for his staunch dedication to the library and the community, as do our best wishes.

Lyme's vigorous library interests are also reflected in the participation of two other of our colleagues in national and state-wide activities. David Washburn, current president of the NHLTA, was New Hampshire's representative at the annual conference of the American Library Association in Detroit last June. David's report verified the many opportunities he had to become acquainted with current trends in the library world. In addition, Geneva Menge was elected chairman of the S. W. District Advisory Council of the State-Wide Library Development Program.

Eleanor Mudge has once again carried the shut-in service throughout Lyme by visiting and delivering books to those unable to make it to the library. A reminder....this service is available to all! In addition, please keep in mind that LARGE PRINT books and magazines are also available for those who need them.

After several years of "settling in", the Lyme school program has finally taken on a more formalized structure. Liason between the school board and the library trustees has been established and guidelines of responsibility have been set down. More importantly, however, a mechanism has been instituted by which the program will be evaluated, on an annual basis, for its effectiveness and its suitability for Lyme's requirements.

The appearance of the library's front lawn was enhanced this fall by the planting of two maple trees. One, in memory of Fred Dunbar, was purchased with funds given by friends and collected at the Lyme Country Store. The second tree was given by the Utility Club in memory of Gladys Claflin.

Necessary maintenance on the brickwork and exterior painting was accomplished last summer in our continuing effort to preserve the library building.

The trustees wish to express their appreciation for the many gifts to the library from individuals and organizations in the community, and to thank all those who have volunteered their time and efforts in support of the library.

LYME HOME HEALTH AGENCY

Report of the Board - 1977

The Agency nurse may be reached by calling 795-2661 week days from 9 - 12. If she is out messages will be given to her.

The basic services provided by the Lyme Home Health Agency include bedside nursing, disease prevention, health education, physical therapy, occasional medical screening opportunities for adults, and regularly scheduled well-child clinics. If intensive medical or constant hospital care is no longer needed, patients can often be discharged earlier from a hospital to the care of our home visiting nurse, thus greatly reducing daily hospital costs. Obviously ours cannot be an emergency service since nurses are restricted to following the doctor's prescription in the care of the sick or injured. In an emergency, therefore, one should call a medical doctor or a hospital emergency service.

Our well-child clinics (intended for pre-school children as young as one day old) are held jointly with the Orford Health Agency. In 1977 249 examinations were made, of which 98 were Lyme children; 57 children of 42 families were served. These children are given complete physical examinations by medical doctors. They are immunized against children's diseases, and tested for possible defects of hearing and vision, the parents being advised if corrective measures are indicated. This service is free to Lyme residents.

During the year our nurse made 488 house calls of which 140 were to patients from 1 day to 64 years old, and 348 were to patients of 65 and over. The kind of service given included 219 calls to patients not confined to bed, 136 for home nursing care of the sick, 122 for health promotion and education, and 11 for social service.

It is with great regret that we report the resignation of our nurse, Mrs. Roger Jenks, after some ten years of dedicated service to the young, the sick, and the elderly of our community. She gave unstintingly of her skill, her time and kind concern. The Agency and the Town owe her a deep debt of gratitude. The new nurse is Miss Elizabeth Maislen who is excellently qualified as to nursing education, training and experience.

REPORT OF LYME RECREATION COMMITTEE

REPORT OF THE CONSERVATION COMMISSION

The Lyme Conservation Commission is glad to report that the acquisition of the Nichols tract was finalized. The parcel was acquired with fifty percent funding from the Bureau of Outdoor Recreation within the Department of the Interior, as provided in the Land and Water Conservation Fund Act. The tract is approximately 21 acres with over 400 feet of frontage on the Northeastern shore of Post Pond; it is contiguous with the town owned Chase Beach. This acquisition is the third parcel the Conservation Commission has acquired in the immediate vicinity of Post Pond.

We would like to remind Lyme's landowners that they may now protect the environmental quality of either part or all of their land for future generations through a conservation deed. In 1978 the per capita rate will remain at \$3.50. The user fee will be reduced to \$45.00 per run, and mileage fee will remain at \$1.00.

To offset the lower user fee it is recommended that updated population figures from the Regional Health Planning Commission be used.

In 1977 the user fee for scheduled transfers was reduced to \$40.00 in hopes of being more competitive. This approach failed to meet the expectations.

During 1977 the Fire Department Personnel donated some 400 hours of their time to take an Emergency Medical Technicians update and refresher course.

Planned activities for 1978 include finalization of treatment protocol for advanced care, and training our Emergency Medical Technicians in Intravenous Therapy.

New equipment for 1978 includes replacing the chassis of the Rescue Unit and delivery of a specialized Rescue tool acquired through a Federal Grant.

LYME YOUTH COUNSELOR COMMITTEE

The Town of Lyme began the year without a youth counselor and unfortunately ended the year in a similar condition. During the year, however, we had the services of two highly trained individuals, Micky Cohen and Glen Morazzini. Micky's tenure was short since her unemployment compensation was ended when she took our job, and she could not support herself on our salary alone. To try to make the salary more attractive the Youth Committee sought and received federal funds to supplement the town expenses. Glen was hired as a full-time youth counselor but personal tragedy ended his stay in Lyme and since that time we have been without a youth counselor.

In response to the comments of previous youth counselors and to make

the job more attractive to a local person we are suggesting and budgeting for a slightly changed position. Because it has been felt that the probation officer function is sometimes in conflict with the counselor function, we are suggesting that two separate positions be created. We are also suggesting that the recreational function be combined with the counselor function so that year-round recreational programs can be provided in which the counselor will be able to stay in close contact with the town's youth and their parents. In this way we hope that we will meet the demonstrated need in our community for a youth counselor with someone from Lyme who will provide a greater degree of permanence and continuity.

March 3, 1977

The School District meeting opened at 7:40 p.m. by the Clerk, Jean Bomhower.

Talbert Bacon explained that our Moderator, Everett Rich, has resigned as School Moderator and since we do not vote on our school officers until Town Meeting day this left us without a Moderator. Talbert asked that we give a vote of thanks to Everett for the years he has been our Moderator.

The meeting was then open to nominations for a Moderator pro tem. David Washburn was nominated and seconded. There were no other nominations so

by a voice vote he was elected Moderator pro tem and took over the meeting at this point.

ARTICLE 1. To hear the reports of Agents, Auditors, Committees, or other officers heretofore chosen, and pass any vote relating thereto.

Luane Cole made motion that we accept motion. Seconded by Everett Rich. Motion affirmative.

ARTICLE 2. To choose Agents or Committees in relation to any subjects embraced in this Warrant and fix their salaries.

Jean Smith made motion to postpone indefinitely Article 2, there being no business to conduct under this article. Seconded by Tom Tupper. Motion affirmative.

ARTICLE 3. To see if the School District will vote to accept the budget submitted by the Budget Committee and pass any vote in relation thereto.

Bill Murphy made motion to accept this motion. Dorcas Chaffee seconded.

After some discussion about the amount of the budget and whether it included the money to be raised in Article 4, the motion was withdrawn and Mary Bowden made a motion to pass over Article 3 until we have voted on Article 4. Seconded by Tony Ryan.

ARTICLE 4. To see if the District will vote to raise and appropriate Eight Thousand Two Hundred Dollars (\$8,200) to make the Plain School structurally sound. (Approved by Budget Committee)

Jean McIntyre made motion; Mary Bowden seconded. Talbert Bacon explained what should be done to make second floor of school safer. He then asked Dick Olmsted to speak.

Mr. Olmsted spoke to us about the building. He said he had talked to engineer and had looked over the building himself and that it did need more support on the second floor and he recommended we do this work.

After more discussion this motion was passed in the affirmative.

ARTICLE 3. To see if the School District will vote to accept the budget submitted by the Budget Committee and pass any vote in relation thereto.

There was some discussion about this motion. Dorf Sears explained why this was in warrant. She felt there were a lot of people who were house-bound or ill or away for the winter that could not be at Town Meeting to vote and this would enable them to vote for School officers.

It was then brought out that this was also on our paper ballot for Town Meeting on Tuesday and the question was asked which vote would be valid. The feeling was the ballot vote on Tuesday would be the legal one but it was not completely clear.

At this point a motion was made to withdraw the former motion and to take a voice vote on this only for the feeling of the people at the meeting.

There was a voice vote in the affirmative.

ARTICLE 6. To see if the School District will authorize the School Board to make application for, to receive and spend in the name of the District, such advances, grants-in-aid or other funds for educational purposes as may now or hereafter be forthcoming from federal, state, local or private agencies.

David Dennis made motion to accept article and it was seconded. Motion affirmative.

ARTICLE 7. To see if the School District will vote to accept the provisions of Public Law 89-10, designed to improve educational opportunities with particular reference to children of low income families, and to appropriate such funds as may be made available to the District under said federal act for such particular projects as may be determined by the School Board. Further, to see if the District will authorize the School Board to make application for such funds and to expend the same for such projects as it may designate.

Tony Ryan made motion to accept motion. Seconded. Motion affirmative.

ARTICLE 8. To transact any other business that may legally come before this meeting.

No other business.

David Washburn read the warrant for Tuesday, Town Meeting day, March 8, 1977.

Talbert Bacon asked that Sallie Ramsden be given a vote of thanks for her work on the School Board the past two years.

David Dennis made motion to adjourn.

Meeting adjourned at 8:40 p.m.

LYME SCHOOL BOARD ANNUAL REPORT

We are pleased to report that an anonymous gift of \$20,000 has been given to the Lyme School District. It is for the construction of an addition to the school building, to be used primarily for art and music purposes. A condition of the gift is that the School District shall take action within one year from the date of the gift "to authorize the construction of such an addition". The members of the Board feel that this addition will fit in well with their long range planning for the school and wish to thank the donor(s) for both generosity and vision.

On the educational front the staff is developing a "skills sequence" for science to take its place along side of the ones already worked out for language arts and math. Also, tests are being devised to measure the progress of individual students in relation to these "skills sequences". Our reading and learning specialists are working with a number of students on an individual basis wherever special needs are apparent. With regard to our educational program as a whole we are encouraged with the results of the Stanford Achievement Tests which are showing improvement in reading performance at all levels.

The shortened school day has been in effect since September and is enabling teachers to do better educational planning and to see individual students where necessary. This year "nutritional" bag lunches are being provided by the school. About 45 students are participating.

A number of volunteers from the community have been helping on a regular basis in the class rooms, in the art program and in such activities as skiing, cooking and so forth. The Board wishes to thank them for adding significantly to the range of opportunities available to our students.

We in Lyme have benefitted from a change in the membership policy of the New Hampshire School Boards Association (NHSEBA). At its Fall meeting the Association voted to have a representative from each local school board. In the past Lyme has shared a representative with the other school districts in the Supervisory Union.

During the past year the teachers of the Lyme School were recognized as constituting a legal bargaining unit for purposes of negotiating a master contract covering salaries, fringe benefits and other areas.

With respect to physical plant, some important projects which were previously authorized were carried out successfully. The athletic fields for soccer and softball were completed during the summer, and the turf should be in shape for use this spring. Also a major relocation and enlargement of the septic system was carried out as well as a reinforcement of the structural supports of the Plains School building.

Other improvements to the school facilities were financed from a balance of approximately \$16,000 which remained in the 1976-77 School District funds at the end of the financial year. Among the projects carried out by vote of the School Board were:

- Painting the Plains School
- Roof repairs on the Barnes School
- New lighting in the gym
- Repairs to the north fire escape (Plains School)
- Remodeling and new fixtures for the girls' room (Plains)
- Storm windows and weatherproofing (Plains)
- Purchase of rug cleaner and vacuum for Plains School
- Repairs to the driveway
- Construction of walkway along front of school (Barnes)

A gift of \$300 was received which has been set aside for use in the music program (hopefully in the new addition). Our gratitude goes to the donor of this gift.

In closing the Board would like to take note of the retirement of Dr. William Putnam as school physician. We wish to express our appreciation to him for his many years of dedicated service to the Lyme School District and to wish him well in his future endeavors.
