### REPORT OF THE ANNUAL MEETING

### TOWN OF WATERVILLE. NEW HAMPSHIRE

# May 18, 1957

Twelve voters of the Town of Waterville assembled at a legally warned meeting held at the residence of Ralph H. Bean on May 18, 1957. Grace H. Bean, Acting Moderator, opened the session at 2:15 p.m. and the following business was transacted and voted upon:

The minutes of the previous year's meeting were accepted as read.

1. The following officers of the town were elected and qualified for the positions as stated:

- 2. In the Report of the Town Clerk, Ralph H. Bean stated that the town had received \$315.58 from auto taxes and that there was no other revenue during the year.

It was noted that \$163.47 was spent in excess of the \$500.00 appropriation for 1956. A motion was passed to approve this expenditure.

\$500.00 was appropriated as a budget to be used for further improvement of the Town House. It is to include heating and electrical fixtures. The selectmen are to appoint a committee to work on this action.

It was voted that the Town House should be a place for quiet activities. For any special functions, the permission of the selectmen should be secured. All gifts to the Town House will be subject to the approval of the above-mentioned committee.

John F. Marr is to be in charge of contacting a person or persons who will advise the Town on the best method of opening the safe.

It was decided that a sign should be placed on the Town House door saying that the building is Town property.
