



Warrant for March Meeting 1908.

The State of New Hampshire.

To the Inhabitants of the Town of Eaton, in the County of Carroll in said State, qualified to vote in Town Affairs.

You are hereby notified to meet at School House, District No. 10, in said Town, on Tuesday, the 10th day of March next, at ten of the clock in the forenoon, to act upon the following subjects:

1st. To choose all necessary Town Officers for the year ensuing.

2nd. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation of the same.

3rd. To see if the town will vote to authorize the selectmen to hire money to pay on debts of the town.

4th. To see if the town will vote to build a new Town Hall and appropriate money therefor.

5th. To see if the town will vote to lay out a new highway around the East side of Crystal Lake and to make an appropriation of fifty dollars to lay out on said highway.

6th. To see if the town will vote to change from the present highway system to one highway district having one or more highway agents not exceeding three.
