## WARRANT FOR THE ANNUAL TOWN MEETING, MARCH 8, 1921

---

### THE STATE OF NEW HAMPSHIRE

*To the Inhabitants of the Town of Brookfield in the [L.S] County  
of Carroll, in said State, qualified to vote in Town Affairs:*

You are hereby notified to meet at the Town Hall, in said Brookfield, on Tuesday, the eighth (8th) day of March, next, at ten of the clock in the forenoon to act upon the following subjects:

(1) To choose all necessary Town officers for the year ensuing.

(2) To raise such sums of money as may be necessary to defray Town charges for the ensuing year, and make appropriations of the same.

(3) To see what the Town will vote to pay for labor on the Highway.

(4) To see what the Town will vote to raise for the extermination of the pine blister rust and gypsy moth.

(5) To see if the Town will vote to accept State aid for highways, and appropriate sufficient money for same.

(6) To see if the Town will vote to raise the sum of one thousand dollars (\$1,000) for two years, if the State will raise the same amount, to build State aid road.

(7) To see if the Town will vote to raise the sum of one hundred dollars (\$100) for Tumble Down Dick Road, and one hundred dollars (\$100) for Tibbeth Hill, if the State will raise the same amount.

(8) To elect three Selectmen—one for three years, one for two years, and one for one year.

(9) To transact any other business that may legally come before said meeting.

Given under our hands and seal the nineteenth day of February in the year of our Lord, nineteen hundred and twenty-one.

## SUPERINTENDENT'S REPORT

*To the School Board of Brookfield,*

*Gentlemen:* It gives me pleasure to submit my second report as Superintendent of your schools. The statistical report covers the school year ending Aug. 31, 1920. The other matters of a general nature belong in part to that year and in part to the present school year.

The following table should receive careful study and consideration:

From this table you will see that the percent of attendance for all the schools for the year was 89. This is not a bad showing, considering the fact that all our schools are rural and the children scattered. The average attendance for the entire state last year was 92. This average, of course, includes both rural and village schools. However, I feel that we should not be satisfied with our record, and that the percentage should have been considerably higher. It appears from the registers, that some

families have not done their full duty in the matter of insisting upon the regular and constant attendance of their children. The convenience to the family of keeping a child at home for several days at one time, or for two or three days per week, to assist in the household or upon the farm, is not to be considered. Legally every child should be in school *all the time the school is in session*, and no parent should keep a child away from school except for sickness, unless the occasion be one of extreme necessity.

The table also shows an excessive number of tardinesses, especially in the Hackett School. Parents should see to it that their children are not only regular, but also punctual in their attendance. I earnestly ask the coöperation of parents with teachers in correcting the faults which I have mentioned.

Last year it became necessary to shorten the school year in the Hackett and Stoneham Schools. In the Hackett School this was due to the fact that it was necessary for the teacher to attend Plymouth Normal School during the month of February, and to the unusual depth of snowfall, which prevented the re-opening of the school in March. At the Stoneham school we were obliged to change teachers in the middle of the year, at a time when no unemployed teachers were to be found. A prolonged vacation was thus made necessary, and the shortened school year was a natural consequence.

The fact that the Churchill School was in session 36 weeks has positively shown that it is neither unreasonable nor difficult to run the schools for a full 36 weeks. This year all the schools were opened early. There have been no interruptions up to this time, and we should be able to complete a full 36-week year before the end of June.

In grading, our schools are not fully up to the standard. This condition is doubtless due to the fact that formerly the school year has been short; the changes in teachers, frequent; and the supply of text books, insufficient. With these faults corrected, a few years' time will make a great difference in the schools. I am

pleased to report an improvement in all, and especially in the Churchill School.

Since my first report, considerable improvements have been made upon the buildings at the Hackett and Churchill Schools. Additional windows have been inserted at both, greatly improving the light in both rooms. The Hackett building has been re-shingled. Chemical toilets have been installed, and these are working satisfactorily.

Under the new school law, it is required that there shall be medical inspection of the pupils of our schools. We have been fortunate in being able to make arrangements with the Red Cross of Wakefield, whereby we have the services of the Red Cross nurse.

Of the 31 children examined by the nurse, 6 had defective eyesight, 6 had some throat trouble, 12 had defective teeth, and 19 were unvaccinated. As the state law requires that all children in school shall be vaccinated, steps were taken to comply with the law. In several instances, where the child was found to have defective eyes, throat, or teeth, after the parents' attention had been called to this fact by the nurse, action was taken to remedy the defect. On the whole I believe that our health work for the first year has been very satisfactory. I hope that we shall be able to continue the present arrangement with the Red Cross.

In order that all citizens may know how the School District of Brookfield has fared in its dealings with the state, I give the following figures:

The total paid to the state, including that portion of the state tax used for educational purposes, the \$2 per capita tax, and the superintendent's excess salary, amounts to \$333.46. The amount received from the state is \$608.62. It is, therefore, shown that Brookfield has received \$275.16 more than it paid to the state, and in addition has had the services of the superintendent free of cost.

In conclusion, I wish to thank the School Board for the help which it has given me, and to express my appreciation of the harmony which has at all times existed in all our relations.
