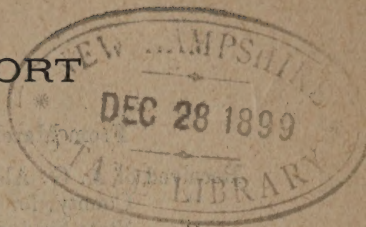

SCHOOL REPORT.

To the Citizens of the Town of Easton:

In compliance with the requirements of law, I have the honor to submit my second annual report of the condition of the schools, which have been under my charge for the year ending March 14th, 1882.

DISTRICT NO. 1.

Three terms of school during the year. Teacher of the summer term, Etta H. Morrison; length of term, eight weeks. Upon my first visit to this school the general appearance was fair, but owing to lack of government and want of punctuality on the teacher's part this school was not a success, and my last examination showed that very little hard work had been done. Register returned but incomplete.

Fall term was taught by Miss Clara M. Hayes; length of term, nine weeks. As I said in my last report, Miss Hayes is one of the best of teachers and one thoroughly understanding the duties and responsible position she occupies when teacher of a district school. The order was of the best and the instruction thorough. The advancement made in the several classes was sufficient evidence that the scholars had been deeply interested in their studies.

Teacher of the winter term, Miss Edith N. Bartlett; length of term, seven weeks. Miss Bartlett labored earnestly and faithfully for the advancement of the school, and insisted on having good order which I deem necessary in any school. The classes were continually broken up by sickness, therefore the progress was not what it would have been had the scholars been more regular in attendance for which the teacher was in no wise blamable. The school was quiet and those present at the last examination showed great improvement in their studies.

DISTRICT NO. 2.

Two terms of school during year; length of Summer term, 9 weeks, which was taught by Miss Susie A. Wood. The school was small, and the order in the school-room perfect. I examined each class, and the progress of the scholars was thorough, but not rapid; showing conclusively that they understood what they had passed over perfectly.

Winter term was also taught by Miss Wood; length, 8 weeks. Mr. Merrill deserves the thanks of the district in securing again the experienced services of so pleasant and valuable a teacher. Under her system of government and instruction, the scholars were orderly, diligent and studious; all the earnestness of the Summer term was manifest in this, and with the same good result.

DISTRICT NO. 3.

Two terms of school during the year under the continuous charge of M. Jennie Wood; length of Summer term, ten weeks. A good scholar, systematic and thorough in her instruction, thoroughly understanding her duty and hesitating not to meet it. The interest of the scholars in the school was manifest, and the teacher thought them worthy of her whole attention. The reading classes made good improvement and the blackboard exercises were second to none in town.

Length of Fall term, eight weeks, and a more beneficial term could not be expected or even desired. The school was quiet, the exercises systematic. The examination at the end of the term showed that the scholars had greatly improved in recitations and deportment. The close attention, prompt and correct answers, showed how ready the little ones had been to receive knowledge, and what pains the teacher had taken to impart it. Miss Wood possesses a superior education and a happy faculty of imparting her knowledge to others. This term continued four weeks by subscription, which is a better recommend than any I might give her.
