



RECORD OF TOWN MEETING

Moderator Richard R. Houghton called the Annual Town Meeting of the Town of Madbury, County of Strafford, and the State of New Hampshire, to order Tuesday, March 11, 2008 at 11:00 AM. The polls were declared open and the following Ballot Clerks were sworn in by the Moderator:

Diane Hodgson

Mary Ellen Duffy

Jill Leavenworth

Moderator Houghton held off starting the evening meeting at 7:00 PM sharp since the ballot clerks ran out of school ballots and had to wait for more to be delivered from Durham. At 7:10 he declared the polls closed rather than the usual 8:00 PM and called the meeting to order.

He asked the assembled citizens (approximately 80) to stand for a moment of silence for those Madbury citizens who have died since last year's Town Meeting and to remain standing for the Pledge of Allegiance led by Town Clerk Pamela A. Seaver.

Those deceased include: Lera Brown, Robert Dowaliby, Stassios Skaltsis, George Abbott, Charles Wharmby, Hock-An Ng, Carol Taylor, Ernest Estes, Helen Brett and Marilyn Hanscom

ARTICLE 1. The following Town Officers were elected by Official Ballot:

ARTICLE 2. Bruce Hodsdon moved and Carol Loughlin seconded a motion to authorize the Selectmen to choose all other Town Officers.

No discussion. Vote was taken.

PASSED

ARTICLE 3. Bruce Hodsdon moved and Janet Wall seconded a motion to raise and appropriate \$1,119,149.00 for general municipal operations. This operating budget warrant article does NOT include appropriations contained in the following special or individual warrant articles.

With not one question asked a vote was taken.

PASSED

ARTICLE 4. Joseph Moriarty moved and Roberta Stearns seconded a motion to raise and appropriate, and authorize the Selectmen to spend, up to the sum of Twenty-Five Thousand Dollars (\$25,000.00) to purchase and equip a police cruiser.

When asked how many cruisers Madbury currently owns, Selectman Moriarty said we have three cruisers and a Chevy Tahoe for mainly winter use. The cruiser model years are a 1995, 2003, and 2006 while the Tahoe is a 2004. The 1995 will be disposed of when we purchase the new one. A resident did ask if we are more likely to get stopped if we purchase a new cruiser. After a hearty laugh from Police Chief Joe McGann and everyone else, the speaker did say, "That was a joke!" A vote was taken with a unanimous affirmative.

PASSED

ARTICLE 5. Peggy Wolcott moved and Joan Valentine seconded a motion to raise and appropriate the sum of Ten Thousand Dollars (\$10,000.00) for the existing Capital Reserve Fund established in Article 9 at the 2002 Town Meeting for a Library Building Fund.

When asked how much money is currently in this fund, Library Trustee Joan Valentine replied approximately \$49,000.00. Selectperson Joan Sundberg confirmed that there would be \$59,000.00 plus in this fund if the Article passes. No further questions or discussion. A vote was taken.

PASSED

ARTICLE 6. Joan Sundberg moved and Kitty Cornwell seconded a motion to raise and appropriate the sum of Fifty Thousand Dollars (\$50,000.00) for the existing Capital Reserve Fund created in Article 9 at the 2000 Town Meeting for the purpose of Purchase of Property and/or Easements.

There were no questions. A vote was taken.

PASSED

ARTICLE 7. Tom Perley moved and Roberta Stearns seconded a motion to raise and appropriate the sum of Ten Thousand Dollars (\$10,0000.00) for the existing Capital Reserve Fund established in Article 8 at the 1994 Town Meeting for the purchase of Fire Equipment.

Janet Wall asked what sort of equipment the Fire Department would be purchasing. Fire Chief Tom Perley replied that they will be equipping a new truck that was purchased at the end of 2007 with a snowplow and other utility truck needs. The new truck is replacing their 1977 utility truck. Roberta Stearns asked if ten thousand dollars was enough. The Chief thought it was. There being no more discussion a vote was taken.

PASSED

ARTICLE 8. Eric Fiegenbaum moved and Allison Cloutier seconded a motion to vote the retention of the unexpended portion of the 2008 Conservation Commission appropriation, said monies to be placed in the Madbury Conservation Fund.

No discussion or questions. A vote was taken.

PASSED

Moderator Houghton took a break before introducing any more articles for voting. He read an article published by Madbury's own Lorraine Morong more than thirty years ago that was all about "petitioned articles". Smiles appeared on the faces of many of those assembled.

ARTICLE 9. A petitioned article was moved by Peter Leavenworth and seconded by Kenneth Bouchard to approve the following resolution to be forwarded to our State Representatives, our State Senator and our Governor: Resolved: We the citizens of Madbury, NH believe in a New Hampshire that is just and fair. The property tax has become unjust and unfair. State leaders who take a pledge for no new taxes perpetuate higher and higher property taxes. We call on our State Representatives, our State Senator and our Governor to reject the "Pledge", have an open discussion covering all options, and adopt a revenue system that lowers property taxes.

Peter Leavenworth explained that this was a non-binding resolution that was being taken up at many NH Town Meetings this year.

A lengthy but friendly debate followed. Madbury's Representative Janet Wall said she would like to meet with residents of Madbury wherever and whenever to talk about this issue.

A vote was taken. There were a few nays but the majority said yea.

PASSED

ARTICLE 10. Conservation Chair Eric Fiegenbaum gave an emotional thank-you to the Hayes family, the voters who came out to the Special Town Meeting last December, the many volunteers and Town Hall staff who helped make the 90 acre Hayes Family Conservation Easement a reality. He presented Barbara and Haven Hayes of Barrington and their son Travis of Madbury, who was absent from the meeting, with two framed aerial photographs of their property with the easement outlined. There was a standing ovation for Eric and the Hayeses.

Diane Hodgson gave a report on salary increases for town officials. This year's salary committee included Richard Houghton, Pamela Seaver and Diane Hodgson. The last consideration was in 1997. The following increases were suggested and subsequently voted and approved by the Board of Selectmen:

Moderator \$250; Auditors \$250 each; Supervisors of the Checklist \$250 each plus \$30 per session; Ballot Clerks \$30 each per election; Fire Chief \$1500; Assistant Fire Chief \$750; Treasurer \$1300; Selectmen \$2000 each

ARTICLE 11. Moderator Houghton introduced Retired Police Chief George Taylor. Selectman Moriarty thanked Chief Taylor for his 31 years of dedicated service to Madbury. His patience and judgment were highly appreciated by the Selectmen. He began his service to the Town in 1976 with no pay, no office and no cruiser. He was a one-man police department who used his own car for a cruiser, and had a budget of \$500 a year. He has taken the department from an all-volunteer force to a part-time professional operation.

Current Chief Joe McGann as well as several part-time patrol officers presented Taylor with a plaque. He was very surprised and overwhelmed when everyone in the hall gave him a standing ovation.

Madbury's new building inspector Mark Morong introduced himself and encouraged anyone with building type questions to stop by his office at the Town Hall, give him a call, or leave a message on his voice mail so he can get back to you as soon as possible.

The meeting was adjourned at 8:05 PM to count the ballots. The meeting was officially adjourned at 8:20 PM.

BOARD OF SELECTMEN

Bruce Hodsdon was re-elected to the Board of Selectmen at the 2008 Town Meeting. Following Town Meeting, Jay Moriarty was elected Chair. In addition to serving as chair, Jay Moriarty was appointed as the Selectmen's representative to the Water Resources Board, and will serve as Road Agent. He will also continue to represent Madbury on the Board of the Lamprey Regional Waste Cooperative and will supervise the Transfer Station. Bruce Hodsdon was appointed the Selectmen's representative to the Recreation Commission. He will continue to act as the Welfare official, and will be the Board liaison to the Police Dept. Joan Sundberg was appointed as the Selectmen's representative to the Planning Board, and will continue to represent Madbury on the Board of the Southern Strafford Community Health Coalition and the McGregor Memorial EMS.

Selectmen's Assistant Diane Hodgson retired after Town Meeting, after serving the town very well for many years. Diane also served as Deputy Town Clerk and Tax Collector. Colette Clickman, who many of you know from her years at the Oyster River School District offices, was hired as Diane's replacement. LeeAnn Simpson was appointed to fill the deputy positions. While we miss Diane, Colette has proved herself a very capable replacement. Please note, however, that it took two people to replace Diane!

In June, the railroad bridge on Perkins Rd. was deemed unfit for use and was closed per order of the Selectmen. Selectmen met with officials from the Dept. of Transportation in July to consider options for the bridge. Options include temporary repair, removal, repair for walking/bike access only, or complete replacement. The bridge remains closed pending a decision by the Selectmen following discussion at Town Meeting.

In other business, the Board updated the Traffic Violation Penalties Ordinance at the recommendation of Chief McGann. Also, the Selectmen authorized a portion of the Town Hall parking lot for temporary parking at the beginning and ending of the school day. A crosswalk has been delineated, and there is a crossing guard on duty during the times the parking lot is in use, providing a safe "drop off and pick up" point for the students. This action was taken at the recommendation of Chief McGann and Moharimet School Principal, Dennis Harrington, who were concerned about the safety of the schoolchildren.

There have been recent changes in personnel at Town Hall. Building Inspector Mark Morong has resigned, and has been replaced by Marcus Everngam. Dr. Roger Temple and Dr. Jack Myers, who served as Health Officer and Deputy Health Officer respectively, have retired from these positions. Their service in these volunteer positions is greatly appreciated. The Board has appointed Dr. David Reeves as Health Officer.

ARTICLE 1: To choose the following Town Officers: (Majority vote required)

A Selectman for the ensuing three years

A Treasurer for the ensuing year

Two Auditors for the ensuing year

A Trustee of the Trust Funds for the ensuing three years

A Cemetery Trustee for the ensuing three years

A Library Trustee for the ensuing three years

ARTICLE 2: To vote to add to the Zoning Ordinances Article XXI Flood Hazard Area Overlay District, intending to bring the town into compliance with federal requirements for participation in Flood Insurance Program(s), as recommended by the Planning Board. (Majority vote required)

ARTICLE 3: To vote to repeal from the Zoning Ordinances Article VII-A Neighborhood Commercial Zone, eliminating that zone and thereby returning the lots in that zone to the surrounding Residential/Agricultural Zone, as recommended by the Planning Board. (Majority vote required)

ARTICLE 4: To choose all other Town Officers. (Majority vote required)

ARTICLE 5: To see if the Town will vote to raise and appropriate \$1,240,583 for general municipal operations. This operating budget warrant article does NOT include appropriations contained in any other warrant articles. (Majority vote required)

ARTICLE 6: To see if the Town will vote to create a capital reserve fund for the purpose of the revaluation of properties and to raise and appropriate \$15,000 to add to this fund and further to name the Board of Selectmen as agents to expend from the fund. ARTICLE 11: Shall the Town of Madbury vote to adopt the provisions of RSA36-A:4-a, I (a) to authorize the Conservation Commission to expend funds to purchase interests in land outside the boundaries of our municipality, subject to the approval of the local governing body? (Majority vote required)

ARTICLE 12: Shall the Town of Madbury vote to adopt the provisions of RSA 36-A:4-a, I (b) to authorize the Conservation Commission to expend funds for contributions to "qualified organizations" for the purchase of property interests, or facilitating transactions related thereto, where the property interest is to be held by the qualified organization and the town will retain no interest in the property? (Majority vote required)

ARTICLE 13: To hear the reports of any Committees, Town Boards, and/or Commissions, and act on any motion thereto.

PLANNING BOARD

The national housing market slowdown is evidenced in Madbury by the small number of house lots created this year. The Planning Board received application for and approved creation of only four (4) additional lots in 2008.

The Planning Board found other work to do in the absence of subdivision reviews including site plan reviews, ordinance change proposals and improvements to Subdivision Regulations and Board Rules. The Redimix site plan review work was suspended early in 2008 while Planning Board decisions are appealed. The process may potentially run for many more months, very possibly returning to the Planning Board eventually for further action. The City of Portsmouth presented improvements to their water system facilities for review and Old Stage Campground has proposed an expansion of their nonconforming use. A Planning Board decision on the latter was the subject of a court appeal and has recently been remanded to the Board for further consideration.

Our ordinances, regulations and rules require continual attention to ensure that these documents reflect the lessons learned by the Board in the course of its work, the ever-changing legal context of planning decisions including new case law and new legislation, and the evolving interests of the community.

A new Flood Hazard Area Overlay District ordinance has been proposed by the Planning Board and will appear on the Town warrant this year. This ordinance will meet federal flood insurance requirements. It must be enacted for Madbury's property owners to qualify for flood insurance.

The Planning Board has proposed elimination of the Neighborhood Commercial Zone. This zone, created many years ago in response to efforts of the then owners of the affected properties, no longer serves the interests of today's owners or the Town in general. The uses allowed in the zone are very restrictive and not consistent with actual current uses in the zone.

Our Subdivision Regulations have been updated to give the Planning Board more flexibility in requiring environmental impact statements from subdividers. Changes also simplify the application fee structure, incorporate a new state fee and edit for general clarity and clearer conformity to state law requirements.

Planning Board Rules have been revised to clarify procedures in some situations in an effort to avoid legal ambiguities and resultant appeals.

During the coming year we anticipate a continued lull in subdivision applications as the housing market will probably remain quiet. The Planning Board is currently considering priorities for the year. Topics likely to receive attention include a review of our water resource protection ordinances for consistency with the state's recently adopted Comprehensive Shoreline Protection Act, a Planning Board inventory of natural resources, and consideration of "Workforce Housing." The latter topic is thrust upon us by the clear local need and recent changes to RSA 674 requiring the town to provide opportunities for workforce housing.

We have added new members to the committee this past year. Members of the committee are listed in the front of the town report. We invite anyone who is interested to volunteer and join the committee and help us expand recreational opportunities in town.

MADBURY PUBLIC LIBRARY

2008 was a busy year for us with both continuity and change. One new thing was a story time for children three and under on Monday mornings. We continue to have a longer story time on Thursday at the same time. We also began a day-time book group that meets on the fourth Monday at two o'clock.

Annual Our first Library Volunteer the Year was Suzie Noronha. We have many dedicated volunteers without whom library could not offer the services it does. It was easy to nominate Suzie for this honor, because for the last five vears she has donated a minimum of two hours a week processing books which arrive in the interlibrary loan box. She calls patrons to tell them that their books have arrived. At the same time she welcomes patrons as they enter the library and assists them in numerous ways.



Thanks to the Friends of the Madbury Library (FOML) we purchased our very own library pass to the New Hampshire Children's Museum in Dover. The day pass for four people is well used and offers Madbury patrons admission at a reduced rate.

A writing group new this year meets monthly, sharing individual work and receiving useful feedback, we recently hosted a traveling doll exhibit featuring characters in well-known children's books, and we continued some community reading and writing programs of past years.

Patrons of all ages participated in this year's Read Around Madbury, choosing from several age-appropriate works from the Marley series (ranging from the adult *Marley and Me* to the picture book *Bad Dog Marley*). We had pet-related programs from Canine Companions for Independence, the Stratham SPCA, and Carol Loughlin, who brought a puppy and discussed things to be aware of when considering getting a pet. A variety of pets visited the library to the delight of our readers, and we had a display of photos of Madbury pets.

In March Suzie and Marian Noronha presented a talk about their work, "Building Schools in Nepal for Kids of Redeemed Slaves" to a full meeting room. Then in April Jill Pare conducted a very informative program on digital scrap-booking.

Area Library Collaborations

<u>For Adults</u>: In March and April we joined with the Durham and Lee libraries to "Celebrate the Granite State." Each library arranged and hosted programs for this series, including our contribution, Wendy Snow Fogg's "Planning, Planting and Maintaining a Successful Organic Garden."

We presented *The War Tapes*, filmed by three NH National Guardsmen during their one-year deployment to Iraq, hosted poet and humorist Neil English, who donated his reading of poems inspired by everyday surroundings and events in New Hampshire, collaborated again on "The Sustainable Living-Green" series by sponsoring programs by UNH's Adam Smargon on lowering environmental impacts through purchase decisions and Steve Pesci on transportation, campus development, and sustainability at UNH and in the area.

For children: During the February and April school vacations (thanks again to FOML) the Durham, Lee and Madbury Libraries sponsored special large-group presentations for children. 110 people enjoyed February's show by Puppeteer Martha Dana. In April, NH Audubon's McLane Center of Concord brought their "Scales and Skins" program, which enthralled the audience of 134 by teaching us about a variety of amphibians and reptiles.

For Families: In May we celebrated the Library's 5th anniversary in our present location with cake and new celebratory bookmarks. Also in May, Hannaford's registered dietitian Megan Bristow came during story time to talk with young families about "Eating for a Healthy Lifestyle." Dr. Katy Lilly of the Woodbury Family Practice helped us to be smarter consumers of health information presented in a variety of media.

Collaboration with local public libraries allows us to bring you and your families programs that we could never afford on our own. Again, thanks to FOML for their financial support of these programs. Every time you donate a gently used book it goes either into the collection or into the FOML Book Sales. Either way helps support the library and its programs.

Summer Reading Program

"G'day for Reading" had our very youngest readers, teens, and adults participating as numerous Australian animals climbed our reading tree each time a young reader finished a book, and a new leaf blossomed for each book read by teens and adults. As the tree grew and animals reached the leaves kids were excited by these visible signs of a reading community. Younger readers learned that their elders read too!

Northeast Credit Union, Houghton's Ace Hardware, and Rebecca's Ice Cream Shoppe in Nottingham supported the program as major donors with \$100 or more in cash or services. Fifteen other donors gave us certificates for ice cream, pizza,

Fisher Cats tickets, plate decorating, movies, fabric, and donuts. The certificates served as reading incentives/rewards for readers of all ages. Each child (from birth through grade 4) got something special each week. These "free" programs do cost money, and we appreciate donations by businesses and individuals alike.

Again with Durham and Lee we brought special events as part of the summer reading. Paul Warnick brought song and dance, Joseph Carringer taught about the music of Australia and didgeridoos, as always Wildlife Encounters Zoo was a big hit as Rachel Cilley returned to take a small group on a special "Wildlife Safari" based on her experiences in Australia.

Annual Bob Connors Picturing Writing Week

Thanks to FOML financial support, we celebrated the fifth year of this writing and illustration experience for kids. Moharimet's Renee Torr returned as our instructor, working with Madbury's talented young artists and illustrators for five mornings.

Other Programs

In October members of the Madbury Fire Department brought a fire truck to the library for Fire Prevention Week. Some children enjoyed climbing into the truck, while others donned firemen's hats.

Bugaboo Creek came to a story time, along with a moose puppet. They shared a book with the children and donated it to the library.

Grants

Thanks to the Kids, Books and the Arts 2008 grant from the NHSL, Joseph Carringer returned several weeks after his large-group presentation to conduct

a small workshop on making and playing the Australian Didgeridoo.

An educator from the Museum of Science brought Science Magic to Madbury thanks to a MOS Traveling Program grant. Held at the Madbury Town Hall on a very rainy day, the program drew 131 people to learn about the science behind apparent



magic. By predicting and observing, children discovered why plates can stay on a table when the table cloth is pulled out and how one can lie safely on a bed of nails—even as an adult audience member pounds a cement block to pieces on the educator's chest!

We were awarded a Bill and Melinda Gates Foundation Opportunity Online Hardware Grant which will, with matching funds from the Friends, bring us three laptop computers over the next two years, including the software and training



needed to take advantage of what the computers can offer to our patrons.

The Friends received a grant a few years ago from the NH Charitable Foundation to determine the future needs of the library. This work was to be conducted in two phases: a library needs assessment and the development of a building program. The needs assessment was completed in 2006; in 2008, as part of the second phase of the grant the Friends hired library consultant Claudia Morner to assist in producing a document using the history and future needs of the library to lay out what is needed for a building. Once completed, it goes out to architects and is the conceptual foundation for the actual drawing of plans.

Information was collected for this process through a survey posted on our web site and handed out at the library and public meetings, a public meeting at Town Hall facilitated by Ms. Morner, and visits to new libraries in towns of our size by some FOML members.

The Building Program document is almost complete and will be available to the public at the library and on our web site. Your comments and suggestions continue to be very important to this project. We hope to have designs in hand sometime in 2009 so that we are prepared to apply for any grants or other funding sources which might become available in the future.

Groups and programs we host at the library include UNH student tutors from Seacoast Reads, CPR and AED training by the McGregor Memorial EMS, Madbury Quilt and Craft group, and the MadLee Knitters, who donate their work to local shelters, hospitals and organizations.

Donations

We are grateful to those who have enriched the library through direct cash

donations, magazine subscriptions, books for our collection or the Friends' book sales, and through cash donations to FOML. We note with gratitude Schnitzer Steel Industries (computer), UNH Physics Library (shelving), and Barnes & Noble (bookcase).

I would like to thank the Friends, Volunteers, Staff and Trustees for their support of the library and of my role within it during my second year here.

When Mayme Trumble moved away, I was worried about finding someone who would keep the library open on "her" Saturday. Thanks to Noreen Gaetjens, that worry was put to rest. Jill Leavenworth and Peggy Wolcott also cover the library one Saturday a month, each.

Volunteers who help out at least once a week include Edna O'Sullivan, Peggy Wolcott and Suzie Noronha. Others work with us as their schedules allow, including Lorraine Morong, Ellie Epstein-White, Barbara Troxell, and Janet Wall.

Ken Wolcott and Eric Fiegenbaum give many hours to the library behind the scenes, keeping our physical plant and computer network running. When I called Ken because we had no water and emailed Eric to tell him a computer had repeatedly crashed, each was on his way in a heartbeat to quietly and capably fix the problem.

Others not listed here take care of our garden, rake leaves or give us a sunny smile when walking in the door. Each person brings a special gift to the library.

2008 Friends officers were Betsy Renshaw, Chair; Pam Seaver, treasurer; Lorraine Morong, Secretary and Doug Hoff, Noreen Gaetjens, Eileen Corrow and Jeanne Bartell, Board Members.





Madbury Public Library

CONSERVATION COMMISSION

Throughout 2007 and into 2008, a number of partners worked on securing conservation easements on the 60 acre portion of Roselawn Farm that is south of Perkins Road in Madbury and Durham. Dea Brickner-Wood from Durham, a conservation volunteer, worked with the Gangwers, Madbury, Durham, the Strafford Rivers Conservancy and the US Natural Resource Conservation Service to reach successful funding for the easements. The easements were recorded on April 18, 2008. Many thanks are owed to Dea for her dedication, and the Gangwers for their generous donation of a portion of the easement value. The

easement helps protect valuable farmland soil, water and wildlife resources, and Madbury's rural character.

The Commission developed baseline documentation (photos and narratives) of the existing conditions on the Hayes conservation easement which closed in December of 2007. The yearly monitoring walks on the three LCIP easements were completed and reported to the State. Our thanks to Marcia Barden, of Hook Mill Road, who lead a walk on Madbury Day of the Hayes easement to acquaint folks with its boundaries and natural resources.

Several development activities in Madbury warranted input from the Commission, which we provided through the Planning and Zoning Boards, and conversations with the Selectmen. Our comments addressed issues of natural and water resource protection. The Commission advocated for minimizing wetland impacts and increased stormwater protections.


The trails behind Town Hall and on the Kingman Farm and Hayes easement are receiving considerable use. In response to comments from numerous hikers, the Commission in conjunction with the Selectmen posted a permanent sign and education material at the kiosk regarding dog ordinances.

In 2008, the State Legislature updated RSA: 36.A which establishes and governs conservation commissions. SB 381 allows towns to contribute conservation funds

to projects sponsored by private conservation groups without having to hold a legal interest in the property. The bill also allows towns to purchase property or easements outside of the town boundaries. Both of these changes clarify a grey area in the law that had long divided municipal attorneys. In the future, towns may not participate in these types of projects without having previously adopted warrant articles allowing them. The Commission will bring the adoption of these articles to the 2009 annual town meeting.

As always, we encourage town residents to bring us their concerns, comments and ideas by letter, email, or attendance at our meetings. We meet on the fourth Monday of the month at 7:00 pm in the Town Hall.

WATER RESOURCES BOARD

The Madbury Water Resources Board is charged with the stewardship of water resources within the Town to the benefit of its citizens and the environment. The Board concerns itself with issues of water quality, quantity, rights, and usage while recognizing these issues go beyond town boundaries and involve complex regional relationships and concerns. Its program is based on recommendations in the Madbury Master Plan.

Several water related issues continued to occupy the Board this year. Applications before the Planning Board regarding the siting of a concrete batch plant and an expansion of a campground were of interest because of their proximity to aquifers and surface waters. The State issued a permit to Pruven Aggregates to draw water from the Bellamy River in Dover for sale as bulk drinking water. The Board also reviewed the water monitoring reports provided by Schnitzer Steel, which operates a transfer yard off Rt. 155.

In another continuing effort, the Board addressed plans for rehabilitating the Hicks Hill water system. A collection of related documents was assembled and posted to an in-house website to make them readily accessible to Board members. Several members took a field trip to the pump house down by the Bellamy River and made some minor repairs.

The Board familiarized themselves with the State Rivers Management and Protection Program and subsequently wrote a letter of support for the Oyster River

Watershed Association's grant application to nominate the Oyster River to the program.

For Madbury Day the Board provided a display and informational material on water testing.

The Board meets on the last Tuesday of the month at 7:00 pm, and interested residents are invited to attend and participate in the discussions.

MADBURY POLICE DEPARTMENT

↑ 008 was an extremely busy year for the Madbury Police Department. The L department rose to the many challenges that occurred.


In February the department transferred from the Strafford Dispatch Center to the New Hampshire State Police Dispatch in Epping for dispatch service. This was done at no cost to the Town and provides excellent service.

The new cruiser arrived in July and was made an unmarked vehicle, used by the Chief of Police and the Detective Sergeant while conducting investigations.

The officers have all received many hours of training, including DWI enforcement, emergency management, domestic violence, officer survival training, Colt armor school, Sig-Arms Armor school, basic criminal investigation, standard field sobriety school, firearms instructor school, all terrain vehicle operation, women in law enforcement street survival school, ground-fighting school, field training officer school, and other training provided to maintain the officers' certifications.

The department had three officers leave during the year. Officer Michelle Montville was hired by the Durham Police Department as a full-time officer. Officer Gerald Moors left to obtain employment in the private sector. Officer Kimberly Arvanitis resigned in December of 2008 to seek a change in her career goals. We wish them well in their future endeavors.

We have hired four new officers. Officer Colton Deschenes and Officer Ryan Mayer have completed the New Hampshire Police Training and Standards Parttime Academy - Class 254, and are now enrolled in the field training stages. Of-

ficer Kevin O'Shea is currently attending the New Hampshire Police Training and Standards Part-time Academy -Class 255. Officer Timothy Mone is a full-time certified police officer working full time with the State of New Hampshire Liquor Commission as an investigator.

As I stated, the year was extremely busy. We experienced a suspicious death in Novem-

ber of 2008, and assisted the New Hampshire State Police Major Crime Unit in this investigation.

No one will forget the ice storm in December. Madbury officers covered 24hour shifts while the power and communication lines were out of service. The officers conducted neighborhood watches and also checked with the elderly and disabled within the community. The Fire and Police Departments worked as a team to provide information and service to the community during the number of days without power.

In 2008 we added quite a few new members: Keith Brody, Jennifer Kray, Scott Lloyd, Mike O'Hara, Kyle Ohlemier, Jared Smith, Derek Young, and Luke Zager. Andrew Davis moved from the rank of Junior Member to Firefighter. Heather Tyree and Mike O'Hara completed NH Firefighter 1 certification.

In December we recognized Arthur Anderson and David Raynes for 30 years of service, Jim Davis for 15, and Ben Dubois for 5. Butch Dresser was named Madbury Firefighter of the Year.

A reminder: NH burning laws require a fire permit any time the ground is not completely covered with snow. If you are burning with snow on the ground, we ask you to contact a Madbury Forest Fire Warden to let them know; this prevents false calls. Permits can only be issued to the property owner, or with written permission of the property owner.

New laws took effect in 2008, prohibiting the burning of anything except clean

brush, less than 5" in diameter. Chimineas and outdoor wood burning fireplaces do require a permit for use; please contact Chief Perley for a seasonal permit.

A summary of the burning laws is available at the Safety Complex. Fire permits may be obtained by contacting Chief Tom Perley (749-3751), Assistant Chief Jim Davis (742-3712), or Deputy Warden Ken Wolcott (742-7494).

In addition, we remind townspeople that NH law requires all oil burners to have a permit to operate (NH RSA 153:5). If you are having your furnace or boiler updated, or your oil burner replaced, please check with your installer to see that a permit has been secured from the Fire Department, There is no cost for this permit or the required inspection. (This does not pertain to gas-fired equipment.)



STRAFFORD REGIONAL PLANNING COMMISSION

Strafford Regional Planning Commission (SRPC), a political subdivision of the State of New Hampshire, serves in an advisory role to Madbury and seventeen other communities in Strafford, Rockingham and Carroll Counties. We provide planning services to boards, officials, and citizens and facilitate regional collaborative efforts to fund regional and local projects.

SRPC's staff offers a range of planning services in transportation, land use, hazard mitigation, economic development, natural resources, and geographic information systems (GIS) mapping and analysis. These services are designed to meet the needs of the volunteers who are the foundation of SRPC communities. Our member communities have access to SRPC educational resources including our website, workshops and forums, and personalized training.

SRPC conducted the following projects and initiatives for Madbury in 2008:

- Secured \$19,800 in federal funds for the development of NH Rivers Management & Protection Program nomination papers for the Oyster River on behalf of the Oyster River Watershed Association.
- Continued updates of GIS databases and the standardized map sets for zoning, transportation and conservation.
- Created a 2005 land use layer for planning and building analyses.
- Completed annual traffic counts and building permit survey.
- Inventoried road name, length, and class changes for 1.9 miles of new public road.
- Provided 16 New Hampshire Planning and Land Use Regulation books with a value of \$832 to land use boards.

In 2009 the NH Charitable Foundation, coordinated through the Piscataqua Regional Estuaries Project, has funded SRPC to prepare an environmental assessment of each Town's land use policies, regulations, and ordinances. SRPC is the Census 2010 Primary Participant for Strafford County. As the federally mandated Metropolitan Planning Organization, SRPC will collect traffic counts, road inventory changes, update the traffic model, provide air conformity analyses, and assist with the development of grant applications for Town projects. We will continue to collaborate with NH DOT, federal agencies and your officials and staff in regard to federally funded transportation programs, NH Ten Year Plan transportation projects and economic stimulus projects for Madbury.

MOSQUITO CONTROL

New Hampshire experienced Eastern Equine Encephalitis (EEE) activity for the fifth year in a row in 2008. Mosquitoes carrying EEE were found in seven communities including Brentwood, Danville, Exeter, Manchester, Newfields, Newmarket and Newton. The State confirmed an emu in Barnstead died from EEE. One sample of mosquitoes from Kensington tested positive for West Nile Virus (WNV). There were no reported human cases of EEE or WNV in New Hampshire. A man from Newburyport, MA died from EEE last season. He had spent time in Gorham, NH and Maine during his likely exposure period.

In Madbury, four traps were set each week from June into October. Adult mosquitoes were caught, identified to species and sent to the State Lab where they were tested for EEE and WNV. Mosquitoes collected in Madbury showed no sign of disease. A total of 3832 mosquitoes were caught and identified in 2008.

Dragon has identified 56 larval mosquito habitats in the Town of Madbury. Crews checked freshwater sites 181 times throughout the season. There were 56 sites treated to eliminate mosquito larvae. In addition, 104 catch basins were treated to combat mosquitoes carrying WNV and EEE. Spraying to control adult mosquitoes was not conducted last season.

The proposed 2009 Mosquito Control plan for Madbury includes trapping mosquitoes for disease testing, sampling wetlands for larval mosquito activity, larviciding where mosquito larvae are found, and emergency spraying when a public health threat exists. The control program begins in April when mosquito larvae are located in stagnant water such as swamps, ditches, and woodland pools. Trapping adult mosquitoes begins in June. The mosquito control program ends in late September or early October when temperatures drop and daylight diminishes.

Homeowners can reduce the number of mosquitoes in their yard by emptying any outdoor containers that hold standing water such as buckets, trash barrels and boats. Tires collect enough water for mosquitoes to survive. It is also a good idea to change the water in bird baths every two or three days.

If you're new in town and do not want your property treated for mosquitoes, then a written request is needed. Please send a letter to Dragon Mosquito Control, P.O. Box 46, Stratham, NH 03885. Be sure to include your name, physical address, phone number, and a description of your property with boundaries. Otherwise, your property may be treated. Anyone who sent a written request in 2008 may call the office to reaffirm your request. Our phone number is 964-8400. You may call our office for assistance regarding mosquitoes, the insecticides we use, spray plans, or questions about EEE or WNV.

CPR Safe School Training and Certification Program

McGregor EMS began its CPR Safe program in 2006. Schools are certified as CPR Safe when they have one or more defibrillators (AEDs) available and have trained over 75% of their teachers and staff in CPR. McGregor EMS has trained and certified the following Oyster River schools as CPR Safe:

- Moharimet Elementary
- Mastway Elementary
- Oyster River Middle School
- Oyster River High School

McGregor purchased additional defibrillators for the schools using \$6,000 in community donations. This program has been cited by the NH State Dept. of Education as a model for other schools.

Homeland Security Grant Awards

For three years in a row McGregor has received Homeland Security Grants for new protective clothing, mobile data terminals and integrated communications equipment for all McGregor vehicles, and most recently, four state of the art multi-function carbon monoxide meters. These grants have saved taxpayers over \$100,000. All have helped to increase McGregor's readiness for both day-to-day and large scale emergencies.

School Emergency Medical Equipment Maintenance Program

At no cost to the schools, McGregor continues to maintain defibrillator and oxygen equipment at the Oyster River schools. This program, together with the CPR Safe program, saves the schools over \$5000, which they had previously paid to a for-profit company.

Paramedic On-call Program

The new 24/7 on-call paramedic program provides enhanced coverage to the community. A McGregor paramedic is available 99% of the time.

Station Renovations

Extensive renovations of our station were done to enhance operational readiness and help retain and attract volunteers.
