THE STATE OF NEW HAMPSHIRE.

To the Inhabitants of the Town of Newton, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall, in said town, on the second Tuesday of March next, at nine o'clock in the forenoon, to act upon the following subjects:

1. To choose a Town Clerk, three Selectmen, Town Treasurer, Tax Collector, Auditors, Road Commissioners, Trustees of Public Library, Constables, Sealer of Weights and Measures, Measurers of Wood and Bark and Surveyors of Lumber, Health Officers, Fence Viewers, and all other necessary town officers and agents for the ensuing year.

2. To raise such sums of money as may be necessary for paying the town debts and defraying the interest thereon, for the support and maintenance of the Public Library, and for other necessary charges arising in said town.

3. To see if the town will vote to raise and appropriate \$25 for Memorial Day purposes.

4. To hear the reports of the Town Treasurer and Board of Selectmen to the Town Auditors, the reports of the Auditors, Agents, Committees, or other officers heretofore chosen or appointed, and to pass any vote relating thereto.

5. To see if the town will vote to authorize the Selectmen to hire money in anticipation of taxes.

6. To see if the town will vote to raise money to enlarge the stage of the Town Hall and make appropriation for the same.

7. To see if the town will vote to establish price for rent of Town Hall.

8. To see if the town will vote to raise money to buy fire apparatus for the town, and make appropriation for the same.

9. To see if the town will vote to raise extra highway money to receive state aid.

To transact any other business that may come before said meeting.

An effort has been made with the limited amount of money to keep the school houses in as good condition as possible.

There are some needed repairs this coming year. The school building at the Junction should be shingled and other small repairs, also a water supply on the school grounds.

The grade around the school house has been completed with satisfaction, and is a great improvement to the place. When raising the shed to the height of the grade, it was found the sills were completely rotted away and new ones were placed beneath.
