WARRANT FOR TOWN OF ACWORTH MARCH 11, 2003

To the inhabitants of the Town of Acworth, NH in the County of Sullivan in said state, qualified to vote in Town affairs:

You are hereby notified to bring your votes for Town Officers, and any other questions. to the Town Hall on Tuesday, the 11th day of March next, between the hours of 10:00 of the clock in the morning until nine of the clock in the evening to act upon the following:

ARTICLE ONE: To vote by non-partisan ballot for the following Town Officers:

Selectmen -- 1 for 3 Year Term Tax Collector -- 1 for 1 Year Term Treasurer -- 1 for 1 Year Term Auditor -- 1 for 1 Year Term Trustee of Trust Funds -- 1 for 3 Year Term Library Trustee -- 2 for 3 Year Terms Library Trustee -- 1 for 2 Year Term Road Committee -- 2 for 3 Year Terms Budget Committee -- 2 for 3 Year Terms Cemetery Trustee -- 1 for 1 Year Term Cemetery Trustee -- 1 for 1 Year Term Cemetery Trustee -- 1 for 2 Year Term Supervisor of Checklist -- 1 for 6 Year Term

ARTICLE TWO: To see if the town will vote by ballot for adoption of an amendment to the Acworth Zoning Ordinance of a RULES OF PROPORTIONALITY which will allow a fairer subdivision of parcels of land which lie partially in both the rural and residential districts. It clears up the problem of which regulations apply in determining lot size and frontage length. The Acworth Planning Board has approved this amendment.

ARTICLE THREE: To see if the town will vote by ballot for adoption of ACWORTH TELECOMMUNICATIONS FACILITIES ORDINANCE approved by the Acworth Planning Board in April 2002. These regulations have been enacted in order to establish general guidelines for the siting of towers and antennas. This Ordinance will enhance the ability of providers of telecommunications services to provide such services to the community effectively and efficiently while protecting the environment, safety and aesthetics of Acworth.

Furthermore, you are hereby notified that discussion and voting on the following articles will commence at 7:30 of the clock in the evening on March 11th next at the Town Hall.

ARTICLE FOUR: To see if the Town will accept the minutes of the Town Meeting of March 12th, 2002

ARTICLE FIVE: To see if the Town will empower the Selectmen to serve as pound keepers, measurers of wood and fence viewers.

ARTICLE SIX: To see if the Town will vote to transfer from the Forest Management Fund into the General Fund up to \$4000.00 of net revenue from the 2002-2003 Gove Town Forest Timber harvest, not to exceed 50% of the final harvest income. Recommended by Selectmen and Budget Committee.

ARTICLE SEVEN: To see if the Town will accept the provisions of RSA 202-A:4-d

- 1. Authorizing the public library trustees to accept gifts of personal property, other than money, which may be offered to the library for any public purpose, and such authorization shall remain in effect until rescinded by a vote of town meeting. II Prior to the acceptance of any gift valued at over \$5,000, the public library trustees shall hold a public hearing on the proposed acceptance. III No acceptance of any personal property under the authority of this section shall be deemed to bind the town or the library trustees to raise, appropriate, or expend any public funds for the operation, maintenance, repair, or replacement of such personal property.
- By Request. Recommended by Selectmen.

ARTICLE EIGHT: To see if the town will accept the provisions of RSA 202-A:11-a -All money received from a library's income-generating equipment shall be retained by the library in a nonlapsing fund and used for general repairs and upgrading and for the purchase of books, supplies and income-generating equipment if approved by the town or city in which the library is located in accordance with RSA 202-A:11-b. By Request, Recommended by Selectmen.

ARTICLE NINE: To see if the Town will vote to accept \$200.00 in trust for the perpetual care of the Ernest S and Geneva W. Lanphear Lot in the Acworth Cemetery. Recommended by Selectmen.

ARTICLE TEN: To see if the town will vote to provide formal conservation status to the town-owned parcels known as the "Acworth Town Wetlands" and the "Gove Town Forest" by placing a conservation easement through an appropriate land conservation organization (such as the Society for the Protection of New Hampshire Forests). Said easement would preclude future building development on these parcels in the interest of maintaining their current respective status as wetland natural area and working forest. Petition by the Acworth Conservation Commission. Not Recommended by Selectmen.

ARTICLE ELEVEN: To see if the town will vote to call on our elected officials from all levels of government, and those seeking office. to work with consumers, businesses, and health care providers to ensure that: Everyone, including the self-employed, unemployed, un – and underinsured, and small business owners, has access to an affordable basic health plan similar to what federal employees receive; Everyone, including employers, consumers, and the state, local and federal government, makes a responsible and fair contribution to finance the health care system; Everyone receives high quality care that is cost efficient and medically effective; and That these efforts help control the skyrocketing cost of health care. By Petition. Not Recommended by Selectmen.

ARTICLE TWELVE: To see if the town will vote to change the Road Agent position from appointed to elected; and to hold a special meeting for said position in May 2003. By Petition. Not Recommended by Selectmen.

ARTICLE THIRTEEN: To see if the town will vote to raise and appropriate the sum of \$25,000.00 (Twenty-Five Thousand Dollars) to be placed in the existing Capital Reserve Fund for the future closure of the town dump. Recommended by the Selectmen and the Budget Committee.

ARTICLE FOURTEEN: To see if the town will vote to raise and appropriate the sum of \$25,000.00 (Twenty-Five Thousand Dollars) for the purchase of a new highway department loader-backhoe and further to expend from the existing Highway Equipment Capital Reserve Fund up to \$45,000.00 (Forty-Five Thousand Dollars) for this purpose. Recommended by Selectmen & Budget Committee.

ARTICLE FIFTEEN: To see if the town will vote to authorize the establishment of a Capital Reserve Fund (Pursuant to RSA 35) for future work on Cold Pond Road and to raise and appropriate the sum of \$50,000.00 (Fifty Thousand Dollars) to be placed in this fund and appoint the Selectmen as agents to expend from this fund. Recommended by Selectmen and Budget Committee.

ARTICLE SIXTEEN: To see if the town will participate in a discussion concerning whether the Village Store Property could house town offices. The Acworth Historical Society has an interest in using an existing and historical building and helping to secure the store's presence in the town. To see also if the town would consider whether a committee should be established and money budgeted to develop this idea. By Petition. Not Recommended by the Selectmen. ARTICLE SEVENTEEN: To see if the town will vote to authorize the establishment of a capital reserve fund (Pursuant to RSA Chapter 35) for the future purchase of a fire truck by the Acworth Fire Department, and to raise and appropriate the sum of \$10,000.00 (Ten Thousand Dollars) to be placed in this fund, and to appoint the selectmen as agents to expend from this fund.

The Selectmen and Budget Committee recommend this article subject to the submission of an appropriate plan by the Fire Department.

ARTICLE EIGHTEEN: To see if the Town will vote to raise sums of money as may become necessary to defray town charges for the ensuing year and make appropriations of the same as recommended in the Budget by the Budget Committee.

ARTICLE NINETEEN: To see if the town will vote to determine whether or not the Town of Acworth should encourage the Trustees of the Trust Funds to petition the Sullivan County Probate Court or Sullivan County Superior Court for permission to spend accrued excess income from eligible perpetual care trusts on the general care, capital improvements or future expansion of the cemetery. This is an advisory vote. Recommended by the Selectmen.

ARTICLE TWENTY: To vote to see if the town will ask our Congressional delegation to oppose the implementation of sections of the Patriot Act and the Homeland Security Act which stand in violation of American's basic rights and freedoms. The USA Patriot Act and the Homeland Security Act contain provisions threatening the guarantees of freedom and liberty set forth over two hundred years ago in the Bill of Rights of the United States Constitution: Freedom of speech, Right of assembly, Protection of privacy. The right to counsel and due process, Protection against unreasonable search and seizure. By Petition.

ARTICLE TWENTY-ONE: To transact any other business that may legally be brought before this Town Meeting.

MINUTES FOR TOWN MEETING MARCH 12, 2002

To the inhabitants of the Town of Acworth in the County of Sullivan in said state, qualified to vote in Town affairs:

You are hereby notified to bring in your votes for Town Officers, and any other questions, to the Town Hall on Tuesday the 12th day of March, between the hours of 10:00 of the clock in the morning until nine of the clock in the evening to act upon the following:

Kenneth Grant, Moderator, called the meeting to order. We had the Pledge of Allegiance and then he read the warrant.

ARTICLE ONE: To vote by non-partisan ballot for the following Town Officers.

Selectmen - 1 Year Term - Thomas Esslinger Selectmen - 3 Year Term - John Balla Tax Collector - Grant Tallman - 1 Year Term Treasurer – Earl F. Luther, Jr – 1 Year Term Auditor - Cheryl Fernald - 1 Year Term Trustee of Trust Funds - Marguerite Hanson - 3 Year Term Library Trustee - Ruth Balla - 3 Year Term Nancy Miller - 3 Year Term Road Committee - Howell Longley - 3 Year Term James Phinizy – 3 Year Term Planning Board - Pamela McWethy - 1 Year Term Richard Bishop - 3 Year Term Stephen Davis – 3 Year Term Budget Committee - James Brown - 1Year Term Linda Christie - 3 Year Term Torrey Greene - 3 Year Term

Furthermore, you are hereby notified that discussion and voting on the following articles will commence at 7:30 of the clock in the evening on March 12^{th} next at the Town Hall.

ARTICLE TWO: Motion was made by Jack Huber and seconded by Jim Brown to accept the minutes of the Town Meeting of March 13, 2001. Jan Augustinowicz brought up the fact that she had mentioned something in Article 14 last year that was not put in the minutes. Minutes were approved after amended to read: In 1986, the N.H. Supreme Court, passed down a ruling, that private property, could not be sold or assumed by town tax lien, until the tax lien equaled the value of the property. Motion passed as amended.

ARTICLE THREE: Motion was made by Thomas Esslinger and seconded by Ralph Balla to see if the Town will vote to raise and appropriate the sum of \$507,000(Five Hundred and Seven Thousand Dollars) for the construction of an addition to and renovation of the Acworth Town Hall; \$434,000(Four Hundred Thirty Four Thousand Dollars) of sum to be raised through the issuance of bonds or notes under and in

compliance with the Municipal Finance Act, RSA 33:1 etseq., as amended; to authorize the Selectmen to apply for, obtain and accept federal, state or other aid, if any, which may be available for said project and to comply with all laws applicable to said project; to authorize the Selectmen to issue, negotiate, sell and deliver said bonds and notes and to determine the rate of interest thereon and the maturity and other terms thereof; and to authorize the Selectmen to take any other action or to pass any other vote relative thereto. And furthermore to authorize the balance of \$73,000.00(Seventy-Three Thousand Dollars) to be transferred from the December 31st undesignated Fund Balance (surplus) for this purpose. And furthermore to authorize the Town Offices Committee to finalize the building design and work with the Selectmen as overseers of the construction.

The Selectmen and the Budget Committee recommend this article. 2/3 ballot vote is required.

Polls must remain open one hour after discussion. Discussion of other business can continue during that time.

Stella Herpel moved to amend and seconded by John Balla the wording of the vote to read: After the word Construction to add: "Construction of the Town Hall addition will reflect an amended design, which eliminates the proposed east-facing gable extension, replacing it with an unbroken roofline and paired windows in regular placement." Discussion continued until 8:55PM at which time the voting started. Discussion of other articles continued at this time and at 10:00PM polls were closed for Article 3 and the votes were counted. We need a 2/3 vote for this to pass.

Count Ballot Vote 78 YES 53 NO 1 BLANK 2/3 vote needed was 88 Motion was defeated.

ARTICLE FOUR: Motion was made by Jack Huber and seconded by Caroline Barth to see if the Town will empower the Selectmen to serve as pound keepers, measurers of wood and fence viewers. Motion passed.

ARTICLE FIVE: Motion was made by Jack Huber and seconded by Rob Vogel to see if the Town will vote to appropriate \$20,000.00 as part of the matching grant funds being pursued by the Conservation Commission to purchase the development right on 200 more or less acres of the David Lyle property. If the Conservation Commission's Application regarding this property is not accepted by the grantors by October 1, 2001, the money will not be appropriated by the Town. By Petition. The Selectmen and Budget Committee do not recommend this article. (This Article was tabled until the next meeting at the March 13th, 2001 Town Meeting.) After much deliberation Thomas Esslinger made the motion and Lyman Young seconded to post pone Article 5 indefinitely. Motion passed.

ARTICLE SIX: Motion was made by Linda Christie and seconded by Rob DeValk to see if the Town will vote to authorize the Acworth Planning Board to appoint up to three (3) alternate members to the board as provided by State RSA's 673:6, 673:11 and others. By request of the Planning Board. Motion Passed.

ARTICLE SEVEN: Motion was made by Evelyn Clowes and seconded by Ed Metsack to see if the Town will vote to instruct the Planning Board to develop a Capital Improvements Program as provided by State RSA's 674:1, 674:5 and others. By request of the Planning Board. Motion Passed.

ARTICLE EIGHT: Motion made by Jack Huber and seconded by Ralph Balla to see if the Town will vote to recind the provisions of the Vote of ARTICLE TEN as adopted by the Town of Acworth on March 13th, 2001 which reads as follows: "To see if the Town will vote to deposit 100% of the revenue collected pursuant to RSA 79-A (the land use change tax) in the Conservation Fund in accordance with RSA 36-A:5 III as authorized by RSA-70A:25II." By Petition. The Selectmen and the Budget Committee recommend this article. After discussion Peter Wotowicz made an amendment to the motion which read " to take out the word recind and take out 100% after will vote to deposit and insert "with an annual cap of \$2000.00. Voted on amendment Yes – 80 No – 37. Now we will vote on ARTICLE EIGHT as amended which

By Petition. It was asked for a ballot vote. Ballot Vote Yes 97 No 18

ARTICLE NINE: Motion was made by Ralph Balla and seconded by Caroline Barth to see if the Town will vote to raise and appropriate the sum of \$15,000 (Fifteen Thousand Dollars) to be placed in the existing Capital Reserve Fund (created in 2000) for the purchase of Highway Equipment. The Selectmen and the Budget Committee recommend this Article. Motion Passed.

ARTICLE TEN: Motion was made by Craig Lawler and seconded by George Collins to see if the town will vote to raise and appropriate the sum of \$25,000 (Twenty Five Thousand Dollars) to be placed in the existing Capital Reserve Fund (created in 2001) for the future revaluation of the Town. The Selectmen and the Budget Committee recommend this Article. Motion Passed.

ARTICLE ELEVEN: Motion was made by Ed Metsack and seconded by Bill Symonds to see if the Town will vote to authorize the establishment of a capital reserve fund (Pursuant to RSA Chapter 35) for the future Town Dump closure and to raise an appropriate the sum of \$25,000.00 (Twenty-Five Thousand Dollars) to be placed in this fund and appoint the Selectmen as agents to expend from the fund. The Selectmen and the Budget Committee recommend this Article. Motion Passed.

ARTICLE TWELVE: Motion was Rob DeValk and seconded by John W. Balla to see if the Town will vote to allow the use of road salt and/or comparable materials on Town Highways as necessary and futhermore to raise and appropriate \$3,000.00 (Three Thousand Dollars) for the building and/or equipment necessary to accomplish this purpose. The Selectmen and the Budget Committee recommend this Article. Motion was Defeated.

ARTICLE THIRTEEN: Motion was made by Ralph Balla and seconded by Ed Metsack to see if the Town will authorize the Selectmen to borrow money in anticipation of taxes. Motion Passed.

ARTICLE FOURTEEN: As Article 3 did not pass we will skip over this article.

ARTICLE FIFTEEN: Motion was made by Rob DeValk and seconded by Sam Stephens to see if the Town will vote to authorize \$27,000 (Twenty-Seven Thousand Dollars) to be transferred from the December 31st undesignated Fund Balance (surplus) for the construction of a parking lot for the Town Hall (also to be used by the church), said lot to be located on property belonging to the town and/or the church.Linda Christie made a motion and Diantha Schierloh seconded to pass over since we did not pass Article 3. The amendment passed as was presented.

ARTICLE SIXTEEN: Motion was made by Ralph Balla and seconded by Jack Huber to see if the Town will vote to raise sums of money as may become necessary to defray town charges for the ensuing year and make appropriations of the same as recommended in the Budget by the Budget Committee.

Tom Esslinger made an amendment to the Article and Lyman Young seconded to increase budget by 35,000 (Thirty Five Thousand Dollars) for Architech fees and Engineer Drawings with the bidding process to proceed with Town Hall Addition. Motion was defeated.

Lyman Young made an amendment to the Article and Rob DeValk seconded to add \$25,000 (Twenty Five Thousand Dollars) to be used for Town Hall renovations. Motion was defeated.

John Tuthill made an amendment and June Blake seconded "To see if the Town will vote to authorize \$25,000 (Twenty Five Thousand Dollars) for the purpose of the Town Hall repairs to be transferred from the Dec 31st undesignated Fund Balance (Surplus). Motion Passed. The Budget will now read: \$535,950.00.

ARTICLE SEVENTEEN: John DeMars got up and spoke to the people about Milfoil Issues that they are having over on Crescent Lake.

Sam Stephens got up and Thanked Kathi Bradt for getting the Grant of \$61,000.00 for the Historical Society to buy the Village Store.

John Balla stood up and asked for a sense of the meeting which way to go on the Town Hall.

Evelyn Clowes made a motion and Ralph Balla seconded "To reconsider Article 3 & Article 14 provided in RSA 33:8-a on a date to be set by the Selectmen and Town Offices Committee. A hand count was taken on this motion. YES 46 NO 35 Motion Passed.

Meeting recessed at 11:30PM to count votes of School Ballots first and then Town Ballots.

Meeting was adjourned at 2:00AM to be reconvened when the Selectmen set a date for the next meeting.

SELECTMEN'S REPORT 2002

It is difficult to characterize 2002 in a single phrase or even paragraph, but it's safe to say that it had a little of everything – the defeat of the Town Hall rehabilitation project, personnel turnover in the Highway Department, participation in a petition to the Superior Court regarding the school funding apportionment formula, a substantial increase in taxable property, getting the town finances on computer, the establishment of a new town committee, a commitment to the first step of dump closure, installation of a handicapped ramp for the Town Hall, and even elimination of the men's room at the Town Hall to provide space for the Tax Collector.

The upcoming year will see the continued involvement by the selectmen in a number of the items listed above, plus some new ones:

- 1. Office of Selectmen Function. The illness of longtime and capable servant of the town, Earl Luther, forced the selectmen to examine the town's accounting and bill paying methods. Our conclusion was that we needed to update our methods to make the system more efficient and responsive. With the help of Scott Luther-Houghton, we were able to start the updating process by getting the town finances on computer. As a result, all checks are now computer generated, and we are able to get updated financial records when needed. Educating those involved with town finances as well as integrating the system into the daily activities of the town will continue in '03, along with a general upgrading of administrative services.
- <u>Dump Closure</u>. Recently the selectmen entered into an agreement with the firm of Underwood Engineers of Portsmouth for dump closure design. We expect the design to begin after weather permits appropriate testing and inspection of the site. If the design progresses as expected, it is likely that dump closure will be considered at the '04 Town Meeting.
- 3. <u>Town Hall Rehabilitation and Office Expansion</u>. The rehabilitation work done in '02, was a small step toward upgrading and rehabilitating our Town Hall, but did little to relieve the need for additional office space. The fact that nothing is being proposed on the '03 warrant to correct these problems does not reflect a change in the town's needs.
- 4. <u>Cemetery Trustees.</u> Recognition of the need for oversight of the maintenance and planning for cemetery needs resulted in the establishment of the Cemetery Trustee committee. This function was also needed to oversee the utilization of cemetery trust fund earnings. <u>Note:</u> Please support the warrant article that would encourage a more flexible use of perpetual care earnings.
- 5. <u>Purchase of a New Loader/Backhoe</u>. The selectmen are recommending the purchase of a new loader/backhoe this year while the old one still has some trade-in value. The town currently has \$45,000 in a capital reserve fund for this purpose. We recommend raising the remainder of the purchase price, about \$25,000, through taxes.
- 6. <u>School Funding Petition</u>. Along with the towns of Langdon, and Alstead, we have petitioned the Sullivan County Superior Court to find the school district taxation apportionment formula illegal. In addition to its questionable legality, the formula is extremely complex, and results in both the operating and capital expenses of each town being "unfunded mandates", ie., our education bill will be decided by those who don't help pay it. We expect a decision by the court during the second quarter of '03.
- Paving Cold Pond Road. The selectmen are proposing the establishment and initial funding of a capital reserve fund for the purpose of paving Cold Pond Road. As a major roadway for traveling into and from town, as well as the connecting route to a major area of town, we feel that it should be paved.

- Election of the Road Agent. The selectmen do not support such a proposal. If elected, the Road Agent would <u>not</u> be answerable to the selectmen and could <u>not</u> be removed for poor performance. Additionally, we do not feel that the Road Agent position should be limited <u>only</u> to citizens of Acworth. We should have the best candidate available, regardless where domiciled.
- 9. <u>Conservation Trusts for Town Lands.</u> The selectmen feel that the town should control town land. The selectmen do not support the creation of a conservation trust for town lands.

We hope that you will attend the town meeting this year and express your views on the various topics to be discussed.

PLANNING BOARD 2002 REPORT

The planning board scheduled 12 meetings during 2002. There were continuing efforts to update town ordinances and regulations and to improve communications with other town boards and committees. No major subdivisions were submitted or acted upon but there were numerous minor subdivisions considered.

Revision of Acworth's Subdivision Regulations has continued but there is still much work to do. The Telecommunications Facilities Ordinance was finished and is being submitted to the town meeting for approval. Acworth's Non-residential Site Review Regulations have been modified and approved by the Planning Board. The PB has asked the selectmen to modify the building permit application to allow distinguishing between residential and non-residential applications. The regulations require submission of nonresidential applications to the PB for review, a hearing and decision on how it meets the objectives of the ordinance.

The town granted the PB the ability to appoint 3 alternate members to the board. As yet, no appointments have been made. We are seeking applicants.

The Upper Valley Lake Sunapee Regional Planning Commission (UVSRPC), of which Acworth is a member and has two appointed commissioners, has continued to assist us with advise and assistance. They reviewed our subdivision regulations and have made suggestions for their improvement. They are also assisting us in completing a revised Acworth Master Plan as required by the state. If funding is available UVSPPC will help us develop a new set of maps and updated census information for inclusion in the Master Plan.

A PB subcommittee has been working on the revision of the Master Plan. If all goes well, a completely revised plan Master will be approved by the PB and made available for distribution in the Fall of 2003. The Master Plan is required for the guidance of the Planning Board in developing and maintaining zoning ordinances and subdivision regulations. It also is a way for the citizens of Acworth to express their feeling and ideas about how Acworth should plan for the future.

A number of issues confront the PB. Among those are the planned establishment of a Quarry at Osgood Ledge, a need the clarify the use of class 6 roads, the revision of Zoning Regulations to deal with road frontage, multiple dwellings on one site, and the development of a Capital Improvements Program.

ACWORTH POLICE DEPARTMENT 2002 TOWN REPORT

2002 saw the department answering 1588 calls. This was down from 2001. The department received over 258 incoming phone calls, made over 1006 out going telephone calls, and received over 376 pages for the year 2002. The department recovered \$250.00 in dog fines, \$29.50 in civil fees, and \$156.00 in bad checks for the town totaling \$435.50. Over 2,245 hours were put into the department for 2002.

I am still working on a contract for a cell phone for the cruiser. The prices are too high at this time. The new astro radio will be programed for digital service this year. We will still maintain an analog program for backup in the event the new digital system goes down. The lap top computer will be installed in the cruiser and I hope to have it in service for 2003 niber reporting. The cruiser will go into the shop in February for a complete under carriage inspection of the brakes, rotors, drums, springs, shocks, struts, and steering. Anything defective will be replaced.

The new dispatch system with the Charlestown Police Department appears to be working out well. There were a few bugs that needed to be worked out at first, but everything seems to be moving along quite well at the time of this writing. The State is in the process of preparing the maps and assigning numbers for the 911 system. Hopefully this will go into effect this summer. This will make finding a residence much easier for the emergency responder.

I would like to thank all the residents for their help and support during the past year and look forward to working with you in the coming year.

There were several incidents this past year where persons waited before calling the police after hearing noises etc. Please if you hear anything out of the ordinary do not hesitate to contact the Police Department. Arriving several hours after the crime has been committed, the department looses a lot of the evidence. I would rather have you call, and have an officer show up and find nothing wrong than to arrive hours late and not be able to gather any evidence or prints.

ACWORTH VOLUNTEER FIRE AND RESCUE CO., INC. 2002 REPORT

Company responses for the year were: Medical Emergency - 29; Emergency Assistance - 9; Motor Vehicle Accident - 9: Mutual Aid Assistance - 7; Fire Emergency - 2; Forest Fire Assistance - 2; False Alarm - 2; Total Responses - 60. This year the responses continued the pattern of increase, with the total more than 258 greater than last year. As before, we continue our efforts to provide the services needed as well as is possible within the framework of our resources.

Drill details have increased with the implementation of a regular schedule of drills held on 2nd and 4th Sundays each month. Under the direction of training officer Joseph Holmes, members have had the opportunity to participate with "hands on" training in situations such as vehicle extrication, effective use of pumps and hoses, and external fire fighting techniques. In September a joint drill involving a mutual aid exercise was conducted by the Company in conjunction with surrounding departments.

Additional storage area has been created. Its purpose is to provide space for tools and equipment which are for seasonal use as well as those being serviced or repaired. By clearing the area at the rear of the main bays, we obtain additional drill or meeting space. We were fortunate to acquire a quantity of used 4 inch hose through the generosity of other departments. Donated funds enabled the purchase of fittings needed to adapt the hose to our equipment. We have tested and placed in service 1200 feet of this hose on our M-1 pumper.

At this writing, we have accepted, with regret, the resignation of June Blake as Assistant Chief. June has served the Company long and well as an EMT in addition to her duties as officer. It is also with regret that we note the passing of John David Lyle, a Company member since 1969.

We want to thank those who have so generously contributed to the company during this year. As mentioned, we strive to do as well as possible with our resources, and your efforts provide us with both moral and financial support. Most especially, we wish to thank those wonderful women of Acworth who made possible the calendar project for the benefit of the Village Store and the Company. Please now your efforts are much appreciated.

In our request for funding for 2003, we are asking for an increase of \$10,000 annually for the next 5 years. Both our pumper and tanker are 30 years old, and we believe it prudent to replace them at this time. It is our intent to purchase a combination pumper/tanker in order to continue to be able to assist in mutual aid responses with tanker capacity while maintaining Class A pumping ability. A review of the market indicates that a unit meeting these requirements will very probably cost in the vicinity of \$150,000. Any cost over the amount requested will be met by the Company from funds raised by other means. We hope the Town will look favorably at our request and thereby enable us to proceed with this worthwhile project.

Meetings are held 2nd Thursday of the month at the fire station. The station is manned each Sunday around 10:00 am for radio check, and drills are held 2nd and 4th Sundays at 10:00 am. Prospective members are welcome to attend any of these activities.

ROAD AGENT 2002 REPORT

Luckily, Mother Nature eased into the area this past year and roads held up well without much mud. In spite of crew changes, we managed to grade all the roads at least once and sometimes twice.

Gravel was applied to H. Putnam Road, Grove Road, Cold Pond Road, Henio Road, Parson's Road, Clarks Road, Black North Road, Quaker City side, and Grout Hill Road. Ditching and paving was done on Beryl Mt. Road as well as around the school and we hope to complete it next year. All the roads on the main line were mowed and brush was cut along East Acworth, Beryl Mt. Road, and Grout Hill road.

Crew changes this year saw John Lyman leave us. I hated to see him go as he was a good worker. Wayne Ring returned but only stayed a short time. Matt Balla was hired but quit after only a few weeks. Presently we have hired Prescott Trafton and he is working out well. Bob Phinney is the third crew member and has been with us for some time.

This coming year we will have to consider replacing the backhoe loader as it has over 8,000 hours on it and has been breaking down more and more, affecting the completion of necessary work. Funds have been set aside for equipment replacement and I would recommend that this is the time to update this piece of equipment while it still has trade in value.

I would like to thank residents for their continued cooperation and patience with snow removal and road repairs through the year. All in all, it has been a productive year along our Acworth roadways.

LIBRARY REPORT 2002

In December 2002, after years of planning and budgeting, the new NHU-PAC (New Hampshire Union Public Automated Catalog) went on-line. This has speeded up the time needed for cataloging and sending records of our holdings to the New Hampshire State Library and has streamlined the interlibrary loan process. Often it is less than a week from a request made to book in patron's hand. In 2002, we filled 37 requests from other libraries for materials in our collection and we had 50 requests from our patrons for interlibrary loans filled by other libraries.

In 2002 we had 1,748 patron visits in which 3083 books, videos, audios and magazines were borrowed and we had 37 visits by Acworth School children. We added 77 items that were gifts and 305 items were purchased bringing the total number of items in the collection to 7,426. We had two special programs for our youngsters and 36 story times. Two open houses, one in July and one in December, were held to welcome Acworth residents and acquaint them with what their library has to offer.

We again participated in the statewide summer reading program. We kicked off our story hours with a fascinating program on New Hampshire and Vermont butterflies presented by Jerry Schneider of Hardwick, VT. A December program on books and the joy of reading was held at the Acworth School. This came to us as part of the CLiF grant received in August and, also as part of the grant, we have been awarded a children's book author/illustrator visit scheduled for the spring.

Inventory of the library collection is winding down. Our aim is to have it complete and an accurate count of the collection before the report to the New Hampshire State Library is due on March 3rd. As one project wraps up another begins. The photographs in the collection are in the process of being sorted and cataloged with an eye to digitizing them and making them available to our patrons. This will be a giant step forward in the conservation of an extremely valuable historic resource.

2003 will be a busy year. The computers from the Gates Foundation grant should be here and up and running by the end of March. I hope you will all stop by the library and get "connected".

ACWORTH SILSBY LIBRARY TRUSTEES REPORT 2002

This year has brought improvement to the library in several areas. Our Librarian, Holly Shaw, has worked with Assistant Librarian Barbara Clark and much appreciated volunteer. Janet Albright and Ella Brown, to continue inventorying the entire collection. This is a necessary if unexciting task, to keep the library collection manageable and accessible, and has been long overdue. The cost of this effort has been supported in part by funds from the Jeffery Trust.

Part of Holly's work is to update library resources. This year, with the help of Ann Hoey of the NH State Library, she reviewed all of the children's books, and then obtained a grant from the Childrens' Literacy Foundation (CliF) of Hanover, which provided \$1,300 of children's books, chosen by Holly. The presentation of these books was made official at a reading and storytelling event at the Acworth Primary School.

In spring of 2003 the Library will provide first class access to the Internet. Holly applied for a grant from the Gates Foundation for computer equipment and software for internet connection and other use by library users. Although initially rejected, her diligence resulted in a grant of \$8,200 to be used for this purpose. In January Holly attends a training session by the Gates Foundation.

We continued to have a very successful book sale on Old Home Day. Please note for next year we encourage donations of books that can be sold for the Library.

Nancy Miller briefly served as a Trustee, and is now succeeded by Melinda Loiselle, who brings with her extensive computer knowledge.

The Friends of the Library have been very helpful with donations for rugs and repointing the stone front steps. In December, the Friends discovered diaries of Millie Moody Marsh or sale on an eBay auction. They collected donations to purchase these remarkable diaries, and donated them to the Library, where they are currently on display.

In the Fall of 2002, the Library has begun, in cooperation with the Historical Society, a major effort to catalog, preserve and digitize the Library's wonderful collection of old photographs. Holly has obtained guidance from professional archivists in the state, to know best how to do this. The first results of this effort are shown in the South Acworth Store, pictures scanned and printed by Gail Wilson. Our intention is to have much of this collection stored on CD, where it can be easily accessible. We would like to ask either the loan or donation of other old pictures from anyone in the community, to be added to this CD collection.




Have you had your well tested recently?

SOLID WASTE 2002 REPORT

The NH/VT Solid Waste Project reports Acworth sent 330 tons of residential waste to be burned at the Wheelabrator Claremont Company's incinerator in 2002, or about 790 lbs. per person based on an estimated population of 835. This is an increase of about 30 tons from 2001, a ten percent increase.

The NH and VT waste districts' ash landfill in Newport, NH, was capped and closed during 2001-2002. Incinerator ash is currently trucked from Claremont to Shrewsbury, MA, for disposal in a landfill operated by a subsidiary of Wheelabrator's parent company.

Acworth paid just under \$110/ton or \$35,809 in direct costs for compactor and container rental, trucking and disposal of residential waste, \$27,141 of this covered the NH/VT Solid Waste Project tipping fee.

Total operating expenses at the transfer station in calendar year 2002 were reported to the budget committee at \$60,522 and include;

- the rental of one open top container, hauling and off-site disposal of construction and demolition debris: \$10,857
- wages and payroll tax: \$7,505
- the fifth of fifteen annual payments to the Sullivan County Regional Refuse Disposal District under the terms of a 1998 court settlement: \$4,000
- miscellaneous expenses of \$2,350 for utilities, repairs, scrap metal removal and managing a small volume of freon, fluorescent tubes and other hazardous items sent to the hazardous waste collection center in Keene.

The volume of construction and demolition debris and recycled materials handled at the transfer station has increased. The amount of Acworth's residential waste going to the incinerator has also increased significantly after remaining relatively constant for several years. Acworth needs to focus on reducing the amount of waste destined for disposal and to manage the transfer station responsibly in order to limit long term liabilities and to better protect air and water quality in the town and in the region.

RECYCLING INFORMATION 2002

Scrap metal is collected at the transfer station and shipped for processing. In late 2001 changes in the scrap market resulted in the town having to pay for metal removal. During 2002 the town began stockpiling metal at the transfer station for periodic removal in larger volumes.

Aluminum cans are collected at the transfer station and shipped for recycling.

Glass is collected, crushed and stored on site for future use.

Estimated amounts of marketable material shipped form Acworth for processing and recycling in 2002 (rounded to the nearest ton):

Tin cans: 3 tons.

Corrugated cardboard: 9 tons.

Newspaper: 7 tons, down from 11 tons in 2001. Some newspaper was diverted for animal bedding in 2002.

Magazines: 5 tons, down from 8 tons in 2001

Total: 24 tons, excluding glass, aluminum and scrap metal.

Avoided cost of disposal: 24 tons at \$110/ton; approximately \$2,600.

The Road Agent and Highway Department personnel provided assistance at the transfer station throughout the year. Hank Carr is the station attendant. Their work and dedication is appreciated as is the continued support and help provided by Acworth's recyclers.

The 20 year disposal contract between the Sullivan County Regional Refuse Disposal District and Wheelabrator expiries in four years. Acworth needs to address long range plans for waste management beyond 2007. Waste reduction and recycling will lessen dependence on off site disposal and can reduce future costs while protecting environmental resources.

Pursuant to statutory mandate, the Selectmen appointed Hanford Auten, Ruth Balla and Jane Esslinger as cemetery trustees this fall. These are positions that have not been filled for several decades. The trustees have met on numerous occasions since that time in an effort to review existing practices and procedures of the Cemetery Association, the sexton, the Trustees of the Trust Funds and the Town. Additionally, the trustees are instituting plans for the safeguarding of records, the expenditure of town and Trust Fund moneys for cemetery purposes and the formalization of the relationship between the Town and the Cemetery Association. The three current appointees have placed their names on the March ballot in anticipation of being able to complete the work that they have initiated.
