Partnership For Academic Clinical Telepractice – Advanced Nursing Education Workforce

PACT-ANEW addresses key needs in our state, such as behavioral health issues, the opioid crisis, and workforce needs for underserved and rural populations through:

- Training for preceptors involved in the Project ECHO program on value-based reimbursement, behavioral health, substance use disorder, telepractice, and more.
- Traineeship/tuition reimbursement funds for primary care nurse practitioner (NP) students providing care to rural and underserved populations.

Providing Project Evaluation and Technical Assistance to NH's COVID-19 Rapid Response Program



IHPP worked with NH DHHS as part of the NH Rapid Response program which was funded by SAMHSA. NH DHHS and community mental health centers were provided funding in response to the COVID-19 pandemic and its impact on members of the health care community and other people with mental health and substance use conditions.






Claims Data in Action

In late September, IHPP released the [NH Claims Report Suite](#). This suite provides a set of healthcare claims-based reports of utilization and cost, with the ability to subset on geographic area and sub-populations. Reports include measures of type of service, specific diseases and conditions, and prescribing of medications. Using available age brackets, data can be customized for different age groups.

Rx per 1,000 for the Top 10 Drug Classes by Total Member Months for the Current Period




As an example, the pharmacy reports include analysis of the most common drug classes. Focusing on the commercially insured population ages 0-18, the most common drug class for the period from July 1, 2018 – June 30, 2019, can be seen above.

The Community Response to Medicaid Work and Community Engagement Requirements: Lessons from New Hampshire

UNH's Institute for Health Policy and Practice (IHPP) and Franklin Pierce School of Law conducted a study, funded by the Robert Wood Johnson Foundation (grant #76038), assessing New Hampshire's Medicaid Work and Community Engagement Requirements and their impact on the state's community providers.

When the Work and Community Engagement Requirements were first implemented in 2019, they were costly for many community health organizations and confusing for beneficiaries, according to the research report, "[The Community Response to Medicaid Work and Community Engagement Requirements: Lessons from New Hampshire.](#)" The Requirements were suspended in July 2019. Ultimately, the US Supreme Court confirmed that the Requirements were illegal in *Philbrick v. Azar*.





The Shifting Health Care Landscape

In June 2020, IHPP hosted a 2-day virtual session to better understand the consumer experience and the State's response to the COVID-19 pandemic. On **Day 1**, we heard from **Lynn Quincy**, Director of the Healthcare Value Hub at Altarum, and **Trish Riley**, Executive Director of the National Academy for State Health Policy (NASHP). On **Day 2** we hosted a facilitated discussion with key stakeholders from New Hampshire's Health Care system.




Biggest Challenges for New Hampshire




Biggest Challenges for Patients in NH

The Guide was updated and enhanced to reflect consumer feedback and changes in law and practice. It now includes information about New Hampshire's three Medicaid Managed Care Organizations, the Doorways, and other resources for both substance use and mental health, as well as a more detailed section intended to assist providers in helping their clients and patients. Providers can use the Guide for instructions on how to assist patients in getting the health insurance and treatment they need.


Addressing the Needs in the Hardest Hit Population



IHPP's Long Term Care and Aging focus area pivoted work in 2020 to address the needs of the hardest-hit population during the COVID-19 pandemic. Working closely with our federal and state partners, we provided expertise and support as the pandemic severely impacted older adults.

Using data to address emerging and urgent needs and respond to the changing COVID landscape.

In partnership with the UMass Boston Healthy Aging Data Report team, data maps were provided to NH DHHS Bureau of Elderly and Adult Services and the ServiceLink Aging and Disability Resource Centers to identify areas in New Hampshire in which there may be an increased risk or burden to older adults during the pandemic.



Facilitating state-wide conversations regarding providing direct care during a pandemic.

Through our shared work with the Institute on Disability in providing backbone support to the [NH Alliance for Healthy Aging](#), we led virtual conversations on the issues faced by direct care workforce during the COVID-19 pandemic.

Supporting Community Partners

Provided an online learning collaborative venue for Person-Centered Options Counselors at the beginning of the pandemic as a mechanism to share best practices for providing person-centered approaches in virtual settings.

Converted our in-person Person-Centered Options Counseling training to an online format as part of our ongoing support of ServiceLink Aging and Disability Center Network.

Assisted NH DHHS Bureau of Elderly and Adult Services in conducting a Rapid Assessment for the distribution of CARES Act Aging and Disability Resource Center funding and supported New Hampshire communities in utilizing the funds.

Healthy UNH partnered with researchers from the Department of Recreation Management and Policy and the UNH Office of Woodlands and Natural Areas in 2020 to assess the effects of recreation use levels on the overall outdoor recreation experience in [College Woods](#). Among other things, this study serves to understand visitor motivations, satisfaction, health outcomes, and preferences toward signage and management actions. Study data will be used to inform future management actions to provide the highest-quality outdoor recreation experiences possible within College Woods. 
Maternal & Child Health Epidemiology 2020-2021



What a year to be an epidemiologist!

Since 2003, IHPP has contracted with the NH Division of Public Health Services to staff the role of the State Maternal and Child Health Epidemiologist with **David Laflamme, PhD, MPH**. A few of Dr. Laflamme's activities within this role are highlighted below:

- Working with the State Registrar of Vital Records to add temporary COVID-related questions to birth and death certificates.
- Building Tableau dashboards to monitor deaths and births with COVID involvement, which are still in use daily at NH DHHS.
- Releasing an update to the [Labor and Delivery closure map](#) when another NH birth hospital closed their birth unit. This map effectively shows the pattern of closures across the center of the state and up the Connecticut River Valley.

Nursing Home ECHO

In response to COVID-19, UNH, JSI, and Dartmouth-Hitchcock teamed up to deliver real-time learning and support to nursing homes across NH, VT, and ME using the Project ECHO[®] model.

- Local, regional and national experts interacted weekly with nursing home participants
- Participants developed a sense of community, purpose, and expanded professional relationships
