TOWN WARRANT.

The State of New Hampshire.

To the inhabitants of the Town of Freedom, in the County of Carroll in said State, qualified to vote in town affairs:

You are hereby notified to meet at Town Hall, in said Freedom, on Tuesday, the thirteenth (13) day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary town officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation of the same.

3. To see what sum of money the town will vote to raise for cutting bushes.

4. To see what sum of money the town will vote to raise for the use of hydrants.

5. To see what sum of money the town will vote to raise for street lighting.

6. To see if the town will vote to buy a light road machine and appropriate money for the same.

7. To see what sum of money the town will vote to raise for the extermination of the white pine blister.

8. To see what sum of money the town will vote to raise for the support of Old Home Week.

9. To see what action the town will take in regard to installing a new moving picture booth to meet the requirements of the underwriters.

10. To see what sum of money the town will vote to raise to apply on the town debt. 11. To see if the town will vote to raise money to repair the roof of the roller house.

12. To see if the town will vote to except State Aid for the construction of roads and appropriate money for the same.

13. To see what sum of money the town will vote to raise for the maintenance of State roads.

14. To see what sum of money the town will vote to raise for summer highways.

15. To see what sum of money the town will vote to raise for breaking winter roads.

16. To see what sum of money the town will vote to raise for decorating soldiers' graves.

17. To see what sum of money the town will vote to raise for the public library in addition to the amount required by law.

18. To see what action the town will take about grading around the town hall.

19. To bring in your ballot upon the question as whether the amendment proposed by the convention to revise the constitution shall be approved.

SUPERINTENDENT'S REPORT.

To the School Board of Freedom:

It is seldom that a year passes in Freedom without some epidemic making a serious inroad upon school attendance. This year has been no exception to the rule; on the contrary the whooping-cough epidemic that occurred during the fall term of 1923 was widespread, and by the nature of the disease the isolation of the children was for a long period. In addition to the whooping cough there were scattered cases of measles, and at the beginning of the present term the enforcement of the vaccination law has produced intermittent attendance for a period.

It is generally unwise to close schools when the socalled children's diseases visit a community. The State Board of Health advises strongly against it. Under any conditions these diseases rarely subside for a period of weeks, and experience has shown that keeping the schools closed does not materially lessen the prevalence of the sickness.

Nevertheless by the poor attendance, our teachers have been placed under a tremendous handicap in their efforts. The results for the year cannot possibly reach as high standards as we had hoped to attain. It also means that parents have an added responsibility to see that their children attend school regularly-every session that the child's physical condition permits it-from now on.

No graduation took place at Freedom last year. In June of the present year there will doubtless be a moderately large group to receive diplomas, as the eighth grade enrolls twelve pupils. A number of these pupils plan to attend high school, which will mean a substantial increase in the number of pupils enrolled in high schools from this district next year. A list of the present high school enrollment is appended to this report. When we consider the special effort that the Freedom boys and girls must make to get this education, much credit is due them, and also the parents for their interest in the matter.

Occasionally one hears it said, usually among the older generation, that the schools of today are not as efficient in the fundamental studies as those of years ago. Your superintendent has had the opportunity, in connection with a certain State requirement, to test out the truth of this assertion with respect to Freedom eighth grade pupils. The studies used were arithmetic and spelling. In 1846 examinations were given in these subjects at Springfield, Mass., to test out ninth-grade pupils of the average age of fifteen years and six months. These tests were again given to ninth-grade pupils at Springfield in 1905. The scores in arithmetic averaged $29\frac{1}{2}\%$ in 1846 and $65\frac{1}{2}\%$ in 1905; in spelling the scores were $40\frac{1}{2}\%$ in 1846 and 51% if 1905.

In November of the present school year these two tests were given to the Freedom eighth-grade pupils of an average age of fourteen years. The arithmetic test was the same in every particular as the old Springfield examination. The spelling test was somewhat revised to meet the needs of modern vocabularies, but the words used were of the same degree of difficulty as those used at Springfield. The scores of the Freedom pupils in both examinations averaged over 80%, rating much higher than those secured by ninth-grade pupils at Springfield, Mass., either in 1846 or 1905. The results of these tests will serve to assure you that when the program of studies for our elementary schools has been enlarged and enriched, it has not been done at the expense of the fundamentals.

During the present year a slight addition to the school equipment has been made, by the purchase of a teacher's desk chair for the lower room and six folding chairs for the general use of both rooms. In a previous report I have suggested the need of a set of wall maps for the use of the higher grades, and I wish to re-iterate the suggestion. Mr. Bennett has tried to supply this want by make-shift arrangements. The need still exists, however, and money used for this purpose would be wisely expended.

It is very gratifying to know that Freedom has once more been granted her full apportionment of State Aid money for school expenditures. Last year and the year previous the total amount received was respectively \$385.63 and \$505.72. This year the school treasurer has received a State check for \$1,207.39.

In closing, let me thank the members of the Freedom Woman's Club for their generous contribution of hot cocoa to the lunches of the children who must remain at the schoolhouse during the noon period. I also appreciate the hearty co-operation of the teachers in this matter. This hot, nourishing drink makes a very material difference in the quality of the work of the children in the afternoon session.
