WARRANT FOR ANNUAL TOWN MEETING.

STATE OF NEW HAMPSHIRE.

*To the Inhabitants of the Town of Wolfeboro,
Qualified to Vote in Town Affairs:*

You are hereby notified to meet in Brewster Memorial Hall, in said Town, on the second Tuesday of March next, at nine o'clock in the forenoon to act upon the following subjects:

ARTICLE I. To see what action the town will take relative to adopting an act of the State Legislature of 1899, known as the Pillsbury Highway Bill, enabling towns to return to the District System in the management of their Highways.

ART. 2. To choose a Town Clerk for the ensuing year.

ART. 3. To choose three Selectmen for the ensuing year.

ART. 4. To choose one or more, not exceeding three Road Agents, in case the Pillsbury Highway Bill is not adopted.

ART. 5. To choose a Superintendent of its Water Works for the ensuing three years, and fix the salary for the same.

ART. 6. To choose two Auditors for the ensuing year.

ART. 7. To choose a Fish and Game Warden for the ensuing year.

ART. 8. To choose a Collector of Taxes, Treasurer, and all other necessary town officers for the ensuing year.

ART. 9. To see what sum of money the town will vote to raise to defray town expenses.

ART. 10. To see what sum of money the town will vote to raise to pay on its indebtedness.

ART. 11. To see what sum of money the town will vote to raise to pay for breaking roads the past winter.

ART. 12. To see what sum of money the town will vote to raise for the construction of concrete sidewalks.

WARRANT FOR ANNUAL TOWN MEETING.

ART. 13. To see what sum of money the town will vote to raise and pay each fireman legally returned for the year 1899, in addition to that required by law.

ART. 14. To see what sum of money the town will vote to raise and pay to James R. Newell Post No. 61, G. A. R., of this town, to assist in defraying the expenses of Memorial Day, May 30, 1899.

ART. 15. To see if the town will vote to refund that part of the town indebtedness known as the "Water Bonds," by the issue of Bonds to be redeemable after ten years and payable in twenty years at a rate of interest not to exceed three and one-half per cent. per annum.

ART. 16. To see what action the town will take relative to adopting the provisions of Chapter 8 of the Public Statutes providing for the establishing and maintaining of Free Public Libraries and the amendments to the said statute, and to raise money to carry out the same.

ART. 17. To see if the town will vote to extend its water system from the residence of John Smith to the Mark Fernald Place, so-called, and raise money to pay for same.

ART. 18. To see if the town will vote to raise the sum of sixty-five dollars to purchase a snow plow to break out the sidewalks.

ART. 19. To transact any other business that may legally come before said meeting.

GENTLEMEN :

The past year has been a busy one for your town officers, much more than the usual routine work having been accomplished.

In the early spring the town was sued for two thousand dollars by Samuel A. Meader, who claimed constant damage from the leakage of our reservoir. After some negotiations a settlement was effected by the town making certain repairs, and paying Mr. Meader one hundred dollars, in consideration of which the suit was withdrawn and an agreement entered into which should protect the town from similar suits in future.

In May, petitions were received urging the laying out of Sewell Street and a connecting link between the two streets running off Bay Street. No opposition whatever being developed at the public hearing they were laid out and constructed.

Mr. Horn has rebuilt the Twombly Bridge, so called, at an expense of nearly \$500, all the bills for which were paid by him from his regular highway allowance excepting a balance of \$89.20, which was authorized by the Selectmen. This bridge was an expensive one to maintain in wood, being a 20-foot span, and as the abutments were considered unsafe it was deemed best to replace it with a new stone structure.)

Mr. Deland, in addition to his regular road work, had a special appropriation of \$500 for the purpose of draining a section of road in the Brewster neighborhood. 1300 feet of 4-inch drain-tile were laid and the trench filled with small rocks and sand, which is confidently expected to make this part of South Main Street passable when the frost leaves the ground in the spring. Although the cost of this job slightly exceeded the appropriation, Mr. Deland claims that the clay carted to other parts of his district has benefited those localities enough to balance the extra cost.

Mr. Hobbs has drained the hill on North Main Street and blown out the boulders from streets and gutters over his district which will prove a permanent benefit to that portion of the roads in future.

The poor bills have been unavoidably increased, more applications for aid having been received by your Overseers than in any recent year.

SELECTMEN'S REPORT.

Liberal appropriations make many improvements possible, nevertheless, gentlemen, we would recommend a degree of conservatism in your appropriations for the present year as experience has shown that a high tax rate is burdensome and in many instances difficult of collection.

REPORT OF HEALTH OFFICER.

TO THE SELECTMEN OF WOLFEBORO :

During the year two cases of measles, two of typhoid fever, two of diphtheria and four of scarlet fever have been reported to the board, none of which were fatal.

I am of the opinion that the use of antitoxin as a remedy for diphtheria is fully established. Since its discovery and general use the death rate in "Germany has decreased from 49 to 2.5. In one immediate district of fifty-four cases not a life was lost." Of the above contagious diseases in this town not one of them could be traced to or from any other. If the places are properly disinfected, the contagion can be stamped out. The science of medicine, the skill in surgery and the better knowledge of sanitation are making rapid strides to revolutionize the world in the treatment of diseases.

"Dr. Carl Schletter of Switzerland has successfully removed the entire stomach from a woman and she gained thirteen pounds in a few weeks after the operation. Again on February 14, 1898, Dr. Charles B. Brigham of San Francisco performed a like operation satisfactory and his patient gained in weight six pounds in as many weeks."

Forty-five deaths have been reported during the year as follows:—

Less than one year old, 5.

From 1 to 10 years of age, 2 From 50 to 60 years of age, 5

From 10 to 20 years of age, 1 From 60 to 70 years of age, 8

From 20 to 30 years of age, 1 From 70 to 80 years of age, 7

From 30 to 40 years of age, 0 From 80 to 90 years of age, 9

From 40 to 50 years of age, 4 From 90 to 100 years of age, 2

The average age of those above one year is 66 years, 6 months and 9 days, which speaks well for our physicians, our water supply and sanitary condition of the town.

I have reported monthly to the State Board of Health and at the close of the year 1898 to the Supervising General at Washington the statistics wanted. I attended the Annual State Convention at Manchester in June and listened to very able addresses by Prof. Smith, of Dartmouth College, Dr. Irving A. Watson, of Concord, Hon. John C. Bickford, of Manchester. His address was on the legal points involved

in the duties of local boards of health and the other two members of the board of health of Manchester gave very instructive addresses, together with some others.

I earnestly recommend that every family in town subscribe and pay one dollar a year for the New Hampshire Sanitary Journal, the official organ of the New Hampshire State Board of Health and the association of local Board of Health.
