TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Newton, qualified to Vote in Town Affairs:

You are hereby notified to meet at the Town Hall, in said town, on the second Tuesday of March next, at nine o'clock in the forenoon, to act upon the following subjects:

1. To choose a Town Clerk, three Selectmen, Town Treasurer, Tax Collector, Auditors, Road Commissioners, Trustees of Public Library, one Trustee of Trust Funds for three years, one Cemetery Trustee for three years, Constables, Measurers of Wood and Bark and Surveyors of Lumber, Fence Viewers, and all other necessary town officers and agents for the ensuing year.
2. To raise such sums of money as may be necessary for paying the town debts and defraying the interest thereon, for the support and maintenance of the Public Library, and for other necessary charges arising in said town.
3. To see if the town will vote to raise and appropriate \$25 for Memorial Day purposes.
4. To hear the reports of the Town Treasurer and Board of Selectmen to the Town Auditors, the reports of the Auditors, Agents, Committees, or other officers heretofore chosen or appointed, and to pass any vote relating thereto.
5. To see if the town will vote to authorize the Selectmen to hire money in anticipation of taxes.
6. To see if the town will vote to raise and appropriate a sum not exceeding \$400.00 to complete the contract for street lighting with the Exeter & Hampton Electric Co.
7. To see if the town will vote to renew the contract with the Exeter & Hampton Electric Co. for street lighting and to raise and appropriate money for the same.

8. To see if the town will vote to accept by gift the Willow Grove Cemetery at Newton Junction and assume the care of same.

9. To see if the town will vote to observe Old Home Week and appropriate an adequate sum for the purpose.

10. To see if the town will vote to raise and appropriate the sum of \$150.00 for the control of the White Pine Blister Rust.

11. To see if the town will vote to raise \$898.50 for Trunk Line Construction.

12. To see if the town will vote to raise \$335.98 for State Aid Maintenance.

13. To see if the town will vote to raise \$100.00 for improving the Town Cemetery or Cemeteries.

To transact any other business that may legally come before said meeting.

The meeting was called to order and the warrant read by the Moderator, Henry L. Burbeck.

A message from Governor Keyes, also from A. B. Hastings, acting State Forester, John B. Jameson, chairman Public Safety Committee, H. N. Spaulding, chairman State Food Administration and the Liberty Loan committee of New England were read by Rev. Bernard Christopher at the request of the Moderator.

Article 2 was taken up, J. W. Locke moved that the sum of \$500.00 be raised for town charges; Mr. John E. Hayford was called upon to explain the new—or “Budget system,” which he did in a very complete manner, after which Mr. Locke withdrew his motion and on motion of Clarence E. Stafford it was voted to take up and vote on each item separately and the following appropriations were made:

Article 9. On motion of Charles Dart, voted to pass over this article.

Article 10. On motion of John F. Germundson, voted to raise no money for the extermination of moths.

Article 11. On motion of John M. T. Currier, voted to pass over that portion of the article not already acted upon.

Article 12. This article is covered by the "Budget" appropriation already acted upon.

Article 13. This article is covered by the "Budget" appropriation already acted upon.

John F. Germundson offered the following resolution and moved its adoption.

"Resolved, that the Town Clerk be instructed to deliver to the Selectmen a complete record of the entire proceedings of this meeting and all subsequent meetings (to) be printed in the Town Reports."

The resolution was adopted.

At 4.30 P. M. the Moderator closed the polls and in the presence of the Town Clerk, Selectmen, and Election Officers proceeded to count the ballots cast for Delegate to the Constitutional Convention, with the following results:

To Chairmen of School Boards and Superintendents of Schools:

It has been the custom of this department in previous years to notify school boards and superintendents on or about February 1, of the amount of money required by law for schools, and the amount to raise entitling districts to state aid.

There is a bill at the present time before the Committee on Education in the House of Representatives which reorganizes the whole system of raising school money and apportionment of state aid. We therefore suggest that you delay your annual school meeting as late as possible in order to follow the new regulations, if this bill becomes a law. School meetings shall be held between "March 1, and April 20." Any necessary information will be immediately forwarded. If no changes are made we shall send the usual information.

Changes in the personnel of the High School staffs must be reported to the office immediately in order that our registration of high school teachers may be kept up to date.

REPORT OF THE SCHOOL BOARD

To the Citizens of Newton:

The report of the School Board will cover only from Feb. 15, 1918 to Aug. 31, 1918, as a law was passed, changing the scholastic and fiscal year so both should expire at the same date.

The Grammar School was in charge of Miss Hazel Gleason. The work accomplished hardly reached the standard we had hoped for. The pupils in this school are capable of good work under favorable conditions.

The Village Primary School was taught by Miss V. Isabelle Rowell. She is a good thorough teacher. Her pupils who were to enter the Grammar School in September were well qualified, and are a credit for the faithful labor spent on them.

Miss Angelia E. Kelly finished the year at the Junction school with the good success of the preceding four years. She works hard for the advancement of her pupils.

Rowe's Corner School was taught by Miss Mary E. Wilbur, who thoroughly maintained the high standard of the work begun in September, 1917.

We desire again to call the attention of parents to the necessity of regular attendance at every session of school and wish each parent would give the matter thoughtful attention. We ask your co-operation in this matter. When a pupil remains away it is not only an injury to that one but to all in the school.

Possibly all do not realize that the amount of our State Aid depends on the attendance. We feel that habits of regularity formed in childhood go with us all through life.

Therefore we desire to have the children of Newton form habits of punctuality and regular attendance at school.

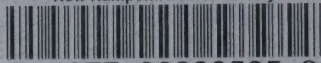
