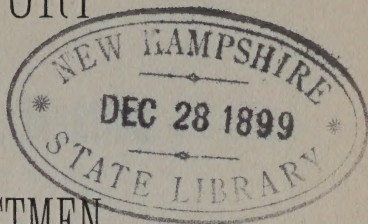

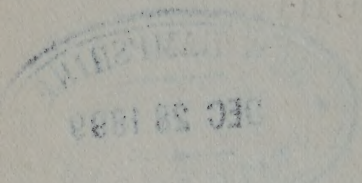



WARRANT FOR ANNUAL MEETING.

THE STATE OF NEW HAMPSHIRE.

 To the inhabitants of the town of Canaan, qualified to vote in town affairs:—
 L. S. } You are hereby notified to meet at the Town House in said town, on the second Tuesday of March next, at ten of the clock in the forenoon, to act upon the following subjects ;

- 1st. To choose a Moderator to preside in said meeting.
- 2d. To choose a Clerk for the ensuing year.
- 3d. To choose three Selectmen for the ensuing year.
- 4th. To choose all necessary town officers and Agents for the year ensuing.
- 5th. To raise such sums of money as may be necessary for the support of schools, for the maintenance of the poor, for laying out and repairing highways and building and repairing bridges, and for other necessary charges arising within the town.
- 6th. To see if the town will vote to abolish the Liquor Agency in said town.
- 7th. To see if the town will vote to let the citizens of Canaan finish and occupy a hall in the upper part of the town house.
- 8th. To see if the town will vote to discontinue the highway leading from near the watering trough below Nathan C. Morgan's, to Enfield line over the hill.
- 9th. To see if the town will vote to re-district the school districts in said town.
- 10th. To see if the town will vote to discontinue the high-

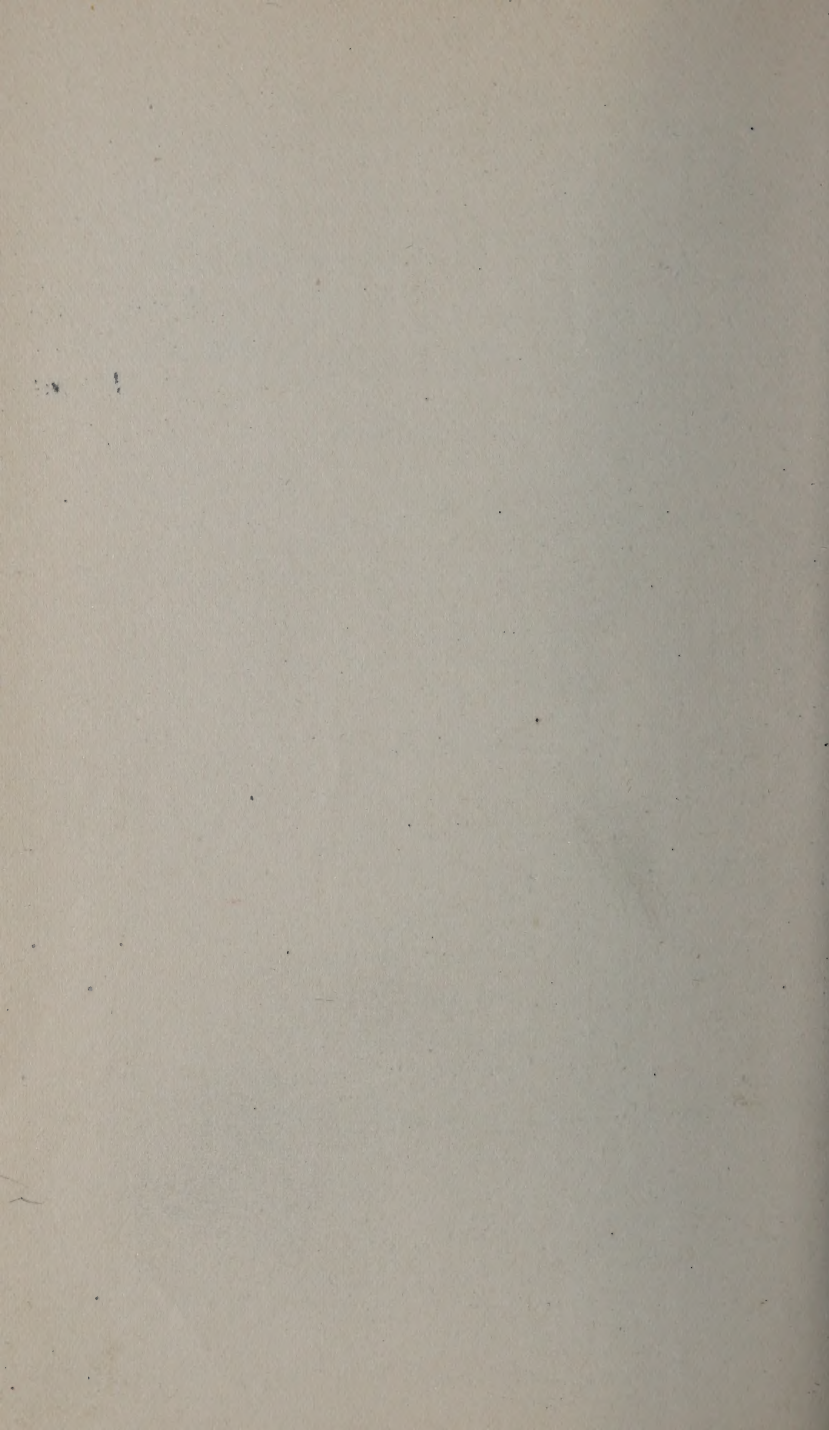
