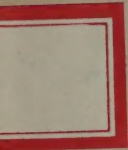

Leaving in my hands, of the money received of the County for the support of Sophrona White, \$7 50. This last item may need explanation, and therefore I would say that my predecessor in office supposed that Sophrona White had a settlement in this town, and for that reason rendered her aid for about eleven weeks. When I assumed the office, I ascertained that she had no settlement in this town, and accordingly turned her over to the County Commissioner. The County paid me \$1 per week from the January term of court, 1874, up to the September term, and from that time they pay us \$1 50 per week, until further agreement. I charge the town for my services in this White case \$7, and for other services as overseer of poor \$15.
