



TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the inhabitants of the town of Lempster, in the County of Sullivan, in said State, qualified to vote in town affairs:

You are hereby notified to meet at Town House East Lempster in said Lempster on Tuesday, the thirteenth (13) day of March next, at ten of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation for the same.
- 3. To see what sum of money the town will Vote to raise for the Maintenance of the Trunk Line Road.
- 4. To see what sum of money the town will Vote to raise for the Maintenance of the State Aid Road.
- 5. To see what sum of money the town will Vote to raise for State Aid construction.
- 6. To see if the town will vote to allow the selectmen to deliver blank inventories at the time they appraise the property for taxation.
- 7. To see what sum of money the town will raise for the prevention of white pine blister rust.
- 8. To see what sum of money the town will raise or appropriate for Old Home day and Memorial day.
- 9. To see what sum of money the town will vote to raise for the Library.
- 10. To see what the town will pay for labor on the Highway.
- 11. To see if the town will vote to reinsure the town hall and Union hall.
 - 12. To see if the town will authorize the selectmen to

borrow money for the town in anticipation of taxes.

- 13. To see if the town will vote to have the common around the soldiers monument at the street moved and raise money therefor.
- 14 To see if the town will instruct the selectmen to dispose of the snow roller now kept at Keyes.
- 15. To see if the town will vote to discontinue the Gulf road so called, leading from the trunk line to Marlow line near the place formerly owned and occupied by Arvin G. Baker, also the branch road leading from the above mentioned road, to the south mountain road, the same being subject to gates and bars.
- 16. To see if the town will discontinue subject to gates and bars, the road leading from Dodge Hollow to Acworth line near the Nathan George farm.
- 17. To see if the town will vote to have the town sheds repaired and raise money therefor.
- 18. To transact any other business that may legally come before said meeting.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

Members of the Lempster School Board:

I, herewith, submit my third report as superintendent of your schools.

At the present time economy is the watchword in all public enterprises. Economy may mean one of two things—the employing of less capital and being satisfied with smaller returns or the more active use of the money invested, thereby insuring increased dividends. That the School Board of Lempster is using its present resources more and more economically is shown by a glance at the following study of the school records during the past five years.

Economical administration means practically no days lost during the school year. It means practically all pupils in school each day. It means practically all pupils present at the beginning of each session. During the past five years the number of school sessions has increased by fourteen and the percent of attendance has remained almost constant at 95. Tardinesses were at their lowest during the past year. This entire record is well above the state average and bespeaks unusual care and interest on the part of the people of Lempster.

A heating system, similar to that of the East Lempster school, has been installed in the Street school this year, resulting in a more even distribution of heat and, we believe, a saving of fuel.

The scholarship of the three schools is being tested by the standardized tests as in former years. This assures us protection from personal opinion which is an uncertain quantity. The fact that two of our teachers have been with us two years and the other three years also promises satisfactory progress. Infrequent changes of teachers, a high per centage of attendance and a full school year are making Lempster a town justly proud of its schools.

I wish again to express my appreciation for the cooperation and advice of the Lempster school board during my period of office.
