To the Inhabitants of the Town of Shelburne, in the
(L. S.) County of Coos, in said State, qualified to vote in Town
Affairs:

You are hereby notified to meet at the Town Hall in said Shelburne on Tuesday, the thirteenth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To hear the reports of Town Officers heretofore chosen and pass any vote relating thereto.
3. To raise such sums of money as may be necessary to defray Town Charges for the ensuing year and make appropriation of the same.
4. To see what sum of money the Town will vote to raise and appropriate for maintenance of Town Highways and Bridges.
5. To see what sum of money the Town will vote to raise and appropriate for State Aid Construction.
6. To see what sum of money the Town will vote to raise and appropriate for the Public Library.
7. To see what sum of money the Town will vote to raise and appropriate for the care of Cemeteries.
8. To see if the Town will authorize the Selectmen to offer discounts on taxes at the rate of 3% for payments by June 1st., 2% by August 1st., and 1% by October 1st.
9. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.
10. To see if the Town will authorize the Selectmen to distribute the inventory blanks when taking inventory.
11. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired by the Town through Tax Collectors deeds.

12. To see whether beer or other lawful alcoholic beverages shall be manufactured or sold locally as permitted under this act.

13. To transact any other business that may legally come before said meeting.

School Superintendent's Report

To the School Board and Citizens of Shelburne:

Your school this year has enrolled 31 pupils with the same teacher in charge as for the previous year. The work of the school has been satisfactory and the pupils have shown by tests and examination that they are progressing at a rate commensurate with their ability and grade.

Last June, four pupils were graduated from the Eighth Grade and all four entered High School in September.

At the present time some real constructive work in Health Supervision of the pupils is being accomplished by the holding of a dental clinic under the Supervision of a school nurse. It would be well if work of this kind could be continued each year.

During the last complete school year, your superintendent made 25 visits of inspection and supervision and the work of the different grades were supervised and checked up with the teacher.

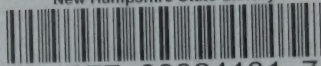
