

#### STATE OF NEW HAMPSHIRE

To the inhabitants of the town of Nelson in the county of Cheshire in said state, qualified to vote in town affairs:

You are hereby notified to meet at town hall in said Nelson on Tuesday the thirteenth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary town officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation for the same.

3. To see what sums of money the town will raise for building and repairing highways and bridges, or take any action relating thereto.

4. To see if the town will vote to accept state aid for road construction.

5. To see if the town will vote to accept state aid for road maintenance.

6. To see what sums of money the town will raise for support of library.

7. To see what sums of money the town will raise for Memorial Day.

8. To see if the town will vote to raise or appropriate money for Old Home Day.

9. To see what sum of money the town will raise for care of cemetery.

10. To elect an agent to enforce the liquor laws.

11. To see if the town will vote to accept in trust the sum of \$50 to be known as the Isaac White Cemetery Trust Fund. The interest of the same to be used to care for the lot as needed.

12. To see if the town will take any action relative to fire protection.

13. To see if the town will vote to give the selectmen the right to borrow money in anticipation of taxes.

14. To transact any other business which may come before meeting.

# REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Nelson:

I submit herein my fifth annual report as superintendent of schools.

A good school gives not only mental training, physical development and righteous morals but also good habits of study, work and living. Indeed, we must continue to place strong emphasis on the oldfashioned word "work."

To enable the pupils in our rural schools to read comprehensively, to spell correctly, to write legibly and clearly and and to talk intelligently is the paramount issue. If these fundamental subjects are thoroughly mastered, mental alertness in numbers and cultural growth in geography, history, civics, etc., will easily follow.

I believe your teachers have had these goals of attainment in mind during the past year. To attain these results, they have used pedagogical methods. When questions of discipline have arisen, careful consideration has been given, prompt and decisive action taken by your teachers. Indeed, we believe in a strict and impartial school govenment, such as a wise judicious and faithful parent would exercises in the family and which will unfold in every child the best qualities and stimulate in him the highest principles and purposes. Schools are created for the pupil and their aim is to educate the young for fitness in life and its realities, and to do this, thorough discipline must be mantained.

Promotions were based on results of following tests:

Ayre's scale in writing and spelling, and Stanford's Achievement test. These were supplemented by tests given by the teachers, superintendent and by a generous consideration of the daily work of the individual pupil throughout the year.

At the Center school, Miss Vera White closed a successful year.

Beginning with September of the present year, Miss May continues her service at Munsonville and Mrs. Hazel Jackson, a teacher of the Center school for seveal years previous to last year, returned to this school for the present year.

At the time of writing, both schools are running smoothly, doing effective work and give promise for a successful year.

In conclusion, I wish to acknowledge the cordial co-operation of teachers, the assistance and help of the school board and the hearty support of parents and citizens.
