

# REPORT OF THE SCHOOL BOARD.

To THE CONWAY SCHOOL DISTRICT:

A few days subsequent to the annual school meeting in March 1888, the School Board met at the town-house and organized as follows.

S. A. Evans was chosen Chairman and Geo V. Eastman, Secretary and Treasurer. It was then agreed, that without relieving each and every member from equal responsibility and authority for the whole school system of the town, the district should be divided into three sections, each one of which should be under the special care and oversight of one member of the board.

Mr. J. B. Nash was assigned that part of the town south and east of and including Conway Center.

S. A. Evans was assigned numbers 13, 5, 6, 10.

Mr. Eastman was to look after the remainder, comprising numbers 8, 14, 15, and 7.

In accordance with the above plan, the business of the school district has been transacted during the past year.

In consequence of the fact that no appropriation for repairs was made at the last annual meeting, the board has confined its labors in this direction to such slight repairs as were absolutely necessary to render the school buildings fit for present use, such as setting glass, painting black-boards, replacing door hangings.

The board would earnestly represent to the tax payers that a true economy in careing for the property of the town, demands, that an appropriation for repairs be made at once. Attention is especially called to the new and expensive buildings in No. 4, 8, and 13, which are suffering for the want of paint; also houses in districts No. 1, 14, and 16, need repair very much. Every year that they are allowed to stand without renewing the paint, adds largely to the expense of doing so, to say nothing of the rapid deterioration of the buildings.

As to the matter of school books, the board has been in a state of uncertainty as to just what course they were authorized to pursue, books have been furnished to pupils, as for several years past, from public funds.

It is hoped that the town will at once indicate the course it desires the board to pursue in this particular.

The board thinks it will be for the advantage of the schools, to make a change in the series of readers, before the next term of school. We therefore request all persons having readers of the series now in use, to turn them in to the board immediately, as they will be taken in exchange and in part payment for new books.

Finally we beg leave herewith to submit our annual report of schools and finances for the year ending in March 1889.

#### DISTRICT No. 1.

Two terms of 10 and 8 weeks both taught by Miss Alice B. Glines. This teacher gave universal satisfaction among the parents and scholars; with good Normal training she would be an excellent teacher no doubt. Wages first term \$7.50 per week including board. Second term \$7. First term whole no. registered 19, average attendance 16. Second term whole no. registered 16. Average attendance 15.

### DISTRICT No. 2.

Julia A. Thoms. Miss Thoms has had considerable experience as a teacher; we know of none who is her superior. Wages per week including board \$6. Whole no. registered 6. Average attendance 4.

#### DISTRICT No. 3.

One term of 9 weeks, taught by Winnie Carlton, a young girl who would, with proper training and experience make a good teacher. She did well in this school, and all interested were satisfied. Wages per week \$5.50. Whole no. registered 9. Average attendance 8.

#### DISTRICT No. 4.

Two terms of 10 and 8 weeks in this district. Mrs. Abbie M. D. Blouin, teacher—There is not the least interest manifested in schools in this district, outside of a very few families. Mrs. Blouin did as well as any one could have done under the same circumstances; whatever the school lacked of success, was in no way attributable to her. Mrs. Blouin is a teacher of great ability and long experience. Wages per week including board \$7. First term, whole no. registered 46. Average attendance 28. Second term, whole no. registered 52. Average attendance 41.

#### DISTRICT No. 5.

In this district, there was one term of 9 weeks, Taught by Mr.

Charles M. Stanley of Brownfield, Me. This school was visited by the board twice; once near the beginning of the term and once near the close. The methods of instruction of this teacher and the general improvement of the pupils were satisfactory. Wages including board \$6. per week. Whole no. of pupils, 8. Average daily attendance 7.

#### DISTRICT No. 6.

The Summer term in this district, was taught by Miss Harriet A. Allen of Wenham Depot, Mass. This school was visited several times, and by all the members of the board.

Miss Allen endeavored conscientiously to do her whole duty by the school, and with commendable success good order was maintained, and decided improvement in scholarship resulted.

Length of school 10 weeks. Whole no. of scholars registered 36. Average daily attendance 23. Wages per week including board \$7.50.

The fall term was taught by Miss Mary K. Davis. Miss Davis maintained the reputation as a teacher which she has so well earned in years past. The school was a success. Length of school 10 weeks. Whole no. of pupils registered 30. Average daily attendance 20.

The citizens in this district, in order to secure as many weeks of school as possible, agreed to give the board of the teacher.

In this way they secured ten weeks of schooling for which the teacher was paid \$5. per week.

### DISTRICT No. 7.

There were two terms in this district of 9 weeks each, taught by Miss Etta Emerson of Conway; and from the success of the school we were very fortunate in securing the services of Miss Emerson. The parents of the schoolars in this district have taken great interest in the school, and gave the board of the teacher in order to lengthen out the school and thus secure two terms.

Wages of teacher \$4 25, board given. First term, whole no. registered 7 Average attendance 7. Second term, whole no. 9. Average attendance 8.

#### DISTRICT No. 8.

#### GRAMMAR.

The first term of 10 weeks was taught by D. H. Lamberton, who had taught one term in this district the year before. The success of this school was somewhat interrupted by Scarlet Fever breaking out near the school-house. Wages per week including board \$12.50 Whole no. registered 51. Average attendance 30.

The second term of 7 weeks was taught by Miss Rose E. Chapman of Hiram Me. Miss Chapman is a teacher of many years experience and came well recommended; we think she taught the most successful school in this district for some time.

Some of the tax payers of this district willingly gave funds enough to extend the school three weeks, making a term of ten weeks. Wages per week including board \$10. Whole no, registered 45. Average attendance 30.

#### PRIMARY.

Both terms of 10 and 7 weeks were taught by Miss Mattie Lewis. This school has been very successful and has given general satisfaction; we think that Miss Lewis with a Normal School training would make one of the best of teachers.

The same trouble interferred with this department the first term as in the Grammar School. The second term was extended by private subscription to ten weeks. Wages per week including board \$7.50. First term no. registered 37. Average attendance 23. Second term whole no. registered 41. Average attendance 31. We think that if the Parents in this district would take more interest in their children attending every day, the school could be made more successful.

#### DISTRICT No. 10.

One term of 9 weeks in this district, taught by Miss Mattie O. Hobbs of Effingham. Miss Hobbs is a teacher of experience and has taught this school before. In spite of some disadvantage due to interference of parents with the discipline of the school, Miss Hobbs succeeded in giving the pupils a profitable term. The board would call attention to the general laws in re-

ference to disturbance of schools when in session and to the fact that it is their duty to see that these laws are respected.

Wages per week \$6 00 including board. Whole no. registered 13. Average attendance 10.

#### DISTRICT No. 12.

Two terms of 6 weeks each, both taught by Miss Hattie Woodward; this was her first experience. She gave general satisfaction, and with experience, will make one of our best teachers.

Wages per week including board \$6.

First term, whole no. registered 10. Average attendance 7. Second " " " 11, " 8.

#### DISTRICT No. 13.

#### PRIMARY.

The summer term was taught by Miss Annette F. Freeman of Bridgton, Me. This school was visited by all the members of the board, and the unanimous opinion was, that it was one of the best in town. The efficient management and instruction of fourty odd little children is a task which tries the capacity of the very best teachers. That this task was ably performed in this instance is admitted by all who knew anything of the school.

Miss Freeman secured and retained the affection of her pupils, which enabled her to govern them without severity, while their progress in their studies was such as to be highly gratifying to all concerned. Length of school 10 weeks. Whole no. registered 44. Average daily attendance 42. Wages including board \$8.

#### GRAMMAR.

Summer term taught by Mr. S. W. March, of Bridgton, Me. This is the third year of Mr. March's service as teacher in this school. It is only necessary to say that the excellent reputation which he had so well earned in the two previous years was amply sustained during this term. Whole no. registered 42. Average daily attendance 39. Wages per week including board \$10.

#### FALL TERM.

The amount of school money remaining to be expended in this

district, if divided between two teachers, would sustain so short a term of school that it seemed hardly profitable to attempt to have any school at all. In fact it would be impossible to induce teachers to accept a school of only three or four weeks: In this emergency it was decided to offer Mr. March the management of both schools, with the understanding that he should get such assistance as he could from some of the older scholars. This was not a very attractive offer, but Mr. M. finally decided to try the experiment. Accordingly the school was opened with 80 pupils. Mr. M. selected Miss Nannie Carleton as his assistant, placing her in the lower school room with about 25 of the small-The result justified an expedient which at first seemed a doubtful one, and a very profitable term was the result The decision of the Selectmen, soon after the opening of the school, that the residue of the dog tax could be turned over to the school fund, helped us out in this school, as in some, others. The board take pleasure in saying that the two teachers acquitted themselves most creditably under the somewhat trying circumstances of the situation. We would especially commend Miss Carlton, who, though young and without experience, demonstrated that she has abundant natural talent to fit her for a first-class instructor. Length of school 10 weeks. Whole number of scholars 80. Average daily attendance 70. Wages per week, Mr. March \$10 00 including board. Miss Carlton, \$2.00

#### DISTRICT No. 14.

Two terms of 9 and 6 weeks each, in this district both taught by Miss Nellie G. Ham of Portsmouth, N. H. Miss Ham is a teacher of experience in the city schools, her method of teaching are among the best, and we find that this school has been a success from beginning to end both in government and in general advancement of the scholars. Wages per week including board \$7 50. First term whole no, registered 24. Average attendance 18. Second term, whole no, registered 14. Average attendance 10.

#### DISTRICT No. 15.

This district is called one of the best in town. Your board secured the services of Miss Helen A Harris, who had taught

two terms in this district the year before. The result was not what was expected, from the report of last year. The greatest lack in Miss Harris as a teacher, is discipline. Your board visited this school several times but was not as well pleased as they would like to have been. Length of school 9 weeks. Whole no registered 37. Average attendance 32. Wages per week \$8. including board. The second term was taught by Miss Julia A. Thom, of Conway. While Miss Thom did not secure as good results as she expected, it was not any fault of hers: we think if parents would listen more to the teacher, and less to the scholars, better results would be secured. Length of term 7 weeks. Wages including board \$8. Whole no registered 25. Average attendance 19.

#### DISTRICT No. 16.

Two terms of 9 and 8 weeks. Both taught by Mary Abbott; an excellent school, both teacher and scholars deserve praise.

Wages per week \$7. First term, whole no. registered 32.

Average attendance 22. Second term, no. registered 34. Average attendance 19.

#### DISTRICT No. 17.

Burbank neighborhood. One term of 6 weeks taught by Winnie Carlton, all parties satisfied. Wages per week \$5. Whole no, registered 6. Average attendance 6.
