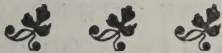

Warrant for Annual Town Meeting, 1921

(L. S.)

STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Wolfeboro qualified to vote in Town affairs:

You are hereby notified to meet at Brewster Memorial Hall, in said Town, on the second Tuesday of March next, at nine o'clock in the forenoon, to act upon the following subjects:

Article 1. To choose a Town Clerk for the ensuing year; three Selectmen, one for three years, one for two years, and one for one year; two Auditors; Treasurer; Collector of Taxes; Prosecuting Liquor Agent for the ensuing year and one Library Trustee for the ensuing three years, and a Constable, and one Trustee of Trust Funds.

Article 2. To bring in your ballots upon each of the questions submitted by the Convention to Revise the Constitution relative to the amendments proposed by said Convention at a session held on January 28, 1921.

Article 3. To elect one or more, not exceeding three highway agents; or instruct the Selectmen to appoint one expert highway agent.

Article 4. To choose all other necessary Town officers and agents.

Article 5. To see if the Town will vote to raise and appropriate the amount of money necessary to secure State Aid for the permanent improvement of highways under the law passed at the January session of the General Court, 1905.

Article 6. To see if the Town will vote to raise and appropriate twenty-five hundred (\$2500) dollars for the repairs of Highways, Bridges and Sidewalks in addition to that required by law.

Article 7. To see what sum of money the Town will vote to raise and appropriate to pay on its indebtedness.

Article 8. To see what sum of money the Town will vote to raise to pay each Fireman, legally returned, for the year 1921 in addition to that required by law.

Article 9. To see what sum of money the Town will vote to raise and appropriate for the Town Public Library, in addition to that required by law.

Article 10. To see what sum of money the Town will vote to raise for free Public Band Concerts for the ensuing year.

Article 11. To see what sum of money the Town will vote to raise and appropriate to pay James R. Newell Post G. A. R., to defray expenses of Memorial Day, May 30th, 1921.

Article 12. To see if the Town will vote to aid and assist the Huggins Hospital, and raise and appropriate money for the same.

Article 13. To see what sum of money the Town will vote to raise and appropriate for Town expenses for the ensuing year.

Article 14. To see if the Town will vote to authorize the Selectmen to hire a sum of money necessary to pay Town expenses in anticipation of Taxes for 1921.

Article 15. To see if the Town will vote to raise and appropriate, the sum of Three thousand (\$3000) dollars to secure a like sum from the State for the maintenance of the State Roads in said Town.

for the maintenance of the East Side Trunk Line, the State to appropriate three hundred dollars.

Article 17. To see if the Town will vote to macadam Union Street and raise and appropriate money for the same.

Article 18. To see if the Town will vote to raise and appropriate the sum of twenty-five (\$25) dollars for each hydrant, the proceeds to be applied toward reducing the indebtedness of the Wolfeboro Water Works.

Article 19. To see if the Town will authorize, empower and direct the Selectmen to appoint three water commissioners to have general supervision of the Water Works and further that the water commissioners be authorized, empowered, and directed to appoint and fix the salary of a superintendent of water works who shall have full charge of the operation and repairs of the water system and collection of water rentals under the direction of the water commissioners, or to take any other action that may be deemed expedient in relation thereto.

Article 20. To see if the Town will vote to build Sewall Road through the land of Samuel Avery and Ralph Horn, and raise and appropriate money for the same.

Article 21. To see if the Town will vote to raise and appropriate the sum of two hundred (\$200) dollars to aid in the suppression of the Gypsy moth.

Article 22. To see if the Town will vote to assist in the observance of Old Home Day 1921 and raise and appropriate money for the same.

Article 23. To see if the Town will authorize the Selectmen to issue permits to local Druggists to fill doctors' prescriptions for intoxicating liquor.

Article 24. To transact any other business that may legally come before said meeting.

Article 16. To see if the Town will vote to raise and appropriate one hundred and fifty (\$150) dollars

HIGHWAY DEPARTMENT**Commissioner's Report**

To Charles R. Grant, Noyes V. Moore and William A. Bixby, Selectmen of Wolfeboro, N. H.

I hereby submit the following report as Highway Commissioner of the Town of Wolfeboro, for the year 1920:

The winter, after February 1st. is fresh in the minds of all the people of Wolfeboro, as one of the most severe winters ever known to the oldest inhabitant.

The town roads were gone over early in the season with the road machine, and the King drag was used throughout the summer. Heavy trucks kept some of the roads almost impassable through the summer, although they were gone over almost constantly with the drag. Some of the roads were worked with the road machine two or three times.

State Aid Maintenance

All the State Roads in town received a coat of

Tarvia B and all the new State Roads received two applications, using in all 14,190 gallons of Tarvia B.

State Aid Construction

Rocks have been broken, ready for the crusher, enough to complete the survey that was laid out in the summer, for the road to be built on Elm Street, also on Farm Road, which came under State Aid this year, 5600 has been graded and built of gravel. (This is a gravel road).

Ossipee and Suncook or Federal Project No. 74

Owing to the high cost of labor and material, it was advised not to do any work on the project except to get rocks ready, which I did to the extent of \$1032.04.

Sewell Road was started and part of the road completed, and stone enough was broken, ready for the crusher, to complete the appropriation made by the Town of \$3000 but an early snowstorm in November put a stop to the completion of the work. (See following report).

A statement of the Folsom Fund has not been given in detail before since I have been in charge of the roads (See following statement). The balance of the appropriation for Cotton Mountain road for the year 1917, which was \$40.25, has been expended.

For cost of Highway Department, see detailed report.

I take this opportunity to extend my thanks to the People of Wolfeboro, who have aided me so kindly in the past four years that I have served as Highway Commissioner.

REPORT OF THE LIBRARIAN

To the Trustees of the Wolfeboro Town Library,

Gentlemen:

The past year has been a busy one at the library, with a larger circulation than for any previous year. There have been 18,436 books and periodicals loaned of these classes, fiction 10,183, non-fiction 2,724, children's books 5,529.

Two hundred new books have been accessioned, 75 of which were contributed. Special thanks are due to Mrs. Carpenter and Mrs. Jenkinson for their generous gifts of books.

Aside from the hospital and schools, but little has been done for those outside of the village precinct. A few who live at a distance come to the library quite as frequently as the patrons who live close by. During the summer months, some students who attend the academy may be willing to try Branch work in their own neighborhoods.

The morning hour of opening during July and August has become an interesting part of the day, some patrons coming from a distance of ten miles. This effort to make the library available to those who come to town only at that time is greatly appreciated.

The experiment of a class in library training was tried this winter, for the first time. This can be made a permanent thing if there is sufficient interest, although it may not be wise to again attempt the teaching of all sides of the work in so brief a time. Knowledge of a card catalog, shelf arrangement, and reference tools is of great use to the student, and is now required in some schools.

The librarian attended the first summer school for librarians held at Durham, N. H., for a week in August, under the supervision of Miss Kingsland of the

State Commission and Mr. Lewis, librarian of the State College Library. There about thirty librarians met to discuss methods and problems of library work. This school was fortunate in its choice of instructors.
