Town Warrant.

To the inhabitants of the Town of Whitefield, in the county of Coos, in said State, qualified to vote in Town affairs. You are hereby notified to meet at Town Hall, in said Whitefield, on Tuesday the tenth day of March next, at nine of the clock in the forenoon to act upon the following subjects, viz :

- 1st. To choose a Town Clerk.
- 2nd. To choose one Selectman for three years.
- 3rd. To choose a Treasurer.
- 4th. To choose all other necessary Town Officers.
- 5th. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations for the same.
- 6th. To raise such sums as may be necessary for the maintenance and building of highways and bridges.
- 7th. To raise such sums as may be necessary for the proper observance of Memorial Day, and appropriate the same to the use of the local American Legion.
- 8th. To raise such sums as may be necessary for the maintenance and building of sidewalks.
- 9th. To raise such sums as may be necessary for the purchase of books and paying all other expenses of the Public Library.
- 10th. To raise such sums as the Town may deem expedient to pay on the Town debt.
- 11th. To raise such sums as may be necessary for the maintenance and building of sewers.
- 12th. To see if the Town will vote to authorize the Selectmen to hire by Town note, such sums as they deem necessary to pay current bills the year ensuing.
- 13th. To see how much the Town will raise to support street lights.
- 14th. To raise such sums as may be necessary to pay interest on the Town debt.
- 15th. To raise such sums as may be necessary for the care and improvements of cemeteries.
- 16th. To see if the Town will vote to raise and appropriate the amount of money necessary to secure State Aid for the permanent improvement of highways under the Law passed at the January session 1905 and amendments thereto.
- 17th. To see if the Town will vote to have the streets in the business part of the Town oiled, and make an appropriation for the same.

- 18th. To see how much money the Town will vote to raise and appropriate for the repairs and maintenance of town buildings.
- 19th. To see if the town will vote to raise and appropriate the sum of \$5,000.00 to secure an additional \$15,000.00 from the State and Federal Government to be used for the reconstruction of the Daniel Webster Highway within the Town.
- 20th. To see if the Town will vote to grant to the Woman's Study Club the free use of the Town Hall for next year's Lecture Course, also the free use of the hall to the schools upon certain occasions.
- 21st. To see if the Town will vote to give prescription permits to the local druggists to sell liquor for medicinal, mechanical and sacramental purposes under the provisions of Chapter 147, Laws of 1917, and amendments thereto.
- 22nd. To raise and appropriate such sums of money as the Town may deem necessary for the suppression of the White Pine Blister Rust Disease.
- 23rd. To see if the Town will vote to raise and appropriate a sum of money necessary to purchase a new large United States Flag.
- 24th. To see if the Town will vote to employ a Traffic Officer for the months of July, August and September, or any other period of time during the summer season, and raise and appropriate a sum of money for the same.
- 25th. To see if the Town will vote to instruct the Selectmen to have the snow plowed off the Trunk Line Highway when necessary during the winter season, so that these highways can be used by automobiles, and to raise and appropriate a sum of money for the same.
- 26th. To see if the Town will vote to raise and appropriate a sum of money, not in excess of one thousand dollars, to widen the Mt. View House turn on the Daniel Webster Highway, and for repairing the Mt. View House road.
- 27th. To see if the Town will vote to observe Old Home Week and raise and appropriate a sum of money for the same.
- 28th. To see if the Town will vote to throw up and discontinue that part of the Old Carroll Road, extending from the bottom of Page Hill southerly to a few rods southerly of the L. O. Sisco turn, being that part of the highway not included in and not now used by reason of the relaying of this part of the highway last summer.
- 29th. To transact any other business that may lawfully come before said meeting.
