The Effingham Volunteer Fire Department, in 1993, showed a roster that has increased in membership during the past year.

Three additional members completed the Fire Fighter 1 course. The course was sponsored by O V M A A. Twelve business and several training session were conducted. The Dept also had a large diameter hose training session at Pine River Road and Mountain Road with area Departments.

The Effingham Fire Dept., Ossipee Valley Mutual Aid and the Carroll County Sheriff's Dept. are continuing a major communications study, working on getting three new Radio Tower sites (Green Mtn - Red Hill - Tyrol).

The department had to replace 2T1 with a 6x6 from N.H. Forestry Dept.

The Effingham Fire Dept. was able to purchase the following equipment in the past year - a 4" Stortz Z valve for 2E5, Drench and Class A foam to aid in fire suppression, 1000 feet of 4" hose, portable Class A foam Proportioner (50/50 match with state), one 16" Smoke Ejector with hangers, Pitot gauge with accessories/case and 6 new air paks with cases.

Communications equipment - 1 new 2-way radio for 2E5 and 1 portable radio for an officer. Also upgraded part of the member turn-out gear.

REPORT OF TOWN FOREST FIRE WARDEN AND STATE FOREST RANGER

During Calendar Year 1993, the State of New Hampshire experienced an average number of wildfires. The three leading causes of these wildfires were campfires left unattended, unsupervised children and debris fires that escaped control. All of these fires are preventable, but ONLY with your help!

Please help your town and state forest fire officials with forest fire prevention. New Hampshire State Law (RSA 224:27 II) requires that, "No person, firm or corporation shall kindle or cause to be kindled any fire or burn or cause to be burned any material in the open, except when the ground is covered with snow, without first obtaining a written fire permit from the Forest Fire Warden of the town where the burning is to be done."

Violations of RSA 24:26 II and the other burning laws of the State of New Hampshire are misdemeanors punishable by fines of up to \$1,000 and/or a year in jail and you are also liable for all fire suppression costs.

The State of New Hampshire, Division of Forests and Lands assisted many towns in wildland fire suppression during 1993 and participated in many fire prevention programs. This year, the nation is celebrating Smokey Bear's 50th anniversary. The State of New Hampshire Forest Protection Bureau will be working with many communities to spread the fire prevention message--"Remember...
Only YOU can prevent forest fires." Fire prevention is the most cost effective fire suppression tool. Please be careful around fires and help us and our communities have a fire safe year.

EFFINGHAM RESCUE UNIT REPORT FOR 1993

Through your generous expenditure of monies, Effingham Rescue was able to take delivery in 1993 of a new Advanced Life Support vehicle and a defibrillation unit. The new vehicle and cardiac monitor will enable our squad to provide more comprehensive medical services to the Town of Effingham and surrounding communities.

In 1993, the Effingham Rescue Unit responded to 46 calls. The breakdown of calls is as follows:

30 Medical Aid

8 Motor Vehicle Accidents

4 Mutual Aid Calls

2 Structure Fires

1 Fire Department Assist

1 Mutual Aid Structure Fire

Effingham Rescue transported 44 patients in 1993. In addition, the squad attended 2 EMS District Meetings, 1 mass casualty drill and performed a special service at the Effingham School.

Our membership is currently comprised of 3 Nationally Registered Emergency Medical Technicians-Intermediate, 5 Nationally Registered Emergency Medical Technicians-Basic and 9 rescue members. Effingham Rescue also has 4 members and 2 potential new members currently attending First Responder classes. Several members will also receive continuing education at a Pediatric Trauma course this spring.

As always, Effingham Rescue is very grateful for the numerous generous donations and cards of thanks that we have received during the past year.

Our sincere thanks to the townspeople for affording Effingham Rescue Unit the opportunity to be of continued service.

The Planning Board passed another slow year due to the lack of growth in New Hampshire. No new subdivisions were created and only several boundary line adjustments.

This is not to say that the Board was not busy in 1993. There were many questions about land use, some of which the Board could not legally act on, as they were concerned with lots of record (i.e. lots in existence before the formation of the Board in 1972). On these lots, only the Wetlands and Steep Slope ordinances apply and, according to state law, the Planning Board has no other jurisdiction.

Other matters concerned violations of Subdivision Regulations and violations of conditions for subdivision. The Board feels that many of these could have been prevented by the simple matter of having a building permit procedure in town. This would not restrict building in any way, but would inform prospective builders of Planning, Steep Slopes and Wetland regulations before a structure was constructed, preventing much aggravation to all.

In 1994, the Board will drop its membership in the Lakes Region Planning Commission. The Board consulted them twice in 1993, making it much more cost effective to pay them on a per use basis rather than the eight hundred plus dollars our dues currently run. When economic conditions warrant it, the Board will renew its membership.

The Board meets the first Tuesday of each month at the Town Hall and welcomes public participation as well as suggestions concerning changes in the regulations.

The water testing this year has shown very little impact on the land. All persons using the Transfer Station will need a permit sticker. If you cannot make it to the Town Hall for a sticker, I will have them available at the Transfer Station this year for your convenience.

REPORT TO DISTRICT ONE CITIZENS

The five-member Executive Council acts much like a Board of Directors within the Executive Branch of your State Government. We have the authority granted to the Governor and Council by constitutional and statutory law for the overall administration of the affairs of State as defined by the NH Constitution, NH statutes, advisory opinions of the Attorney General and opinions of the NH Supreme Court.

We each represent one-fifth of the population divided into five districts. Our District consists of 98 towns and four cities spread over all or parts of five of New Hampshire's ten counties. The current population of our district is 221,000 people - basically the land area north of Concord.

Of prime importance to this region is the development of the highway transportation program throughout the State. The NH Legislature by law set in motion a two-year cycle which will start July 1, 1994 which requires each Councilor to hold public hearings to ascertain highway and transportation needs. We then will make a recommended plan for highways to the NH Legislature by February 1997. Governor Merrill will be making his 1994 recommendations to the NH Legislature by February15, 1994. Town, cities, counties and citizens having an interest in this should contact their local State Representatives and State Senator.

Another project that is of continuing interest to this District is the nomination and confirmation of individuals to the dozens of State boards and commissions on which the Governor and Council are required to fill with qualified and interested citizens. If you are interested, please forward a copy of your resume to me.

LAKES REGION PLANNING COMMISSION

The Lakes Region Planning Commission is a voluntary association of local communities designated by area towns as the organization that brings towns and cities within the Region together. By associating and pooling resources, local governments have a highly trained professional staff available to them for a wide variety of services. Areas of current expertise include land use planning, transportation planning, master planning, environmental planning, capital improvement programming, impact fee studies, economic and community development, housing, fiscal and environmental impact analysis, geographic information systems and computerized cartography, household hazardous waste collections and site plan review. Communities may also obtain the services of a professional planner on a regular basis through our circuit rider program. The Commission also serves as a collective voice in issues involving the state and federal government. We are cognizant of the role we have to protect and further the interests of our communities.

Your support enables the LRPC to undertake comprehensive regional planning and to carry out various projects and programs of regional benefit. Over the past year, the LRPC:

- o Provided consultation and assistance to thirty-one member communities.
- o Met repeatedly with state officials and agency representatives to influence policy and help keep the Region an active participant in many ongoing State programs.
- Contracted and coordinated the 10th, and largest, regional household hazardous waste program in the Lakes Region serving over nineteen municipalities in a one day super collection.
- o Initiated the start of the Lake Winnipesaukee Watershed Project which includes the preparation of a Manual of Model Ordinances, especially for communities having lakefront lands.
- Sponsored local sessions of the N.H. Law Lecture Series.
- o Served as a board member on the Belknap County Economic Development Council, a regional consortium of area towns for economic betterment.
- o Staffed critical parts of the U.S. Route 3 and N.H. Route 11 community oriented transportation study of the Route 3 & 11 transportation corridor from Franklin to Laconia. The final report is scheduled for early 1994.
- o Served on the Route 3 & 11 Policy Advisory Committee advocating a consensus approach for projects to be recommended in the 3 and 11 study.
- Initiated discussion of state support for a study of siting a conference facility in the Lakes Region. Legislation for this idea was submitted in 1994 (SB 701).

- o Provided each town in the region with GIS plots of wetlands, through a cooperative project with the N.H. Office of State Planning. We are also represented on the N.H. GIS Advisory Committee. We are also working on a cooperative GIS partnership with Plymouth State College.
- o Started data collection efforts on the Route 16 Feasibility Study; a federally mandated study designed to investigate measures to preserve the Route 16 transportation corridor as an efficient conveyer of people and goods.
- o Initiated discussion on a land capability analysis of the Newfound Lake watershed. This effort will be funded by the N.H. Dept. of Environmental Services and will include assistance from the Newfound Lake Association and the communities within the watershed.
- o Continued to participate on and support the N.H. Heritage Trails efforts. The N.H. Heritage Trail is a recreational trail generally following the Pemigewasset and Merrimack Rivers from the Canadian border to the Massachusetts border.
- Started a cooperative wetlands evaluation project with the Audobon Society,
 Office of State Planning and Central Region Planning Commission. Held two
 workshops and will work with Ossipee and Wolfeboro on wetland evaluations.
- Met individually with all thirty-one towns in the region to discuss changes to the
 existing regional transportation improvement program. This information will assist
 the LRPC with the preparation of an updated regional transportation improvement
 program.
- Completed point and non-point source pollution mapping of towns in the Region and transferred this information into the LRPC's geographic information system.
- Continued to administer the Region II Transportation Advisory Committee in coordination with the N.H. Department of Transportation. This group meets throughout the year and has established regional transportation priorities which are annually presented to the Governor's Highway Advisory Council and the State Department of Transportation for future transportation improvement projects.
- o Continued to administer and participate in a number of master plan updates throughout the Region including, but not necessarily limited to Tamworth, Northfield, Holderness, Gilmanton and Sanbornton.
- Received a special commendation for unique and significant accomplishments in the field of town, city and regional planning from the Northern New England Chapter of the American Planning Association for our Industrial Siting Study.

During 1993, Kimball Chase Company provided the following services to the Town:

- 1) Continued water quality monitoring of groundwater and the South River.
- 2) Transfer Station permitting.
- 3) Transfer Station design and layout.

The results obtained from water quality monitoring indicate the same conditions as 1992. The landfill is generating leachate, but is having minimal impact upon groundwater. No surface water impact has been noted. Reports are issued three (3) times each year to the Town and the New Hampshire Department of Environmental Services (NHDES).

We are currently completing the Interim Closure Application for the solid waste landfill. The interim closure presents significant savings to the Town, due to its lower construction cost, if accepted by NHDES. Construction could possibly begin in the summer of 1994.

Kimball Chase appreciates the work which Effingham has asked us to undertake since 1988. We look forward to continuing our work with the Town and addressing its solid waste disposal requirements in this coming year.
