TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Westmoreland in the County of Cheshire, in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Town Hall in said Westmoreland on Tuesday, the Twelfth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.
3. To see if the town will vote to adopt the provisions of the municipal budget act.
4. To hear the reports of agents and auditors and take any action thereto.
5. To see if the town will accept state aid for state road construction of the Class II road known as Chesterfield road and raise and appropriate or set aside for said purpose the sum of \$819.00; or will accept state aid for construction of Class V roads and raise and appropriate or set aside for said purpose the sum of \$574.57.

6. To see what sum of money in addition to what is required by law the town will vote to raise and appropriate for the support of highways and bridges.

7. To hear the report of the committee appointed to investigate the feasibility of a fire fighting apparatus and take any action relating thereto.

8. To see if the Town will vote to buy fire fighting apparatus and raise and appropriate or borrow money for the same.

9. To see what sum of money if any the Town will raise and appropriate for upkeep of cemeteries, etc.

10. To see what sum of money if any the Town will vote to raise and appropriate or borrow to repair or rebuild the bridge near the Westmoreland and Walpole town line on the road leading past the George H. Aldrich place so-called.

11. To see what sum of money if any the town will vote to raise and appropriate or borrow to excavate the brook bed in the brook near Walpole and Westmoreland town line on the river road so-called leading to Town of Walpole.

12. To see if the Town will vote to discontinue the road leading from the residence of May Capron to the house known as the Clinton Hall place and the road leading from Westmoreland Village to East Westmoreland Village near the Cornelia Leach place so-called.

13. To see if the Town will vote to apply calcium chloride to part of the E. R. U. section of the town road known as the River Road and Spofford Road and raise and appropriate money for the same.

14. To see what sum of money if any the Town will vote to raise and appropriate or borrow to change the course of Patridge Brook near the Henry J. Dutton place so-called.

15. To see what sum of money if any the Town will vote to raise and appropriate for the purchase of snow plow or blade.

16. To see if the Town will vote to petition the Superior Court for the discontinuance of the road known as Beebe Hill.

17. To see what action the Town will make relating to a discount on taxes if paid before certain dates.

18. To see if the town will vote to raise and appropriate the sum of \$75.00 for the purchase of a safe to be used for holding Town Records.

19. To see what disposition the Town will vote to make of the income of the Jothan Lord fund.

20. To see if the Town will vote to raise and appropriate a sum not exceeding \$100 for the support of the library.

21. To see if the Town will vote to accept the legacy of the late Mrs. Hannah H. Draper. The 2nd clause of her will gives you \$8,000 "in memory of my twin brother, William S. Starkey, who died in the civil war, to be held by said selectmen as a trust fund to be known as the William S. Starkey Gift fund, said selectmen to invest and reinvest the same, the net income therefrom to be paid over to the aged and needy people of Westmoreland, by said selectmen, in their discretion."

22. To see if the Town will vote to print all unpaid taxes up to the current year in the town report.

23. To see if the Town will vote to authorize the selectmen to borrow money in anticipation of taxes.

24. To transact any other business that may legally come before said meeting.

REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Westmoreland:

I herewith submit my second report as Superintendent of Schools.

ORGANIZATION AND ENROLLMENT

No changes in the teaching positions were made this year. The teachers are all well qualified for work with their particular groups. They have been loyal, enthusiastic, and cooperative.

School work is being accomplished in accordance with the standards of the State. Standard achievement tests are being given and reports are required relative to the work completed in each grade.

A new standard dictionary and a set of maps were purchased for the school at East Westmoreland. This school is also supplied with a set of reference encyclopedias loaned by the Parent-Teachers' association. Some of the other schools are much in need of up-to-date material of this nature. If one school could be equipped each year, the cost to the district would not be prohibitive.

The school at Westmoreland Corner has an excellent school library. Books are available for the pupils of all grades. A box of books has recently been received from a friend who has made similar contributions at other times. A fund of twenty dollars from local sources was assigned for the purchase of books for the library. The children enjoy these books and derive much of value from them.

Seven libraries of fifteen books each have been made up from the sample reading material which has accumulated in

the office. These are being loaned to the schools in the supervisory union. These books are especially appreciated by the younger children who usually find it difficult to locate supplementary reading suitable to their age. Some of the teachers have secured the loan of books from the state library and from the state board of education. The value of reading good books and of learning to use reference material correctly, cannot be over emphasized.

The Parent-Teachers' associations have arranged for special instruction in music and art at East Westmoreland and for music at Westmoreland Depot. Student teachers from Keene Normal school have been procured for this work. In the other two schools this instruction is given by the teachers. At a recent institute for rural teachers, a report was made of the excellent work done by the pupils at the village school.

Milk is being supplied each day to twenty pupils in the Westmoreland schools. Cod liver oil is provided and given by recommendation of the school nurse. These are provided from federal funds. Noon lunches are supplemented with a hot dish during the winter.

The Parent-Teachers' association at East Westmoreland organized a dental clinic to further the work which was begun with federal funds. A fund of fifteen dollars was contributed for this purpose. The school is now on the 100% list.

Contributions from the P. T. A. at the Depot and at the Village enabled these schools to complete the dental work 100%.

At Westmoreland Corner the sum of \$5.00 was assigned for music. This money was used to buy equipment for the rhythm band.

The pupils at the Corner school appreciate the kind interest of Mr. Hutchins who has each year supplied decorations and favors for their Hallowe'en party.

The members of the P. T. A. at Westmoreland Village supply the materials for one hot lunch each week. Help has also been given in the purchase of noon lunch equipment.

BUILDINGS AND EQUIPMENT

A tour of inspection was made to determine the repairs necessary in the schools of the district. The necessary work for each school was listed and arrangements were made for doing that which seemed most urgent. At the Depot school new curtains were installed and the ceiling, walls, and wood-work were painted. At East Westmoreland, the roof was repaired, ceiling in upper grade room was whitened, and a concrete step was added at the entrance. Storage space in the wood shed at the Corner school was increased by removing unused partitions. The seats and desks at the Corner school were replaced with the new single unit type. At the Village school a store room was provided for scholar supplies, janitor supplies, and books.

The playground apparatus furnished by Mr. Sherman for the Village school and the contributions of Mr. Britton and Mr. Hoyle for athletic equipment, are greatly appreciated by the pupils of this school.

The screens at the East Westmoreland school were furnished by the Parent-Teachers' association.

The number of cases of tardiness as indicated in the above table, is excessive. The apparent increase may be due to a new State ruling governing the attendance record of pupils on transportation routes. There are some families in the district where the children are permitted to remain at home on school days without sufficient cause. It has been necessary to refer several cases of this nature to the State truant officer. Poor attendance is a serious school problem. Not only does it affect the progress of the children who are absent, but it limits the efficiency of the school work in general.

Inspection of pupils made in October 1934, showed the following defects:

128 pupils were examined.

4 pupils showed defective vision—uncorrected.

1 pupil showed defective hearing.

10 pupils showed poor posture.

25 pupils were underweight.

83 pupils were in need of dental care.

27 pupils have enlarged or diseased tonsils.

12 pupils have enlarged glands in neck.

26 pupils were unvaccinated, without proper excuse.

7 pupils were vaccinated once unsuccessfully.

Dental clinics were held Nov. 6th, 9th, 14th, 15th, 20th, 21st, 26th, 27th, 1934 at Dr. G. Alex. Campbell's office, Keene, N. H.

11 pupils had their teeth cared for by their own dentist.

Tonsil clinics were held Feb. 16th, July 13th, at the Mousley hospital June 20th, Dec. 1st, 1934 at the Keene Community hospital.

7 cases were treated.

5 cases were treated privately.

Six pupils had special eye examinations, defects corrected.

An underweight clinic was held April 24th, 1934. Thirty-five pupils were given chest examination by Dr. Robert Kerr, of the New Hampshire Tuberculosis Association.

Much work was made possible through contributions from the Child Health Recovery program.

I wish to express the appreciation of the district to those who so kindly furnished transportation for the pupils to the dental clinics. Also to the East Westmoreland P. T. A., local Red Cross chapter, South Village P. T. A., for assistance given in carrying on the work in the past year.

I also wish to express my appreciation to Supt., teachers, pupils and parents for their help and cooperation.
