Town Warrant.

To the inhabitants of the Town of Whitefield, in the County of Coos and State of New Hampshire, qualified to vote in Town affairs. You are hereby notified to meet at the Town Hall in said Town of Whitefield, on Tuesday, the eleventh day of March, next, at nine o'clock in the forenoon, to act upon the following subjects, viz :

1. To choose a Town Clerk, one Selectman to serve for a period of three years, a Treasurer, two Highway Agents, two Library Trustees, Trust Fund Trustee, Auditor, Memorial Field Committeeman for six years, and all other necessary town officers.
2. To raise and appropriate such sums of money as may be necessary for--
 - a. Town officers' salaries.
 - b. Town officers' expenses.
 - c. Election expenses.
 - d. Municipal Court expenses.
 - e. Care and repair of Town Buildings.
 - f. Police Department.
 - g. Health Department and Vital Statistics.
 - h. Highways and Bridges.
 1. State Aid Maintenance.
 2. Town Road Maintenance
 3. Street Lighting
 4. General expense highway department
 5. Snow removal
 6. Oiling highways
 - i. Public Library.
 - j. Town Poor.
 - k. Memorial Day.
 - l. Band Concerts.
 - m. Cemeteries.
 - n. Sewers.
 - o. Interest on Temporary loans.
 - p. Interest on debt.
 - q. State Aid Road Construction.
 - r. Sidewalk Construction.
 - s. Payment on principal of Town debt.

3. To see if the Town will vote to raise not to exceed the sum of fifteen hundred dollars for repairs to South Whitefield Road. (Petition.)
4. To see if the Town will vote to raise not to exceed the sum of twenty-five hundred dollars for repairs to Mountain View Road.
5. To see if the Town will vote to raise not to exceed the sum of three hundred dollars for repairs of road to Asa Flint's house.
6. To see if the Town will vote to raise not to exceed the sum of one thousand dollars for repairs of Brown Street Road. (Petition.)
7. To see if the Town will vote to raise a sufficient sum of money to provide electric lighting of the Town Clock.
8. To see if the Town will vote to elect one highway agent only commencing with the March Town Meeting 1931.
9. To see if the Town will vote to grant to the Woman's Study Club, American Legion, Public Schools (under proper supervision) and other organizations for public purposes the free use of the Town Hall, or by the payment of actual expenses of heating, lighting and janitor service.
10. To see if the Town will vote to give prescription permits to the local druggists to sell spirituous liquor for medicinal, mechanical and sacramental purposes under the provisions of our Public Laws.
11. To choose two delegates to the Constitutional Convention.
12. To see if the Town will vote to authorize the selectmen to borrow money by temporary loan in anticipation of taxes.
13. To transact any other business that may lawfully come before the meeting.

Given under our hands and the seal of the Town this twenty-fourth day of February, in the year of our Lord one thousand nine hundred and thirty, and of the Independence of the United States of America the one hundred and fifty-fourth.
