



During the year, under the new school law, the Selectmen have appraised and taken the several school-houses and all school property in the town excepting that in the Woodsville District appraising it at \$4,492.86. This amount was included in the taxes assessed, being remitted by the Collector, by direction of the Selectmen.

There was also the sum of \$376.69 of school money re-

maining unexpended in the hands of the Treasurer and in the hands of the Prudential Committees of certain districts which was also remitted by the Collector by direction of the Selectmen to the tax payers of the several districts to which this money was apportioned under the old law.
