THE STATE OF NEW HAMPSHIRE
TOWN WARRANT

To the inhabitants of the Town of Whitefield, in the County of Coos and State of New Hampshire, qualified to vote in town affairs. You are hereby notified to meet at the Town Hall in said Town, on Tuesday, the thirteenth day of March next, at nine o'clock in the forenoon, to act upon the following subjects:

1. To choose a Town Clerk, one Selectman to serve for a period of three years, a Town Treasurer, Highway Agent, two Library Trustees, two Trust Fund Trustees, Auditor and all other necessary town officers.

2. To raise and appropriate such sums of money as may be necessary for—

- a. Town officers' salaries.
- b. Town officers' expenses.
- c. Election expenses.
- d. Municipal Court expenses.
- e. Care and repair of town buildings.
- f. Police department.
- g. Health department and Vital Statistics.
- h. Sewer maintenance.
- i. Highway and Bridges.
 1. Snow removal.
 2. Town maintenance.
 3. Street lighting.
 4. General expense highway department.
- j. Public Library.
- k. Town Poor.
- l. Old Age Assistance.
- m. Memorial Day.
- n. Soldiers' Aid.
- o. Band concerts.
- p. Cemeteries.
- q. Interest.
 1. Temporary loans.
 2. Town debt.
- r. Sidewalk maintenance.
- s. Payment on principal of town debt.

3. To see if the Town will vote to grant to the Woman's Study Club, American Legion, Public School (under proper supervision) and other organizations for public purposes the free use of the Town Hall.
4. To see if the Town will vote to authorize the selectmen to borrow money by temporary loans in anticipation of taxes.
5. To see if the Town will authorize the selectmen to administer or dispose of any real estate acquired by the Town through tax collector's deeds, or otherwise.
6. To see if the Town will vote to accept State Aid Construction and raise money for same.
7. To see if the Town will vote to raise and appropriate not to exceed \$500 for a new snow plow.
8. To see whether beer or other lawful alcoholic beverages shall be manufactured or sold locally as permitted under laws of 1933.
9. To see if the Town will vote to discontinue as a public highway that portion of the East Whitefield Road extending from a point northeasterly of the driveway leading to Sylvester Newell dwelling house to the Jefferson town line, subject to gates and bars.
10. To see if the Town will vote to discontinue as a public highway the road leading from the East Whitefield Road northerly to the Ed Hildreth farm, so-called, subject to gates and bars.
11. To transact any other business that may lawfully come before the meeting.

Given under our hands and the seal of the Town this twenty-sixth day of February, in the year of our Lord one thousand nine hundred and thirty-four, and of the Independence of the United States of America the hundred and fifty-eighth.

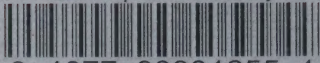
