# State of New Hampshire

---

SEAL

To the inhabitants of the Town of Gorham, in the County of Coos, in said State, qualified to vote in town affairs:

You are hereby notified to meet in Municipal Hall on Tuesday the eleventh day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To elect one selectman for three years, and choose all other necessary town officers for the ensuing year. Also to elect two delegates to the State Constitutional Convention at Concord, June next.
2. To see what sum the town will vote to raise and appropriate for street lights.
3. To see if the town will vote to authorize the selectmen to distribute the inventory blanks when taking the inventory.
4. To see what sum the town will vote to raise and appropriate for the Public Library.
5. To see what action the town will take in regard to raising and appropriating money for police the ensuing year.
6. To see what action the town will take in regard to raising and appropriating money for the maintenance of a trunk line road.
7. To see what sum the town will vote to raise and appropriate for highways and bridges.
8. To see what sum the town will vote to raise and appropriate for water and sewer maintenance.
9. To see what sum the town will vote to raise and appropriate for Common.
10. To see what sum the town will vote to raise and appropriate for the retirement of Municipal Bonds.
11. To see what sum the town will vote to raise and appropriate for District Nurse.
12. To see what sum the town will vote to raise and appropriate for the retirement of Cascade Water Bonds.
13. To see what sum the town will vote to raise and appropriate for a public dumping ground.
14. To see what sum the town will vote to raise and appropriate for skating rink.

15. To see what action the town will take in regard to installing additional street lights along the Lancaster Road from the residence of Albion Reid to the Randolph town line.

16. To see what sum the town will appropriate for Band Concerts.

17. To see what action the town will take in regard to raising and appropriating money for permanent roads on Cascade Hill, same to be spent under the supervision of the selectmen.

18. To see what action the town will take in regard to raising and appropriating money for the Town Building on Androscoggin Street.

19. To see what action the town will take in regard to raising and appropriating money for the Grand Army.

20. To see what action the town will take in regard to raising and appropriating money for the American Legion.

21. To see what sum the town will vote to raise and appropriate for sidewalks on Glen Street, Wilson Street, and Jewell Street.

22. To see if the town will vote to instruct the Selectmen to employ an unmarried stenographer and bookkeeper, preferably one who is a graduate of our high school, and that such stenographer and bookkeeper be requested to do the work pertaining to such position required by all the different departments of the town, at a reasonable salary and without making extra charge against any one of the departments for which she is employed.

23. To see if the town will vote to require the proprietors of the Canadian National Railways to lower the highway known as Cross Street where it is crossed by their railroad so that it will be sufficiently below the railroad to safely accommodate travel upon both said highway and said railroad.

24. To see if the town will vote to allow a discount of two per cent on all taxes, excepting poll taxes, paid to the tax collector on or before the first day of August in each tax year including 1930.

25. To see if the town will vote to purchase Coleman truck and Sargent plow.

26. To see if the town will empower the Selectmen to give Quit Claim Deeds on property bought for taxes.

27. To see if the town will vote to purchase garage on Jewell Street for a storehouse.

28. Sec. 1. To see if the town will vote to rescind the vote of 1929, Article 15.



Sec. 2. To see if the town will vote to abolish the so-called water trough now located on the north side of Main Street and opposite Exchange Street, and in lieu thereof a drinking fountain be installed and maintained at or near this location, the said expense to be taken out of the Water and Sewer maintenance.

29. To see if the town will vote to raise and appropriate a sufficient sum of money to relay the present spiral pipe of the town water and sewer system, from its present connection with the Perkins Brook intake to its branch to the reservoir, with a new twelve-inch cast iron pipe, and to provide money for the same by borrowing upon its notes, bonds, or other obligations, and choose such committees, officers, or agents as may be necessary or convenient to carry out any vote that may be passed under this article.

30. To see if the town will vote to appoint a committee of five to see at what price the Randolph Hill water system and the water rights on the brook supplying said system can be purchased by the town, and if the price is considered reasonable by said committee, to procure estimates of the value of said system and water rights and plans, specifications and estimates of the cost of extending said system, including any reservoir or reservoirs that may be necessary for storage or pressure reduction, into the town of Gorham for the purpose of supplying the inhabitants of Gorham Hill with water for fire extinguishing and domestic purposes; and to appropriate the sum of \$200 out of any unappropriated moneys in the treasury for the use of said committee to defray its necessary expenses and charges; said committee to report at an adjourned meeting of this annual meeting and upon said report at said adjourned meeting, to see if the town will vote to acquire said system and water rights at such price as may be agreed upon, and extend the same into the town of Gorham for the purposes aforesaid; and raise and appropriate a sufficient sum of money for said purpose by assessment of taxes or raise a sufficient sum by issuing bonds, notes or other obligations of the town.

31. To see if the town will adopt the following ordinance:

Sec. 1. No shanties or cheap buildings will be allowed to be built or moved onto any lot on the principal streets of the village of Gorham including the upper village, without a permit from the Selectmen.

Sec. 2. Any ordinance respecting this subject heretofore established by the town which might conflict with this ordinance

is hereby repealed.

32. To hear reports of town officers, agents, committees heretofore chosen, and pass any vote relating thereto.

33. To transact any other business that may legally come before the meeting.

We attach a condensed report of the following recommendations:

The State Highway department estimate the cost of Trunk Line maintenance \$17,300.00. Of this amount the State will pay one-half. We therefore recommend that the town appropriate and raise \$8,650.00 for Trunk Line maintenance.

We recommend the amount of \$12,000.00 be appropriated and raised for Town maintenance, and that out of this amount Jewell Street be permanently built and tarred.

We recommend the amount of \$5,000.00 be appropriated and raised for permanent roads at Cascade Hill.

We recommend that the town purchase the Chandler Garage on Pleasant and Jewell Streets for a storehouse, and appropriate and raise \$3,500.00 for this purpose.

We recommend that the town appropriate \$6,400.00 for the purchase of the new truck and snow plow, this amount to be taken from funds on hand; also that the truck be used as much as possible the year round for town purposes.

We recommend the amount of \$500.00 be appropriated and raised to apply on repairs of the Town Building on Androscoggin Street occupied by the American Legion.

We recommend the amount of \$480.00 be appropriated and raised for band concerts.

We recommend the amount of \$2,900.00 be appropriated and raised for sidewalks, to be used as follows: \$200.00 to extend the present sidewalk on Jewell Street; \$700.00 on Glen Street from Railroad Street to Promenade Street; and the balance continuing

the walk on Church Street to Wilson Street; and on Wilson Street.

We recommend the town empower the selectmen to hire sufficient money to expend with the State and Canadian National Railway to return Peabody River and Moose River to their original courses.

We recommend that the town take some action in regard to replacing the old spiral pipe in Heath District, which we understand is fast going to ruin.

The Budget Committee does not care to recommend extending lights to the Randolph line.

If no new projects appear more than are contained in our budget, the tax rate should be about \$30.00 per \$1,000.00.

The District Nursing Service of Gorham is entering upon its twelfth year. During 1929 a total number of 2,218 visits were made.

Other visits, such as friendly (social welfare), investigation, business, etc., have also been made.

Health talks have been given in the schools up to the Seventh Grade. The children are examined for defective vision, poor posture, pediculosis, etc. Physical defects found by the school physician in his examination of pupils have been reported to the parents by the nurse and in many cases these defects have been corrected.

In addition to the work done in the elementary grades, the nurse has given instructive talks on home nursing and demonstrations in bandaging, control of hemorrhage, treatment of burns, etc., to a class of High School girls studying Domestic Arts.

I want to thank all those who have in any way helped in the work, and those who have given clothing and other supplies.

Especially do I want to thank the ladies of the Gabalot Club for the good work they have done and are doing. They are real social workers and show in a quiet but very substantial way, their desire to make conditions better.

This is to certify that we have examined the accounts of the various departments of the Town of Gorham for the fiscal year ending January 31, 1930, and report as follows:

The receipts of the Town as shown by the books of the Selectmen and Town Treasurer were checked as to source and amount.

The disbursements of the Town as shown by the books of the Selectmen and Town Treasurer were checked with the vouchers and checks drawn. All checks were signed by at least two of the Selectmen and countersigned by the Town Treasurer. The money received by the Town Treasurer was deposited in the White Mountain National Bank. The payrolls and bills were attached to the vouchers.

The accounts of the Water and Sewer Department were checked with the books of the Selectmen and Town Treasurer.

The payrolls and bills of the Highway Department were checked with the books, vouchers and checks of the Selectmen and Town Treasurer. A few minor errors appeared in some of the payrolls.

The accounts of the Town Clerk were checked with the books of the Selectmen and Town Treasurer, with exception noted.

The accounts of the Town Library Department were checked with the books of the Selectmen and Town Treasurer.

The accounts of the District Nursing Department were checked with the books of the Selectmen and Town Treasurer.

The accounts of the Municipal Court were checked with the Complaints, Warrants and Docket.

The accounts of the Trustees of Trust Funds were checked.

The accounts of the Agent of the Municipal Building were checked with the books of the Selectmen and Town Treasurer; this account does not include \$500.00 received by the Town for the rooms occupied by the Masons.

The accounts of the Tax Collector, including the account committed for collection, the amount collected including extra taxes, interest, property taxes sold and abatements were checked with the books of the Selectmen and Town Treasurer. We

would suggest that the Selectmen furnish the Tax Collector with two books; one showing the property taxes and the other the poll taxes.

The funds received by the various Departments were turned over to the Town Treasurer and covered by proper receipts.

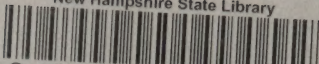
