RECORD OF TOWN MEETING

Dunbarton, N. H., March 11, 1930

Meeting called to order and warrant read by the Moderator, John W. Farrar.

ARTICLE 1. Upon motion made by Iru M. Waite, Voted to instruct the Moderator to cast one vote for David M. Hadley for Town Clerk.

The Moderator then cast one vote for David M. Hadley, who was declared elected, and in open meeting took the oath of office.

Upon motion made by Walter C. Blackman, Voted to instruct the Clerk to cast one vote for John Bunten, for Town Treasurer.

The Clerk then cast one vote for John Bunten, who was declared elected, and in open meeting took the oath of office.

Vote for Selectman for three years:

Whole number of votes given in—132.

C. C. Wheeler had 11.

Cyrus C. Wheeler having the majority of all votes given in, was declared elected.

Harold L. Burnham having the majority of all the votes given in, was declared elected, and in open meeting took the oath of office.

Upon motion made by Frank E. Garvin, Voted to take up Article 3, To chose a Delegate to the Constitutional Convention.

Upon motion made by Frank E. Garvin, Voted to adjourn for one-half hour.

Upon motion made by Mary L. Bunten, Voted that the Clerk be instructed to cast one vote for Jerrie J. Sampson, for Trustee of Trust Funds for three years.

The Clerk then cast one vote for Jerrie J. Sampson, who was declared elected.

Upon motion made by Frank E. Garvin, Voted to instruct the Moderator to cast one vote for Alice M. Hadley, for Library Trustee for three years.

The Moderator then cast one vote for Alice M. Hadley, who was declared elected and in open meeting took the oath of office.

Upon motion made by Louis D. Holcombe, Voted that the remaining Town Officers be chosen by acclamation.

Chose for Auditors—David Story, Earle H. Stone.

Chose for Constable—Walter C. Blackman.

Upon motion made by Walter Gould, Voted that the Selectmen be instructed to appoint such other constables as they may see fit.

Chose for Fence Viewers—Weston P. Lord, Louis D. Holcombe.

Chose for Sextons—John Bunten, Center Cemetery.
 Ralph Walker, North Cemetery.
 Perley E. Warriner, East Cemetery.

Chose for Surveyors of Wood and Lumber—Walter C. Blackman, Abraham L. Burnham, and John W. Far-
 rar.

ART. II. Upon motion made by Frank E. Garvin, Voted to raise and appropriate \$2,925, to defray town charges for the ensuing year.

ART. IV. Chose for member of Town Forest Committee:

For three years, Abraham L. Burnham.

For two years, Mary C. Barnard.

For one year, Dane Ireland.

ART. V. Upon motion made by Alfred Earle, Voted to raise and appropriate \$2,150.39 for Town Highways.

ART. VI. Upon motion made by Reginald Crosby, Voted to accept State Aid Construction, and raise and appropriate money for the same.

Upon motion made by Walter Gould, Voted that the Town and the State co-operate on building the State Road from Burnham's corner to the Bow line.

Upon motion of Weston P. Lord, Voted that this road construction be completed on or before October first, 1930.

ART. VII. Upon motion made by Frank E. Garvin, Voted to accept State Aid Maintenance, and raise and appropriate the amount of money required for the same.

Also, that the Town appropriate \$1,000 from the funds in the Treasury to pay the sum of \$1,000, voted for State Aid Maintenance at the last Special Town Meeting.

ART. VIII. Upon motion made by Philander M. Lord, Voted to pass over the article.

Upon a division of the house, 35 voted no; 42 voted yes.

ART. IX. Upon motion made by Philander M. Lord, Voted to instruct the Selectmen to paint the Town Hall.

Upon motion made by Uru M. Waite, Voted that money be appropriated from funds in the treasury to cover the expense of painting the Town Hall.

ART. X. Upon motion made by Iru M. Waite, Voted that the Selectmen be instructed to combine the fire house and tractor shed and provide heating facilities for the same, and raise and appropriate the sum of \$300 for that purpose.

ART. XI. Upon motion made by Frank E. Garvin, Voted to raise and appropriate \$25 for Memorial Day.

ART. XII. Upon motion made by Frank E. Garvin, Voted to raise and appropriate a sum equal to \$55 for the support of the Library.

ART. XIII. Epon motion made by Louis D. Holcombe, Voted to raise and appropriate \$250 for the care of cemeteries—\$50 for East Cemetery, \$100 for the Center Cemetery and \$100 for the North Cemetery.

ART. XIV. Upon motion made by Frank E. Garvin, Voted to raise and appropriate \$400 for the control of the White Pine Blister Rust.

ART. XV. Upon motion made by Harold L. Burnham, Voted to convert the Huard lot into a Town Forest.

ART. XVI. Upon motion made by Louis D. Holcombe, Voted that the reports as amended by the Selectmen be accepted.

Vote for Delegate to the Constitutional Convention:

Whole number of votes given in—44.

Charles A. Little had 1 vote.

Eugene S. Tucker had 1 vote.

STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Dunbarton, in the County of Merrimack, in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Dunbarton on Tuesday, the tenth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.
3. To see if the Town will vote to raise and appropriate for town highways a sum equal to forty-five cents on each one hundred dollars assessed valuation of 1930.
4. To see if the Town will vote to accept State Aid construction and raise and appropriate money for the same.
5. To see if the Town will vote to accept State Aid maintenance, and raise and appropriate money for the same.
6. To see what action the Town will take to repair and preserve the Town Common and raise and appropriate money for the same.
7. To see how much money the Town will vote to raise and appropriate for Memorial Day.

8. To see if the Town will vote to drill an artesian well on the Common for Town Hall water supply and raise and appropriate money for the same.

9. To see if the Town will vote to remove the box heating stove in the lower hall and replace it with an electric hot plate and raise and appropriate money for the same.

10. To see how much money the Town will vote to raise and appropriate above the amount required by law for the support of the library.

11. To see how much money the Town will vote to raise and appropriate for the care of cemeteries.

12. To see if the Town will vote to raise and appropriate money for the control of White Pine Blister Rust.

13. To see if the Town will vote to make any additions or improvements to the Town Hall, and raise and appropriate money for the same.

14. To see what action the Town will take towards extending electric light lines and raise and appropriate money for the same.

15. To see if the Town will vote to tar a piece of Class V highway and raise and appropriate money for the same.

16. To see if the Town will vote to buy a gasoline water pump for fire protection and raise and appropriate money for the same.

17. To see if the Town will vote to buy a truck and raise and appropriate money for the same.

18. To see if the Town will vote to buy a snow scraper blade for use with truck and raise and appropriate money for the same.

19. To see if the Town will vote to use the Australian Ballot System in voting hereafter for its Town officers.

20. To see what action the Town will take relative to selling snow rollers.

21. To hear reports of Agents, Auditors, and other officers heretofore chosen, and pass any vote relating thereto.

22. To transact any other business that may legally come before this meeting.

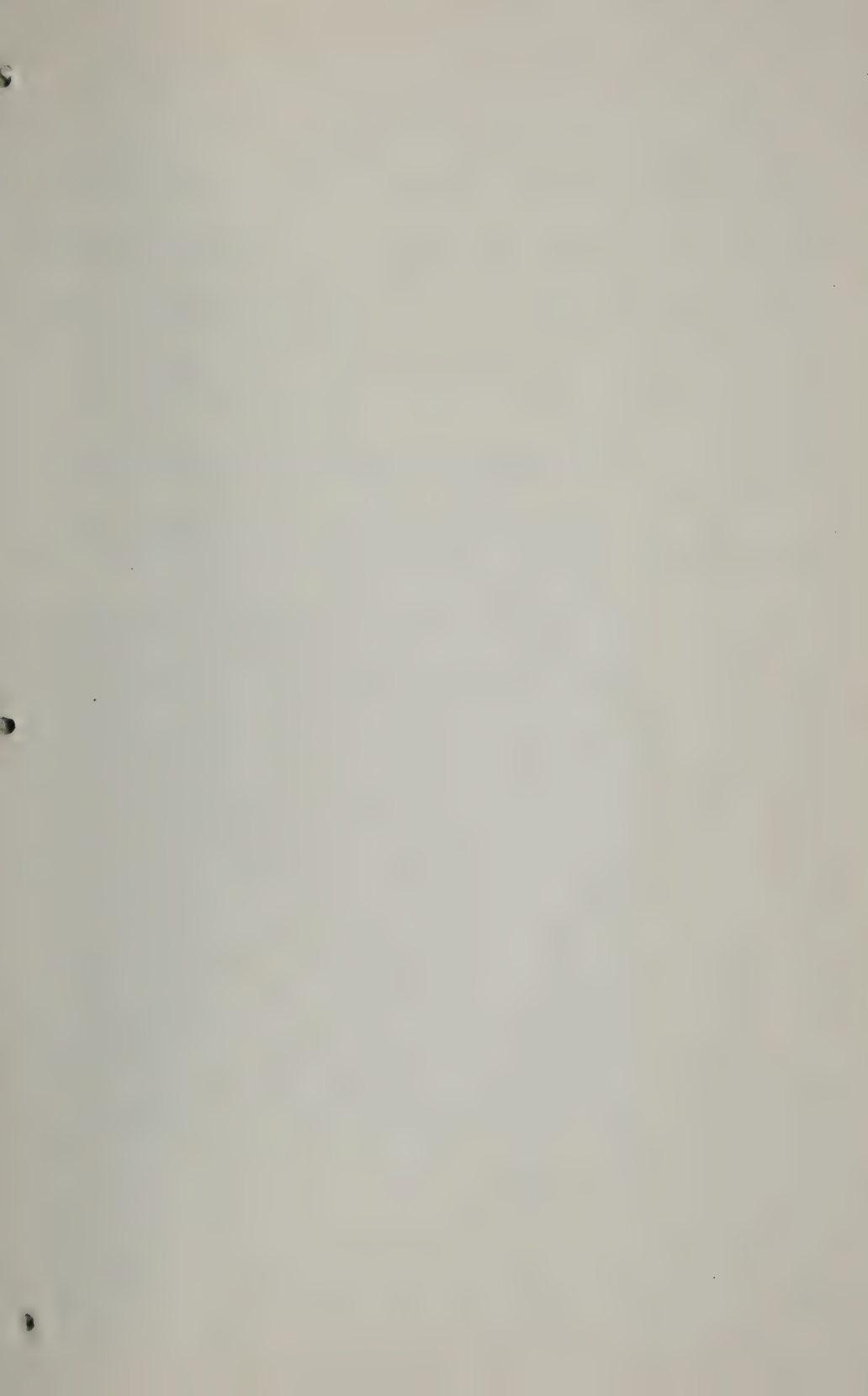

Comparison of the preceding table of statistics with last year's report will show that while the state average of attendance is on the increase, Dunbarton's average dropped almost one per cent since the year before. The three smaller schools—Burnham Hill, South Dunbarton and Waite—still showed an average for 1929-1930 that is better than that of the state as a whole.

In the matter of tardiness, Burnham Hill had the best record. Our town has no cause to be proud of the fact that we have two and one-half times as many tardinesses as the average for the entire state. Parents can be very helpful by co-operating to decrease the number of tardinesses in our schools, and helping to develop in our children the desirable habit of being on time.

CHANGES IN SCHOOL POPULATION AND SCHOOL CALENDAR

The Burnham Hill School is closed this year because there are too few pupils in that neighborhood to warrant the maintenance of a school. The children are transported from that district to the Centre School.

By vote of the school board, the recommendation made last year for a longer school year was adopted. The present school year will consist of 180 school days. A visiting day for a teacher, or a day spent at a teacher's institute, are counted by a teacher as a school day; other holidays are not so counted.

OUR SCHOOL BUILDINGS

During the past summer, the Centre School building has been thoroughly remodeled. The old chimney being defective, a new one was built. Additional windows were put in on the left of the pupils, and a portable blackboard built in such a way as to shut off the direct light from the right of the room. No windows, however, were removed. A new ventilating heater, which works on a principle similar to a one-pipe furnace or "Heatrola," has replaced the worn-out stove. A steel

ceiling, painted white, and buff-colored walls, help make the room light. Separate entrances to boys' and girls' toilet rooms have been built. New shingles on the roof completed the job.

COMMUNITY CO-OPERATION

The people of Dunbarton, both individually and through their organizations, have always shown a commendable spirit of willingness to co-operate with school teachers and authorities. The Dunbarton Community Club shows a great deal of interest in the work of the schools, and deserves especial thanks for its annual award of one dollar to the pupil who shows the greatest improvement in each one of our schools. In the South Dunbarton district, a Parent-Teacher Association has recently been formed, which in many helpful ways is showing itself to be a live organization.

A REVISED STATE PROGRAM OF STUDIES

During the past summer a new edition of the "Program of Studies for the Elementary Schools" was issued by the State Board of Education. This volume of nearly 500 pages is the work of committees of teachers and superintendents, who have worked diligently for more than a year to complete this important task. The principal changes made by the program are as follows:

a. *More emphasis on reading.* The 1921 program of studies stated that most children have become independent readers by the end of grade III, and gave little or no emphasis to formal instruction in reading beyond that point. It is now recognized that further instruction for most pupils is necessary. Training in silent reading as well as oral reading is emphasized.

b. *Less arithmetic for the first two grades.* Certain processes with numbers that seem very difficult for young children are mastered with comparative ease by pupils who are a little older, and whose minds have developed to a point where they can understand such problems. It seems good judgment to

postpone the more formal number work until the minds of the pupils are mature enough to grasp it successfully.

c. *More American history, and less European.* There was a time when stories of American history were taught in almost every grade, and this plan resulted in much tiresome repetition. In order to avoid this, the 1921 program assigned to Grades 5 and 6 stories of Hebrew, Greek, Roman and English history. While there is much valuable material in this field, experience has shown that two years of work upon it was too much time, and that one year is probably sufficient. In the new program, the fifth grade is given stories of our own country. The sixth grade studies the European background of American history, and this serves as a basis for a more thorough understanding of our country's development as studied in the seventh and eighth grades.

d. *More definite standards or goals in each subject.* Throughout our new program, there are helpful suggestions for teaching different subjects effectively. There are also many specific statements as to the degree of mastery expected in each grade. Both of these features should be of help to teachers in securing a higher quality of work on the part of their pupils.

e. *Particular reference to the needs of the rural teacher.* Teaching a rural school has a technique all its own. A teacher who can do a splendid job of teaching in a city school may find herself quite at a loss in a one-room school with six or more grades. It is encouraging to find this fact recognized by the authors of our new program of studies, and to find many helpful suggestions advanced for the use of the teacher in a rural school.

RECOMMENDATIONS FOR THE COMING YEAR

1. *Visit school one or more times each year.* All parents are urged to call at the school which their children are attending, for at least half an hour at some time during the year. We are always glad to welcome parents and neighbors

at our schools. Their visits help in many ways, especially by developing a better understanding between parents and teachers.

2. *Improved attendance and less tardiness.* It is manifestly a waste of money to pay a teacher to teach children, if the children are not there to learn. No excuse other than ill health should keep a child from school a single day. Furthermore, the habit of being late, which many of us adults have formed, ought not to be encouraged in our children. Parents, by taking care, can prevent much of the absence and tardiness which mar our records each year.

3. *Continued improvement of school buildings.* For three years now, the district has followed the commendable practice of doing its repair work in a thorough and permanent fashion, concentrating on certain schools that seemed most in need of improvement. This method of working should be continued. This summer there seems to be no buildings in need of as expensive a job of reconstruction as the Burnham Hill and Centre buildings have required. Separate entrances to the toilets at South Dunbarton should be provided, and this can be done at small cost. New seats, and certain minor improvements, are desirable for the Waite school.

CONCLUSION

Grateful acknowledgment is here made of the cordial co-operation of school board members, teachers and other citizens of Dunbarton. Let us continue to practice the motto, "Work together for the good of the children."
