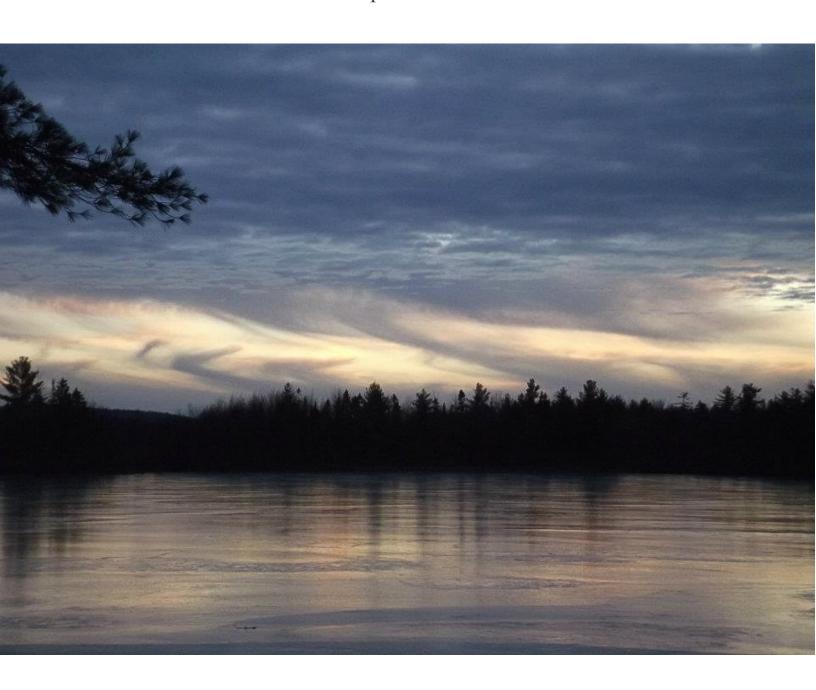

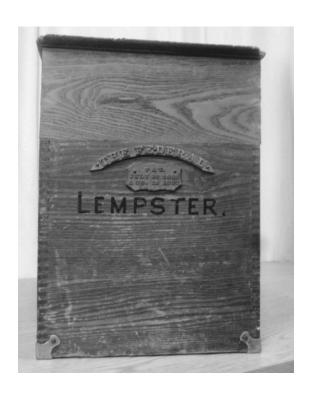

Commemorating the 100th Anniversary of NH Presidential Direct Primary

During the January 1891 session, the New Hampshire legislature passed an act requiring the use of secret ballots, also known as "Australian" ballots, because they were first used in that country.

"To enforce the secrecy of the ballot," the law said, the Secretary of State among other things was to prepare and print all ballots at public expense, and "provide every city and town with a <u>ballot-box</u> for use at each polling place."

Ballot boxes were therefore ordered constructed and delivered by Secretary of State Ezra Stearns of Rindge to the then 272 voting places in New Hampshire in time for use in the November 8, 1892 presidential election. These boxes were each constructed to include a counting device with a hand-crank and a bell to signal each ballot cast.

Town of Lempster, NH. Board of Selectmen's – Annual Report 2016

We have all heard the commonly spoken of beginnings of Lempster from many sources. I would like to relate some not so well known facts and concepts of the early years of the Town of Lempster. In order to do this I will draw on the thoughts of Dorothy Hathaway of our own town. She prepared an extensive dissertation about Lempster while attending Dartmouth College titled "Good Men and True Women".

- Lempster had a rough start. In 1735, 1753, 1761, 1767 re-grant after re-grant of the land occurred. By 1770 only eight families settled here, therefore, another charter extension occurred. The first census was taken in 1790, there were 416 residents. The population continued to rise and in 1830 had risen to 999.
- Those living here were trying to farm in what has been described at best as "difficult". The lands
 were rocky and not very fertile. Some of the inhabitants developed multipurpose farms and
 small enterprising businesses.
- Since this report comes out in the year of 2017 I would like to mention that there are plans for a
 yearlong series of activities. If this bit of history has sparked some interest, then seek out more
 in the months to come from those who really know the story.

2016 Town Highlights

- The Board of Selectmen acting as the Emergency Management Director brought together all department heads to review and up-date the Local Emergency Operations Plan. This is required every five years to enable the town to apply for grants as well as being prepared for emergencies. The Board is still looking for a volunteer to fill this position.
- The Town Office Building underwent a face lift this past year. Everett Thurber did a wonder job
 in refurbishing the medallion on the back of the Town Office. The fact that we had House of
 Correction workers and our Highway Department doing the paint work we saved many dollars
 in the process. A thank you goes out to Gregg Lynch for voluntarily doing the majority of the
 prep work to make the painting possible.
- Mountain Road was totally rebuilt; new culverts, ditches, signage and line painting this year.
 The work makes for a smooth ride, better run off control, easier plowing and makes it safer for years to come.

Auditor's Report

The 2015 Auditor Report, required by the state each year, was completed and returned to DRA in April of 2016. Each section of the report was accepted without issue by DRA. Once all of the 2016 data is available, I will meet with the individuals responsible for the six areas to be covered in the town auditor report. There is a separate section of the report pertinent to the general ledger, treasurer, tax collector, trustees, town clerk and library. The final report will be completed and returned to the Department of Revenue Administration by April 1, 2017.

All Town purchases must have the original signed invoice accompanying the town's payment stub. This is required by NH law. I take the time to check each purchase to make sure that a physical document is filed with the record of payment. The practice of attaching the original signed invoices is important for making sure Town money is being spent appropriately and identifies the person responsible for the purchase. Each department head is responsible for approving all department expenditures. To the extent possible the purpose of the expenditure is noted; for example, a part for a specific town truck. Over the past several years, the departments have done an exemplary job providing the necessary documentation for purchases.

An accurate inventory of all town equipment and property is necessary to comply with statutes. Each department is responsible for the department's respective inventory. It is important to have updated files for insurance purposes; in case of a fire or theft as well as clearly identifying what equipment each department is responsible for. The matter of accurate inventory was discussed in 2014 again in 2015 and the town has continued to improve on this practice. Establishing a consistent town practice for each department is the goal.

The employees responsible for receiving funds, handling funds and paying town expenses are doing so efficiently and are complying with State RSA's. Records of receipts and expenditures are being accurately recorded by town employees.

Lempster Fire Department Annual Report

The Lempster Fire Department continues to provide the town with the best service that we can. We strive to do this with training, pride and ownership of what we do day to day. We continue to train twice a month, with one EMS training and one Fire training. The Fire and Rescue meet every Wednesday to maintain the equipment and vehicles, train, and also maintain the fire station.

The Fire Department members pride themselves on dedication and this year we recognize someone that exemplifies this. David Loring has served for 33 years and continues to serve in a lesser and well deserved capacity as a Life Member. Davey joins Phil Tirrell and Barbara Chadwick on this List. Thank You Davey!

In the last year, the members have worked hard to keep their skills sharp and knowledge of an ever changing world of hazards and new techniques. The members achieve this through outside sources and a committed training officer in Deputy Chief Langlois. Another program the fire department is implementing is a "cancer awareness" program. This is to try to reduce carcinogens in certain areas of the station and also stop the men and women from bringing them home to their families. This is achieved by isolating areas of the station and some easy personal hygiene measures.

The Fire Department has also worked hard to find every avenue to provide the town with the best equipment possible and also replace equipment in a reasonable manner. Lempster Fire has placed a grant application in to assist with replacing the hydraulic auto extrication tools, as well as the air bags used for lifting. These pieces of equipment are 20 years old and with the new vehicle construction they work hard and slow to gain access to a patient. If the town is fortunate enough to get this grant, 95% will be paid by the grant and only 5% will be the responsibility of the town.

The men and women of the Fire Department continue to get out in the public. The members enjoy the social events such as the Pancake Breakfast and other dinners held at the fire house. The crew also enjoys educating the public on fire safety. This is achieved at courses and on calls to residents homes. The men and women take pride in assisting a service that is top notch; this can be something so small like changing an elderly couples smoke detector batteries at a medical call. The crew also continues to provide a fire safety program at the Lempster Community School for grades K-4.



This past year the crews were busy answering the calls for service, in total we ran 174 calls. This is roughly an 8.5% increase over last year. 75 medical, 9 building fires, 5 chimney fires, 3 vehicle fires, 20 MVA, 6 MVA w/ extrication, 13 brush fires, 8 unauthorized burns, 13 trees/wires, 6 cover assignments, 2 fire alarms, 2 haz-mat, 2 search and rescue, and 10 service/ other calls. As always the goal when we are out on or returning from a call is to return all members home safe. We strive to provide the community with the best service we can and we all thank you for your continued support!

2016 Forest Fire Department Report

It was another dry year with plenty of brush fires. In 2015 when we had a major fire in a hard to reach area we were assisted by many of our neighboring towns. The lack of snow and the drought made this year worse! This year we were the ones to assist our neighboring towns. Again most of the brush fires were day time when it is hard to find fire fighters able to leave work to fight fire. We sent brush fire crews and equipment to the two Stoddard fires, two in Goshen, one in Marlow, and a couple in Newport, and four in Alstead. One of the brush fires in Alstead involved a building and a long run for water with many tankers. We were three days in Acworth on Gove Hill with one of the inaccessible, super dry, dig it out type of fires!

The rest of the equipment planned for the brush truck last year that we didn't have the money for due to the big expense fire, was purchased this year. Other needed items that we realized we didn't have and should, were obtained with the matching grant we received. This has made the brush truck very usable!

The UTV has become a very valuable piece of equipment, in that it is a smaller sized unit that will go in further on smaller trails than the truck. Between the two of them, it has cut down on a lot of the inaccessible areas.

Being retired, I am available during the day. However, being old enough to retire means things don't move as well as before and I can't do as much for as long! I have moved down to a deputy warden, with my son David taking over the Warden position. Over the years he has taken a lot of the brush fire training, and has the experience of growing up in a family that has been involved in firefighting. I will continue doing what I can. I will still be writing fire permits. This year we have written over 158 permits, almost half of them seasonal, and not one of them needed the Fire Dept. to bring it under control, unlike some of the illegal ones!

Brush fire permits are only good after 5 PM until 9 AM unless it is raining. Permits are still needed in the rain. When there is good snow cover, permits are not needed but dispatch should be notified when burning. Permits can be obtained online at nhfirepermit.com. This will involve a convenience fee or can be obtained from the Warden David Richards, Deputy Warden Jim Richards, Fire Chief Jon Thomas, or Barbara Richards at no charge.

The Sullivan County Sheriff's Office has completed our 9th year of service to the Town of Lempster. The Town is currently being served by four deputies that provide service at various times throughout the week. Chief Deputy Jeremy Wilson, Sergeant Michael Batista, Deputy Justin Merrill and Deputy Glen St. Amant are the deputies assigned to patrol the town. All of them are full-time certified and trained. They also have a significant amount of experience in Law Enforcement which I believe allows us to provide a very professional service to the town.

The Claremont Dispatch Center received 604 calls for service in 2016 which is a decrease from 2015. While the town experienced a number of years with an increased call volume it is nice to see the trend going the other way. This is especially gratifying considering the trends our nation has seen over the last couple of years.

Many issues in the community can be complex. These issues often include difficulties with family, finances, and more often drugs. Many issues such as these can take a significant amount of time and planning to resolve. Some community issues can be more easily resolved. In the past year, we received a large number of calls for traffic accidents. Most of these accidents were caused as a result of either wildlife or the weather. We recognize that each traffic accident is significant in its own right, but many are easily preventable. We urge everyone to please slow down, recognize danger signs and drive accordingly.

We also saw a large number of animal complaints. These are issues that can take a significant amount of time to resolve, but are very easily prevented. Generally, NH law does not allow for most animals to be free roaming. NH law also allows victims of free roaming at-large animal's compensation for damages to their person or property. Please be sure to keep your dogs and other animals on a leash or make provisions that will prevent them from leaving your property. Taking a few simple steps can prevent property damage, personal injury and legal ramifications.

The Sheriff's Office continues to make strides at becoming the best we can be. In 2016 we took custody of a new fleet of cars, we began working on and continue to update our policy manual, and all of our patrol deputies have become certified to administer NARCAN.

We are grateful for the opportunity to serve the citizens of Lempster and I appreciate both your support and assistance.

ARTICLE 19: To see if the Town will vote to raise and appropriate the sum of \$30,000.00 to be added to the Town Bridge Repair and Reconstruction Expendable Trust (CIP 018) previously established. The Selectmen recommend this appropriation. (Majority vote required)

Motion: Mrs. Grenier Second: Mr. Sauer Mr. Thurber indicated two bridges that would be requiring attention this year. (Mountain Rd over the Ashuelot and Crescent Lake Rd over Cold River) Article 19 passed by show of hands.

ARTICLE 20: To see if the Town will vote to raise and appropriate the sum of \$25,000.00 to be added to the Town Highway Equipment Capital Reserve (CIP 026) previously established. The Selectmen recommend this appropriation. (Majority vote required)

Motion: Mr. Sauer Second: Mrs. Grenier Article passed.

ARTICLE 21: To see if the Town will vote to raise and appropriate the sum of \$50,000.00 to be added to the Road Repair and Reconstruction Capital Reserve (CIP 048) previously established. The Selectmen recommend this appropriation. (Majority vote required)

Motion: Mr. Sauer Second: Mrs. Grenier Article passed.

ARTICLE 22: To see if the Town will vote to raise and appropriate the sum of \$14,250.00 for the purpose of the fourth payment of the lease-purchase of the Highway Department Backhoe (CIP 049). The Selectmen recommend this appropriation. (Majority vote required)

Motion: Ms. Richards Second: Mr. Sauer Article passed.

ARTICLE 23: To see if the Town will vote to raise and appropriate the sum of \$1,000.00 to be added to the Transfer Station Equipment Capital Reserve (CIP 021) previously established. The Selectmen recommend this appropriation. (Majority vote required)

Motion: Mrs. Grenier Second: Mr. Thurber Article passed.

ARTICLE 24: To see if the Town will vote to raise and appropriate the sum of \$1,000.00 to be added to the Landfill Closure Capital Reserve (CIP 022) previously established. The Selectmen recommend this appropriation. (Majority vote required)

Motion: Mrs. Grenier Second: Mr. Thurber Article passed.

ARTICLE 25: To see if the Town will vote to raise and appropriate the sum of \$1,000.00 to be added to the New Cemetery Capital Reserve (CIP 023) previously established. The Selectmen recommend this appropriation. (Majority vote required)

Motion: Ms. Stamatakis Second: Mr. Wirkkala Article passed.

ARTICLE 26: To see if the Town will vote to raise and appropriate \$12,900.00 to remove three trees in the cemetery. The Selectmen recommend this appropriation. (Majority vote required)

Motion: Ms. McGinnis Second: Ms. Stamatakis Ms. Stamatakis, Cemetery Trustee, spoke about the need to remove three large trees that are in danger of damaging stones in the oldest part of the East Lempster Cemetery. She reviewed the efforts of the Trustees to find the most economical option for the trees removal that would have the least negative impact on the stones and plots. She answered several questions from the audience. Article 26 passed by show of hands.

ARTICLE 27: To see if the Town will vote to raise and appropriate the sum of \$2,500.00 to be added to the Cemetery Tree Management Capital Reserve (CIP 047) previously established. The Selectmen recommend this appropriation. (Majority vote required)

Motion: Ms. McGinnis Second: Mr. Wirkkala Ms. Stamatakis indicated that additional tree work would be needed in the Cemetery. Article passed.

ARTICLE 28: To see if the Town will vote to discontinue the following Capital Reserve Funds. Said funds, with accumulated interest to date of withdrawal, are to be transferred to the municipality's general fund. (Majority vote required) Forest Fire Truck Capital Reserve (CIP 005) and Fire Pumper Capital Reserve (CIP 008).

Motion: Mr. Thurber Second: Mrs. Grenier Mrs. Richards indicated that there was a total of \$4.31 to be transferred from the two CIP accounts. Article passed by voice vote.

ARTICLE 29: To see if the Town will vote to establish a Special Forest Maintenance Fund under the terms of RSA31:113 with 10% of funds from Timber Harvest of the Town Forest, up to \$5,000.00, going into the fund and the remainder going into the Town's General Fund. (Majority vote required)

Motion to amend: Mr. Sauer Second: Mrs. Grenier The amendment is to be as follows: <u>To see if the Town will vote to establish a Special Forest Maintenance Fund under the terms of RSA31:113 with 100% of funds from Timber Harvest and other agricultural endeavors of the Town Forest going into the Special Forest Maintenance Fund. The motion to amend was passed by a show of hands. Questions as to why a special fund needed to be established were addressed by the Selectboard. Article 29, as amended, was passed by a show of hands</u>

ARTICLE 30: To see if the Town will vote to raise and appropriate the sum of \$29,945.00 for the purpose of repairing the rafters and painting the Miner Memorial Library with said funds to come from an LCHIP grant for this purpose. This special warrant article will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the rafters and painting is completed or by December 31, 2021, whichever is sooner. The Selectmen recommend this appropriation. (Majority vote required)

Motion: Mrs. Grenier Second: Mr. Tremblay Article passed.

ARTICLE 31: To see if the Town will vote to raise and appropriate the sum of \$1,000.00 for the purpose of supporting Old Home Day events. The Selectmen recommend this appropriation. (Majority vote required)

Motion: C. Richards Second: Mr. Tremblay Article passed.

ARTICLE 32: Shall the Town modify the provisions of RSA 72:9-a for elderly exemption from property tax in the Town of Lempster, based on assessed value, for qualified taxpayers, to be as follows: for a person 65 years of age up to 75 years, \$40,000.00; for a person 75 years of age up to 80 years, \$60,000.00; for a person 80 years of age or older, \$80,000.00. To qualify the person must have been a New Hampshire resident for at least 3 consecutive years; own the real estate individually or jointly, or if the real estate is owned by such person's spouse, they must have been married to each other for at least 5 consecutive years. In addition, the taxpayer must have a net income of not more than \$18,000.00, or if married, a combined net income of not more than than \$26,000.00;, which includes social security and pension payments; and own net assets not in excess of \$70,000.00 excluding the value of the person's residence. (Majority vote required)

Motion: Mrs. Grenier Second: Mr. Thurber The Selectboard pointed out that the only change being made to the established Elderly Exemption Credit is to increase the income limits to \$18,000 for single and \$26,000 for married taxpayers. Town Clerk, Gayle Newton, indicated that Mrs. Richards, Deputy Clerk, had surveyed other towns in the area to determine what income limits were used for their Elderly Exemption Credits. The results showed that Lempster's were lower in comparison. Article 32 passed by a show of hands.

ARTICLE 33: To transact any other business that may legally come before this Town Meeting.

Motion to adjourn: D. Richards Second: C. Richards Motion to adjourn passed.

- Two lot subdivision of property owned by David L. Stewart, Sand Pond Road and Huntley Road (Map 246, Lot 004 and Map 247, Lot 036) (March);
- Merger of Lots of Record of property owned by Darryl and Terrie Waterman, 104 Charlestown Turnpike (Map 225-17, Lot #2 and 225-18, Lot 4) (April);
- Lot line adjustment of property owned by Gary and Cara Cote, Hurd Road (Map 223, Lot 039 and 040) (June);
- Major subdivision (three lot subdivision by virtue of road requirements) and annexation of property owned by Keith and Della Fulton, Brown Road (Map 227, Lot 7 and Map 232, Lot 25.011) (September);
- Major subdivision (two lot subdivision but major due to a multiple subdivision within a five year period) of property owned by Robert Simino and located on Lempster Street and Keyes Hollow Road in Lempster, N.H. (Map #213, Lot #22.1) (December).

Cemetery Trustees

The Cemetery Trustees are responsible for the care and maintenance of the town cemetery, located behind the Town Offices on the corner of Route 10 and the 2nd NH Turnpike. The Trustees assist family members who are interested in having a loved one interred at the cemetery and help coordinate arrangements for burial. The Cemetery Trustees actively promote a tradition of stewardship of the cemetery within the community and appreciation of its cultural and historical significance.

The Cemetery Trustees have been focusing for several years on the need to remove large and decaying trees in the cemetery that pose a risk of causing extensive damage. In the past, damage and displacement of gravestones has been caused by large root systems, and falling limbs and trees have been a concern. The Trustees are very grateful that in 2016 the voters allocated funds through a warrant article to enable the removal of three trees that were the highest priority. This work was accomplished in May. County Forester Dode Gladders has provided advice and guidance to the Trustees on past and future tree maintenance needs.

The Highway Department has provided routine maintenance in the cemetery, and has shown exceptional care and commitment in its work. The Trustees would like to express their appreciation to the Selectmen and Highway Department for their ongoing commitment and support.

The Trustees retained Stone Vault of Newport to repair or restore numerous stones. The Trustees consulted with Gardiner Stetson of GK Stetson Blacksmiths about options to restore cast iron fencing that has fallen down or fallen apart in places. A plan is being developed to restore the fencing in stages.

The Trustees worked on revisions to the cemetery regulations and consulted with the Selectmen on several details. Revised regulations were adopted in September. Copies are available online at http://lempsternh.org/PolicyFormFees.html or at the Town Office.

The Cemetery Trustees are actively involved in the planning for the Town's 250th anniversary, and plan to develop a program relating to the cemetery.

In May, Sue King, 4th grade teacher at the Lempster Community School, brought her students to the cemetery to place flags on the graves of veterans, as she has done for many years. This was the first year that the group consisted entirely of Lempster students. Many townspeople showed up to greet the students and talk about Town history.

The Trustees worked with the Selectmen to have the picket fence in the cemetery painted. About two-thirds of the fence was painted this year and the rest will be finished in 2017. Thee Trustees planted geraniums around the Civil War monument. The Trustees also put up a sign to discourage people from riding horses in the cemetery.

The Cemetery Trustees were saddened to learn of the death of Larry Johnson. Larry had generously donated to the Cemetery Trustees and the Historical Society volumes of notebooks he created over many years with photographs of graves, locations and other information.

The Cemetery Trustees usually meet the third Monday of the month at 4:00 at the Town Office.

LEMPSTER CONSERVATION COMMISSION

2016 was a year for the Lempster Conservation Commission (LCC) to look to future years and plan activities to embrace our natural resources and environment. Highlights included organizing the annual plant sale, a road-side clean-up day and trail clearing at Duck Pond.

For roadside cleanup, we tackled Mountain Road from Route 10 to the Town Line and included Lovejoy Road and 2nd NH Turnpike from the Meeting House to Route 10. Over 96 large garbage bags were filled compared to 2015 of 49 bags. This occurred on April 30th. This year we were supported by families of the Parent Teacher Group representing the Lempster Community School, the Ladies Auxiliary of the Lempster Fire Department and the LCC appreciate their support! We thank other residents in Lempster who regularly maintain other sections of roads and streets. Please do **YOUR** part to help keep litter off the sides of our roads!

The LCC annual plant sale was well attended on May 21, along with held over plants on May 28 at the Historic Society "Yard Sale". We raised over \$700.

The LCC was again able to contribute generously to the control of invasive pond weeds. Donations of \$2000 were given to the Long Pond and \$1500 to Sand Pond's individual Lake Host programs. This money is sent to NH Lakes Association for distribution to paid hosts at each lake. If you use either or both lakes, please consider signing up as a volunteer or inquiring about becoming a paid lake host. For 2017, we will require reporting standards in compliance with LCC guidelines for future considerations for funding.

The LCC supported, in conjunction with the Friends of the Miner Memorial Library, a VINS program presentation on "Birds of Prey" during Old Home Day. This event was well attended with standing room only, and people were visibly impressed!

During Old Home Day weekend, a trail walk at the Indian Cave was well attended and we are thankful for the Lewis Allen Family hosting this event, held at their request every ten years. This was held on Sunday morning, August 14th prior to the Boy Scouts Luncheon and attended by 26 people. Geologist Walter Beckworth, in a report to the Town sometime before 1960, stated that the "Oldest land in the world is in Lempster." We natives and residents may still speak of "Old Lempster" in the deepest reverence.

The LCC are involved with the plans and celebration for Lempster's 250th anniversary. We plan to provide a print map of open hiking trails within the town which are open to the public. The LCC is working on a new trail plan for the Long Pond Town Forest.....stay tuned!

During October the LCC met with Ellen and Foote Stetson to learn of their concern with beaver activity along Grandview Road, abutting their property. Their request was to offer a solution from the common cure.....trap them. Their recommendation was for installing a system inspired and designed by Skip Lislse of "Beaver Deceivers" of Grafton, Vermont. The installation will control the water levels, prevent flooding of Grandview and protect the ecological resources beavers maintain. In November, the LCC agreed to provide 50% of the cost and the Stetson's provided the remaining 50%.

Future activities include: evaluating the apple orchard and pruning off Earls Lane. Once completed, the orchard will be open to the public and residents of Lempster for PYO.



The LCC urges anyone with an interest in helping our town conserve our wonderful resources and would like to be involved, they are encouraged to make themselves known to a member, or anyone in the Town Office.

Lempster Historical Society Report for 2016

2016 turned out to be another interesting and busy year for The Lempster Historical Society, as we worked to preserve and present Lempster History.

Our home base is History Hall which was the former Methodist Church and this year we made some significant repairs and restoration work there. We hired Alan Chandler at Colonial Carpentry to repair and restore the front entrance to History Hall and that was accomplished in time for it to be looking good for Old Home Day. We also asked Alan to repair and restore the rear cellar entrance to the building and that was completed in September. Photographs of this work can be seen in the Fall 2016 Edition of The Historian Newsletter.

Bill Murgatroy installed solar lighting on the west side of the building for improved safety at night meetings. We hired Jason Fulton to grade the lawn on the east side of History Hall to improve water drainage away from the building.

In addition to these improvements, we hired Gerard Leone of Slate and Copper Roofing to do a concentrated review of the roof which resulted in the replacement of about 300 slates.

Our other building is the Dodge Hollow Schoolhouse and this was painted this summer by Roy Malool's Company based in Newport. Roy donated this service to us which was much appreciated.

We put on two presentations at History Hall: "The Battle of Culp's Hill" presented in March by Gary Ward and "The Cougar Returns to the East"; presented in July by Susan Morse.

In August we supported and planned Old Home Day activities and co sponsored a hike to Indian Cave with the Conservation Commission.

Historical Society Member, Bill Murgatroy, designed the Commemorative Medallion for Lempster's Sestercentenial Celebration and he also wrote a book entitled <u>The Missing Mapmaker</u> which was written for the Celebration. It can be purchased at LHS events, on line at Amazon, at Violet's Book Exchange in Claremont and by contacting Bill in Lempster.

The Society received a major historical input when David and Kate Strachan brought boxes of historical papers to us for the archives. The donation included over 400 items; photos, letters, journals, and ledgers pertaining to the Butler Family and businesses in Lempster in the 1800's.

Sadly, we lost one of our members in 2016 with the passing of Lauri Johnson. Over a number of years he spent many days of research in the Lempster Cemetery creating records to show who is buried there and where the graves are located. He also compiled many note books full of Lempster History with much of it showing his research on the Nichols and related families. His estate gave all of his research, including 24 notebooks and boxes of papers, to the Historical Society. We will be spending many hours filing and storing this huge lot of Lempster History.

Looking ahead to 2017 we are planning to repair and paint the steeple at History Hall and we would also like to get the external wood trim painted. These projects and others we'll get involved in cost money and we will gratefully accept donations to help us with the costs.

The Lempster Historical Society is a 501 (c) (3) organization and all donations are tax deductible for the donor. The Society is not supported by Town Taxes.
