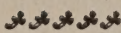

THE STATE OF NEW HAMPSHIRE**To the Inhabitants of the Town of Francestown in the County
of Hillsboro in Said State, Qualified to Vote in Town
Affairs**

You are hereby notified to meet in Town Hall in said Francestown on Tuesday, the thirteenth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation of the same.

3. To see how much money the town will vote to raise for the observance of Memorial Day or take any action relating thereto.

4. To see if the town will vote to raise and appropriate money necessary to secure State Aid for the permanent improvement of highways.

5. To see if the town will vote to raise and appropriate the sum of twenty-five dollars, the amount necessary to secure State Aid for the maintenance of town's State Aid highway.

6. To see if the town will vote to raise and appropriate the sum of fifty dollars towards defraying the expenses of the Oak Hill Grange fair or take any action relating thereto.

7. To see if the town will vote to authorize the Selectmen to borrow a sufficient sum of money to pay current expenses in anticipation of taxes.

8. To see if the town will vote to raise and appropriate a sum of money sufficient to purchase a new sidewalk snow plow or to take any action in relation thereto.

9. To see if the town will vote to raise and appropriate the sum of thirty five dollars for payment of annual interest on Woodbury fund note for current year.

10. To hear the reports of Agents, Auditors, and Committees heretofore chosen and take action on the same.

11. To transact any other business that may legally come before said meeting.

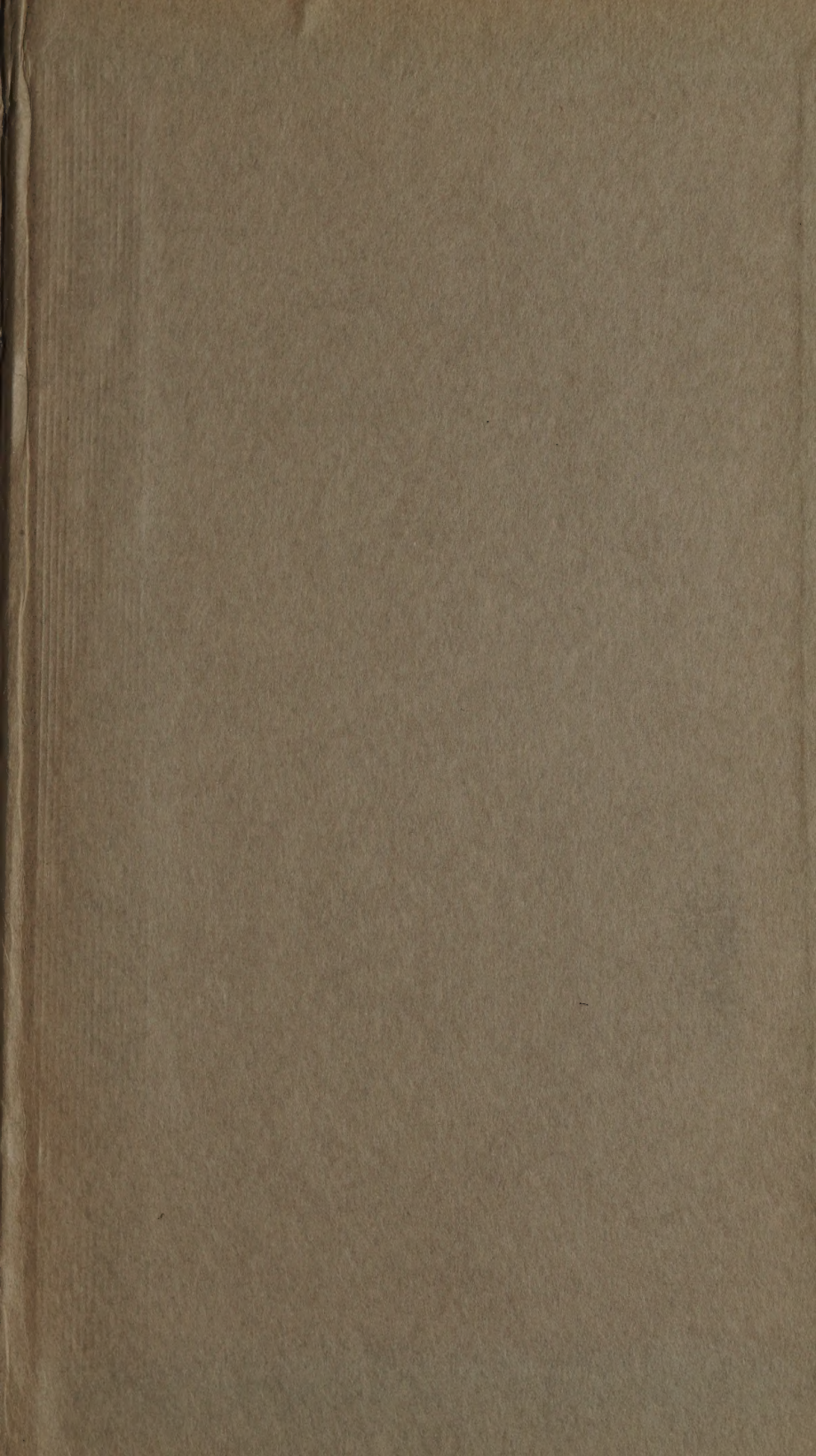
